## **Safety Information**

## **Handling Static Sensitive Devices**

**Attention:** Static electricity can damage this device and your system unit. To avoid damage, keep this device in its static protective bag until you are ready to install it. To reduce the possibility of electrostatic discharge, follow the precautions listed below:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- · Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and possibly damage the device.
- While the device is still in its anti-static package, touch it to an unpainted metal
  part of the system unit for at least two seconds. (This drains static electricity
  from the package and from your body.)
- Remove the device from its package and install it directly into your system unit
  without setting it down. If it is necessary to set the device down, place it on its
  static-protective package. (If your device is an adapter, place it component-side
  up.) Do not place the device on your system unit cover or on a metal table.
- Take additional care when handling devices during cold weather, as heating reduces indoor humidity and increases static electricity.

## Chapter 1. Overview

The 9.1GB 10K ULTRA SCSI Hot-Swap Disk Drive Unit is a 3.5" form factor disk drive. The disk drive is mounted on a hot-swap carrier and may or may not contain a plastic spacer. If your disk drive has a plastic spacer, when assembled, the disk drive, spacer, and carrier occupy the space equivalent to a 1.6" high disk drive. If your disk drive does not have a plastic spacer, when assembled, the disk drive and carrier occupy the space equivalent to a 1.0" high disk drive.

The disk drive supports both Fast/Wide SCSI and Ultra-SCSI synchronous data transfer rates up to 40MB per second. The feature capacity of the 9.1GB 10K ULTRA SCSI Hot-Swap Disk Drive Unit is 9, 100, 369, 920 bytes. The hot-swap carrier is used in systems in which disk drives can be removed or inserted without turning off the machine. Refer to the illustration on page 3.

The disk drive meets the Small Computer System Interface-2 (SCSI-2) standards set by the American National Standards Institute (ANSI).


## Chapter 2. Adding a Hot-Swap Disk Drive

This chapter describes how to add a disk drive to your system unit without turning off the system unit. The 9.1GB 10K ULTRA SCSI Hot-Swap Disk Drive Unit is supported on several operating systems. This chapter also includes instructions for configuring the disk drive on an AIX system. If you use another operating system, refer to your operating system documentation for information about configuring a hot-swap disk drive.

#### Installing the Disk Drive

To install the disk drive, do the following:

1. Your disk drive may or may not have a plastic spacer. Refer to the illustration below to determine whether your disk drive has a plastic spacer. If your disk drive has the plastic spacer, do not remove the plastic spacer. Continue with step 2.

	2.	Install the 9.1GB 10K ULTRA SCSI Hot-Swap Disk Drive Unit into your system unit according to the installation procedures provided in your system unit documentation, then return here.		
		<b>Note:</b> The SCSI address for the disk drive is automatically set when the disk drive is installed into your system. Do not attempt to set the SCSI address for the drive using jumpers.		
3. Check that the green LED is on. If the green LED is blinking or does no appear, there is a problem with the drive. Repeat step 2 above. If the problem still exists after repeating step 2, see "Running Diagnostics" on page 5.

#### **Running Diagnostics**

You can also run diagnostics to test the disk drive and reduce the possibility of:

- Unpredictable SCSI errors
- System hangs
- System damage (to a device, backplane, or adapter)
