- · Reduce the weight of the rack cabinet by removing equipment starting at the top of the rack cabinet. When possible, restore the rack cabinet to the configuration of the rack cabinet as you received it. If this configuration is not known, you must observe the following precautions:
  - Remove all devices in the 32U position and above.
  - Ensure that the heaviest devices are installed in the bottom of the rack cabinet.
  - Ensure that there are no empty U-levels between devices installed in the rack cabinet below the 32U level.
- If the rack cabinet you are relocating is part of a suite of rack cabinets, detach the rack cabinet from the suite.
- Inspect the route that you plan to take to eliminate potential hazards.
- · Verify that the route that you choose can support the weight of the loaded rack cabinet. Refer to the documentation that comes with your rack cabinet for the weight of a loaded rack cabinet.
- Verify that all door openings are at least 760 x 230 mm (30 x 80 in.).

- Ensure that the four leveling pads are raised to their highest position.
- Ensure that there is no stabilizer bracket installed on the rack cabinet during movement.
- Do not use a ramp inclined at more than 10 degrees.
- When the rack cabinet is in the new location, complete the following steps:
  - Lower the four leveling pads.
  - Install stabilizer brackets on the rack cabinet.
  - If you removed any devices from the rack cabinet, repopulate the rack cabinet from the lowest position to the highest position.
- If a long-distance relocation is required, restore the rack cabinet to the configuration of the rack cabinet as you received it. Pack the rack cabinet in the original packaging material, or equivalent. Also lower the leveling pads to raise the casters off of the pallet and bolt the rack cabinet to the pallet.

## Power and cabling information for NEBS (Network Equipment-Building System) **GR-1089-CORE**

The following comments apply to the servers that have been designated as conforming to NEBS (Network Equipment-Building System) GR-1089-CORE:

The equipment is suitable for installation in the following:

- Network telecommunications facilities
- Locations where the NEC (National Electrical Code) applies

The intrabuilding ports of this equipment are suitable for connection to intrabuilding or unexposed wiring or cabling only. The intrabuilding ports of this equipment must not be metallically connected to the interfaces that connect to the OSP (outside plant) or its wiring. These interfaces are designed for use as intrabuilding interfaces only (Type 2 or Type 4 ports as described in GR-1089-CORE) and require isolation from the exposed OSP cabling. The addition of primary protectors is not sufficient protection to connect these interfaces metallically to OSP wiring.

Note: All Ethernet cables must be shielded and grounded at both ends.

# Installing the 57/96 and 14G/30 expansion units

Use this overview as a guide to the tasks required for installing the 57/96 and 14G/30 expansion units (PCI-DDR 12X Expansion Drawer) into a rack and cabling it to a server.

#### **Procedure**

You can use the following table to read about and complete the high-level tasks for installing the 57/96 and 14G/30 expansion units.

Table 1. Tasks to install the expansion unit into a rack

Determine where to install the expansion unit in the rack and mark the location.	The expansion unit is installed in a shell that is mounted to the rack.

# Installing the 57/96 and 14G/30 expansion units: Details

The detailed installation procedure includes information from online references that are specified in the overview. You can use the expanded instructions in this procedure to install your expansion unit into a rack and to cable it to a server.

## Before you begin

- This information is provided in printed form as a list of basic tasks for installing the 57/96 and 14G/30 expansion units. For the most current version, use the online information: Installing the 5796 and 7314-G30 expansion units.
- This procedure assumes that you are installing the 57/96 or 14G/30 expansion unit into an existing rack. If the rack is not yet installed, you must first complete the procedure for Installing the rack.
- Before installing the expansion unit into a rack, read the Rack safety notices.

#### **About this task**

To install the 57/96 or 14G/30 expansion unit, complete the following tasks:

- 1. Unpack the expansion unit as follows:
  - a. Refer to the kitting list provided with the rack installation kit, and complete a parts inventory.
  - b. Locate the rack-mounting hardware kit and the system rail assemblies that were included with your expansion unit.
- 2. Determine where to install the expansion unit in the rack. Choose one of the following options:
  - **a.** If you are installing the system unit into an existing shell, skip this step and continue with step 5 on page 8
  - b. If you have a rack-mounting template, use it to mark the location.
  - c. If you do not have a rack-mounting template, perform the following steps to mark the location:
    - 1) Determine where in the rack to place the expansion unit in relation to other system hardware. As you plan, keep the following steps in mind:
      - a) Organize larger and heavier units into the lower part of the rack.
      - b) Plan to install units into the lower part of the rack first.
      - c) Record the EIA locations in your plan.

**Note:** The expansion unit is four Electronic Industries Alliance (EIA) units high. An EIA unit is 44.50 mm (1.75 in.) in height. The rack contains three mounting holes for each EIA unit of height. This enclosure, therefore, is 177.8 mm (7 in.) high and covers 12 mounting holes in the rack.

The following illustration shows a 1-EIA unit and a 4-EIA unit. Depending on the rack manufacturer, the EIA units might be separated either by color or by a line. The holes along the EIA strip are not evenly spaced. If your rack has no color or line separation between EIAs, assume that each EIA section begins where the hole spacing is closest together.




Figure 1. EIA units with expandable rails for the 5796 expansion unit

- 2) Face the front of the rack and working from the left side. Make a note of the lowest EIA unit to be used for the expansion unit. Use tape, a marker, or a pencil to mark the top mounting hole (A) of the lowest EIA unit. Count up two holes and place another mark beside that mounting hole (B). Mark the rack so that these marks can also be seen from the rear of the rack
- 3) Begin with the hole identified by your mark for **B**. Count up two holes and place a nut clip **(C)** in that mounting hole. Count up two holes and place a nut clip **(D)** in that mounting hole.
- 4) Repeat the last two steps to place two marks and place two nut clips on the corresponding mounting holes on the front-right side of the rack.
- 5) Go to the back of the rack. On the left side, find the EIA unit that corresponds to the lowest EIA unit marked on the front of the rack.
- 6) Mark the top mounting hole (E) of this EIA unit. Count up two holes and place another mark beside that mounting hole (F). Count up four holes and place another mark beside that mounting hole (G).
- 7) Repeat the last step to place three marks on the corresponding mounting holes on the rear-right side of the rack.
- 3. Install the rail assembly into the rack as follows:

**Important:** To complete this procedure, it is suggested that you use two people to attach the rail assembly to the rack. Position one person in front of the rack and one person at the rear of the rack. **CAUTION:** 

Installing the rails in the rack is a complex procedure. To install the rails correctly, you must perform each task in the following order. Failure to do so might cause rail failure and potential danger to yourself and the system unit.

a. Loosen the two screws (B) in the middle of both rails (A) to allow each rail to extend.




Figure 2. Extending the rails

- b. Starting at the rear of the rack, extend the left rail. Insert the rail pins **(C)** into the marked locations on the rack so that it is facing upward (L shape).
- **c**. From the rear of the rack, extend the right rail and insert the rail pins **(C)** into the marked locations.
- d. Move to the front of the rack, extend the left rail and insert the rail pins **(C)** into the marked locations.
- e. Extend the right rail and insert the rail pins (C) into the marked locations.
- f. Using one M5 screw (D), secure the left rail to the front of the rack into the lower location (E).

**Important:** Do not install a screw in the top location at this time. It will secure the shell to the assembly.




Figure 3. Attaching the rails to the front of the rack

- g. Using one M5 screw (D), secure the right rail to the front of the rack into the lower location (E).
- h. Move to the rear of the rack and locate the marks that were previously made on the back-left rail. Using two M5 screws (G), secure the rail arm to the rack at the location of the two lowest marks.




Figure 4. Attaching the rails to the back of the rack

i. Align the top alignment pin of the bracket **(F)** with the highest mark, and use one M5 screw **(G)** to secure the bracket to the rack at this location.

Note: The bracket will face inward.

- j. Locate the marks that were previously made on the back-right rail of the rack. Using two M5 screws (G), secure the rail arm to the rack at the location of the two lowest marks.
- k. Align the top alignment pin of the bracket **(F)** with the highest mark, and use one M5 screw **(G)** to secure the bracket to the rack at this location.
- I. Tighten the two screws **(B)** in the middle of the left rail and the two screws **(B)** in the middle of the right rail. See Figure 2 on page 5.
- 4. Install the shell as follows:
  - a. From the front of the rack, place the shell (A) on the rails and slide it into the rack.




Figure 5. Installing the shell into the rack on the expandable rails

- A ShellB Retaining screws (four)
- b. Secure the shell **(A)** to the rack by installing and tightening retaining screws **(B)** into the top and bottom holes on each side of the front of the shell.
- 5. Install the expansion unit into the shell as follows:
  - a. Remove the front and back shipping covers of the 57/96 or 14G/30. These shipping covers are secured by four thumb screws each. Two screws are located on the top of the cover and two are located on the sides of the cover.
  - b. If you are installing an expansion unit (H) into an existing shell (G) that has a filler plate (F), remove the filler plate by pressing down on the top tabs and pulling it out.




Figure 6. Removing the filler plate

- c. Slide the expansion unit (H) into the shell.
- d. Use a thumb screw (I) to install the cable retention bracket (J).
- **e**. If you have two expansion units to install, repeat the last four steps to install the second expansion unit.
- f. If only one expansion unit is installed in the shell, install the filler plate (N) in the blank slot in the shell by sliding the filler plate up under the top tab of the shell. Gently press the filler plate into place.




Figure 8. Installing the filler plate

- g. Insert the posts on the bottom of the cover (A) into the hooks on the chassis of the enclosure.
- h. Press in on the two latches (C) on the right and left of the front cover.




Figure 9. Front cover on a model 14G/30

i. Press the cover onto the chassis and release the latches. The cover securely snaps into place.

- j. Replace the two thumbscrews (B) into the slots on the left and right of the front cover.
- 6. Cable the expansion unit to the server as follows:

**Attention:** Consult your server documentation to determine if the server must be powered off before connecting the expansion unit. If you cannot determine the requirement for your server, power off the server before connecting the cables.

#### **Notes:**

- This unit uses system power control network (SPCN) cables to connect to the server.
- If you are adding a new expansion unit or migrating expansion units from another IBM POWER<sup>®</sup> server, you might not be able to allocate the expansion unit resources to logical partitions on the new server until an SPCN firmware update is completed for the expansion units.
- a. Review connector information for the hardware in your configuration as follows:
  - 1) Review the following connector locations figure for the 57/96 or 14G/30.




Figure 10. Model 57/96 or 14G/30 connector locations

- 2) Review connector information for the system. For details on systems connector locations, see "Connector locations" on page 23.
- b. Cable the expansion unit as follows:
  - 1) Based on your system configuration and power requirements, choose one of the following options for installing your expansion unit:

**Important:** For more information about the system power requirements for your configuration, see Overview for I/O expansion units (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7hamconcepts.htm).

- If you are connecting your expansion units to an existing system that can remain powered on, continue with step 6b2 on page 12.
- If you are connecting your expansion units to an existing system that must be powered off, perform the following steps:

- a) Remove power from the system. For details, see Stopping a system or logical partition (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7haj/ crustopsys.htm).
- b) Go to step 6b5 on page 13.
- If you are connecting your expansion units to a new system being installed, continue with step 6b5 on page 13.
- 2) Verify the existing 12X configuration. If problems with the 12X loops are discovered in this step, they must be corrected before continuing with this procedure. Follow the appropriate step to determine if there are problems with the 12X configuration.
  - If your system is managed by a Hardware Management Console (HMC) or Systems Director Management Console (SDMC), see Verifying the 12X loops with an HMC or SDMC (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7ham/ ipham\_verifyriohslloopwhmc.htm). One of the steps in that task is to verify the status of the links in the 12X loops. When you are instructed to use the **View Hardware Topology** task on the HMC, you can use the **Save** button to save the current hardware topology. This action allows you to compare the topology that existed before the expansion units were added with the topology that was created by adding the expansion units.
  - If your system is not managed by an HMC or SDMC, see Verifying the 12X loops without an HMC or SDMC (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/ p7ham/ipham\_verifyriohslloopwohmc.htm).
- 3) Verify the existing system power control network (SPCN). For details, see Verifying the system power control network (http://publib.boulder.ibm.com/infocenter/systems/scope/ hw/topic/p7ham/verifyspcn.htm). If you discover a problem with the SPCN, you must correct the problem before continuing.
- 4) Set the SPCN Firmware Update Policy to prevent firmware updates over the serial SPCN interface.
  - The SPCN Firmware Update Policy controls when and how SPCN firmware on expansion units is updated. The default setting for the SPCN Firmware Update Policy is Enabled. This setting allows for firmware updates to be completed over the 12X interface whenever an update is required and does not allow updates over the slower serial SPCN interface.
  - a) Access the Advanced System Management Interface (ASMI) using an authority level of administrator or authorized service provider. For details on using the ASMI, see Managing the Advanced System Management Interface (http://publib.boulder.ibm.com/ infocenter/systems/scope/hw/topic/p7hby/asmi.htm).
  - b) In the ASMI navigation area, expand System Configuration and select Configure I/O Enclosures.
    - · If the SPCN Firmware Update Policy shows Expanded, record the current setting so you can restore it later. Then change the setting to Enabled.
    - · If the SPCN Firmware Update Policy shows Enabled or Disabled, continue without changing the setting.
  - c) Verify that no SPCN firmware updates are in progress by checking the Power Control Network Firmware Update Status column. This column shows In Progress and a percent complete if an SPCN firmware update is in progress.
    - If an SPCN firmware update is in progress, check the Power Control Network Firmware Update Status column to determine the type of update. Then choose one of the following actions:
    - If the SPCN firmware update is an High Speed Link (HSL) update, wait for the update to complete before continuing. An HSL update of the SPCN firmware completes quickly.
    - If the SPCN firmware update is a serial update, either wait for the update to complete or stop the update. A serial update of the SPCN firmware can take 20 minutes or more depending on how many expansion units are in the configuration.

To determine when the update is completed, select **Configure I/O Enclosures** every 15 - 30 seconds until Not Required is displayed in the Power Control Network Firmware Update Status column. Do not use the **Back** or **Refresh** buttons on the browser to monitor the status.

If you choose to stop the update, the update will be restarted from the beginning after you have completed the procedure. To stop the update, perform the following steps:

- i. Click Stop SPCN Firmware Update in the Configure I/O Enclosures window.
- ii. Click **Configure I/O Enclosures** every 15 30 seconds until Pending is displayed in the Power Control Network Firmware Update Status column. Do not use the **Back** or **Refresh** buttons on the browser to monitor the status.
- 5) Remove or open the back cover of the system unit.
- 6) To connect the expansion units with 12X cables, see Connecting expansion units with 12X cables (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7ham/direct.htm).

**Note:** If you are installing expansion units in an existing 12X loop with the system powered on, serviceable events and informational logs might be generated when you disconnect and reconnect cables. This action is normal and will be covered later in the procedure.

7) To connect the expansion units with SPCN cables, see Connecting expansion units with SPCN cables (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7ham/spcndirect.htm).

**Note:** If you are installing expansion units in an existing SPCN loop with the system powered on, serviceable events and informational logs might be generated when you disconnect and reconnect cables. This action is normal and will be covered later in the procedure.

8) Connect the power cables for the expansion units that you are installing to the power source. Then connect them to the power supplies on the expansion units. If you installed the expansion units with the system's power off, continue with step 6b10. If not, continue with the next step.

**Note:** Plug the power cable into the power source before connecting it into the power supply of the expansion unit.

9) The expansion units power on automatically. After the expansion units that you have installed are powered on and you have waited 10 minutes for the hardware initialization to complete, continue with step 6b11.

**Tip:** For each expansion unit, wait for the green power indicator to light solid on the control panel of the expansion unit that just powered on. This action might take 1 - 10 minutes. During this time, a yellow attention indicator might be lit on the control panel of the expansion unit that just powered on. After the green power indicators are lit on the control panels of all the expansion units that were just powered on, wait 10 additional minutes for hardware initialization to complete before proceeding to step 6b11.

- 10) To start the system or logical partition, see Starting the system or logical partition (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7haj/crustartsys.htm).
- 11) Verify the SPCN configuration. After reading the following note, see Verifying the system power control network (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7ham/verifyspcn.htm).

**Note:** While concurrently adding an expansion unit, it is normal for error logs and event logs to be created with the following SPCN-related reference codes. The number and combination of these logs is dependent on the configuration. The logs can be ignored during this

verification step if their timestamps indicate that they occurred during the add procedure and if the resources that they refer to were involved in the procedure.

- 10009133: The 12X loop was disrupted. This reference code appears in an informational log.
- 10009135: The SPCN loop was opened. This reference code might appear in a serviceable event or an informational log.
- 10009136: An SPCN firmware update was stopped. This reference code appears in an informational log.
- 10009137: The 12X loop was disrupted. This reference code appears in an informational log.
- 10009139: The SPCN loop was closed. This reference code appears in an informational log.
- 1000913B: An SPCN firmware update was required, but not automatically started. This reference code appears in a serviceable event. This condition is corrected in step 6b15 on page 16.
- 1000910A: An SPCN firmware update was initiated. This reference code appears in an informational log.
- 100091DE: An SPCN firmware update completed. This reference code appears in an informational log.
- 12) Verify that the Power Control Network Identifier value is set correctly for the expansion units you are adding by completing the following steps:
  - a) Access the ASMI by using an authority level of administrator or authorized service provider. For details about using the ASMI, see Managing the Advanced System Management Interface (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/ topic/p7hby/asmi.htm).
  - b) In the ASMI navigation area, expand System Configuration and select Configure I/O Enclosures.
  - c) Review the Enclosure Configuration table to locate the expansion units that you added.
  - d) Use the following information to verify that each expansion unit that you added has the correct Power Control Network Identifier:
    - Identifier 0x8D is for 57/96 and 14G/30 expansion units.
    - Identifier 0x8E is for 58/02 and 58/77 expansion units.
  - e) If an incorrect Power Control Network Identifier is specified for an expansion unit that you have added, contact your service provider for assistance before continuing with this procedure.
- 13) Verify the 12X configuration. After reading the following note, perform one of the following actions:
  - If your system is managed by an HMC or SDMC, see Verifying the 12X loops with an HMC or SDMC (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/ p7ham/ipham\_verifyriohslloopwhmc.htm). If you saved the original hardware topology before adding expansion units in step 6b2 on page 12, the saved topology now appears in Last Valid Hardware Topology section of the View Hardware Topology output. This operation enables you to compare the topology that was created by adding the expansion units to the topology that existed before the expansion units were added.
  - If your system is not managed by an HMC or SDMC, see Verifying the 12X loops without an HMC or SDMC (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/ p7ham/ipham\_verifyriohslloopwohmc.htm).

Note: While concurrently adding an expansion unit, it is normal for error logs and event logs to be created with the following 12X-related reference codes. The number and combination of these logs is dependent on the configuration. The logs can be ignored during this verification step if their timestamps indicate that they occurred during the add procedure and if the resources that they refer to were involved in the procedure.

- B70069E7: A 12X link was restored. This reference code appears in an informational log.
- 14) Check for and handle new serviceable events that were generated during the procedure by performing the following steps:
  - a) Choose one the following options:

**Important:** Multiple options might apply to your configuration. Choose only the first option that applies.

- If your system is managed by an HMC, perform the following steps:
  - i. In the navigation area, select **Serviceability** > **Manage Serviceable Events**.
  - ii. Continue with step 6b14b.
- If your system is managed by an SDMC, perform the following steps:
  - i. On the Welcome page, click the Manage tab.
  - ii. Click Service and Support Manager > Serviceable Problems.
  - iii. Continue with step 6b14b.
- If your system is not managed by an HMC or SDMC and has a partition running the Virtual I/O Server (VIOS) operating system, perform the following steps:
  - i. Log in as the padmin user. If you need assistance, contact the system administrator.
  - ii. Type diagmenu -d sysplanar0 -E xx and press Enter, where xx is a number 1 60 that specifies a number of days. This command returns results for the most recent number of days specified. The suggested range is 30 days.
  - iii. On the DIAGNOSTIC MODE SELECTION display, highlight the **Problem Determination** option, and press Enter.
  - iv. Continue with step 6b14b.
- If your system is not managed by an HMC or SDMC and has a partition running the AIX® operating system, perform the following steps:
  - i. Log in as the root user, or use the CE login. If you need assistance, contact the system administrator.
  - ii. Type diag -d sysplanar0 -E xx and press Enter, where xx is a number 1 60 that specifies a number of days. This command returns results for the most recent number of days specified. The suggested range is 30 days.
  - iii. On the DIAGNOSTIC MODE SELECTION display, highlight the **Problem Determination** option, and press Enter.
  - iv. Continue with step 6b14b.
- If your system is not managed by an HMC or SDMC and has a partition running the Linux operating system, perform the following steps:
  - i. Log in as the root user. If you need assistance, contact the system administrator.
  - ii. Type servicelog -query='serviceable=1 AND closed=0 AND time\_event>="yyyy-mm-dd"' (where *yyyy-mm-dd* is the day on which the procedure occurred). Press Enter.
  - iii. Continue with step 6b14b.
- b) Specify event criteria that includes events that were generated during the procedure.

- c) Close any serviceable events generated during the procedure that include one of the reference codes listed in step 6b11 on page 13 or step 6b13 on page 14.
- d) Perform problem analysis on any remaining open serviceable events.
- 15) Start necessary SPCN firmware updates.

If reference code 1000913B was found in step 6b11 on page 13, an SPCN firmware update is needed. However, due to the current SPCN Firmware Update Policy, the update could not be initiated automatically. Therefore, the SPCN firmware update must be initiated manually. Wait for the SPCN firmware updates to complete before continuing to the next step. This update could take 20 minutes to several hours, depending on the number of expansion units on the SPCN loop and the current level of the SPCN firmware in the expansion units that were added.

  - b) In the ASMI navigation area, expand **System Configuration** and select **Configure I/O** Enclosures.
  - c) Change the SPCN Firmware Update Policy setting to the setting recorded in step 6b4 on page 12. Use the default setting, which is **Enabled**.
- 17) Verify the new configuration. For details, see Verifying that the new configuration is functioning (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/topic/p7ham/ verify.htm).
- 18) If the system has logical partitions, you can now assign I/O slots in the expansion units that were added to logical partitions.

You have completed the addition of your expansion unit.

    - If your system is not managed by a Hardware Management Console (HMC) or Systems Director Management Console (SDMC), continue with step 7b.
    - If your system is managed by an HMC, continue with step 7c.

  - b. Choose one the following options:

**Important:** Multiple options might apply to your configuration. Choose only the first option that applies.

- If your system is running the Virtual I/O Server (VIOS) operating system, continue with step 7e on page 17.
- If your system is running the AIX operating system, continue with step 7f on page 17.
- If your system is running the Linux operating system, continue with step 7g on page 18.
- c. Use the HMC to verify that no serviceable events include 10009xxx reference codes (where x is any character 0 - 9 or A - F) by completing the following steps:
  - 1) In the navigation area, select **Service Management**.
  - 2) In the contents area, select Manage Serviceable Events.
  - 3) In the Manage Serviceable Events window, perform the following steps:
    - a) Click Open for the Serviceable Event Status field.

- b) Select the machine type, model, and serial number (MTMS) of the server you are working with for the **Reporting MTMS** field.
- c) Click ALL for all other fields and click OK.
- 4) Scan for any serviceable events that include 10009xxx reference codes, and perform one of the following actions:
  - If there are no serviceable events with 10009xxx reference codes, click **Cancel** twice to exit Manage Serviceable Events.

- d. Use the SDMC to verify that no serviceable events include 10009xxx reference codes (where x is any character 0 9 or A F) by completing the following steps:

  - 2) Expand Hosts.
  - 3) Right-click the host and clickService and Support > Reference Code History.
  - 4) Scan for any serviceable events that include 10009xxx reference codes, and perform one of the following actions:
    - If there are no serviceable events that include 10009xxx reference codes, close the Reference Code History window.
    - If serviceable events include 10009xxx reference codes, there might be problems with the SPCN loop. Perform problem analysis on the serviceable events to correct the problems before continuing. If you need assistance, contact your service provider.
  - 5) Go to step 7h on page 18.
- e. Use the VIOS error log to verify that there are no 10009xxx errors (where x is any character 0 9 or A F) by completing the following steps.
  - 1) Log in as the padmin user. If you need assistance, contact the system administrator.
  - 2) Type diagmenu -d sysplanar0 -E xx and press Enter, where xx is any number 1 60 that specifies a number of days. This command returns all 10009xxx error log entries for the most recent number of days specified. The suggested range is 30 days.
  - 3) Highlight the **Problem Determination** option in the DIAGNOSTIC MODE SELECTION display. Press Enter.
  - 4) Search the results that are displayed to identify problems with 10009xxx reference codes. You might need to scroll down in the display to see all of the results.

**Note:** If the Problem Determination results contain serviceable events that have already been reported, the PREVIOUS DIAGNOSTICS RESULTS display is shown. Respond to the **Do you want to review these previously reported errors?** prompt by highlighting the YES response, and then press Enter.

- 5) Based on the results of your search, perform one of the following options:
  - If there are no problems with 10009xxx reference codes, press Enter to return to the command line.
  - If there are problems with 10009xxx reference codes, there might be problems with the SPCN loop. Perform problem analysis on the problems to correct them before continuing. If you need assistance, contact your service provider.
- 6) Go to step 7h on page 18.
- f. Use the AIX error log to verify that there are no 10009xxx errors (where x is any character 0 9 or A F) by completing the following steps.
  - 1) Log in as the root user, or use the CE login. If you need assistance, contact the system administrator.

- 2) Type diag -d sysplanar0 -E xx and press Enter, where xx is any number 1 60 that specifies a number of days. This command returns all 10009xxx error log entries for the most recent number of days specified. The suggested range is 30 days.
- 3) Highlight the **Problem Determination** option in the DIAGNOSTIC MODE SELECTION display. Press Enter.
- 4) Search the results that are displayed to identify problems with 10009xxx reference codes. You might need to scroll down in the display to see all of the results.

Note: If the Problem Determination results contain serviceable events that have already been reported, the PREVIOUS DIAGNOSTICS RESULTS display is shown. Respond to the Do you want to review these previously reported errors? prompt by highlighting the YES response, and then press Enter.

- 5) Based on the results of your search, perform one of the following options:
  - If there are no problems with 10009xxx reference codes, press Enter to return to the command line.

  - 2) Type servicelog --query='refcode like "10009%" AND serviceable=1 AND closed=0' and
  - 3) Search the results that are displayed for problems with 10009xxx reference codes and statuses that are open. If there are problems with 10009xxx reference codes, there might be problems with the SPCN loop. Perform problem analysis on the problems to correct them before continuing. If you need assistance, contact your service provider.

Note: You might need to scroll down in the display to see all of the results.

- 4) Go to step 7h.
- h. Verify that no inactive expansion units are in the SPCN by performing the following steps:

Important: If you are here because the procedure to concurrently add expansion units instructed you to perform this task following steps to connect the power cables and power on the expansion units, do not perform the following steps to clear the inactive enclosures. Contact your service provider for assistance.

- b) Wait for the completion indication, and repeat steps 7h2 and 7h3. If inactive expansion units remain, do not continue. Contact your service provider for assistance.

- 3) Review the display to determine if there are any expansion units that require correction. If you find one or more rows that contain a Location code value of UTMP*x.xxx.xxxxxxx*, where *x* is any character 0 9 or A Z, continue to step 7j to provide the necessary corrections. If there are no rows with Location codes that require correction, continue to step 7k on page 20.
- j. For each expansion unit found in your review, complete the following steps to correct the machine type, model, and serial number (MTMS) values. After you have completed the corrections required for all expansion units identified in your review, continue to step 7k on page 20.

**Important:** If your expansion unit contains one or more I/O slots that are owned by active partitions running the VIOS, AIX, or Linux operating system, these partitions will not automatically recognize the MTMS value corrections that you are about to make. For these partitions to recognize the new values, you will be required to take additional action that is potentially disruptive. Before proceeding with this step, review step 7j5 to determine whether it is possible to take the required actions at this time. If it is not, continue to step 7k on page 20 without performing this step.

  - b) Enter the correct serial number in the **Serial number** field.
  - c) Do not update the Power Control Network Identifier field.
  - d) Click Save settings.
- 4) In the ASMI navigation area, expand **System Configuration** and click **Configure I/O Enclosures** again. Verify that the values you entered are displayed in the information for the expansion unit that you selected in step 7j3. If the values that you entered are not displayed, wait for a few minutes and repeat this step. If the problem persists, contact your service provider for assistance.

Important: Do not click Back for the purpose of verifying your values.

- 5) If the expansion unit that you corrected contains one or more I/O slots that are owned by active partitions running the AIX, VIOS, or Linux operating system, the corrections will not be recognized by those partitions until you take one of the following actions:
  - Power off and power on the expansion unit. To perform this task, select one of the following options:
    - If the system is managed by an HMC, click Serviceability > Hardware > Power On/Off Unit to perform this task.
    - If the system is managed by an SDMC, click Service and Support > Hardware > Power On/Off Unit to perform this task.
    - If the system is not managed by an HMC or SDMC, you must choose one of the other options in this list.
  - Power off and power on active partitions that own I/O slots in the expansion unit that you
    corrected and that are running the AIX, VIOS, or Linux operating system.

- Dynamically remove I/O slots in the expansion unit that you corrected from active partitions that are running the AIX, VIOS, or Linux operating system, and then dynamically add the slots back to those partitions. To perform this task, select one of the following options:
  - If the system is managed by an HMC, click Dynamic Logical Partitioning > Physical **Adapters** to perform this task.
  - If the system is managed by an SDMC, click Dynamic Logical Partitioning > Manage Virtual Server to perform this task.
  - If the system is not managed by an HMC or SDMC, you must choose one of the other options in this list.
- Power off and power on the server.
- k. Return to the procedure that sent you here.
- 8. Verify that the new expansion unit configuration is functioning. Choose from the following options:
  - a. If your system is not managed by an HMC, see Verifying the installed part.
  - b. If your system is managed by an HMC, perform the following steps:
    - 1) To view more information about the managed system, choose a system console option:
      - If your system is managed by an HMC, complete the following steps:
        - a) From the navigation area, expand **Systems Management**.
        - b) Click Servers.
        - c) Select the system with which you want to work. Information about the system is shown under the Tasks section in the content area.
      - If your system is managed by an SDMC, complete the following steps:
        - a) From the navigation area, expand **Hosts**.
        - b) Click the server with which you want to work. Information about the system is shown under the Actions menu.
    - 2) To verify the new expansion units, complete the following steps:
      - a) To view the properties of the managed system, choose a system console option:
        - i. If your system is managed by an HMC, complete the following steps:
          - i) Select the server for which you want to verify the configuration.
          - ii) Click **Tasks** > **Properties**.
          - iii) Click the I/O tab.
        - ii. If your system is managed by an SDMC, complete the following steps:
          - i) On the **Welcome** page, click the **Resources** tab.
          - ii) In the content pane, select the server for which you want to verify the configuration.
          - iii) Click **Actions** > **Properties**.
          - iv) Click the **Inventory** tab.
      - b) Verify that the new expansion units are displayed in the list. It might take several minutes for the new expansion units to be displayed in the list.

**Tip:** To refresh the list of expansion units, choose a system console option:

- For the HMC option, repeat steps 8b2aiii and 8b2aiiii.
- For the SDMC option, repeat steps 8b2aiiiii and 8b2aiiiv.

It is not necessary to exit the Properties task before repeating these steps, but doing so reduces the number of active tasks.

If the I/O Properties window does not display the new expansion units after 10 minutes, verify the installation by completing the following steps:

i. Ensure that the expansion units are powered on and that the power cables are connected to the power source and the expansion units.

- ii. Ensure that the 12X cables are connected correctly. For details, see Connecting expansion units with 12X cables (http://publib.boulder.ibm.com/infocenter/systems/scope/hw/ topic/p7ham/direct.htm).




Figure 11. Model 02E/4B connector locations on a rack-mounted model




Figure 12. Model 02E/4B connector locations on a stand-alone model

Notes: The 02E/4C server supports 12X DDR and PCIe cable connector locations as follows:

- The card installed in the C1 slot can contain either two 12X DDR cable ports for I/O expansion unit support or one PCIe cable port for PCIe storage enclosure support. The C1 slot cannot provide both 12X DDR and PCIe cable ports.
- The card installed in the C8 slot can contain either two 12X DDR cable ports for I/O expansion unit support or one PCIe cable port for PCIe storage enclosure support. The C8 slot cannot provide both 12X DDR and PCIe cable ports.
- The port card type installed in the C1 slot can differ from the port card type installed in the C8 slot.
- The location and use of the SAS port are unaffected by the types of ports found in the C1 and C8 slots.
- The 02E/4C server supports one GX adapter, which can be installed in the C1 slot.




Figure 13. Model 02E/4C connector locations on a rack-mounted model




Figure 14. Model 05F/6B connector locations on a rack-mounted model




Figure 15. Model 05F/6B connector locations on a stand-alone model




Figure 16. Model 05E/6C connector locations on a rack-mounted model




Figure 17. Model 33E/8B connector locations on a rack-mounted model




Figure 18. Model 17M/MB or 79M/HB connector locations




Figure 19. Model 17M/MC or 79M/HC connector locations




Figure 20. Model 57/96 or 14G/30 connector locations
