Σημαντικές οδηγίες σχετικά με την ασφάλεια

- Σημείωση

Παρακαλούμε διαβάστε πρώτα τις σημαντικές πληροφορίες για την ασφάλεια.

Οι πληροφορίες αυτές μπορούν να σας βοηθήσουν να χρησιμοποιείτε τον προσωπικό σας υπολογιστή ThinkPad με ασφάλεια. Ακολουθήστε και φυλάξτε όλες τις πληροφορίες που παρέχονται μαζί με τον υπολογιστή ThinkPad σας. Οι πληροφορίες που περιέχονται σε αυτό το έγγραφο δεν τροποποιούν τους όρους της σύμβασης αγοράς που συνάψατε ούτε τη Δήλωση Περιορισμένης Εγγύησης της Lenovo.

Η ασφάλεια των πελατών είναι σημαντική για τη Lenovo. Τα προϊόντα μας είναι σχεδιασμένα να είναι ασφαλή και αποτελεσματικά. Ωστόσο, οι προσωπικοί υπολογιστές είναι ηλεκτρονικές συσκευές. Τα καλώδια ρεύματος, οι μετασχηματιστές και άλλα εξαρτήματά τους μπορούν να δημιουργήσουν κινδύνους που θα μπορούσαν να έχουν ως αποτέλεσμα την πρόκληση τραυματισμών ή ζημιών, ειδικά σε περίπτωση κακής χρήσης τους. Για να μειώσετε αυτούς τους κινδύνους, ακολουθήστε τις οδηγίες που παρέχονται με το προϊόν σας, δώστε σημασία σε όλες τις προειδοποιήσεις που υπάρχουν στο προϊόν και στις οδηγίες λειτουργίας και διαβάστε προσεκτικά όλες τις πληροφορίες που περιέχονται σε αυτό το έγγραφο και παρέχονται με το προϊόν σας, μπορείτε να συμβάλετε στην προστασία σας από κινδύνους και να δημιουργήσετε ένα ασφαλέστερο περιβάλλον εργασίας.

Σημείωση: Οι πληροφορίες αυτές περιέχουν αναφορές σε μετασχηματιστές και μπαταρίες. Πέραν των φορητών προσωπικών υπολογιστών, η Lenovo παρέχει ορισμένα προϊόντα (όπως π.χ. ηχεία και οθόνες) με εξωτερικούς μετασχηματιστές. Αν έχετε ένα τέτοιο προϊόν, οι πληροφορίες αυτές ισχύουν για το προϊόν σας. Επιπρόσθετα, ο υπολογιστής σας μπορεί να περιέχει μια εσωτερική μπαταρία σε μέγεθος νομίσματος, η οποία τροφοδοτεί με ηλεκτρικό ρεύμα το ρολόι του συστήματός σας ακόμα και όταν ο υπολογιστής είναι αποσυνδεδεμένος. Επομένως οι πληροφορίες σχετικά με την ασφάλεια των μπαταριών ισχύουν για όλους τους υπολογιστές.

Καταστάσεις που πρέπει να αντιμετωπίζονται άμεσα

Τα προϊόντα μπορούν να υποστούν ζημιές λόγω κακής χρήσης ή αμέλειας. Σε ορισμένες περιπτώσεις, οι ζημιές ίσως είναι τόσο σοβαρές ώστε το προϊόν να μην πρέπει να χρησιμοποιηθεί ξανά έως ότου ελεγχθεί και, αν είναι αναγκαίο, επισκευαστεί από εξουσιοδοτημένο τεχνικό.

Όπως και με κάθε ηλεκτρονική συσκευή, πρέπει να προσέχετε το προϊόν όταν βρίσκεται σε λειτουργία. Σε πολύ σπάνιες περιπτώσεις, μπορεί να αντιληφθείτε μια οσμή ή να παρατηρήσετε καπνό ή σπίθες να εξέρχονται από τον υπολογιστή σας. Επίσης, μπορεί να ακούσετε ήχους που υποδηλώνουν κάποιο πρόβλημα. Οι συνθήκες αυτές ίσως απλά να σημαίνουν ότι έχει υποστεί βλάβη κάποιο εσωτερικό εξάρτημα, με ασφαλή και ελεγχόμενο τρόπο. Ίσως όμως υποδηλώνουν πιθανό πρόβλημα ασφάλειας. Ωστόσο, μη διακινδυνέψετε και μην προσπαθήσετε να διαγνώσετε το πρόβλημα μόνοι σας.

Ελέγχετε συχνά τον υπολογιστή σας και τα εξαρτήματά του, ώστε να εντοπίζετε τυχόν ζημιές, φθορά ή ενδείξεις κινδύνου. Αν υπάρχει οποιαδήποτε αβεβαιότητα σχετικά με την κατάσταση ενός εξαρτήματος, μη χρησιμοποιήσετε το προϊόν. Επικοινωνήστε με το Κέντρο Υποστήριξης Πελατών ή με τον κατασκευαστή του προϊόντος για οδηγίες σχετικά με τον έλεγχο του προϊόντος και, αν είναι απαραίτητο, την επισκευή του. Στην απίθανη περίπτωση που παρατηρήσετε οποιαδήποτε από τις συνθήκες που αναφέρονται παρακάτω, ή αν έχετε οποιεσδήποτε ανησυχίες σχετικά με την ασφάλεια του προϊόντος, σταματήστε να το χρησιμοποιείτε και αποσυνδέστε το από την πρίζα και από τις τηλεπικοινωνιακές γραμμές έως ότου επικοινωνήσετε με το Κέντρο Υποστήριξης Πελατών για περαιτέρω καθοδήγηση.

- Καλώδια ρεύματος, φις, μετασχηματιστές, επεκτάσεις καλωδίων, συσκευές προστασίας από υπέρταση ή τροφοδοτικά που έχουν κοπεί, ραγίσει, σπάσει ή υποστεί ζημίες.
- Ενδείξεις υπερθέρμανσης, καπνού, σπίθας ή φωτιάς.
- Ζημιές σε μια μπαταρία (όπως ρωγμές ή παραμόρφωση), αποφόρτιση μπαταρίας ή συσσώρευση ξένων ουσιών επάνω στη μπαταρία.
- Περίεργοι ήχοι ή δυνατή οσμή προερχόμενη από το προϊόν.
- Ενδείξεις ότι έχει χυθεί υγρό ή έχει πέσει κάποιο αντικείμενο επάνω στον υπολογιστή, το καλώδιο ρεύματος ή το μετασχηματιστή.
- Έκθεση του υπολογιστή, του καλωδίου ρεύματος ή του μετασχηματιστή σε νερό.
- Πτώση του προϊόντος ή άλλες ζημιές στο προϊόν.
- Μη κανονική λειτουργία του προϊόντος παρά τη χρήση του σύμφωνα με τις οδηγίες λειτουργίας.

Σημείωση: Αν παρατηρήσετε τέτοιες συνθήκες σε προϊόν (π.χ. μια επέκταση καλωδίου) που δεν έχει κατασκευαστεί από ή για τη Lenovo, σταματήστε να χρησιμοποιείτε αυτό το προϊόν έως ότου επικοινωνήσετε με τον κατασκευαστή του προϊόντος για περαιτέρω οδηγίες, ή έως ότου προμηθευτείτε κατάλληλο προϊόν αντικατάστασης.

Γενικές οδηγίες ασφάλειας

Τηρείτε πάντα τις ακόλουθες προφυλάξεις για να μειώσετε τον κίνδυνο τραυματισμού και πρόκλησης ζημιών.

Συντήρηση

Μην επιχειρήσετε να επισκευάσετε ένα προϊόν μόνοι σας, εκτός αν σας ζητηθεί συγκεκριμένα από το Κέντρο Υποστήριζης Πελατών. Χρησιμοποιείτε μόνο εξουσιοδοτημένο παροχέα υπηρεσιών, εγκεκριμένο για την επισκευή του συγκεκριμένου προϊόντος.

Σημείωση: Ορισμένα εξαρτήματα μπορούν να αναβαθμιστούν ή να αντικατασταθούν από τον πελάτη. Τα εξαρτήματα αυτά ονομάζονται Μονάδες Αντικαθιστώμενες από τον Πελάτη (Customer Replaceable Units - CRU). Η Lenovo προσδιορίζει ρητώς τα εξαρτήματα που αποτελούν μονάδες CRU και παρέχει τεκμηρίωση με οδηγίες όταν ενδείκνυται η αντικατάστασή τους από τον πελάτη. Πρέπει να ακολουθείτε πιστά όλες αυτές τις οδηγίες όταν αντικαθιστάτε μονάδες CRU. Να βεβαιώνεστε πάντα ότι έχετε σβήσει και αποσυνδέσει το προϊόν από οποιαδήποτε πηγή ρεύματος πριν επιχειρήσετε να πραγματοποιήσετε την αντικατάσταση. Για οποιεσδήποτε ερωτήσεις ή διευκρινίσεις, επικοινωνήστε με το Κέντρο Υποστήριξης Πελατών.

Αν και δεν υπάρχουν κινητά μέρη στον υπολογιστή αφού αποσυνδέσετε το καλώδιο ρεύματος, απαιτούνται οι ακόλουθες ειδοποιήσεις για λόγους πιστοποίησης UL.

Προσοχή: Προτού ξεκινήσετε την αντικατάσταση μονάδων CRU, κλείστε τον υπολογιστή και περιμένετε τρία έως πέντε λεπτά μέχρι να μειωθεί η θερμοκρασία στο εσωτερικό του υπολογιστή πριν ανοίξετε το κάλυμμα.

Καλώδια ρεύματος και μετασχηματιστές

Χρησιμοποιείτε μόνο τα καλώδια ρεύματος και τους μετασχηματιστές που παρέχονται από τον κατασκευαστή του προϊόντος. Το καλώδιο ρεύματος και ο μετασχηματιστής προορίζονται αποκλειστικά για χρήση με αυτό το προϊόν. Δεν πρέπει να χρησιμοποιηθούν σε καμία περίπτωση με οποιοδήποτε άλλο προϊόν.

Ποτέ μην τυλίγετε ένα καλώδιο ρεύματος γύρω από το μετασχηματιστή ή άλλο αντικείμενο. Αν το κάνετε, μπορεί το καλώδιο να καταπονηθεί, με αποτέλεσμα να φθαρεί, να κοπεί ή να τσακίσει. Αυτό μπορεί να είναι επικίνδυνο.

Να βεβαιώνεστε πάντα ότι τα καλώδια ρεύματος δεν περνούν από σημεία όπου μπορεί να πατηθούν, να γίνουν αιτία να σκοντάψει κάποιος ή να τρυπηθούν από αντικείμενα.

Να προστατεύετε τα καλώδια και τους μετασχηματιστές από υγρά. Για παράδειγμα, μην αφήνετε τα καλώδια ή τους μετασχηματιστές κοντά σε νεροχύτες, μπανιέρες ή τουαλέτες, ή σε δάπεδα που καθαρίζονται με υγρά καθαριστικά. Τα υγρά μπορούν να προκαλέσουν βραχυκύκλωμα, ειδικά αν το καλώδιο ή ο μετασχηματιστής έχει φθαρεί λόγω κακής χρήσης. Τα υγρά μπορούν επίσης να προκαλέσουν σταδιακή διάβρωση των ακροδεκτών του καλωδίου ρεύματος ή/και του μετασχηματιστή, κάτι που μπορεί να προκαλέσει υπερθέρμανση.

Πάντα να συνδέετε τα καλώδια ρεύματος και τα καλώδια σήματος με τη σωστή σειρά και να βεβαιώνεστε ότι όλα τα καλώδια ρεύματος έχουν συνδεθεί πλήρως και με ασφάλεια στις υποδοχές.

Μη χρησιμοποιήσετε οποιονδήποτε μετασχηματιστή στον οποίο υπάρχουν ενδείξεις διάβρωσης στους ακροδέκτες εισόδου εναλλασσομένης τάσης ή/και ενδείξεις υπερθέρμανσης (π.χ. παραμορφωμένο πλαστικό) στην είσοδο εναλλασσόμενης τάσης ή σε οποιοδήποτε σημείο του μετασχηματιστή.

Μη χρησιμοποιείτε καλώδια ρεύματος στα οποία υπάρχουν ενδείξεις διάβρωσης ή υπερθέρμανσης στους ακροδέκτες σε οποιοδήποτε άκρο ή αν το καλώδιο έχει υποστεί οποιεσδήποτε φθορές.

Επεκτάσεις καλωδίων και σχετικές συσκευές

Βεβαιωθείτε ότι οι επεκτάσεις καλωδίων, οι συσκευές προστασίας από υπέρταση, οι μονάδες αδιάλειπτης παροχής ρεύματος και τα πολύπριζα που χρησιμοποιείτε καλύπτουν τις ηλεκτρικές προδιαγραφές του προϊόντος. Ποτέ μην υπερφορτώνετε αυτές τις συσκευές. Αν χρησιμοποιηθούν πολύπριζα, το φορτίο δεν πρέπει να υπερβαίνει τις προδιαγραφές του πολύπριζου. Για οποιεσδήποτε ερωτήσεις σχετικά με τα ηλεκτρικά φορτία και τις προδιαγραφές, συμβουλευτείτε έναν ηλεκτρολόγο.

Φις και πρίζες

Αν κάποια πρίζα που σκοπεύετε να χρησιμοποιήσετε με τον υπολογιστή έχει ενδείξεις ζημιών ή διάβρωσης, μην τη χρησιμοποιήσετε έως ότου αντικατασταθεί από ηλεκτρολόγο.

Μη λυγίζετε ή τροποποιείτε το φις. Αν το φις έχει υποστεί ζημιές, επικοινωνήστε με τον κατασκευαστή για να το αντικαταστήσετε.

Ορισμένα προϊόντα έχουν φις τριών ακροδεκτών. Το φις αυτό μπορεί να συνδεθεί μόνο σε γειωμένη ηλεκτρική πρίζα. Αυτό γίνεται για λόγους ασφάλειας. Μην παρακάμψετε αυτή την προφύλαξη επιχειρώντας να συνδέσετε το φις σε μη γειωμένη πρίζα. Αν δεν μπορείτε να συνδέσετε το φις στην πρίζα, επικοινωνήστε με έναν ηλεκτρολόγο για να προμηθευτείτε έναν εγκεκριμένο προσαρμογέα ή για να αντικαταστήσετε την πρίζα με άλλη, κατάλληλη πρίζα. Ποτέ μην υπερφορτώνετε μια πρίζα. Το συνολικό φορτίο του συστήματος δεν πρέπει να υπερβαίνει το 80% του φορτίου που προβλέπεται από τις προδιαγραφές του κυκλώματος διακλάδωσης. Για οποιεσδήποτε ερωτήσεις σχετικά με τα ηλεκτρικά φορτία και τις προδιαγραφές του κυκλώματος διακλάδωσης, συμβουλευτείτε έναν ηλεκτρολόγο.

Βεβαιωθείτε ότι η πρίζα ρεύματος που χρησιμοποιείτε είναι σωστά καλωδιωμένη, εύκολα προσβάσιμη και βρίσκεται κοντά στον εξοπλισμό. Μην τεντώνετε τα καλώδια ρεύματος με τρόπο που μπορεί να προκαλέσει φθορά στα καλώδια.

Συνδέετε και αποσυνδέετε τον εξοπλισμό προσεκτικά από την πρίζα.

Μπαταρίες

Όλοι οι προσωπικοί υπολογιστές που κατασκευάζονται από τη Lenovo περιέχουν μια μη επαναφορτιζόμενη μπαταρία που παρέχει ηλεκτρικό ρεύμα στο ρολόι του συστήματος. Επίσης, πολλά φορητά προϊόντα, όπως οι φορητοί υπολογιστές ThinkPad, χρησιμοποιούν μια επαναφορτιζόμενη μπαταρία για την παροχή ρεύματος στο σύστημα όταν δεν είναι συνδεδεμένο σε πρίζα. Οι μπαταρίες που παρέχονται από την Lenovo για χρήση με το προϊόν σας έχουν υποβληθεί σε δοκιμές συμβατότητας και πρέπει να αντικαθίστανται μόνο με εγκεκριμένες μπαταρίες.

Ποτέ μην επιχειρήσετε να ανοίξετε ή να επισκευάσετε μια μπαταρία. Μη χτυπήσετε, τρυπήσετε ή κάψετε μπαταρίες και μη βραχυκυκλώσετε τις μεταλλικές επαφές. Μην εκθέσετε τη μπαταρία σε νερό ή άλλα υγρά. Η επαναφόρτιση της μπαταρίας πρέπει να γίνεται μόνο σύμφωνα με τις οδηγίες που περιλαμβάνονται στην τεκμηρίωση του προϊόντος. Η κακή χρήση ή ο κακός χειρισμός μπαταριών μπορεί να προκαλέσει υπερθέρμανση της μπαταρίας, η οποία μπορεί να έχει ως αποτέλεσμα την έκλυση αερίων ή φλόγας από τη μπαταρία. Αν η μπαταρία σας έχει υποστεί βλάβη ή αν παρατηρήσετε οποιαδήποτε διαρροή από τη μπαταρία ή συσσώρευση υλικών στα άκρα της μπαταρίας, σταματήστε να τη χρησιμοποιείτε και αντικαταστήστε τη με καινούργια από τον κατασκευαστή της μπαταρίας.

Οι μπαταρίες μπορούν να υποστούν βλάβη όταν παραμένουν αχρησιμοποίητες για μεγάλες χρονικές περιόδους. Για ορισμένες επαναφορτιζόμενες μπαταρίες (και ειδικά για μπαταρίες λιθίου-ιόντων), η παραμονή της μπαταρίας εκτός χρήσης σε κατάσταση αποφόρτισης μπορεί να αυξήσει τον κίνδυνο βραχυκύκλωσης της μπαταρίας, η οποία μπορεί να μικρύνει τη διάρκεια ζωής της μπαταρίας, αλλά και να αποτελέσει κίνδυνο για την ασφάλεια. Μην αφήνετε τις επαναφορτιζόμενες μπαταρίες λιθίου-ιόντων να αποφορτίζονται πλήρως και μην τις αποθηκεύετε σε κατάσταση αποφόρτισης.

Θερμότητα και εξαερισμός

Οι υπολογιστές παράγουν θερμότητα όταν βρίσκονται σε λειτουργία καθώς και κατά τη φόρτιση των μπαταριών. Οι φορητοί υπολογιστές παράγουν μεγάλη θερμότητα λόγω του μικρού τους μεγέθους. Τηρείτε πάντα τις ακόλουθες προφυλάξεις:

- Μην αφήνετε τη βάση του υπολογιστή σε επαφή με το μηρό ή άλλο μέρος του σώματός σας για μεγάλο χρονικό διάστημα όταν είναι σε λειτουργία ο υπολογιστής ή όταν φορτίζεται η μπαταρία. Ο υπολογιστής παράγει κάποια θερμότητα κατά τη διάρκεια της κανονικής λειτουργίας του. Η παρατεταμένη επαφή με το σώμα μπορεί να προκαλέσει δυσφορία ή ακόμα και εγκαύματα.
- Μη χρησιμοποιείτε τον υπολογιστή ή φορτίζετε την μπαταρία κοντά σε εύφλεκτα υλικά ή σε περιβάλλον όπου υπάρχει κίνδυνος εκρήξεων.
- Οι σχισμές εξαερισμού, οι ανεμιστήρες ή/και οι ψύκτρες του προϊόντος παρέχονται για σκοπούς ασφάλειας, άνεσης και αξιόπιστης λειτουργίας. Εάν τοποθετήσετε το προϊόν επάνω σε κρεβάτι, καναπέ, χαλί ή άλλη μη σταθερή επιφάνεια ίσως φράξετε κατά λάθος αυτά τα εξαρτήματα. Ποτέ μην φράσσετε, καλύπτετε ή απενεργοποιείτε αυτά τα εξαρτήματα.

Πρέπει να ελέγχετε τον επιτραπέζιο υπολογιστή σας για συσσώρευση σκόνης κάθε τρεις μήνες. Πριν από τον έλεγχο, απενεργοποιήστε τον υπολογιστή και αποσυνδέστε το καλώδιο παροχής ρεύματος από την πρίζα. Στη συνέχεια, αφαιρέστε τη σκόνη από τα ανοίγματα εξαερισμού καθώς και από τις οπές στην πρόσοψη. Εάν παρατηρήσετε συσσώρευση σκόνης στο εξωτερικό του υπολογιστή, πρέπει να ελέγξετε και το εσωτερικό του υπολογιστή και αν αφαιρέσετε τη σκόνη από το εσωτερικό του υπολογιστή και από την ψύκτρα, τα ανοίγματα εξαερισμού του τροφοδοτικού και τους ανεμιστήρες. Πριν ανοίξετε το κάλυμμα του υπολογιστή απενεργοποιήστε τον υπολογιστή και αποσυνδέστε το καλώδιο παροχής ρεύματος. 





Caring for your ThinkPad computer

Though your computer is designed to function reliably in normal work environments, you need to use common sense in handling it. By following these important tips, you will get the most use and enjoyment out of your computer.

Important tips:

Be careful about where and how you work

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer dissipates some heat during normal operation. This heat is a function of the level of system activity and battery charge level. Extended contact with your body, even through clothing, could cause discomfort or, eventually, a skin burn.
- Place liquids away from your computer to avoid spills, and keep your computer away from water (to avoid the danger of electrical shock).
- Store packing materials safely out of the reach of children to prevent the risk of suffocation from plastic bags.
- Keep your computer away from magnets, activated cellular phones, electrical appliances, or speakers (within 13 cm/5 in).
- Avoid subjecting your computer to extreme temperatures (below 5°C/41°F or above 35°C/95°F).

Be gentle with your computer

- Avoid placing any objects (including paper) between the display and the keyboard or under the keyboard.
- Do not drop, bump, scratch, twist, hit, vibrate, push or place heavy objects on your computer, display, or external devices.
- Your computer display is designed to be opened and used at an angle slightly greater than 90 degrees. Do not open the display beyond 180 degrees, as this might damage the computer hinge.

Carry your computer properly

- Before moving your computer, be sure to remove any media, turn off attached devices, and disconnect cords and cables.
- Be sure your computer is in standby or hibernation mode, or turned off, before moving it. This will prevent damage to the hard disk drive and data loss.
- When picking up your open computer, hold it by the bottom. Do not pick up or hold your computer by the display.

• Use a quality carrying case that provides adequate cushion and protection. Do not pack your computer in a tightly packed suitcase or bag.

Handle storage media and drives properly

- Avoid inserting diskettes at an angle and attaching multiple or loose diskette labels, as these can lodge in the drive.
- If your computer comes with an optical drive such as CD, DVD, or CD-RW/DVD drive, do not touch the surface of a disc or the lens on the tray.
- Wait until you hear the CD or DVD click into the center pivot of an optical drive such as CD, DVD, or CD-RW/DVD drive before closing the tray.
- When installing your hard disk, diskette, CD, DVD, or CD-RW/DVD drive, follow the instructions shipped with your hardware, and apply pressure only where needed on the device. See your on-board help system for information on replacing your hard disk drive (open ThinkVantage Productivity Center by pressing the Access IBM button).

Take care in setting passwords

• Remember your passwords. If you forget a supervisor or hard disk password, Lenovo will not reset it, and you might have to replace your system board or hard disk drive.

Tips on using your computer in tablet mode

- If you close the computer display, make sure that the display is rotated either at 0 degrees, so that if faces the keyboard, or at 180 degrees, so that the back of the display faces the keyboard.
- Do not pick up or hold the computer by the display only.
- Do not hit, vibrate, or bump the computer display.
- To allow free ventilation, do not place any obstacle, such as a thick-piled carpet or a soft cushion, in front of the fan.
- When you use the computer in picture frame mode, in which the display is rotated until the back of the display is facing the keyboard, hold the display with one hand and use the Tablet Digitizer Pen.
- If you hold the computer in one hand while using it in tablet mode, do not expose it to excessive vibration, shock, or rotation.
- Do not use the computer outdoors. Do not expose it to rain.
- If you put your computer in a carrying case, put it into notebook mode and close the display.

Tips on using the Tablet Digitizer Pen

• Use only the Tablet Digitizer Pen that was shipped with your ThinkPad X41 Tablet computer or that you purchased with that computer as an option.

Only this pen is designed for use with the ThinkPad X41 Tablet computer. Any other pen might stick in the penholder or cause other problems.

• The Tablet Digitizer Pen is not waterproof. Take care not to soak or dip the pen in water.

Other important tips

- Your computer modem might use only an analog telephone network, or public-switched telephone network (PSTN). Do not connect the modem to a PBX (private branch exchange) or any other digital telephone extension line because this could damage your modem. Analog phone lines are often used in homes, while digital phone lines are often used in hotels or office buildings. If you are not sure which kind of phone line you are using, contact your telephone company.
- Your computer might have both an Ethernet connector and a modem connector. If so, be sure to connect your communication cable to the correct one, so your connector is not damaged. See your on-board help system for information on the location of these connectors (press the Access IBM button to open ThinkVantage Productivity Center).
- Register your ThinkPad products with Lenovo (refer to the Web page: www.lenovo.com/register/). This can help authorities return your computer to you if it is lost or stolen. Registering your computer also enables Lenovo to notify you about possible technical information and upgrades.
- Only an authorized ThinkPad repair technician should disassemble and repair your computer.
- Do not modify or tape the latches to keep the display open or closed.
- Take care not to turn your computer over while the ac adapter is plugged in. This could break the adapter plug.
- Turn off your computer if you are replacing a device in a device bay, or else verify that the device is warm-or hot-swappable.
- If you exchange drives in your computer, reinstall the plastic bezel faces (if supplied).
- Store your external and removable hard disk, diskette, CD, DVD, and CD-RW/DVD drives in the appropriate containers or packaging when they are not being used.
- Before you install any of the following devices, touch a metal table or a grounded metal object. This action reduces any static electricity from your body. The static electricity could damage the device.
 - PC Card
 - Smart Card
 - Memory Card, such as SD Card, Memory Stick, and MultiMediaCard
 - Memory module

- Mini-PCI Card
- Communication Daughter Card

Cleaning the cover of your computer

Occasionally clean your computer as follows:

- Prepare a mixture of a gentle kitchen-use detergent (one that does not contain abrasive powder or strong chemicals such as acid or alkaline). Use 5 parts water to 1 part detergent.
- 2. Absorb the diluted detergent into a sponge.
- 3. Squeeze excess liquid from the sponge.
- 4. Wipe the cover with the sponge, using a circular motion and taking care not to let any excess liquid drip.
- 5. Wipe the surface to remove the detergent.
- 6. Rinse the sponge with clean running water.
- 7. Wipe the cover with the clean sponge.
- 8. Wipe the surface again with a dry, soft lint-free cloth.
- **9**. Wait for the surface to dry completely and remove any cloth fibers from the computer surface.

Cleaning your computer keyboard

- 1. Absorb some isopropyl rubbing alcohol on a soft, dust-free cloth.
- 2. Wipe each keytop surface with the cloth. Wipe the keys one by one; if you wipe several keys at a time, the cloth may hook onto an adjacent key and possibly damage it. Make sure that no liquid drips onto or between the keys.
- 3. Allow to dry.
- 4. To remove any crumbs and dust from beneath the keys, you can use a camera blower with a brush or cool air from a hair drier.

Note: Avoid spraying cleaner directly on the display or the keyboard.

Cleaning your computer display

- 1. Gently wipe the display with a dry, soft lint-free cloth. If you see a scratchlike mark on your display, it might be a stain transferred from the keyboard or the TrackPoint pointing stick when the cover was pressed from the outside.
- 2. Wipe or dust the stain gently with a soft, dry cloth.
- **3**. If the stain remains, moisten a soft, lint-free cloth with water or a 50-50 mixture of isopropyl alcohol and water that does not contain impurities.
- 4. Wring out as much of the liquid as you can.

- 5. Wipe the display again; do not let any liquid drip into the computer.
- 6. Be sure to dry the display before closing it.

Care for the fingerprint reader

The following actions could damage the fingerprint reader or cause it not to work properly:

- Scratching the surface of the reader with a hard, pointed object.
- Scraping the surface of the reader with your nail or anything hard.
- Using or touching the reader with a dirty finger.

If you notice any of the following conditions, gently clean the surface of the reader with a dry, soft, lint-free cloth:

- The surface of the reader is dirty or stained.
- The surface of the reader is wet.
- The reader often fails to enroll or authenticate your fingerprint.

Diagnosing problems

If you have a problem with your computer, you can test it by using PC-Doctor for Windows. To run PC-Doctor for Windows, do as follows:

- 1. Click Start.
- 2. Move the pointer to All Programs and then to PC-Doctor for Windows.
- 3. Click **PC-Doctor**.
- 4. Choose one of the tests, from either **Device Categories** or **Test Scripts**.

- Attention

Running any tests may take up to several minutes or longer. Make sure you have time to run the entire test; do not interrupt the test while it is running.

The **System Test** of the **Test Scripts** runs some tests of critical hardware components, but it does not run all of the diagnostic tests in PC-Doctor for Windows. If PC-Doctor for Windows reports that all of the tests in the **System Test** have been run and that it has found no problems, consider running more of the tests in PC-Doctor for Windows.

If you are preparing to contact the Support Center, be sure to print the test log so that you can rapidly provide information to the help technician.

Troubleshooting

If you do not find your problem here, refer to your on-board help system. To open ThinkVantage Productivity Center, press the Access IBM button. The following section only describes problems that might prevent you from accessing the help system.

Error messages

Notes:

- 1. In the charts, x can be any character.
- 2. The version of PC-Doctor referred to here is PC-Doctor for Windows.

Errors without messages

Problem:

When I turn on the machine, nothing appears on the screen and the machine does not beep while starting up.

Note: If you are not sure whether you heard any beeps, turn off the computer; then turn it on again, and listen again. If you are using an external monitor, refer to "Computer screen problems" on page 24

Solution:

If a power-on password is set, press any key to display the power-on password prompt, and then type the correct password and press Enter.

If the power-on password prompt does not appear, the brightness level might be set to minimum brightness. Adjust the brightness level by pressing the Fn+Home.

If the screen still remains blank, make sure that:

• The battery is installed correctly.

- The ac adapter is connected to the computer and the power cord is plugged into a working electrical outlet.
- The computer power is on. (Turn on the power switch again for confirmation.)

If these items are properly set, and the screen remains blank, have the computer serviced.

Problem:

When I turn on the machine, nothing appears on the screen, but I hear two or more beeps.

Solution:

Make sure that the memory card is installed correctly. If it is, but the screen is still blank, and you hear five beeps, have the computer serviced.

If you hear 4 cycles of 4 beeps each, the Security Chip has a problem. Have the computer serviced.

Problem:

When I turn on the machine, only a white pointer appears on a blank screen.

Solution:

Reinstall your operating system, and turn on the computer. If you still see only the pointer on the screen, have the computer serviced.

Problem:

My screen goes blank while the computer is on.

Solution

Your screen saver or power management may be enabled. Move the TrackPoint or press a key to exit the screen saver, or press the power switch to resume from standby or hibernation.

Problem:

The DOS full-screen looks smaller.

Solution:

If you use a DOS application that supports only 640×480 resolution (VGA mode), the screen image might look slightly distorted or appear smaller than the display size. This is to maintain compatibility with other DOS applications. To expand the screen image to the same size as the actual screen, start the ThinkPad Configuration Program and click **LCD**; then enable the **Screen expansion** function. (The image might still look slightly distorted.)

Note: If your computer has a screen expansion function, you can use the Fn+F8 keys to expand the screen image.

A password problem

Problem:

I forgot my password.

Solution:

If you forgot your power-on password, you must take your computer to a Lenovo authorized servicer or marketing representative to have the password canceled.

If you forgot your hard disk password, Lenovo authorized servicer will not reset your password or recover data from the hard disk. You must take your computer to a Lenovo authorized servicer or a marketing representative to have the hard disk drive replaced. Proof of purchase is required, and a fee will be charged for parts and service.

If you forgot your supervisor password, Lenovo will not reset your password. You must take your computer to a Lenovo authorized servicer or a marketing representative to have the system board replaced. Proof of purchase is required, and a fee will be charged for parts and service.

A power switch problem

Problem:

The system does not respond, and you cannot turn off the computer.

Solution:

Turn off the computer by pressing and holding the power switch for 4 seconds or more. If the computer is still not reset, remove the ac adapter and the battery.

Keyboard problems

Problem:

All or some of the keys on the keyboard do not work.

Solution:

If an external PS/2 keyboard is connected, the numeric keypad on your computer does not work. Use the numeric keypad on the external keyboard.

If an external numeric keypad or a mouse is connected:

- 1. Turn off the computer.
- 2. Remove the external numeric keypad or the mouse.
- 3. Turn on the computer and try using the keyboard again.

If the keyboard problem is resolved, carefully reconnect the external numeric keypad, external keyboard, or mouse, making sure that you have seated the connectors properly.

If keys on the keyboard still do not work, have the computer serviced.

Problem:

A number appears when you type a letter.

Solution

The numeric lock function is on. To disable it, press and hold Shift; then press NumLk.

Problem:

All or some of the keys on the external numeric keypad do not work.

Solution:

Make sure that the external numeric keypad is correctly connected to the computer.

Problem:

All or some keys on the external PS/2 keyboard do not work.

Solution:

If you are using the X4 Dock, connect the keyboard connector to the keyboard/mouse connector on the X4 Dock. If you use a mouse and an external keyboard simultaneously, you need the keyboard/mouse connector. Make sure that keyboard/mouse connector is correctly connected to the mouse connector of the X4 Dock, and that the keyboard cable is correctly connected to the keyboard connector of the keyboard/mouse connector.

If the connection is correct, disconnect the cable and make sure that the built-in keyboard operates properly. If the built-in keyboard works, there is a problem with the external keyboard. Try using a different external keyboard.

TrackPoint problems

Problem:

The pointer drifts when the computer is turned on or after it resumes normal operation.

Solution:

The pointer might drift when you are not using the TrackPoint during normal operation. This is a normal characteristic of the TrackPoint and is not a defect. The pointer drifts for several seconds under the following conditions:

- When the computer is turned on.
- When the computer resumes normal operation.
- When the TrackPoint is pressed for a long time.
- When the temperature changes.

Problem:

The mouse or the pointing device does not work.

Solution:

Make sure that the TrackPoint is set to Automatic in the ThinkPad Configuration Program. Then detach the mouse or the pointing device, and try using the TrackPoint. If the TrackPoint works, the error might be due to the mouse or the pointing device.

Make sure that the cable for the mouse or the pointing device is securely connected to the X4 Dock.

If your mouse is incompatible with the PS/2 mouse, disable the TrackPoint, using the ThinkPad Configuration Program.

Note: For more information, see the manual supplied with the mouse.

Problem

The mouse buttons do not work.

Solution

Change the mouse driver to **Standard PS/2[®] Port Mouse**, and then reinstall **PS/2 TrackPoint**. Drivers are provided in the C:\IBMTOOLS\DRIVERS directory on your hard disk drive. If your hard disk drive does not contain device drivers, refer to the ThinkPad Web site. To access this Web site, press the Access IBM button and open ThinkVantage Productivity Center.

Problem

The scrolling or magnifying glass function does not work.

Solution

Check the mouse driver in the Device Manager window, and make sure that the PS/2 TrackPoint driver is installed.

Standby and hibernation problems

Problem:

The computer enters standby mode unexpectedly.

Solution:

If the processor overheats, the computer automatically enters standby mode to allow the computer to cool and to protect the processor and other internal components. Also, check the settings for standby mode, using Power Manager.

Problem:

The computer enters standby mode immediately after Power-on self-test (POST) (the standby indicator light turns on).

Solution:

Make sure that:

• The battery is charged.

• The operating temperature is within the acceptable range. Refer to "Specifications" on page 5.

If these items are correct, have the computer serviced.

Problem:

The critical low-battery error message is displayed, and the computer immediately turns off.

Solution:

The battery power is getting low. Connect the ac adapter to the computer, or replace the battery with a fully charged one.

Problem:

When you take action to return from standby mode, the computer display remains blank.

Solution:

Check whether an external monitor was disconnected while the computer was in standby mode. Do not disconnect the external monitor while the computer is in standby mode or hibernation mode. If no external monitor is attached when the computer resumes, the computer display remains blank and output is not displayed. This restriction does not depend on the resolution value. Press Fn+F7 to bring up the computer display.

Note: If you use the Fn+F7 key combination to apply a persentation scheme, press Fn+F7 at least three times in three seconds, and the image is displayed on the computer screen.

Problem:

The computer does not return from standby mode, or the standby indicator stays on and the computer does not work.

Solution:

If the system does not return from standby mode, it may have entered standby or hibernation mode automatically because the battery is depleted. Check the standby indicator.

- If the standby indicator is on, your computer is in standby mode. Connect the ac adapter to the computer; then press Fn.
- If the standby indicator is off, your computer is in hibernation mode or power-off state. Connect the ac adapter to the computer; then press power button to resume operation.

If the system still does not return from standby mode, your system may stop responding and you cannot turn off the computer. In this case, you need to reset the computer. If you have not saved your data, it may be lost. To reset the computer, press and hold the power button for 4 seconds or more. If the system is still not reset, remove the ac adapter and the battery.

Problem:

Your computer does not enter standby or hibernation mode.

Solution:

Check whether any option has been selected that would disable your computer from entering standby or hibernation mode.

Problem:

The system does not wake up at the time set on the timer, if the computer is not connected to an ac power source,

-or-

The system does not enter hibernation mode from suspend mode if the computer is not connected to an ac power source.

Solution:

The timer-wake-with-battery-operation is disabled by default. If you enable this function, the computer could wake up and begin running while it is being carried; this could lead to damage to the hard disk drive.

With this risk in mind, you can enable the timer-wake-with-batteryoperation.

- 1. Turn your computer off and then on again; then, while the message, "To interrupt normal startup, press the blue Access IBM button" is displayed at the lower left of the screen, press the Access IBM button. Rescue and Recovery screen opens.
- 2. Click Access BIOS. The System Restart Required window is displayed.
- **3**. Click **Yes**. The computer restarts, and the BIOS Setup Utility menu appears.
- 4. With the cursor key, select **Config**; then press Enter. The **Power** submenu is displayed.
- 5. Select Timer Wake with Battery Operation by pressing Enter.
- 6. With the F5 or F6 key, select Enabled; then press Enter.
- 7. Press F10 and Enter to save this setting and exit this utility.

For information about the BIOS Setup Utility, see "BIOS Setup Utility" in Access IBM, your on-board help system.

Problem:

The Fn+F12 key combination does not cause the computer to enter hibernation mode.

Solution:

The computer cannot enter hibernation mode:

- If you are using one of the communication PC Cards. To enter hibernation mode, stop the communication program, and then remove the PC Card or disable the PC Card slot. Click the **Safely Remove Hardware** icon in the taskbar.
- If the hibernation mode is not enabled. To enable it, do as follows:
- 1. Start the ThinkPad Configuration Program.
- 2. Click Power Management.
- 3. Click the **Hibernate** tab.
- 4. Select the hibernate support checkbox.
- 5. Click OK.

Note: You can enter hibernation mode by pressing Fn+F12 only if the PM driver has been installed on your computer.

Computer screen problems

Problem:

The screen is blank.

Solution:

- Press Fn+F7 to bring up the image.
 - **Note:** If you use the Fn+F7 key combination to apply a presentation scheme, press Fn+F7 at least three times in three seconds, and the image is displayed on the computer screen.
- If you are using the AC adapter, or using the battery, and the battery status indicator is on (is green), press Fn+Home to make the screen brighter.
- If the standby status indicator is on (is green), press Fn to resume from the standby mode.
- If you still have the problem persists, do the Solution in the problem below.

Problem:

The screen is unreadable or distorted.

Solution:

Make sure that:

- The display device driver is installed correctly.
- The screen resolution and color quality are correctly set.
- The monitor type is correct.

To check these settings, do as follows:

- 1. Right-click on the desktop, click **Properties**, then click the **Settings** tab.
- 2. Check whether the screen resolution and color quality are correctly set.
- 3. Click Advanced.
- 4. Click the **Adapter** tab.

- 5. Make sure "Mobile Intel(R) 915GM/GMS,910GML Express Chipset Family" is shown in the adapter information window.
- 6. Click the **Properties** button. Check the "Device status" box and make sure the device is working properly. If not, click the **Troubleshooter** button.
- 7. Click the **Monitor** tab.
- 8. Make sure the information is correct.
- **9**. Click the **Properties** button. Check the "Device status" box and make sure the device is working properly. If not, click the **Troubleshooter** button.

Problem:

The screen stays on even after you turn off your computer.

Solution:

Press and hold the power switch for 4 seconds or more to turn off your computer; then turn it on again.

Problem:

Missing, discolored, or bright dots appear on the screen every time you turn on your computer.

Solution:

This is an intrinsic characteristic of the TFT technology. Your computer's display contains multiple thin-film transistors (TFTs). A small number of missing, discolored, or bright dots on the screen might exist all the time.

Battery problems

Problem:

The battery cannot be fully charged by the power-off method in the standard charge time for your computer.

Solution:

The battery might be over-discharged. Do the following:

- 1. Turn off the computer.
- 2. Make sure that the over-discharged battery is in the computer.
- 3. Connect the ac adapter to the computer and let it charge.

If the battery cannot be fully charged in 24 hours, use a new battery.

If the optional Quick Charger is available, use it to charge the over-discharged battery.

Problem:

Your computer shuts down before the battery status indicator shows empty, *-or-* Your computer operates after the battery status indicator shows empty.

Solution:

Discharge and recharge the battery.

Problem:

The operating time for a fully charged battery is short.

Solution:

Discharge and recharge the battery. If your battery's operating time is still short, use a new battery.

Problem:

The computer does not operate with a fully charged battery.

Solution:

The surge protector in the battery might be active. Turn off the computer for one minute to reset the protector; then turn on the computer again.

Problem

The battery does not charge.

Solution

You cannot charge the battery when it is too hot. If the battery feels hot, remove it from the computer and allow it to cool to room temperature. After it cools, reinstall it and recharge the battery. If it still cannot be charged, have it serviced.

Hard disk drive problems

Problem:

The hard disk drive makes a rattling noise intermittently.

Solution:

The rattling noise might be heard when:

- The hard disk drive starts accessing the data or when it stops.
- You are carrying the hard disk drive.
- You are carrying your computer.

This is a normal characteristic of a hard disk drive and is not a defect.

Problem:

The hard disk drive does not work.

Solution:

In the startup menu in BIOS Setup Utility, make sure that the hard disk drive is in the "Boot priority order". If it is in the device list of "Excluded from boot order", the hard disk drive is disabled. Move it into the "Boot priority order".

A startup problem

Problem:

The Microsoft[®] Windows[®] operating system will not start.

Solution:

Use the Rescue and Recovery workspace to help solve or identify your problem. Starting the Rescue and Recovery workspace is easy.

To open Rescue and Recovery, do the following:

- 1. Turn off your PC, then turn it on again.
- 2. Watch the screen carefully while your PC starts. When "To interrupt normal startup, press the blue Access IBM button" message is displayed at the lower left of the screen, press the blue Access IBM button. The Rescue and Recovery workspace opens. A window such as this will appear:



- **3**. After the Rescue and Recovery workspace opens, you can do the following:
 - Rescue and Restore your files, folders, or backups.
 - Configure your system settings and passwords.
 - **Communicate** by using the internet and link to the ThinkPad support site.
 - Troubleshoot and diagnose problems using diagnostics.

In the top panel of the Rescue and Recovery workspace, you can click the following to open other pages or exit the utility:

Events Viewer provides general information about application, security, and system events. It also provides error and warning information for each event.

System Information enables you to see key hardware and software information about your computer. This information might be valuable when trying to diagnose problems.

Warranty Status enables you to see when your warranty expires, the terms of service for your computer, or a list of replacement parts.

Help provides information about the various pages in the Rescue and Recovery workspace.

Restart closes the Rescue and Recovery workspace, and resumes the startup sequence that was interrupted.

Fingerprint authentication problems

If your finger(s) have any of the following conditions, you may not be able to register or authenticate it:

- Your finger is wrinkled.
- Your finger is rough, dry or injured.
- Your finger is very dry.
- Your finger is stained with dirt, mud, or oil.
- The surface of your finger is very different from when you registered your fingerprint.
- Your finger is wet.
- A finger is used that has not been enrolled.

To improve the situation, try the following:

- Clean or wipe your hands to remove any excess dirt or moisture from the fingers.
- Enroll and use a different finger for authentication.
- If your hands are too dry, apply lotion to them.

Other problems

Problem:

The computer locks or does not accept any input.

Solution:

Your computer might lock when it enters standby mode during a communication operation. Disable the standby timer when you are working on the network.

To turn off the computer, press and hold the power switch for 4 seconds or more.

Problem:

The computer does not start from a device you want.

Solution:

Refer to the Startup menu of the BIOS Setup Utility. Make sure that the startup sequence in the BIOS Setup Utility is set so that the computer starts from the device you want.

Also make sure that the device from which the computer starts is enabled. In the startup menu in the BIOS Setup Utility, make sure that the device is included in the "Boot priority order" list. If it is included in the "Excluded from boot order" list, it is disabled. Select the entry for it in the list and press the x key. This moves the entry to the "Boot priority order" list.

Problem:

The computer does not respond.

Solution:

IRQs for the PCI are all set as 11. The computer does not respond because it cannot share the IRQ with other devices. Refer to the ThinkPad Configuration Program.

Problem:

The computer cannot connect to the local network, shared devices or network printers, but can connect to the Internet.

Solution:

On your desktop, click the Symantec Client Security icon, then click the Symantec Home and Office Networking Wizard icon and follow the instructions.

Problem:

The computer can not play a CD, or the sound quality is not good.

Solution:

Be sure that the disk meets the standards for your country. Usually, a disk that meets the local standards is marked with a CD logo on the label. If you use a disc that does not meet these standards, we cannot guarantee that it will play, or that, if it does play, the sound quality will be good.



Problem:

An application does not run correctly.

Solution:

Make sure that the problem is not being caused by the application.

Check that your computer has the minimum required memory to run the application.

Refer to the manuals supplied with the application. Check the following:

- The application is designed to operate with your operating system.
- Other applications run correctly on your computer.
- The necessary device drivers are installed.
- The application works when it is run on some other computer.

If an error message appears while you are using the application program, refer to the manuals supplied with the application.

On some models, the following application programs may not run correctly. Download the latest version from the Web site listed below:

- ThinkPad 2.5 inch Hard Disk Drive Firmware Update Utility (version released before January 24, 2005): The latest version is available at http://www.lenovo.com/think/support/
- Drive Fitness Test (v3.99 or earlier): The latest version is available at http://www.hitachigst.com/hdd/support/download.htm

Notes:

- 1. Lenovo does not guarantee the proper operation of the Drive Fitness Test.
- **2**. To use an additional hard disk drive, update the firmware to the latest version.

If the application still does not run correctly, contact your place of purchase or a service representative for help.

Starting BIOS Setup Utility

Your computer provides a program, called BIOS Setup Utility, that enables you to select various setup parameters.

- Config: Set the configuration of your computer.
- Date/Time: Set the date and time.
- Security: Set security features.
- Startup: Set the startup device.
- Restart: Restart the system.

Note: You can set many of these parameters more easily by using the ThinkPad Configuration Program.

To start BIOS Setup Utility, do as follows:

- 1. To protect yourself against accidental loss of data, back up your data and computer registry. For details see "Data backup-and-restore tools" in your on-board help.
- 2. Remove any diskette from the diskette drive, and then turn off the computer.
- **3**. Turn on the computer; then, while the "To interrupt normal startup, press the blue Access IBM button" message is displayed at the lower-left of the screen, press the Access IBM button. The Rescue and Recovery workspace opens.
- 4. Click Access BIOS. The System Restart Required window is displayed.

- 5. Click **Yes**. The computer restarts, and BIOS Setup Utility screen appears. If you have set a supervisor password, the BIOS Setup Utility menu appears after you enter the password. You can start the utility by pressing Enter instead of entering the supervisor password; however, you cannot change the parameters that are protected by the supervisor password. For more information, refer to the on-board help.
- 6. Using the cursor keys, move to an item you want to change. When the item you want is highlighted, press Enter. A submenu is displayed.
- 7. Change the items you wish to change. To change the value of an item, use the F5 or F6 key. If the item has a submenu, you can display it by pressing Enter.
- 8. Press F3 or Esc to exit from the submenu. If you are in a nested submenu, press Esc repeatedly until you reach the BIOS Setup Utility menu.

Note:If you need to restore the settings to their original state as of the time of purchase, press F9 key to load the default settings. You can also select an option in the Restart submenu to load the default settings or discard the changes.

9. Select Restart; then press Enter. Move the cursor to the option you want for restarting your computer; then press Enter. Your computer restarts.

Recovering pre-installed software

Your computer hard disk has a hidden, protected area for backups. Contained within this area is a complete backup of the hard disk as it was shipped from the factory and a program called the Rescue and Recovery.

If you performed a backup operation using the Rescue and Recovery program, you also have one or more backups stored that reflect the contents of the hard disk, as it existed at various points in time. These backups might be stored on your hard disk, or a network drive, or on removable media, depending on the options you selected during the backup operation.

You can use either the Rescue and Recovery program or the Rescue and Recovery workspace to restore the contents of the hard disk to an earlier state using any of the stored backups. The Rescue and Recovery workspace runs independently of the Windows operating system. Therefore, you can start it by pressing the blue Access IBM button when prompted during startup.

After the Rescue and Recovery workspace opens you can perform a recovery operation, even if you are unable to start Windows. For more information about using Rescue and Recovery features, see "Data backup-and-restore tools" or "Introducing Rescue and Recovery" in your on-board help.

To recover the hard disk to its original contents, do the following:

Notes:

- 1. If the optical drive is not attached to your ThinkPad computer during recovery, DVD software and CD-recording software will not be installed. To ensure that they will be installed correctly, attach your ThinkPad computer to the X4 Dock and install the optical drive in the Ultrabay Slim before performing a recovery operation.
- 2. The recovery process might take up to 2 hours.

Attention: All of the files on the primary hard disk partition (usually drive C) will be lost in the recovery process. However, before any data is overwritten, you will be given the opportunity to save one or more files to other media.

- 1. If possible, save all your files and shut down your operating system.
- 2. Turn off your computer for at least 5 seconds.
- **3**. Turn on your computer. Watch the display carefully. While the message, "To interrupt normal startup, press the blue Access IBM button" is displayed at the lower left of the screen, press the Access IBM button. The Rescue and Recovery workspace opens.
- 4. Click **Restore your system**.
- 5. Click **Restore my hard drive to the original factory state** and then click **Next**.
- 6. Follow the instructions on the screen.
- 7. When the recovery process finishes, press Enter key. Your computer will restart with the pre-installed operating system, drivers, and software.

Upgrading the hard disk drive

You can increase the storage capacity of your computer by replacing the hard disk drive with one of greater capacity. You can purchase a new hard disk drive from your reseller or Lenovo marketing representative.

Notes:

- 1. Replace the hard disk drive only if you upgrade it or have it repaired. The connectors and bay of the hard disk drive were not designed for frequent changes, or drive swapping.
- 2. The Rescue and Recovery workspace and the Product Recovery program are not included in the optional hard disk drive.


Attention Handling a hard disk drive

- Do not drop the drive or subject it to physical shocks. Put the drive on a material, such as soft cloth, that absorbs the physical shock.
- Do not apply pressure to the cover of the drive.
- Do not touch the connector.


The drive is very sensitive. Incorrect handling can cause damage and permanent loss of data on the hard disk. Before removing the hard disk drive, make a backup copy of all the information on the hard disk, and then turn the computer off. Never remove the drive while the system is operating, in standby mode, or in hibernation mode.

To replace the hard disk drive, do the following.


- 1. **Turn off the computer**; then disconnect the ac adapter and all cables from the computer.
- 2. Close the computer display, and turn the computer over.
- 3. Remove the battery.
- 4. Remove the Tablet Digitizer Pen from its slot.




5. Remove the screw that secures the hard disk drive.




6. Open the computer display; then stand the computer on its side and remove the hard disk drive by pulling the cover away from the computer.



7. Detach the cover from the hard disk drive.




- 8. Attach the cover to a new hard disk drive.
- 9. Insert the hard disk drive and its cover into the hard disk drive bay; then firmly install them.




- 10. Close the computer display and turn the computer over so that its bottom side is up.
- 11. Reinstall the screw.

- **13**. Reinstall the battery.
- 14. Turn the computer over again. Connect the ac adapter and the cables to the computer.

Replacing the battery

- 1. **Turn off the computer, or enter hibernation mode.** Then disconnect the ac adapter and all cables from the computer.
 - **Note:** If you are using a PC Card or Secure Digital Card, the computer might not be able to enter hibernation mode. If this happens, turn off the computer.
- 2. Close the computer display, and turn the computer over.
- 3. Slide the battery lock to the unlock position.




4. Slide and hold the battery latch **1** ; then remove the battery **2** .



7. Turn the computer over again. Connect the ac adapter and the cables to the computer.




To attach an Extended Life Battery to the computer, do the following:









What this Warranty Covers

Lenovo warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to Lenovo's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original date of installation and is specified in Part 3 -Warranty Information. The date on your invoice or sales receipt is the date of installation unless Lenovo or your reseller informs you otherwise. Unless Lenovo specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse, accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which Lenovo is not responsible; and
- any non-Lenovo products, including those that Lenovo may procure and provide with or integrate into a Lenovo Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

Lenovo does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

Warranty service may be provided by Lenovo, IBM, your reseller if authorized to perform warranty service, or an authorized warranty service provider. Each of them is referred to as a "Service Provider."

If the Machine does not function as warranted during the warranty period and your problem cannot be resolved over the telephone or electronically, through your application of software updates, or with a CRU, your Service Provider, will either, at its discretion, 1) repair it to make it function as warranted, or 2) replace it with one that is at least functionally equivalent. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

Governing Law

Both you and Lenovo consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your

and Lenovo's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.

THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR JURISDICTION TO JURISDICTION.

Jurisdiction


