

### Part 1: Quick Installation Guide

#### Installing the Enhanced IDE drive

Follow these instructions to install the Enhanced IDE tape drive:

- 1. Turn off the computer and unplug the power cables from the power outlet for the computer and all attached peripherals.
- 2. Open the computer.
- Touch the static-protective bag containing the tape drive to an unpainted metal surface on the computer for at least 2 seconds. Remove the drive from the static-protective bag, holding the drive by the edges, and place it on the bag.
- Refer to the bottom view of the tape drive to locate the IDE configuration block and how to set a position ON (A) or OFF (B).



The IDE configuration block pin assignments are:

7 and 8: Reserved 5 and 6: MS 3 and 4: SL 1 and 2: CS

5. Set the IDE jumper ON for the setting that applies to your IDE configuration. The tape drive is preset at the factory to slave (SL).

If your computer has one hard disk drive and one IDE controller, configure the tape drive as a slave (SL) by placing a jumper over vertical pins 3 and 4 (ON). Some hard disk drives might require you to change its jumper setting (master to master with a slave attached) if you attach a second device to the IDE controller.

#### If your computer has two IDE controllers:

Place the hard disk drives on the primary IDE controller and place the other storage devices (tape drive or CD-ROM drive) on the secondary IDE controller.

If the tape drive is the only device on the secondary IDE controller, configure it as a master (**MS**) by placing a jumper over vertical pins 5 and 6.

If the tape drive is sharing the IDE controller with another device, configure it as slave (SL) by placing a jumper over vertical pins 3 and 4.

Refer to your computer documentation to see if your computer supports the cable select (**CS**) setting. Most computers do not use this feature.

6. Locate an available bay or space in your computer to mount the tape drive. The drive can be mounted in either a horizontal or vertical position. The drive fits in a 3.5-inch (1-inch high) standard bay. You can also mount the drive in a 5.25-inch (1.6-inch high) bay using the 5.25-inch mounting kit provided. The installation instructions are located on the mounting kit packaging.

The following table lists the available bays for IBM PC IntelliStation professional workstation and desktop PC models. Some of these computer systems require an additional cosmetic bezel (included) when installing a removable media device such as a tape drive. Some workstations also might have a lockable door covering the drive bays. **If you are installing the tape drive into any server with a lockable door, you might not be able to close this door whenever the data cartridge is inserted.**

- Remove the bay cover, if necessary. Slide the tape drive into the bay, and secure it with the mounting screws provided in the option package. Do not use any other screws to secure the drive. Using screws that are too long might damage the drive.
- 8. Locate the IDE bus cable (usually a 50-pin ribbon cable) that is inside your computer, and attach one of the connectors on the cable to the tape drive. Ensure that pin 1 of the cable (usually color-coded) aligns with pin 1 of the IDE connector on the tape drive. If your computer system does not have connectors on the drive, you might need to use the IDE cable included with the option.
- 9. Locate an available power cable inside your computer, and connect it to the four-pin power connector on the tape drive.
- 10. Replace the computer cover, and secure it in place.
- 11. Reconnect the ac power cord and any other signal cables to the outside of your computer, and plug the power cord into an available power outlet. Turn on all attached devices; then turn on the computer.
- 12. Install the software using the instructions given by the README file on the tape software CD. The CD contains tape backup and restore applications for most desktop operating systems.

To install the backup software for native Windows NT 4.0 support:

a. From the Windows NT desktop, select **Start**, **Settings**, **Control Panel**, **Tape Device**.

- b. Windows NT detects a "New SCSI Tape Device" and prompts you to install the IDE (QIC-157) device driver.
- c. Click OK.
- d. Insert the Windows NT Workstation CD and click OK.
- e. Windows NT will display the location of the needed files, directory **i386**, on the CD drive. If the correct drive is not shown on the "Copy files from:" list, click the down-arrow button and select the correct CD drive for the computer.
- f. Click OK.
- g. Windows NT will now complete the device driver installation.

To verify that the driver is correctly loaded, go to the desktop and select **Start**, **Settings**, **Control Panel**, **Tape Devices**.

- h. Start Windows NT Backup by selecting **Programs**, Administrative Tools, Backup.
- i. The software installation is now completed.



### Part 2: User's Guide

### **Product description**

The IBM tape option allows you to save and restore data files. The tape drive has the following features:

#### Tape capacity

Provides capacity to 20 GB<sup>3</sup> per cartridge when using the TR-5 Tape Cartridges and the software compression features of the included software application. The actual capacity per cartridge varies depending on various factors, which include the type of backup data, the data cartridge type, and the condition of the media. The 20 GB value assumes a 2:1 compression ratio.

#### High speed data transfer

Maximizes data transfer to 2 MB per second when using the software compression features of the drive. If your computer is not capable of supporting this data transfer rate, the drive will automatically adjust tape speed to maintain streaming.

#### Streaming-tape intelligence

Provides a continuous tape motion for an uninterrupted precisely coordinated flow of data to and from the tape cartridge. This *streaming* motion, combined with the *serpentine* recording method contributes to the increased storage capacity, efficiency, and speed of this cartridge technology.

#### Serpentine recording method

Uses the *serpentine* recording method, which decreases read time by reading or writing data in both the forward and reverse directions. With this method, the tape is not rewound at the end of a track. Instead, the drive heads are logically or mechanically switched to a different position on the tape and another track is written or read in the reverse direction. The individual tracks are sequential to minimize the amount of head motion as the heads change position for each track.

#### Installation flexibility

Installs in a standard 5.25-inch half-high or a 3.5-inch slim bay. Can also be installed into a one-third height bay, using a special rail kit which is included.

#### **Backward compatibility**

Provides read compatibility with IBM TR4 IDE tape options (IBM part number 06H9720). **Note:** This drive does not provide read or write compatibility with any other travan format.

#### Tape software support

Option includes backup/restore applications for the following operating systems:

### Installing the Enhanced IDE drive


This section provides instructions for installing the Enhanced IDE tape drive.

#### Step 1. Preparing for installation

- 1. Turn off the computer and unplug the power cables from the power outlet for the computer and all attached peripherals.
- Open the computer. For specific information on opening your computer refer to the documentation that comes with your computer. Become familiar with the computer internal components, and determine what kind of configuration you need to install.
- 3. Locate an available IDE connector in your computer. An IDE cable normally has two connectors for attaching IDE devices. Some IDE controllers have two IDE cables for attaching up to four devices. You can have the situation where your computer does not have an IDE connector available to attach the tape drive. Free up an IDE connector such as to install the tape drive.
- 4. Touch the static-protective bag containing the tape drive to an unpainted metal surface on the computer for at least 2 seconds. Remove the drive from the static-protective bag, holding the drive by the edges, and place it on the bag.

#### Step 2. Configuring the IDE drive

Refer to the bottom view of the tape drive to locate the IDE configuration block and how to set a position ON (A) or OFF (B).



The IDE configuration block pin assignments are:

7 and 8: Reserved

5 and 6: MS

- 3 and 4: SL 1 and 2: CS
- $\mathbf{I}$  and  $\mathbf{Z}$ . Co

Set the IDE jumper ON for the setting that applies to your IDE configuration. The tape drive is preset at the factory to slave (**SL**).

If your computer has one hard disk drive and one IDE controller, configure the tape drive as a slave (SL) by placing a jumper over vertical pins 3 and 4 (ON). Some hard disk drives might require you to change its jumper setting (master to master with a slave attached) if you attach a second device to the IDE controller.

Refer to the jumper settings or documentation that comes with your hard disk drive.

If your computer has two IDE controllers:

Place the hard disk drives on the primary IDE controller and place the other storage devices (tape drive or CD-ROM drive) on the secondary IDE controller. This is a good practice to avoid possible performance or compatibility limitations with your operating system.

If the tape drive is the only device on the secondary IDE controller, configure it as a master (MS) by placing a jumper over vertical pins 5 and 6.


If the tape drive is sharing the IDE controller with another device, configure it as slave (SL) by placing a jumper over vertical pins 3 and 4.

Refer to your computer documentation to see if your computer supports the cable select (**CS**) feature. With the cable select feature there is a special cable. The placement of the devices on the cable connectors determines whether a device is master or slave, if the devices are set to **CS**. Most computers do not use this cable feature.

**Note:** If your computer system has only one IDE cable with one connector, replace the cable with the two-drop cable that comes with the option.

#### Step 3. Attaching the cables

1. Locate the IDE 1 and power 3 connectors using the illustration of the bottom view of the tape drive.



The tape drive connectors are:

- 1 IDE connector
- 2 IDE connector pin 1
- 3 Power connector
- 2. Locate the appropriate IDE cable and spare connector and attach it to the tape drive 1 . Use a 40-pin ribbon cable to connect the tape drive on the rear of the drive. The connector is keyed and will fit only one way. Do not force it. If it does not attach easily, turn the connector around and try it again. Ensure that line 1 of the IDE cable (usually color coded) aligns with pin 1 2 of the IDE connector.
- Locate an unused power connector coming from the computer power supply. If all power cables are in use, purchase a dc Y-connector at your computer dealer or electronics store. Locate

an available power cable and connect it to the four-pin power connector on the tape drive 3. The cable connector is keyed and will fit properly only one way.

#### Step 4. Mounting the drive

 Locate an available bay or space in your computer to mount the tape drive. The drive can be mounted in either a horizontal or vertical position. The drive fits in a 3.5-inch (1-inch high) standard bay. You can also mount the drive in a 5.25-inch (1.6-inch high) bay using the 5.25-inch mounting kit provided. When you attach the brackets to the sides of the 3.5-inch tape drive, you increase the width and height of the drive. The instructions for using the 5.25-inch mounting kit are located on its packaging. Use only those parts necessary for your particular installation; some parts may not be required.

The following table lists the available bays for IBM PC IntelliStation professional workstation and desktop PC models. Some of these computer systems require an additional cosmetic bezel (included) when installing a removable media device such as a tape drive. Some workstations also might have a lockable door covering the drive bays. If you are installing the tape drive into one of these servers or workstations, you can use the included recess bezel kit to install the tape drive. With the recess bezel kit, the tape drive sits further back in the bay, so the tape

cartridge does not stick out and keep the door from closing completely.

- 2. Remove the cover plate from the bay selected. Slide the drive partially into the bay. Align the drive-bay screw holes with the threaded holes in the drive housing (or bracket, if applicable).
- 3. Use the screws provided to secure the drive in the bay. Using the wrong size screws can damage the drive. Usually two screws are used on each side. Some installations use the screw holes on the bottom (circuit board side) of the drive. Do not overtighten the screws. Make sure that the drive is securely mounted.

#### Step 5. Completing the installation

Check your work before closing the computer.

- 1. Be sure that the power and interface connectors are securely attached.
- Be sure that the cables are neatly routed. They must not: Get in the way when the cover is replaced Impede the power supply fan blade Block air flow paths
- 3. Replace the computer cover and secure it in place.
- 4. Reconnect the ac power cord and cables. Turn on all attached devices; then turn on the computer.

To install the backup software for native Windows NT 4.0 support:

- 1. From the Windows NT desktop, select **Start**, **Settings,Control Panel,Tape Device**.
- 2. Windows NT detects a "New SCSI Tape Device" and prompts you to install the IDE (QIC-157) device driver.
- 3. Click OK.
- 4. Insert the Windows NT Workstation CD and click OK.
- 5. Windows NT will display the location of the needed files, directory i386, on the CD drive. If the correct drive is not shown on the "Copy files from:" list, click the down-arrow button and select the correct CD drive for the computer.
- 6. Click OK
- 7. Windows NT will now complete the device driver installation.

To verify that the driver is correctly loaded, go to the desktop and select **Start**, **Settings**, **Control Panel**, **Tape Devices**.

- 8. Start Windows NT Backup by selecting **Programs**, **Administrative Tools**, **Backup**
- 9. The software installation is now completed.

To install the additional Seagate backup software for Windows 98, Windows 95 or Windows NT:

- 1. Place the Seagate Backup Exec CD in your CD-ROM.
- 2. If your operating system is configured for autoplay, the setup program will run automatically. If the setup program does not run automatically, select **Run** from the **Start** menu. Then type *x*:\setup, where *x* is the drive letter for your CD-ROM, and press Enter.
- 3. Follow the on-screen instructions.
- 4. Restart Windows to complete software installation.

To install the additional Seagate backup software for Windows 3.1:

- 1. From Program Manager, select File, Run.
- 2. Type *x*:\setup, where *x* is the drive letter for your CD-ROM, and press Enter.
- 3. Follow the on-screen instructions.
- 4. Restart Windows to complete software installation.

This tape option is also compatible with many other backup and restore applications not included on the tape software CD. Contact the supplier of your favorite backup and restore software to see if they support the Travan 5 class of tape drives. Follow the instructions provided with your software to install and configure the tape drive.

### Using the tape drive

This section provides information on using the features of the tape drive.

#### Loading and unloading tape cartridges

The illustration shows the front panel of the tape drive.




The front panel of the tape drive contains the cartridge opening and one round, green light 1. This green light indicates drive activity. When the green light is OFF, the drive is not active.


Your tape drive has a flip-up door that covers the cartridge opening when you do not have a tape cartridge in the drive. Once you insert a cartridge, the tape drive holds it in place using a positive locking mechanism.

**Note:** Do not remove the tape cartridge while the drive is operating. Complete any tape operation and wait until the green activity light is OFF before removing the cartridge.

To load a cartridge, insert it with the metal base plate down and the tape access door facing the drive. The following illustration shows loading of a cartridge.




To unload a cartridge, wait until the drive activity light is OFF and then pull the cartridge straight out. The following figure illustrates unloading a cartridge.




#### Setting the write-protect switch

Tape cartridges feature a write-protect switch located in the upper-left corner of the cartridge. You can set the switch to keep data from being written on the tape. Use this switch when you want to make sure that important data on the tape will not be overwritten.

The illustration below shows the cartridge with the switch 1 in the nonprotected (read and write) or unlocked position.



The following illustration shows the switch 2 in the protected (read only) or locked position.



To return a cartridge to the unprotected write state, push the switch towards the end of the cartridge or unlocked position.

#### **Reviewing performance considerations**

The tape option is ideally suited to streaming operations, as opposed to multiple-start-and-stop tape movement. Frequent start-and-stop operations are often the result of data underruns. Start-and-stop operation can also increase the stress on both the drive and the media.

Your backup application and other system characteristics can also affect performance. Alternative operating systems, file system structures and backup applications might give significantly different performance results. If you need to improve the performance of the tape backup application, consider one or more of the following:

Disable data compression (if used) using your backup application software.

Reduce the number of other applications that might be running simultaneously with the backup application.

### Maintenance

You need to perform minimal maintenance to ensure that your tape drive operates in peak condition. This section explains how to care for the tape cartridges and how to clean the drive head.

#### Caring for tape cartridges

The following points are guidelines for storing and using the cartridges:

Do not open the tape access door of the cartridge or touch the tape itself.

Keep cartridges away from sources of electromagnetic fields, such as telephones, dictation equipment, mechanical or printing calculators, motors, and bulk erasers. Do not place the cartridges on the computer monitor or on the base unit of the computer. Keep cartridges away from direct sunlight and heat sources, such as radiators or warm air ducts.

Keep cartridges free of moisture. Do not wet or submerge cartridges in any liquid.

Do not expose cartridges to temperature extremes.

Retension tape cartridges that have not been used for more than a month before restoring or backing up data. Retensioning is the winding and rewinding of a tape cartridge. This action restores the proper tape tension to the media. The back-up application software provides a function to retension a tape cartridge.

#### Cleaning the tape head

To properly maintain the drive, periodically clean the tape head. You do not need to perform any other periodic maintenance. Use a dry process cleaning cartridge such as IBM PN 16G8583 or Imation 0-5122-12132-6 to clean the tape head once a month, or after each eight hours of continuous read/write operations, whichever occurs first. The dry process cleaning cartridges can be obtained through your local computer supplies dealer. You also need to clean the drive two hours after you first use a new data cartridge.

Once the cleaning cartridge is inserted into the tape drive, the cleaning process is automatic. The entire process takes only a few seconds and is completed when the drive activity light stops flashing. The cleaning cartridge is good for 30 cleaning operations.

- 1. If you are having installation or configuration problems, refer to the detailed sections on installation found in this manual, and review any README.TXT files found on the installation diskettes.
- 2. Visit the Personal Computing Support Web site specific to the model of option you have purchased. Updated installation instructions, hints and tips, or updated system-specific notes are often published in this section. You might find that later device drivers are available that will improve the performance and compatibility for your new option.
