Chapter 1. Introduction

The IBM 64 MB and 256 MB USB 2.0 Memory Keys are small portable USB storage devices that enable you to share data between any notebook and desktop system with a functional USB port, without the use of a diskette. The 64 MB and 256 MB Memory Keys offer considerably more space than a 1.44 MB diskette for you to store text, presentations, spreadsheets, or multimedia files.

This manual explains installation and usage of the IBM 64 MB and 256 MB USB 2.0 Memory Keys with Microsoft[®] Windows[®] 98 SE, Microsoft Windows Millennium Edition (Me), Microsoft Windows 2000 Professional, and Windows XP. For instructions on installing your key in Microsoft Windows NT[®] Workstation, refer to the README included on the CD that comes with this option.

Chapter 2. Installation requirements

Before you install the IBM 64 MB or 256 MB USB 2.0 Memory Key, be sure that you have:

- One of the following operating systems:
 - Windows 98
 - Windows Me
 - Windows 2000
 - Windows XP
 - Windows NT
- An available USB connector

The following optional items are necessary if you will be using the Memory Key as a bootable device. See Chapter 5, "Using IBM Memory Key Boot Utility", on page 33.

- BIOS that supports bootable USB storage devices. If you are uncertain about whether the BIOS supports bootable USB devices, contact your computer manufacturer. If needed, there might be an available update.
- The BIOS documentation that came with your computer or BIOS update, if applicable.

Installing the Memory Key in WIndows Me, Windows 2000, or Windows XP

Windows Me, Windows 2000, and Windows XP have built-in support for the USB 2.0 Memory Key and no device drivers are required. Simply attach the Memory Key to the USB connector. The Memory Key is now ready to use and is displayed as a removable disk with a letter designation (for example, E:).

Installing the Memory Key in Windows 98

The Windows 98 device driver files must be installed on your computer before the Memory Key can be used. To install the Memory Key device drivers in Windows 98, do the following:

- 1. Attach the Memory Key to the USB connector.
- 2. The New Hardware Wizard window will open.
- 3. In the New Hardware Wizard click Next.
- 4. Select Search for the best driver for your device, and then click Next.
- 5. Insert the CD-ROM that shipped with your Memory Key.
- 6. Select CD-ROM and click Next. Follow the on-screen instructions.

- 7. The memory key is now ready to use and is displayed as a removable disk in the My Computer window.
- **Note:** A flashing light-emitting diode (LED) indicates data is being accessed. Do not remove the key while the LED is flashing or you might lose the data files.

Installing the Memory Key in Windows NT

Please refer to the instructions in the Windows NT Driver User Manual that is included on the *IBM 64 MB and 256 MB USB 2.0 Memory Key CD* that is shipped with your Memory Key.

Note: The KeySafe and MyKey applications are not supported in Windows NT.

Chapter 3. MyKey

MyKey is a tool that enables you to access and customize your Memory Key through the Memory Key console. Messages and prompts guide you through the short MyKey installation, use and customization procedures, enabling you to make your Memory Key more personal, fun and easier to use. This chapter also includes some important frequently asked questions (FAQs).

System setup

Your computer must meet the following requirements to install and use MyKey:

- Pentium[®] II 266MHz
- 1.7 MB free disk space (on drive C)
- Operating Systems: Windows 98 SE, Windows Me, Windows 2000, or Windows XP (Windows 98 requires a Memory Key device driver)
- MyKey application is not supported in Windows NT®
- · Administrative privileges for Windows 2000 and XP

For optimal performance, the key works optionally with a graphic accelerator that supports 24-bit color depth.

Installation

MyKey is supported on IBM 64 MB and 256 MB 2.0 Memory Keys. If your Memory Key supports MyKey, make sure you have the latest MyKey version, which you can download from www.pc.ibm.com/support, and search under 64 MB or 256 MB USB 2.0 Memory Key.

To install MyKey, do the following:

1. Insert the *IBM 64 MB and 256 MB USB 2.0 Memory Key CD* that was shipped with your key and open the "Software" folder.

2. Double-click the MyKey icon.



- **3**. On the install screen, check the box if you want a shortcut to MyKey on your desktop. A shortcut to MyKey and Uninstall MyKey is automatically created in the Start menu. Click **Finish** to start using MyKey, or **Cancel** to abort the installation.
 - **Note:** By default, MyKey is loaded automatically with Windows. You can disable this option from the Settings window.

Wait a few moments until the MyKey icon is added to your system tray on the bottom of your screen, next to the clock. Use this icon for the easiest and fastest access to all MyKey functions.



To uninstall the MyKey application go to the **Start -> All Programs -> MyKey IBM -> Uninstall MyKey IBM**.

MyKey customization

To open the main menu to access MyKey functions, right-click the MyKey tray icon. Each of the options in this menu is described below.

Visual indication

This icon displays the Memory Key console each time you insert your Memory Key into your computer's USB connector.

Audio indication

This sound occurs when you insert your Memory Key into your computer USB connector.

Splash screen

This screen displays while MyKey is loading.

Autorun process

This process automatically launches various applications based on autorun instructions set in your Memory Key, similarly to CD-ROM autorun. For advanced autorun features, see "Additional features" on page 19.

Load with Windows

By default, MyKey is loaded when Windows begins to enable Memory Key advanced features. If you disable this feature, you will need to start MyKey manually from your computer Start menu.

Create desktop shortcut

This creates or removes a MyKey shortcut on your desktop.

Always on top

By default, the Memory Key console floats in front of all windows for quick and easy access. If you disable this feature, the Memory Key console becomes a normal window.

Select your language

To select your preferred language, do the following:

- 1. Select your preferred language. The supported Languages are English, French, Spanish, Italian, German, Portuguese, Chinese (Traditional or Simplified), or Japanese. Only the supported languages are displayed in the combo box. Correct display of the selected language depends on the specific Windows version you are using and the system location you select (Control panel->Regional settings). If Windows does not support the language you have selected, a "?" is displayed instead of the language name.
- 2. Make sure that you can read the welcome message displayed next to the language selection combo box. If you can read the message, click **OK** to implement the language change. All screen shots and text will change according to the language selected.

Hide/Show

Click Hide or Show to turn off or display the Memory Key console display.

Help

This option launches the IBM support site where you will be able to search for information on your memory Key and its applications.

About

This option provides information about the current version.

Exit

When you exit MyKey, Memory Key quick access and advanced functionality are disabled.

MyKey popup messages

MyKey uses popup messages, as shown below, to provide information or to inform you of Memory Key events. This type of message automatically disappears after a few seconds, or you can click it to close it immediately.



Memory key console

The Memory Key console enables you to access your Memory Key to store and retrieve files, launch installed applications and customize the Memory Key.

The Memory Key console displays the Memory Key logo, your Memory Key drive letter and the Memory Key label. To change this display with your personal icon or label, see "MyKey personal icon" on page 13. To move the Memory Key console, click and hold the left mouse button anywhere inside it, drag it to a different location, and then release the left mouse button.



LCD

The liquid crystal display (LCD) shows your Memory Key total capacity and free space. The free space indicator turns red when 5% or less of your total disk space is free.

The LCD display shown in Figure 8: Privacy Zone Indication indicates if you have logged into your Privacy Zone by using KeySafe. The LCD display indicates if your Memory Key is write protected. For further details on write protection, see "Enable/disable write protection" on page 15.

Buttons

Click any of the buttons described below to enable them.

Tools

The **Tools** button opens the Memory Key console menu. This menu contains the Memory Key console settings (see "Memory key console" on page 10), advanced features such as synchronization, and personal folders.

Browse

Click the Memory Key browse button to open the Memory Key drive in Windows Explorer and to access all your files (both those secured in your Privacy Zone and public files).

Close (X)

Click **X** to close the Memory Key console. The console will disappear in the tray icon, and the message "Exiting Memory Key by Clicking X" will be displayed, advising you that the program will continue to run in the taskbar. Click the checkbox if you do not want this message to be displayed when you

exit in this manner.



To re-open the Memory Key console, double click the tray icon or select **Show**" from the MyKey menu (see "MyKey customization" on page 7.

Eject

The **Eject** button helps to ensure the integrity of all data stored on your Memory Key before you remove it. Click **Eject**, wait for the safe removal message, and then remove your Memory Key. Alternately, for all operating systems except Windows 2000 and Windows XP, you can use the green arrow in the tray menu to safely remove your Memory Key.

Attention: Removing your Memory Key without using the Eject button or the green arrow in the toolbar can result in data loss!

Personalizing your memory key

To personalize your Memory Key with your own icon, a special sound, or your own label, click the **Tools** button on the Memory Key console and select **Settings** (see "MyKey customization" on page 7). The Memory Key Settings window is displayed.

MyKey personal icon

To change the default icon, open the MyKey Personal Icon combo box and choose from these options:

- Select any of the eleven icons included with MyKey.
- Select an icon file by browsing files that you have either created or want to download from the web.

Click **OK** to apply the change.

Note: This operation will fail if the Memory Key is write-protected.

MyKey personal sound

To change the default sound, open the MyKey Personal Sound combo box and choose from these options:

- Select any of the ten sounds included with MyKey.
- Select a different sound by browsing files that you have created or want to download from the Web. You can listen to any of the sounds you select by clicking **Play**. Click **OK** to apply the change.

Note: This operation will fail if the Memory Key is write-protected.

MyKey personal label

To personalize your Memory Key and simplify content identification, type a personal label, such as your name or a category (up to 14 characters) to identify the contents of your Memory Key.

Memory key version

Your Memory Key version is the last item listed in the Memory Key Preferences window. You will need this information if you contact Technical Support for help.

Advanced features

When MyKey is running, you can access a number of advanced features that make Memory Key easier to use. Click **Tools** and then click an option in the Advanced Features menu. This section describes these features.



Login/logout privacy zone

If you have created a Privacy Zone on your Memory Key using KeySafe, you can login/layout of this zone easily by providing the correct password in the Login Privacy Zone window. After a fifth unsuccessful attempt to login, Safe Eject your Memory Key, reinsert it in your tray, verify your password and try logging in again.

After you have successfully logged into your Privacy Zone, the text in the window changes to Logout Privacy Zone. To logout, just click this option in

the Advanced Features menu.

Enable/disable write protection

To protect your Memory Key from viruses or data loss when plugging it into a computer whose security and integration are questionable, MyKey enables you to write-protect your Memory Key. This prevents protected files from being deleted, created or modified.

Synchronization options

MyKey synchronization options speed up and simplify the process of synchronizing your work between two or more computers, or simply backing up files. Available synchronization options include:

- Folder: This option synchronizes all folders and sub-folders.
- **My Favorites:** This option synchronizes your My Favorites folder on your computer and your Memory Key Favorites folder on your Memory Key.
- **My Documents:** This option synchronizes your My Documents folder on your computer and your Memory Key Documents folder on your Memory Key.

First-time folder use

To enable folder synchronization for first-time use, proceed as follows:

- 1. Select **Synchronize Folders** from the MyKey Console Tools menu. The first time you use the synchronization feature on a new computer or with a new Memory Key, the Synchronization Settings window opens.
- 2. Select the folders you would like to synchronize. The first folder must be an existing local folder. The second folder must be an existing Memory Key folder.
 - **Note:** If identical files exist in both your local and Memory Key folders the first time you attempt to synchronize them, MyKey will not know which file is the most up-to-date version. Therefore, make sure to assign different names.
- 3. Click **OK** to start the synchronization process, or **Cancel** to exit.

Subsequent folder use

After you have selected the folders to synchronize, proceed as follows:

- 1. Select **Synchronize Folders** from the MyKey Console Tools menu. This opens the Synchronization Details window. A list of the required actions, awaiting your approval, is displayed.
- 2. Click Settings to access/change the displayed settings.

3. Click **Synchronize** to authorize all file operations (you cannot select a partial list).

- 4. If an error occurs during a file operation (for example, the disk is full or there is a bad path or file), an error message displays. Click **OK** to continue synchronizing the remaining files, or **Cancel** to stop the process.
- 5. Click **OK** when a message is displayed indicating synchronization completion.

Folder synchronization rules

The following rules apply to the synchronization process:

- **New file:** If a new file is created in any folder, MyKey enables you to create the same file in the other folder or folders.
- **Deleted file:** If a file was deleted in any folder, MyKey enables you to delete the file in the other folder or folders.
- **Modified file:** If a file was modified in any folder, MyKey enables you to replace the file in the other folder or folders. If the file was modified in all folders, MyKey enables you to skip this file without performing any operation.
- **Renamed file:** Renaming a file is equivalent to deleting it and creating a new one. Therefore, the rules for "Deleted file" apply.

Creating personal folders

Personal folders are file folders that help you to categorize or organize your files for quick retrieval. To create a personal folder, proceed as follows:

1. Click **OK** to confirm personal folder creation.



The following directories are created:

- My Memory Key, similar to your Desktop, stores general files that you access frequently.
- Memory Key Documents, similar to your My Documents folder, stores work files. This folder stores files from the Synchronize My Documents operation.
- Memory Key Favorites, similar to your Favorites folder, stored your favorites. This folder stores files from the Synchronize My Favorites operation.
- 2. To access any files in your personal folders, you can do one of the following:
 - Open your My Profile folder from Windows Explorer.

• Click Tools on the Memory Key Console to display and access files.



Additional features

MemoryKey has two additional features, discussed below.

Send to Memory Key Drive

Your designated Memory Key drive is automatically added to the Send To menu, enabling you to right click a file and save it on your Memory Key drive.



Autorun

The MyKey autorun function enables a wide variety of files, such as hypertext markup language (HTML) web pages, to be launched automatically when you insert your Memory Key into the USB port of a computer.

MyKey runs and executes the Memory Key autorun.ini file. You can disable this feature from the MyKey Settings window. The MyKey autorun syntax is slightly different and more extensive than a CD-ROM autorun syntax.

A typical autorun.inf file contains two lines in text format (ASCII) to launch the file start.htm. For example, the syntax of the autorun.inf file that launches the Memory Key Web page might be:

[launcher]

open=www.memorykey.com

As another example, the syntax of the autorun.inf file that launches the Windows calculator (calc.exe) might be:

[launcher]

open=calc.exe

Troubleshooting

MyKey displays a number of messages with guidelines for troubleshooting, where possible, as follows:

- Fatal error This general error message indicates that a fatal error has occurred from which the application cannot recover.
- Windows version not supported This message displays if you try to run MyKey on a version of Windows not supported. (See "System setup" on page 5.)
- No administrative privileges The application terminates if you attempt to run MyKey on a computer where you do not have administrative privileges.
- Large fonts MyKey is designed to use small fonts, and may not provide optimal display viewing if you use large fonts. To switch to small fonts, open your control panel, and select this sequence:

Display Properties -> Settings -> Advanced -> Font Size.

- Unable to connect to Memory Key This message indicates that MyKey was unsuccessful in obtaining information from your Memory Key such as version number, capacity, your personal settings, etc.
- Unable to eject Memory Key This message usually indicates that you have not closed all applications or files on your Memory Key before trying to remove it. Close any open application or file, and then try again to remove your Memory Key.
- The device 'xxx' cannot be stopped right now. Try stopping the device again later This message appears after you click **Stop** in the Unplug or Eject Hardware window. It usually indicates that you have not closed all applications or files on your Memory Key before trying to remove it. Close the MyKey application and try again. If the message displays again, close all open applications or files, and then try to remove your Memory Key again.
 - **Note:** This message is generated by the operating system, not the MyKey application, and is relevant only for Windows Me, Windows XP, or Windows 2000.

Frequently Asked Questions (FAQs)

A few of the most frequently asked questions are listed below.

Q: How do I check which version of MyKey I'm using?

A: The simplest way is to right click the MyKey tray icon, and then click **About**.

Q: Can I use MyKey with more than one Memory Key on my computer?

A: Yes.

Q: Why can I use MyKey only on certain computers?

A: You can only use MyKey on computers for which you have administrative privileges.

Q: Why can't I copy files to my Memory Key?

A: Your Memory Key may be write-protected or you may not have enough free disk space. If your Memory Key is write-protected, you will see the Write Protection logo on the LCD display of your MyKey Console.

Q: How can I restore my Memory Key Console after I close it?

A: Double click or right click your MyKey tray icon and select Show.

Chapter 4. Using multilingual KeySafe[™]

KeySafe enables you to create and access a password-protected secure area, called a Privacy Zone, on your IBM Memory Key. Messages and prompts guide you through setting up KeySafe with your password and customizing the Privacy Zone to suit your personal and business needs for securing your information. This text summarizes the procedures, and also includes some Frequently Asked Questions (FAQs).

System requirements

- Pentium II 266MHz
- 800KB free disk space
- Operating Systems: Windows 98 SE, Windows Me, Windows 2000, or Windows XP (Windows 98 requires a device driver)
- KeySafe is not supported in Windows NT
- Access to your main drive (usually drive C)
- Administrative privileges for Windows 2000 and Windows XP

For optimal performance, use the Memory Key with a graphic accelerator that supports 24-bit color depth.

Getting started

Attention: When you create your Privacy Zone, the Memory Key is formatted and ALL data will be lost. Back up your files before you create your Privacy Zone.

Creating the Privacy Zone

To create the privacy zone, do the following:

- 1. Select the removable diskette drive that you have assigned to your Memory Key and double-click the **KeySafe** icon.
- 2. Select your preferred language from the language window and click **OK**. Supported languages are English, French, Spanish, Italian, German,

Portuguese (Brazilian), Chinese (Traditional or Simplified), and Japanese.

FAQs

Q: How do I check which version of KeySafe I'm using?

A: The simplest way is to right click the KeySafe icon on your Memory Key, and then click Properties and Version.

Q: How do I upgrade KeySafe to the newest version?

A: Download the zipped file from the web (www.pc.ibm.com/support) to your desktop; search under 64 MB or 256 MB USB 2.0 Memory Key. Unzip it and copy the exe file to your Memory Key. Launch it from your Memory Key by double clicking KeySafe. Do not use the shortcut you may have created on your desktop or quick launch bar, since this will launch the old version.

Q: Can I change only my KeySafe password without formatting my Privacy Zone?

A: Yes, using the Change Password button in the KeySafe Settings window Please note that when you change your password without the Change Password button, your Memory Key is formatted and ALL data is lost.

Q: I would like to secure all the data on my Memory Key. Why am I limited to a Maximum Privacy Zone of 90%?

A: Your Memory Key needs space to run KeySafe, as well as information about your Memory Key. 10% of your Memory Key is kept free to save space for upgrades and future applications without hindering KeySafe operation.

Q: How do I know if I'm working in my Privacy Zone or in the Public Zone?

A: If you're working in Windows 2000 or 98 ME, the KeySafe icon is displayed with a red lock inside it when you're in your Privacy Zone. If you're working in Windows 98, 2000, ME or XP, the background color in your root file folder or in your Memory Key icon is blue when you're in your Privacy Zone. (This visual indication is not seen if you have selected a classic folder view on your computer.)

Q: How do I switch between the Public Zone and my Privacy Zone?

A: Launch KeySafe from your desktop, Memory Key or quick launch bar. If you see a prompt asking for your password, this means that you are currently in the Public Zone. To switch to your Privacy Zone, enter your password and click OK. If you see a pop-up window with a prompt asking you for logout confirmation from your Privacy Zone, this means that you're working in your Privacy Zone. To switch, click OK. To remain logged into your Privacy Zone, click Cancel.

Q: I accidentally deleted KeySafe from my Memory Key. How can I access data in my Privacy Zone?

A: Copy the KeySafe exe from the CD that shipped with your key or go to (http://www.pc.ibm.com); search under 64 MB or 256 MB USB 2.0 Memory Key and download the exe. The Privacy Zone that you previously designated will be accessible.

Q: Can I use KeySafe with more than one Memory Key on my computer?

A: Yes. All IBM 64 MB and 256 MB Memory Keys support the KeySafe application installed on your operating system.

Q: Can I use more than one Memory Key with KeySafe simultaneously?

A: No.

Q: Why can I use KeySafe only on certain computers?

A: You can only use KeySafe on computers for which you have administrative privileges.

Q: Is there an alternate way to format both the Public and Private Zones on my Memory Key if KeySafe formatting fails?

A: Yes. Use the OS format utility. Then copy KeySafe and you're ready to use it.

Chapter 5. Using IBM Memory Key Boot Utility

The IBM Memory Key Boot Utility enables you to make your Memory Key into a bootable disk. After using the application and turning your Memory Key into a bootable disk, you will be able to boot IBM computers from the Key.

System setup requirements

- BIOS that supports bootable USB devices. If you are uncertain about whether the BIOS supports bootable USB devices, contact your computer manufacturer. If needed, there might be an available update.
- The BIOS documentation that came with your computer or BIOS update, if applicable.

- 2. Insert your Memory Key. The disk properties, such as capacity or file system, are displayed in the relevant fields of the application window.
- **3**. To create a volume label, type the label name in the Volume label field (up to 11 characters).
- 4. To begin creating a boot disk, click **Start**. A warning message displays informing you that all your files will be deleted. To continue, click **OK**. To cancel the formatting process, click **Cancel**.
- 5. After clicking **Start**, a progress bar displays indicating the status of the formatting process. After the formatting completes, a message displays indicating that the formatting process was successful.
- 6. To exit the program without creating a boot disk, click Cancel.

Notes:

a. Creating a boot disk requires formatting the Memory Key. This will delete all files that are on the Key.

- b. If you begin the formatting process, you will not be able to abort it before it ends.
- **c**. Do NOT remove the Memory Key while formatting, and be sure to close all applications that might use the Memory Key.

Booting your computer with the IBM Memory Key

To boot your computer with the IBM Memory Key, do the following:

- 1. Turn off your system. Insert the boot Memory Key into any available USB slot.
- 2. Turn on your system and use the steps outlined in your desktop or mobile computer documentation to access your BIOS settings. Locate the section that determines the Boot or Startup Order of the disks on your desktop or mobile computer.
- 3. Change the order to the following:
 - Legacy diskette drive (might not be applicable depending on your desktop or mobile computer configuration)
 - ATAPI CD-ROM drive or optical drive
 - Hard Drive USB Memory Key
 - Hard Drive your main hard disk drive or drives with your operating system or data files
- 4. Save your setting changes and exit the BIOS.
- 5. Restart your computer. It should boot to a DOS prompt using the Memory Key.

Troubleshooting

- Creating a boot disk on a key with a Privacy Zone: If you previously created a Privacy Zone on your Memory Key (using the KeySafe application), you will need to delete this Privacy Zone before running the boot application. The way to delete this Privacy Zone is by running KeySafe and setting the Privacy Zone to "0". For more information, refer to the KeySafe manual on the CD.
- **Creating a boot disk on a write-protect enabled key:** If you previously set your key to be write protected (using MyKey application), you will need to disable this feature before you run the boot application. For more information, refer to the MyKey manual on the CD.
- Using multiple Memory Keys simultaneously: If you have inserted more than one Memory Key, you will be prompted to remove the keys, and leave only the key you want to use as a boot disk plugged in.

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines: IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty: The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. **Items Not Covered by Warranty:** IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND**.

Warranty Service: To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;

- 2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and
- 3. where applicable, before service is provided:
 - a. follow the problem determination, problem analysis, and service request procedures that IBM or your reseller provides;
 - b. secure all programs, data, and funds contained in a Machine;
 - **c**. provide IBM or your reseller with sufficient, free, and safe access to your facilities to permit them to fulfill their obligations; and
 - d. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability: Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.
