General safety guidelines

Always observe the following precautions to reduce the risk of injury and property damage.

Service

Do not attempt to service a product yourself unless instructed to do so by the IBM Support Center. Use only an IBM authorized service provider who is approved to repair your particular product.

Note: Some parts can be upgraded or replaced by the customer. These parts are referred to as Customer Replaceable Units, or CRUs. IBM expressly identifies CRUs as such, and provides documentation with instructions when it is appropriate for customers to replace those parts. You must closely follow all instructions when performing such replacements. Always make sure that the power is turned off and that the product is unplugged from any power source before you attempt the replacement. If you have any questions or concerns, contact the IBM Support Center.

Power cords and power adapters

Use only the power cords and power adapters supplied by the product manufacturer.

Never wrap a power cord around the power adapter or other object. Doing so can stress the cord in ways that can cause the cord to fray, crack or crimp. This can present a safety hazard.

Always route power cords so that they will not be walked on, tripped over, or pinched by objects.

Protect the cord and power adapters from liquids. For instance, do not leave your cord or power adapter near sinks, tubs, toilets, or on floors that are cleaned with liquid cleansers. Liquids can cause a short circuit, particularly if the cord or power adapter has been stressed by misuse. Liquids can also cause gradual corrosion of the power cord terminals and/or the connector terminals on the adapter which can eventually result in overheating.

Always connect power cords and signal cables in the correct order and ensure that all power cord connectors are securely and completely plugged into receptacles.

Do not use any power adapter that shows corrosion at the ac input pins and/or shows signs of overheating (such as deformed plastic) at the ac input or anywhere on the power adapter.

Do not use any power cords where the electrical contacts on either end show signs of corrosion or overheating or where the power cord appears to have been damaged in any way.

Extension cords and related devices

Ensure that extension cords, surge protectors, uninterruptible power supplies, and power strips that you use are rated to handle the electrical requirements of the product. Never overload these devices. If power strips are used, the load should not exceed the power strip input rating. Consult an electrician for more information if you have questions about power loads, power requirements, and input ratings.

Plugs and outlets

If a receptacle (power outlet) that you intend to use with your computer equipment appears to be damaged or corroded, do not use the outlet until it is replaced by a qualified electrician.

Do not bend or modify the plug. If the plug is damaged, contact the manufacturer to obtain a replacement.

Some products are equipped with a three-pronged plug. This plug fits only into a grounded electrical outlet. This is a safety feature. Do not defeat this safety feature by trying to insert it into a non-grounded outlet. If you cannot insert the plug into the outlet, contact an electrician for an approved outlet adapter or to replace the outlet with one that enables this safety feature. Never overload an electrical outlet. The overall system load should not exceed 80 percent of the branch circuit rating. Consult an electrician for more information if you have questions about power loads and branch circuit ratings.

Be sure that the power outlet you are using is properly wired, easily accessible, and located close to the equipment. Do not fully extend power cords in a way that will stress the cords.

Connect and disconnect the equipment from the electrical outlet carefully

Batteries

All IBM personal computers contain a non-rechargeable coin cell battery to provide power to the system clock. In addition many mobile products such as Thinkpad notebook PCs utilize a rechargeable battery pack to provide system power when in portable mode. Batteries supplied by IBM for use with your product have been tested for compatibility and should only be replaced with IBM approved parts.

Never attempt to open or service any battery. Do not crush, puncture, or incinerate batteries or short circuit the metal contacts. Do not expose the battery to water or other liquids. Only recharge the battery pack strictly according to instructions included in the product documentation.

Battery abuse or mishandling can cause the battery to overheat, which can cause gasses or flame to "vent" from the battery pack or coin cell. If your battery is damaged, or if you notice any discharge from your battery or the buildup of foreign materials on the battery leads, stop using the battery and obtain a replacement from the battery manufacturer.

Batteries can degrade when they are left unused for long periods of time. For some rechargeable batteries (particularly Lithium Ion batteries), leaving a battery unused in a discharged state could increase the risk of a battery short circuit, which could

shorten the life of the battery and can also pose a safety hazard. Do not let rechargeable Lithium-Ion batteries completely discharge or store these batteries in a discharged state.

Heat and product ventilation

Computers generate heat when turned on and when batteries are charging. Notebook PCs can generate a significant amount of heat due to their compact size. Always follow these basic precautions:

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer produces some heat during normal operation. Extended contact with the body could cause discomfort or, potentially, a skin burn.
- Do not operate your computer or charge the battery near flammable materials or in explosive environments.
- Ventilation slots, fans and/or heat sinks are provided with the product for safety, comfort, and reliable operation. These features might inadvertently become blocked by placing the product on a bed, sofa, carpet, or other flexible surface. Never block, cover or disable these features.

CD and DVD drive safety

CD and DVD drives spin discs at a high speed. If a CD or DVD is cracked or otherwise physically damaged, it is possible for the disc to break apart or even shatter when the CD drive is in use. To protect against possible injury due to this situation, and to reduce the risk of damage to your machine, do the following:

- · Always store CD/DVD discs in their original packaging
- Always store CD/DVD discs out of direct sunlight and away from direct heat sources
- Remove CD/DVD discs from the computer when not in use
- Do not bend or flex CD/DVD discs, or force them into the computer or their packaging
- · Check CD/DVD discs for cracks before each use. Do not use cracked or damaged discs

Being lightweight and compact in size the C400 is a great departmental solution and allows you to move it easily from the boardroom to the conference room, or to customer locations. Some main features of this projector are:

- Sharp and clear images with a high contrast ratio of 1200:1
- Asset management: Remotely check the status of your C400 PROJECTOR via a
 Web browser (password protected), through an RJ-45 connection (lamp life and
 technical status), or have projector send proactive e-mail to your projector
 administrator.
- Beautiful reproduction of high-quality images from your PC and other media sources (i.e.: DVD Player).




Figure 1-1. Standard Accessories

Important:

- · Avoid using the projector in dusty environments
- Leave the power cable plugged in (for 2-5 minutes) until the projector returns to room temperature before placing the projector inside the soft case. Placing the projector into the case too soon after switching off the power could cause the projector to overheat and will shorten lamp life.
- Be sure to attach the lens cap and place the projector into the soft case with the lens facing upward to avoid damaging the lens.




Figure 1-2. Front view of projector




Figure 1-3. Side view of projector




Figure 1-4. OSD buttons and LEDs




Figure 1-5. Rear view of projector




Figure 1-6. Bottom view of projector

- 4 Projection lamp cover


Chapter 2. Setting up the projector

This chapter provides information on positioning the projector, connecting a computer source and displaying and adjusting an image.

Starting the projector

To start the projector, do the following:

 Connect the power cord to the projector as shown below. Connect the other end of the cord to an electrical outlet. The Power and Lamp-ready LEDs turn on.



- 2. Remove the lens cover.
- 3. Attach the input devices.
- 4. Turn on the connected input devices.
- 5. Be sure that the Power LED is on (not flashing) amber and then press the **Power** button to turn on the projector.

The projector display window opens and the projector detects connected devices. If you connected the projector to an IBM computer, press Fn+F7 on the computer to switch the display output to the projector. If you connected the projector to a non-IBM computer, refer to the documentation that came with your computer for information on how to change the display output.

Attention: Do not look directly into the projection lens when the lamp is turned on. The bright light might harm your eyes.

- 6. If you have connected more than one input device to the projector, toggle the **Source** button to change devices. (DVD and HDTV are supported through the DVI-I cable connector.)
- 7. For information on turning off the projector, go to "Turning off the projector."

Attention: Before moving the projector, be sure to power down the projector normally and disconnect the projector from the main power source. See "Turning off the projector" for more information on turning off the projector normally.

Turning off the projector

To turn off the projector, do the following:

1. Press the **Power** button.

The projector prepares for shut-down and the Wait a moment message displays, as shown below. The projector turns off automatically within 5 seconds.



Note: This operation can be cancelled by pressing a button other than the Power button. Pressing the Power button again will turn off power.

Note: Leave the power cable plugged in for at least 2-5 minutes until the projector returns to room temperature before placing the projector inside the soft case. Placing the projector into the case too soon after turning off the power could cause the projector to overheat.

2. Press the **Power** button when the Power Off?/Press Power again message displays, as shown below.



The projector turns off.

Positioning the projector

To determine where to position the projector, consider the size and shape of your screen, the location of your power outlets, and the distance between the projector and the rest of your equipment. Following are some general guidelines:

- Position the projector on a flat surface at a right angle to the screen. The projector must be at least 1.5 m (4.9 ft) from the projection screen.
- Position the projector within 2.7 m (9 ft) of your power source and within 1.8 m (6 ft) of your video device (unless you purchase extension cables). To ensure adequate cable access, do not place the projector within .15 m (6 in.) of a wall or other object.
- Position the projector the desired distance from the screen. The distance from the lens of the projector to the screen, the zoom setting, and the video format determine the size of the projected image.

Attention: Ensure that projector air flow is sufficient and not blocked or using recirculated air. Please also ensure that the projector is not in a confined space.




Figure 2-2. Image width



Adjusting the projector level and height

To adjust the projector level and height, complete the following procedure:

- To raise the height of the projector, lift the projector 1 and press the height-adjuster buttons 2. The elevator foot 3 drops down.
- 2. To make minor adjustments to the height, rotate the elevator foot 4 as shown below.
- 3. To lower the level of the projector, press the height-adjuster button and press down on the top of the projector.




Note:

- The projector table or stand should be level and sturdy.
- Position the projector so that it is perpendicular to the screen.
- Be sure the cables are *not* in a place where they can knock over the projector.


Adjusting the image

To adjust the zoom, focus, and keystone for the image, do the following:

1. Twist the rings on the projector to adjust the focus 1 and zoom 2, as shown below.



2. Use the **Keystone** buttons on the projector or the remote to correct image-trapezoid (wider top or bottom) effect. The Keystone buttons on the remote and projector are shown below.



The keystone control appears on the On Screen Display (OSD), as shown.




Adjusting the volume

To adjust the volume, do the following:

1. Press the **Volume +/-** buttons on the projector or the remote control. The volume control appears on the OSD.



2. Use the **Volume** +/- buttons shown below to adjust the level.




- 3. Press the Mute button (on the remote control only) to turn off the volume.
- 4. Press any Volume +/- buttons on the projector or remote control to turn off

Connecting devices

Computers and video devices can be connected to the projector at the same time. Refer to the documentation that comes with the connecting device to verify that the device has the appropriate output connector.





Before you begin


Before you can use the remote control, you must install the AAA batteries that come with this projector. To install the batteries, do the following:

Note:

- Use only AAA alkaline batteries.
- Dispose of used batteries according to local government ordinance regulations.
- Remove the batteries when not using the remote control for prolonged periods.
- 1. Remove the battery compartment cover from the remote control as shown.




2. Insert the supplied batteries into the remote control battery compartment, aligning the polarity (+/-) of the batteries with the polarity icons in the compartment, as shown.


Using the remote control


Operating range

This remote control uses infrared transmission to control the projector. It is not necessary to point the remote directly at the projector. The remote control will function within a maximum radius of 10m (32.8 ft) and 30° above or below the projector level. If the projector does not respond to the remote control, please see Appendix B, "Troubleshooting," on page B-1.

Note: The remote will still work when it is pointed at the projected image.

Projector and remote control buttons

The projector can be operated using the remote control or the buttons on the top of the projector. All operations can be carried out with the remote control. The figure below shows the corresponding buttons on the remote control and on the projector for OSD menu operation.

Chapter 5. On-Screen Display menu controls

This projector has an On-Screen Display (OSD) that lets you make image adjustments and change various settings.

Note: You must have a display on the screen in order to access the OSD.

Navigating the OSD

You can use the remote control or the buttons on the top of the projector to navigate and make changes to the OSD. The following sections show the menus in the OSD.

Language

To set the OSD language, do the following:

Note: The default OSD language is English.

- 1. Press the Menu button. The Language menu displays.
- 2. Press the cursor left/right buttons until Language is highlighted.
- 3. Press the cursor up/down buttons until the language you want is highlighted.
- 4. Press **Enter** to select the language.
- 5. Press the **Menu** button twice to close the OSD.

The image below shows the Language menu. The default language is English.




Quality menu

The Quality menu can be found through the main menu. To access the Quality menu, follow these steps:

- 1. Press the **Menu** button to open the main menu.
- 2. Press the cursor left/right button to move to the Quality menu.








Figure 5-1. Setup Menu with single input




Figure 5-2. Setup Menu with dual input

Appendix A. Maintenance

This chapter provides information on projector maintenance.

Cleaning the projector

Cleaning the projector to remove dust and grime will help ensure trouble-free operation.

- Be sure to turn off and unplug the projector at least 1 hour before cleaning. Failure to do so could result in a severe burn.
- Use only a dampened cloth when cleaning. Do not allow water to enter the ventilation openings on the projector.
- If a little water gets into the projector interior while cleaning, leave it unplugged in a well-ventilated room for several hours before using.
- If a lot of water gets into the projector interior when cleaning, have the projector serviced.

Cleaning the lens

To clean the lens, complete the following procedure:

1. Apply a non-abrasive camera lens cleaner to a soft, dry cloth.

Note: Avoid using an excessive amount of cleaner, and do not apply the cleaner directly to the lens. Abrasive cleaners, solvents or other harsh chemicals might scratch the lens.

2. Lightly wipe the cleaning cloth over the lens in a circular motion. If you do not intend to use the projector immediately, replace the lens cap.

Cleaning the case

Follow the steps below to clean the projector case:

- 1. Wipe off dust with a clean dampened cloth.
- 2. Moisten the cloth with warm water and mild detergent (such as dish detergent), and wipe the case.
- 3. Rinse all detergent from the cloth and wipe the case again.

Note: To prevent discoloration or fading of the case, do not use abrasive alcohol-based cleaners.

Replacing the projector lamp


The projector lamp should only be replaced with an IBM certified replacement part, which you can order from your business partner or go to www.ibm.com/pc.

To replace the projector lamp, complete the following procedure:



- 2. Use a Phillips-head screwdriver to remove the screw from the lamp compartment cover as shown in 1.
- 3. Remove the lamp compartment cover as shown in 2.




- 4. Remove the two screws from the lamp module as shown in 3.
- 5. Lift the module handle up and pull up firmly as shown in 4.



6. Reverse steps 1 through 5 to install the new lamp module.

Resetting the lamp timer


After replacing the lamp, you should reset the lamp hour counter to zero. Please follow the steps below.

- 1. Press the **Menu** button to open the main menu.
- 2. Press the cursor left/right button to move to the Information menu.
- 3. Press the cursor up/down button to move down to Lamp Hour Reset.
- 4. Press Enter to select Lamp Hour Reset. The OSD will show "Please see User Manual..."
- 5. Press the buttons on the remote or on the projector in the following order: Down Arrow, Up Arrow, Left Arrow, Right Arrow. This will confirm the lamp hour reset.

Attention: Lamp Life is a measure of brightness degradation only, and is not a specification for the time it takes a lamp to fail and cease light output. Lamp Life is defined as the time it takes for more than 50% of a lamp sample population to have brightness decrease by approximately 50% of the rated lumens for the specified lamp. For example, if the defined life of your lamp is 1500 hours and its brightness is rated at 2650 lumens, then there is a 50% chance that over 1500 hours of run time, your lamp will have decreased its brightness by 50% to approximately 1325 lumens.

Using the security slot

The projector has a security slot, as shown below in **1** . Refer to the information that comes with the lock for instructions on how to use it.



Appendix B. Troubleshooting

The guidelines below provide tips to deal with problems you may encounter while using the projector. If the problem remains unsolved, contact your dealer for assistance.

Common problems and solutions

Check the following before proceeding to the problem-specific solutions.

- Us a different electrical device to confirm that the electrical outlet is working.
- Ensure that the projector is turned on.
- Ensure all connections are securely attached.
- Ensure the attached device is turned on.
- Ensure a connected PC is not in suspend mode.
- Ensure a connected notebook computer is configured for an external display. This is usually done by pressing an Fn-key combination on the notebook.

Tips for troubleshooting

In each problem-specific section, try the steps in the order suggested. This may help you to solve the problem faster.

Try to pinpoint the problem and thus avoid replacing non-defective parts. For example, if you replace batteries and the problem remains, put the original batteries back and go to the next step.

Keep a record of the steps you take when troubleshooting. The information may be useful when calling for technical support or for service personnel.

Troubleshooting information

The following table provides troubleshooting information for the projector. In some cases, more than one possible solution is provided. Try the solutions in the order they are presented. When the problem is solved, you can skip the additional solutions.

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems

When you contact IBM for service, you must follow the problem determination and resolution procedures that IBM specifies. An initial diagnosis of your problem can be made either by a technician over the telephone or electronically by access to an IBM website. The type of warranty service applicable to your Machine is specified in Part 3 - Warranty Information. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

Governing Law


