一般安全准则

维修

请勿试图自己维修产品,除非 IBM HelpCenter 指示您这样操作。请仅允许经 IBM 授权和批准的维修人员维修您的产品。

注: 某些部件可由客户升级或更换。这些部件被称为"客户可更换部件"或 CRU。IBM 明确地标明了这些 CRU,并提供了文档,文档中含有客户何时可以更换这些部件的说明。进行此类更换时,您必须严格按照所 有说明进行操作。在您尝试更换前,请始终确保电源关闭,并且已经从所有电源拔出产品的电源插头。如果您 有任何问题或疑问,请联系 IBM HelpCenter。

电源线和电源适配器

请仅使用产品制造商提供的电源线和电源适配器。

切勿将电源线缠绕在电源适配器或其它物体上。环绕电源线会绷紧电源线从而导致电源线磨损、破裂或弯曲。 这会引起安全隐患。

始终沿特定线路布置电源线以避免遭践踏、绊倒他人或被物体夹紧。

避免电源线和电源适配器接触到液体。例如,切勿将电源线或电源适配器放在水槽、水盆、盥洗室附近,或放 在用液体清洗剂清洁过的地板上。液体会导致短路,尤其是因误用而绷紧电源线或施压于电源适配器时。液体 还会引起电源线终端和/或适配器上的连接器终端逐渐腐蚀,最终导致适配器过热。

始终以正确的顺序连接电源线和信号电缆,并确保所有的电源线连接器都牢固而完全地插入在插座中。

请勿使用交流电源输入引脚处出现腐蚀迹象和 / 或交流电源输入处或其它地方出现过热迹象(例如变形的塑料)的电源适配器。

请勿使用任何一端的电气触点出现腐蚀或过热迹象的电源线,也不要使用出现任何损坏现象的电源线。

延长线和相关设备

确保您使用的延长线、电涌保护器、不间断电源和电源拖板的额定值符合产品的电气要求。请勿使这些设备过载。如果使用电源拖板,负载不应该超出电源拖板的输入额定值。如果您对于电源负载、电源要求和输入额定 值有疑问,请咨询电工获取更多信息。

插头和插座

如果您想要用于计算机设备的插座(电源插座)出现损坏或腐蚀的情况,请勿使用该插座,直至有资格的电工将其更换。

请勿弯曲或改装电源插头。如果电源插头损坏,请与制造商联系以获得替换品。

某些产品装配有三线插头。该插头仅适合插入接地的电源插座。这是一种安全装置。请勿通过尝试将其插入非 接地插座弄坏这种安全装置。如果您无法将插头插入插座,则联系电工以获取核准的插座适配器或用支持该安 全装置的插座替换该插座。请勿使电源插座过载。整个系统负载不应该超出分支电路额定值的 80%。如果您对 于电源负载和分支电路额定值有疑问,请咨询电工以获取更多信息。

请确保您使用的电源插座正确连接、使用方便并紧靠设备放置。完全展开电源线时请勿使其紧绷。

请小心地将设备连接到电源插座和从电源插座断开连接。

电池

全部 IBM 个人计算机都包含不可充电的纽扣电池为系统时钟提供电源。另外,许多移动式产品(例如 ThinkPad 笔记本 PC)利用充电电池在便携方式下提供系统电源。IBM 提供的用于产品的电池已经过兼容性测试,并且 只可用 IBM 批准的部件进行更换。

请勿尝试打开或维修任何电池。请勿压碎、刺穿或焚烧电池或使金属触点短路。请勿将电池与水或其它液体接触。只能严格根据产品文档中所包含的说明对电池进行充电。

滥用或不正确处理电池会引起电池过热,而过热会导致电池或纽扣电池释放气体或发出火焰。若电池已经损坏 或者发现有物质从电池中流出或电池引线上有异物堆积,请停止使用该电池,并从电池制造商处获取新电池。

电池长期闲置不用后,其性能会下降。对于某些可充电电池(尤其是锂离子电池),将其以放电状态闲置可能 会增加发生电路短路的风险,这样会缩短电池寿命,也会引起安全隐患。请勿将可充电锂离子电池完全放电, 或将这些电池以放电状态存储。

产品散热与通风

当计算机开启和电池充电时,计算机会发热。由于外型轻巧紧凑,因此笔记本 PC 会产生很大的热量。请始终 遵循以下基本预防措施:

- 当计算机运行或电池充电时,请避免使计算机底部与腿部或身体任何部分的接触时间过长。计算机在正常 操作过程中会产生一些热量。与身体长时间的接触会导致不适甚至可能灼伤皮肤。
- 请勿在易燃物质附近或易爆环境中操作计算机或对电池充电。
- 为了安全、舒适和可靠地操作产品,随产品一起提供了通风槽、风扇和/或散热器。将产品放在床、沙发、地毯或其它柔性物体表面上有可能无意中会妨碍这些功能部件的运行。切勿阻塞、覆盖或禁用这些功能部件。

CD 和 DVD 驱动器安全

CD 和 DVD 驱动器以高速度旋转光盘。如果 CD 或 DVD 破裂或有其它物理损坏,则在使用 CD 驱动器时 光盘可能断裂或者甚至粉碎。要避免因这种情况造成伤害的可能性并且减少损坏您机器的危险,请执行以下操 作:

- 始终将 CD/DVD 光盘存放在它们的原始包装中
- 存放 CD/DVD 光盘时, 始终确保避免阳光直射并且远离直接热源
- 不使用时,从计算机中取出 CD/DVD 光盘
- 请勿弯曲 CD/DVD 光盘或将它们强行放入计算机或它们的包装
- 使用每张光盘前,请检查 CD/DVD 光盘是否有破裂。请勿使用破裂或损坏的光盘

产品描述

本选件包用于多媒体应用程序。驱动器随附的 CD 包含有用于以下操作系统的软件:

- Microsoft[®] Windows[®] 2000 Professional
- Microsoft Windows Millennium Edition (Me)
- Microsoft Windows XP

选件包包含以下物品:

- 用户指南和软件 CD(包含《Multi-Burner Plus 驱动器用户指南》和软件应用程序)
- IBM Multi-Burner Plus 驱动器
- 四个安装螺钉 (M3 x 5 mm, 已开槽)
- IDE 电缆
- 《IBM Multi-Burner Plus 驱动器快速入门指南》
- 《激光安全指南》

如果某一物品缺少或损坏,请与购买处联系。务必保留购货凭证;可能需要它来接受保修服务。有关技术支持 信息,请参阅第 D-1 页的附录 D,『Service and Support』。

Multi-Burner Plus 驱动器与 DVD Forum DVD-Multi Recorder 规格兼容,并且可以刻录和读取 DVD-RAM、DVD-RW 和 DVD-R(一般使用 650 nm)介质。驱动器同样可以刻录和读取 DVD+RW Alliance DVD+RW 和 DVD+R 格式。另外,该驱动器可以刻录 CD-R、CD-RW(标准、高速、超高速和超高速+)介质,并且使用缓冲区欠载保护技术来进行可靠的 CD 和 DVD 刻录。Multi-Burner Plus 驱动器可以读取许多其 它格式的介质,包括 DVD 视频、VCD、音频 CD 和多段、扩展体系结构(XA) CD 以及 Kodak Photo CD。 该 Multi-Burner Plus 驱动器设计用来安装在使用集成驱动电子设备(IDE)或增强型 IDE(EIDE)体系结构的 计算机中。

软件描述

IBM Multi-Burner Plus 驱动器用户指南和软件 CD 包含以下软件:

Intervideo WinDVD Creator

该软件使您能够将视频文件刻录到 DVD-RW、DVD-R、DVD+RW 和 DVD+R 介质,这些介质可以在大多数独立的 DVD 播放器中播放。您还可以在刻录之前使用此软件来编辑和修改自己的视频资料。同样支持 DVD-RAM 刻录。

如果在您的计算机中装有模拟或 IEEE 1394 捕获设备,则可以使用此软件来刻录照相机中的视频。

• IBM Drive Letter Access (DLA)

该软件使您能够像写入软盘一样,使用盘符来直接写入 CD 和 DVD 介质。您还可以格式化 DVD-RAM、DVD-RW、DVD-R、DVD+RW 和 DVD+R 介质。通过 DLA,您可以拖放文件、创建新目录 或将文件从几乎任何应用程序直接保存到 Multi-Burner Plus 驱动器。

• UDF Reader

该软件使您能够安装软件,以便通过 DVD 驱动器读取其它计算机上的 DVD-RAM、DVD-RW、DVD+RW 和 CD-RW 介质。

IBM RecordNow

该软件使您能够复制 CD、创建音频 CD、创建 MP3 CD 和制作数据 CD。同样可以使用 RecordNow 来将数据写入 DVD-RAM、DVD-RW、DVD-R、DVD+RW 和 DVD+R 光盘以在其它计算机或兼容的消费电子产品中使用。还可以创建可引导 CD 并且保存 CD 映像来供以后刻录。

• IBM Simple Backup

该软件使您能够在 DVD-RAM、DVD-RW、DVD-R、DVD+RW、DVD+R、CD-R 或 CD-RW 介质上创建系 统文件的完整备份或增量备份,并允许您在系统崩溃时复原计算机。

Intervideo WinDVD

该软件使您能够在计算机上回放 DVD 视频或从硬盘驱动器播放视频文件。

注: 某些图形适配器(如 FIREGL、Intergraph 和 3dLabs)不支持 DVD 视频回放。

安装要求

在安装驱动器之前,请确保计算机满足以下系统要求:

• 最低微处理器要求: Intel[®] Pentium[®] 或同等产品

对于 DVD 制作和回放, 您必须具有 Intel 奔腾 II 266MHz 微处理器或更高版本以及 AGP 2X 视频。

- 最低 RAM 要求: 32 MB (带有 UMA 的系统: 64 MB)

开始前

在安装 Multi-Burner Plus 驱动器之前,请阅读以下各部分中的信息。

操作预防措施


请采用以下操作预防措施来保护您的驱动器:

- 将 Multi-Burner Plus 驱动器保存在防静电袋中直到您准备好安装该驱动器。在安装的时候请尽量少移动;移动可能使静电积累起来。
- 小心操作驱动器。跌落或震动该驱动器可能会损坏其内部的组件。
- 请勿强行插入 IDE 电缆或电源线。这样做可能会损坏接口或驱动器。

驱动器控件和接口

驱动器前视图



1 光盘托盘

此托盘是装入和取出光盘的地方。

2 忙指示灯

当驱动器读取、写入或播放光盘时,此指示灯将亮起。


3 紧急弹出孔

4 打开 / 关闭按钮

按此按钮时可打开和关闭光盘托盘。

第2章安装

本章包含了 IBM Multi-Burner Plus 驱动器的硬件和软件的安装说明和操作信息。

安装驱动器

请完成以下步骤来安装该驱动器:

步骤 1. 打开计算机

- 1. 关闭计算机和所有连接的设备。
- 2. 从计算机和所有连接的设备上拔下所有电源线。
- 3. 从计算机上卸下外盖。有关卸下计算机外盖的说明,请参考计算机文档。


步骤 2. 除去驱动器的包装

- 在打开包装驱动器的防静电袋之前,让袋子与未上漆的金属表面接触至少两秒钟。这样可排尽包装和您身体上的静电。
- 2. 从袋子中取出驱动器。

如果必须将驱动器放下,则请将防静电袋放在垫平的表面上,再将驱动器放在防静电袋上。

步骤 3. 设置配置跳线

如图所示,通过在配置插针上安插跳线,可将您的驱动器设置为主 1、从 2 或电缆选择 3。



请使用以下准则来确定驱动器的正确配置。

- 如果驱动器是与 IDE 电缆连接的唯一设备,则请将其配置为主设备。这是预设配置。
- 如果驱动器是在 IDE 电缆上的第二个设备,则请将其配置为从设备。请务必将另一个设备配置为主设备。在 某些情况下,当同一电缆上的另一个设备配置为从设备时,硬盘驱动器可能需要"存在从设备情况下的主 设备"跳线设置。有关在其它设备上设置配置跳线的更多信息,请参考计算机随附的文档。
- 一些计算机使用特殊的 ATA 电缆,该电缆的两根电线反接在设备接口中,使得可以通过电缆而非跳线位置 来配置驱动器。请仅对配备了这些特殊电缆的计算机使用电缆选择位置。请参阅计算机随附的文档,以确 定您的 ATA 适配器是否需要将跳线置于电缆选择位置。

如果将跳线置于电缆选择位置, IDE 电缆会根据电缆上驱动器的位置自动指定主设置和从设置。无论该驱动器是与电缆连接的唯一设备还是第二个设备,您都必须对此布线系统使用电缆选择设置。最靠近 IDE 控制器的驱动器会自动成为主驱动器。IDE 电缆上的任何其它设备也须设置为电缆选择。

步骤 4. 将驱动器安装在托架中

注意


在将螺钉直接固定到驱动器中时,请务必使用选件包中的 M3 x 5 mm 安装螺钉。使用过长的螺钉可能 会损坏驱动器。

您可以将驱动器水平或垂直地安装在计算机中。如果垂直安装驱动器,则必须在关闭驱动器托盘之前固定好放 入驱动器的任何光盘,否则驱动器将无法正确读取光盘。

- 将驱动器滑入托架中。您的计算机可能需要一定的步骤来安装存储设备。有关存储设备的更多信息,请参 考计算机随附的文档。
- 2. 将驱动器托架的螺钉孔对准驱动器外壳或安装支架的螺纹孔。
- 请先不要旋紧螺钉,以检查它们的位置。通常,每一侧使用两个螺钉。验证是否已对准;然后拧紧螺钉以 固定驱动器。请勿拧得过紧。

步骤 5. 将电缆连接到驱动器

下图显示了电缆连接到驱动器的位置。



 将 40 针 IDE 电缆接口 1 连接到驱动器上的 IDE 接口。对齐电缆,将着有颜色的一侧靠近电源线接口
2 如果没有电缆连接到 IDE 端口、如果计算机 IDE 电缆上只有一个设备接口或者如果计算机中的现有 电缆是低速 40 线类型,请使用该选件随附的 80 线高速 IDE 电缆。IDE 电缆最多可有三个接口。当要在 IDE 电缆上仅连接一个设备时,为获得最佳信号质量,请将此电缆的一端连接到 IDE 端口,并将电缆的另 一端连接到设备上。请勿使用中间接口。

如果要将两个设备连接到 IDE 电缆上,请将电缆的一端连接到 IDE 端口,并将主设备和从设备连接到另 一端的其余接口。许多计算机具有两根电缆,用于连接最多四个 ATA 设备。为获得最佳性能,请将快速设 备(硬盘驱动器)连接到与主 IDE 端口相连的电缆上,再将该驱动器或其它速度较慢的设备(CD-ROM 驱 动器、磁带机和软盘驱动器)连接到与次 IDE 端口相连的电缆上。

2. 将四针电源线 2 连接到驱动器上的电源接口。

确保电缆不会受到计算机外盖的挤压,且所有其它电缆和电源连接都是安全可靠的。

步骤 6. 完成硬件安装

- 1. 确保驱动器妥善安装并且各接口已牢固连接。
- 2. 确保电缆不妨碍计算机外盖,并且未挡住电源风扇叶片或气流通路。
- 3. 重新安装计算机外盖。
- 4. 重新连接所有外接设备。

5. 将所有电源线重新连接到电源插座。

步骤 7. 安装软件

该驱动器的所有软件都包含在用户指南和软件 CD 上。用户指南和软件 CD 包含本用户指南、IBM RecordNow、IBM Simple Backup、IBM DLA、Intervideo WinDVD 和 WinDVD Creator Plus。请完成以下过程来安装软件:

- 1. 将用户指南和软件 CD 插入驱动器。如果 CD 自动启动,则请跳至步骤 6。
- 2. 如果 CD 没有自动启动,则请单击开始,然后单击运行。
- 3. 输入 e:\launch.bat, 其中 e 是 CD 或 DVD 驱动器的盘符。
- 4. 单击**确定**。
- 5. 选择语言。
- 6. 选择您要安装的软件。
- 7. 请按照屏幕上的指示信息进行操作。
- 8. 安装好该软件之后,重新启动计算机。
- 注: 为了使该驱动器完全发挥作用,请安装浏览器窗口中列出的除 UDF Reader 以外的所有软件应用程序。UDF Reader 用于不能识别 UDF 文件的其它计算机。
- 注: 快速安装将覆盖已经安装的任何版本的软件。

步骤 8. 设置系统以用于 CD 回放

为了在驱动器上播放音频 CD,必须启用数字回放。数字回放使用 IDE 数据电缆(而不是使用模拟音频电缆) 将音频数据从驱动器发送到计算机。计算机再将数字数据转换为模拟音频,虽然这样做计算机的工作速度会略 微有所降低,但通常可以换来较好的回放质量。要收听 CD 音频,有两个部分需要设置:配置驱动器和配置回 放应用程序。

配置驱动器以用于数字回放

如果您使用的是 Windows XP, 则驱动器应该自动配置为数字回放。

使用驱动器

使用可刻录介质

Multi-Burner Plus 驱动器可以在以下类型的介质上刻录:

- **DVD-RAM**:优化数据存储的多次写介质。DVD-RAM 介质可以在大多数现代 DVD-ROM 驱动器中读取, 但是不能由一些顶置 DVD 播放器来读取。
- **DVD-R**: 与顶置 DVD 播放器和计算机有最佳兼容性的一次性写介质。DVD-R 介质可以在几乎任何类型的 DVD-ROM 驱动器或 DVD 播放器中读取。

- **DVD-RW**: 可以在大多数顶置 DVD 播放器和几乎所有计算机中读取的多次写介质。一些老式的 DVD 播放器可能无法读取该介质。
- **DVD+R**: 与顶置 DVD 播放器和计算机有良好兼容性的一次性写介质。老式的 DVD 播放器和计算机 DVD-ROM 驱动器可能无法读取该介质。
- **DVD+RW**: 可以在许多顶置 DVD 播放器中读取的多次写介质。老式的计算机 DVD-ROM 驱动器和顶置播 放器可能无法读取该介质。
- CD-R: 可以在大多数 CD 和 DVD 播放器中读取的一次性写介质。
- CD-RW: 可以在许多 CD 和 DVD 播放器中读取的多次写介质。

使用单面和双面 DVD-RAM 介质

DVD-RAM 介质有单面和双面两种类型可供使用。


2.6 GB 和 4.7 GB 的类型是单面的。9.4 GB 的类型是双面的。要在介质的两面都存取数据,您必须从驱动器中取出该介质,将其翻过来,然后再重新插入驱动器中。

从盒中取出光盘

DVD-RAM 介质有裸式光盘或盒式两种形式可供使用。要在 Multi-Burner Plus 驱动器中使用盒式介质,您必须首先从盒中取出光盘。

注: 在类型 1 盒中的介质不可移动,并且不能在该驱动器中使用。所有其它的盒类型(2-9)是可移动的并且 可以在 Multi-Burner Plus 驱动器中使用。

从盒中取出光盘




使用圆珠笔的笔尖推动并折断锁销片 1。要取出光盘,请使用圆珠笔在盒盖锁 2 上向下推并将盒盖 3 拔 出。当盒盖打开时,就可以取出光盘了。

处理光盘的预防措施

当处理取出的光盘时要小心。碎屑、灰尘颗粒、指纹、涂抹或刮花可能降低介质的刻录和回放的性能。要清除 灰尘或其它碎屑,请使用 CD 清洁工具包。使用柔软的干布来清洁光盘。请勿使用溶剂来清洁光盘表面。当给 光盘标号时,只能使用软性的标签笔写在印刷的标签面上或光盘盒上。避免直接阳光照射、高温和潮湿。请勿 在光盘的任何一面贴标签。

使用 CD-R 和 CD-RW 光盘

Multi-Burner Plus 驱动器还可以写入 CD-R 和 CD-RW 光盘。CD-RW 光盘可以多次擦除并重新使用,而 CD-R 光盘只能写一次。小心地处理和清洁光盘,特别是可写的介质类型。有关怎样才能延长光盘寿命的信息,请参考第 2-10 页的『处理和保养光盘』。

注:

- 1. CD-R 光盘可在大多数音频 CD 播放机上播放。CD-RW 光盘只可在某些音频 CD 播放器上播放。
- 2. 某些消费者音频播放器将仅播放在标有特定于音频的介质上刻录的光盘。
- 3. CD-R 介质速率是按写速度分级的。要获得驱动器的最高刻录速度,需要额定值为 40x 或更高速率的介质。 要获得最佳效果,请将写速度限制为介质额定速度。在选件工具包中包含的 RecordNow 软件允许您根据需 要限制最大刻录速度。



使用 DVD 播放器软件

本部分描述了如何使用和定制 DVD 播放器软件。您可以在用户指南和软件 CD 上的自述文件中找到关于 DVD 播放器软件的当前信息。

在使用软件之前

WinDVD 需要兼容的视频设备驱动程序和 IDE 总线控制才能工作。有关启用 DMA 总线控制和找到视频设备 驱动程序的信息,请参阅第 C-1 页的附录 C,『定制设备驱动程序配置设置』。

使用 DVD 播放器

在您将 DVD 视频光盘插入驱动器后, DVD 播放器软件将自动启动并且开始播放该视频光盘。如果 DVD 光盘既包含视频内容又有程序内容,则程序内容将自动播放。

要查看视频 / 程序 DVD 光盘的视频内容,请转至开始菜单,启动 WinDVD,并单击播放。

在 Microsoft Windows XP 中, 您也可以通过使用 Windows Media Player 应用程序来播放 DVD 视频内容。

更改 DVD 区域代码

"区域化和复制保护"(DVD 区域代码)使用内容扰乱系统(CSS)标准来防止未经授权复制 DVD 上所分发的知识产权。它最初是"美国电影协会"(MPAA)请求用来保护视频私有权,但是现在适用于任何内容。 CSS 通过禁止没有正确授权的未加密的数据传送来发挥作用。回放系统必须发放许可证给 CSS 来解码加密的数据。

CSS 规范将全球分为七个独立的区域。对一个区域指定的内容无法在另一个区域通过回放系统来读取。在使用 CSS 来防止 DVD 内容的数字复制的同时,另一项由 Macrovision 设计的技术则用来防止 DVD 内容的模拟 复制。Macrovision 标准是一种扰乱系统,电影业界广泛地使用它来防止未经授权使用商业 VCR 复制视频内容。 DVD 回放系统必须同时支持 CSS 和 Macrovision 复制保护标准。

您首次将一张 DVD 视频光盘插入驱动器时,将会提示设置区域。如果重新定位到世界的另一个区域,则您可 以使用 DVD 播放器软件来更改区域代码。

注: 您只能更改 DVD 区域代码五次。在做了五次区域代码更改后,该驱动器只能播放与您所设置的第五个区 域代码关联的 MPEG-2 视频字幕。

要更改区域代码,请执行以下操作:

- 1. 开启计算机并启动操作系统。
- 2. 单击开始。
- 3. 选择**程序**。
- 4. 单击 Intervideo WinDVD。
- 5. 单击 Intervideo WinDVD。
- 6. 单击属性图标打开"属性"窗口。

- 8. 插入一张新区域的单区域 DVD。
- 9. 选择您所在国家或地区的正确的区域代码。
- 10. 单击确定。

使用 Drive Letter Access (DLA)

提供的 Drive Letter Access (DLA) 使您可以将数据写入 DVD-RAM、DVD-RW、DVD-R、DVD+RW、DVD+R、CD-R 和 CD-RW 介质。 DVD-RAM、DVD-RW、DVD+RW 和 CD-RW 介质可以写入多次, 而 DVD-R、DVD+R 和 CD-R 介质只能 进行一次格式化和写入。

要格式化并且写入 DVD-RAM、DVD-RW、DVD-R、DVD+RW、DVD+R、CD-R 或 CD-RW 介质,请:

- 1. 将光盘插入驱动器。
- 2. 双击我的电脑。右键单击 Multi-Burner Plus 驱动器的盘符。
- 3. 单击格式化。格式化一张 DVD 可能最多花费 90 分钟。
- 4. 格式化完成后,您可以将文件拖放到 Multi-Burner Plus 驱动器图标,或可以在"Windows 资源管理器"中 移动文件。

使 CD-R 和 DVD-R 介质在其它计算机中兼容:

- 1. 双击我的电脑。右键单击 Multi-Burner Plus 驱动器的盘符。
- 2. 单击使兼容。

要在其它计算机中使用 UDF 格式的 DVD-RAM、DVD-RW、DVD+RW 或 CD-RW 介质,则可以使用用户指 南和软件 CD 中包含的 UDF Reader。要使用 UDF Reader,请按照此过程进行操作:

- 1. 将用户指南和软件 CD 插入您要在其中使用 UDF 格式光盘的计算机的 CD 或 DVD 驱动器。
- 2. 单击**开始**。
- 3. 单击运行。
- 4. 输入 e:\UDF\1anguage, 其中 e 是该 CD 或 DVD 驱动器的盘符, 而 language 是您的语言。
- 5. 单击确定。
- 6. 双击 SETUP.EXE 并按照屏幕上的指示信息操作。
- 注:
- 1. 只有那些没有再安装一个 DLA 程序的系统需要 UDF Reader。
- 2. 如果没有在 Windows XP 中选择"和 DLA 一起使用"菜单项,则将使用 Windows XP CD 刻录。

使用 RecordNow

RecordNow 允许您刻录 DVD、音频 CD、数据 CD 并且复制现有光盘。它还允许您将映像保存到硬盘驱动器 并且从先前创建的映像烧录光盘。有关使用 RecordNow 的详细信息包含在 RecordNow 帮助中。可以通过按 RecordNow 菜单中的 F1 来访问 RecordNow 帮助。

要启动 Windows Me 或 Windows 2000 中的 RecordNow, 请选择开始 → 程序 → IBM RecordNow。

RecordNow 项目

- 一旦 RecordNow 启动, 就可以选择具有不同功能的三个选项卡。
- Audio Project 选项卡允许您创建音频 CD、MP3 Jukebox 磁盘或者收听音频 CD 或制作 CD 标签。
- Data Project 选项卡允许您制作数据光盘、制作精确副本、擦除可重写光盘或制作 CD 或 DVD 标签。
- Backup Project 菜单允许您对文件进行归档、制作精确副本、保存 CD 或 DVD 的映像、将保存的映像烧录 到磁盘或制作磁盘标签。

对于所有可附加的 CD 和 DVD 项目,在选中某个项目后,RecordNow 将从驱动器中的 CD 或 DVD 上的任何数据。

制作可引导 CD 或 DVD

要制作可引导 CD 或 DVD,请打开数据项目并且按项目窗口右上角的可引导 CD 按钮。将提示您从硬盘选择 引导映像或从软盘制作引导映像。

关于 CD 和 DVD 映像

RecordNow 可以保存和创建 ISO 和 GI 类型的 CD 映像。ISO 映像只能用于保存只有一个数据会话的数据 CD。必须使用 GI 格式保存音频 CD、DVD、多会话 CD 和混合类型的 CD。

使用 Intervideo WinDVD Creator

通过 Intervideo WinDVD Creator,可以捕获、编辑和刻录视频和音频文件。还可以通过 Intervideo WinDVD Creator 来将自己的视频和音频文件创建和刻录成 DVD 视频。有关 Intervideo WinDVD Creator 功能的更多 详细信息,请参考用户指南和软件 CD 上的联机 WinDVD Creator Plus 用户指南。

在 WinDVD Creator 主窗口中的主功能区域是 **Capture、Edit、Author** 和 **Make Movie**。您可以从这些功能导入并编辑自己的视频和音频文件;然后将它们保存为以下任一受支持的格式: MPEG-1、MPEG-2、ASF、WMV 和 AVI。

当您已经准备好您的视频和音频文件后,通过执行 Capture 和 Edit 的步骤,然后可以从 Author 功能中添加定制的菜单。您可以导入自己的静态图像或选择样本图像中的一个作为菜单背景。当电影就绪后,转到 Make Movie,该处可以选择用于创建电影的输出格式和视频标准。将您的电影写入光盘或将它保存到硬盘驱动器以便以后写入。如果使用 WinDVD Creator Plus 在硬盘驱动器上创建 DVD 映像,则可以从 Project 菜单选择 Load Image to Burn。

WinDVD Creator 同样提供使用 **Disk Manager** 而不需要使用硬盘驱动器上的任何附加空间来将视频直接刻录 到可刻录 DVD 介质的能力。通过 Disk Manager,可以捕获新的视频或使用已有的视频文件,然后通过创建定 制菜单完成电影。可以 +VR 或 -VR 视频格式创建电影。通过 Disk Manager,可以在任何时候编辑电影(添 加或删除视频片段或更改定制菜单)。

注: 对于老式的顶置 DVD 播放器, +/-VR 格式化磁盘具有有限的兼容性。



计算机问题可能是由硬件、软件或人为错误引起的。使用本部分中的信息,您也许可以自己解决问题或收集有 用的信息以发送给服务技术人员。您也可能需要参考该计算机、操作系统或声卡的文档。

请查看以下列表,以获取可能适合您所遇到的情况的任何问题描述。

• 您的计算机或驱动器没有正确运行,或忙指示灯没有亮起。

采取以下操作:

- 1. 检查在驱动器中的光盘是否标签朝上。
- 2. 检查所有的设备是否正确连接到计算机和电源插座。
- 3. 关闭计算机,拔下计算机和所有连接设备的电缆,并卸下计算机外盖。
- 检查所有电源线和 IDE 电缆是否连接牢固。断开 IDE 电缆连接并检查其是否弯曲或插针未对齐。如果 没有发现任何问题,则请重新连接该电缆。
- 将计算机外盖装回原处,并重新连接所有电缆和电源线。开启计算机,重新启动操作系统,再按打开/ 关闭按钮。如果托盘未能打开并且忙指示灯没有亮起,则请关闭计算机并尝试使用另一个 4 芯直流电源 线。
- 6. 检查该 IDE 电缆上有颜色标记的一端是否对准了 IDE 端口上的插针 1,并且最靠近该驱动器上的电源 线。请参阅第 2-2 页的『步骤 5. 将电缆连接到驱动器』。
- 7. 检查该 IDE 电缆上的此驱动器和任何其它设备的设置是否正确。请参阅第 2-1 页的『步骤 3. 设置配置 跳线』。
- 8. 请执行以下操作:

如果该设备图标仍然没有出现,则请检查电缆连接和设备跳线设置,并解决任何可能存在的冲突。

• 操作系统没有识别该驱动器, 或该驱动器性能不稳定。

- 1. 在创建特殊的 CONFIG.SYS 和 AUTOEXEC.BAT 文件之前,请在方便的目录中建立这些文件的备份副本。在 DOS 提示符下,请执行以下操作:



附录 E. IBM Statement of Limited Warranty - Z125-4753-0804/2004

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms, Part 2 - Country-unique Terms, and Part 3 - Warranty Information. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. Unless IBM specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- · failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems

When you contact IBM for service, you must follow the problem determination and resolution procedures that IBM specifies. An initial diagnosis of your problem can be made either by a technician over the telephone or electronically by access to an IBM website.

The type of warranty service applicable to your Machine is specified in Part 3 - Warranty Information.

You are responsible for downloading and installing designated Machine Code (microcode, basic input/output system code (called "BIOS"), utility programs, device drivers, and diagnostics delivered with an IBM Machine) and other software updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

If your problem can be resolved with a Customer Replaceable Unit ("CRU") (e.g., keyboard, mouse, speaker, memory, hard disk drive), IBM will ship the CRU to you for you to install.

If the Machine does not function as warranted during the warranty period and your problem cannot be resolved over the telephone or electronically, through your application of Machine Code or software updates, or with a CRU, IBM or your reseller, if approved by IBM to provide warranty service, will either, at its discretion, 1) repair it to make it function as warranted, or 2) replace it with one that is at least functionally equivalent. If IBM is unable to do either, you may return the Machine to your place of purchase and your money will be refunded.

IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Exchange of a Machine or Part

When the warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

Your Additional Responsibilities

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to:

- 1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;
- 2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and

4. Limitation of Liability

IBM is responsible for loss of, or damage to, your Machine only while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller are responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM for any reason. You should remove all such information from the Machine prior to its return.

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

Governing Law


