# Chapter 1. Introducing the IBM BladeCenter Management Module

This  $\mathit{IBM}^{\circledR}$   $\mathit{BladeCenter}^{\circledR}$   $\mathit{Management Module Installation Guide}$  contains information about:

- Installing your management module
- · Configuring your management module

**Note:** The illustrations in this document might differ slightly from your hardware.

For installation details, see Chapter 2, "Installing and removing a management module," on page 7. For additional information, see the instructions in your BladeCenter documents.

Your management module is one of two management modules that can be installed in the IBM @server BladeCenter Type 8677 enclosure.

**Note:** Only one management module can be active; the second management module, if present, provides redundancy.

You can obtain up-to-date information about your management module and other IBM server products at http://www.ibm.com/eserver/xseries/

Record information about the management module in the following table.

The product name, machine type and serial number are located on the identification label on the side of the BladeCenter Management Module. You will need this information when you register your BladeCenter Management Module with IBM. The media access control (MAC) address also is located on the identification label. See "Overview of the management module" on page 5 for an illustration that shows the location of the identification label.

**Note:** The MAC address is also located on a separate label on the bottom front of the management module.

The management module functions as a service processor and a keyboard/video/mouse (KVM) multiplexor for the multiple blade servers in a BladeCenter unit. You configure the BladeCenter unit and modules through the management module, configuring information such as the management module and I/O module IP addresses. The management module provides the following external connections: keyboard, mouse, and video for use by a local console, and one RJ-45 connector for a 10/100 Mbps Ethernet remote management connection.

The service processor in the management module communicates with the service processor in each blade server for functions such as:

- · Blade server power-on requests
- · Blade server error and event reporting
- · Blade server requests for keyboard, mouse, and video
- Blade server requests for diskette drive, CD-ROM drive, and USB port

The management module also communicates with the I/O modules, power modules, blower modules, and blade servers in the BladeCenter unit to detect their presence or absence and any error conditions, sending alerts when required.

# Related documentation

This *Installation Guide* contains setup and installation instructions for the IBM BladeCenter Management Module. This document also provides general information about your management module, including information about getting started, first-time connection to the management module, how to configure your management module, and how to get help.



The following illustration shows the management module.



# Chapter 2. Installing and removing a management module

The following illustration shows the management-module bay locations.



**Attention:** To maintain proper system cooling, each module bay must contain either a module or a filler module; each blade bay must contain either a blade or a filler blade.

# Installation guidelines

Before you begin to install the management module in your BladeCenter unit, read the following information:

- Become familiar with the safety and handling guidelines specified under "Safety" on page v and "Handling static-sensitive devices" on page 8, and read the safety statements in the BladeCenter unit option publications.
- The orange color on components and labels in your BladeCenter unit identifies hot-swap components. You can install or remove hot-swap modules and, with some restrictions, hot-swap blade servers while the BladeCenter unit is running. For complete details about installing or removing a management module, see the detailed information in this chapter.
- The blue color on components and labels identifies touch points where you can grip a component, move a latch, and so on. You do not have to disconnect the BladeCenter unit from power to install or replace any of the hot-swap modules on the rear of the BladeCenter unit. Shut down the operating system and turn off a hot-swap blade server on the front of the BladeCenter unit before removing the blade server, but you do not have to shut down the BladeCenter unit itself.

# System reliability considerations

**Attention:** To help ensure proper BladeCenter cooling and system reliability, make sure that:

- Each of the module bays on the rear of the BladeCenter unit has either a module or filler module installed.
- Each of the blade bays on the front of the BladeCenter unit has either a blade server or filler blade installed.
- Each of the drive bays in a blade server storage expansion option has either a hot-swap drive or a filler panel installed.
- A removed hot-swap module, blade server, or drive is replaced within 1 minute of removal.
- Cables for the option modules are routed according to the illustrations and instructions in this document.
- A failed blower is replaced as soon as possible, to restore cooling redundancy.

Failure to replace a blade server or module with another blade server, module, filler blade or filler module within one minute can affect system performance in the blade servers.

# Handling static-sensitive devices

**Attention:** Static electricity can damage electronic devices and your BladeCenter unit. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an
  unpainted metal part of the BladeCenter chassis or any unpainted surface on
  any other grounded rack component for at least two seconds. (This drains
  static electricity from the package and from your body.).
- Remove the device from its package and install it directly into your BladeCenter unit without setting it down. If it is necessary to set down the

- device, put it back into its static-protective package. Do not place the device on your BladeCenter chassis or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

# Preparing for management module redundancy

Management module redundancy requires specific minimum levels of firmware. If you intend to install a second management module in the BladeCenter unit, make sure that you have downloaded and applied the latest level of firmware from the IBM Support Web site.

Complete the following steps to prepare your management modules for redundancy:

- 1. Go to the IBM Support Web site at http://www.ibm.com/pc/support/ to check for technical information, hints, tips, and the latest firmware.
- 2. Download the latest management module firmware and use the management module Web interface to apply it to your current management module (see "Using the management and configuration program" on page 25 for instructions about logging in to the Web interface).
  - a. In the MM Control section in the navigation pane, click **Firmware Update**.
  - b. Click **Browse** to locate the firmware file you downloaded; then, click **Update**. Follow the instructions on the screen.
- 3. Install the second management module in the available management-module bay (see "Installing a management module" on page 10 for instructions).
- 4. Wait up to 10 minutes while the primary management module transfers firmware and configuration information to the second management module.

The management modules are now prepared for redundancy.

#### Notes:

- 1. Whenever power is restored to a BladeCenter unit that has two functional management modules installed, the management module in bay 1 is automatically the active management module, even if the module in bay 2 was the active module before power was removed.





Complete the following steps to install a management module.

- Read the safety information beginning on page v and "Installation guidelines" on page 7 through "Handling static-sensitive devices" on page 8
- 2. If you are installing a second management module, read "Preparing for management module redundancy" on page 9.
- 3. Remove the acoustic attenuation module, if one is installed, from the rear of the BladeCenter unit.



**Note:** If you are replacing the only management module in the BladeCenter unit, and the management module is functional, you might want to save the configuration file to another medium before you proceed; you will be able to apply the saved configuration file to the replacement management module. See "Restoring a saved configuration file" on page 28 for information about applying a saved configuration file.

- 4. If you are replacing a management module, remove the current module from the bay (see "Removing a management module" on page 14). If you are adding a management module, remove the filler module from the selected management module bay and store the filler module for future use.
- 5. If you have not already done so, touch the static-protective package that contains the management module to an unpainted metal part of the BladeCenter unit or any unpainted surface on any other grounded rack component for at least 2 seconds.

- 6. Remove the management module from its static-protective package.
- 7. Ensure that the release latch on the management module is in the open position (perpendicular to the module).
- 8. Slide the management module into the selected management-module bay until it stops.
- Push the release latch on the front of the management module to the closed position.
- 10. Make sure that the OK LED on each management module is lit, indicating that the management modules are operating correctly.
- 11. Connect the necessary cables to the management module. See "Cabling the management modules" on page 15 for more information.
- 12. Replace the acoustic attenuation module, if you removed it in step 3 on page 12.
- 13. If this is the only management module in the BladeCenter unit, configure the new management module. See Chapter 4, "Configuring the management module," on page 21 for more information. If this is the secondary management module, and you followed the instructions in "Preparing for management module redundancy" on page 9, no configuring is necessary. The secondary management module receives the configuration and status information automatically from the primary management module when necessary. However, if you have not already done so, you must apply the latest level firmware from the IBM Support Web site to the primary management module to ensure smooth changeovers; return to "Preparing for management module redundancy" on page 9 for instructions.

Note: Do not initiate any management module changeover for up to 10 minutes after installing the secondary management module; the secondary management module needs the time to receive firmware and initial status information from the primary management module.

# Removing a management module

#### Statement 8:





#### **CAUTION:**

Never remove the cover on a power supply or any part that has the following label attached.



Hazardous voltage, current, and energy levels are present inside any component that has this label attached. There are no serviceable parts inside these components. If you suspect a problem with one of these parts, contact a service technician.


Complete the following steps to remove a management module.

#### Note:

- These instructions assume the BladeCenter unit is connected to power.
- If you are removing the only management module in the BladeCenter unit, you might prefer to stop all management-module local and remote sessions before proceeding, to avoid unexpected termination of sessions.
- If you are replacing the only management module in the BladeCenter unit, and the management module is functional, you might want to save the configuration file to another medium before you proceed (under the MM Control section in the navigation pane, click Configuration File and follow the instructions under Save MM Configuration); you will be able to restore the saved configuration file to the replacement management module. See "Restoring a saved configuration file" on page 28 for more information about applying a saved configuration file.
- If you have just installed a second management module in the BladeCenter unit, do not remove the first (primary) management module for up to 10 minutes; the second (secondary) management

module needs the time to receive initial status information and firmware levels from the primary management module.

- Read the safety information beginning on page v and "Installation guidelines" on page 7 through "Handling static-sensitive devices" on page 8.
- 2. Remove the acoustic attenuation module, if installed, from the rear of the BladeCenter unit (see step 3 on page 12 for location).
- 3. Disconnect any cables from the selected management module.
- 4. Pull the release latch all the way toward the bottom of the management module until it stops, as shown in the illustration. The module moves out of the bay approximately 0.6 cm (0.25 inch).



- 5. Slide the module out of the bay and set it aside. Within 1 minute, place either another module of the same type or a filler module in the bay.
- 6. If you placed another management module in the bay, reconnect any cables that you disconnected in step 3; then, verify that the OK LED on the management module is lit.
- 7. If you have not already done so, configure the replacement management module. See Chapter 4, "Configuring the management module," on page 21 for more information.
- 8. Replace the acoustic attenuation module option, if you removed it in step 2.

# Cabling the management modules

When two management modules are installed in an IBM BladeCenter unit, only one management module is active; the second management module, if present, provides redundancy. The active management module is the primary module; the redundant management module is the secondary module. If the

primary management module fails, or if you request a changeover through the Web interface, the secondary management module becomes active and primary.

Given this information, decide how you want the keyboard, video, and mouse at the BladeCenter unit to be handled when changeover occurs, and cable the management modules accordingly.

Complete the following steps to cable the management modules in an IBM BladeCenter unit:


- Connect the Ethernet port on each management module to your Ethernet network. When changeover occurs between the management modules, you will be able to communicate with the new primary management module without additional intervention, such as switching a single Ethernet cable between the management modules.
- 2. To be able to use the local keyboard, video, and mouse after changeover occurs, connect these devices to the management modules in one of the following ways (see "Management module input/output connectors" on page 18 for the location of each connector):
  - Use an external keyboard, video, and mouse (KVM) switch. Cable the keyboard, video, and mouse connectors on both management modules to the KVM switch, and connect the KVM switch to the local keyboard, monitor, and mouse. When changeover occurs, the new primary management module automatically controls the local keyboard, monitor, and mouse.
  - Cable only to the active management module. When management module changeover occurs, you can move the keyboard, monitor, and mouse cables to the new active management module.
  - Use a duplicate keyboard, monitor, and mouse for the second management module. With a second keyboard, monitor, and mouse always connected to the second management module, no switching or recabling is required when changeover occurs.

If you always use a remote session to communicate with the blade servers in the BladeCenter unit, you do not need to connect a local keyboard, monitor, and mouse to either management module.

# Chapter 3. Management module LEDs and external ports

This chapter describes the LEDs and controls on the IBM BladeCenter Management Module. This chapter also identifies the external ports on the management module.

# Management module controls and indicators



Management module LEDs: These LEDs provide status information about the management module and remote management connection. For additional information, see the "Light Path Diagnostics" section in the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *BladeCenter Documentation* CD.

- **Power-on:** When this green LED is lit, it indicates that the management module has power.
- Active: When this green LED is lit, it indicates that the management module is actively controlling the BladeCenter unit.

**Note:** Only one management module actively controls the BladeCenter unit. If there are two management modules installed in the BladeCenter unit, this LED is lit on only one.

- Management-module error: When this amber LED is lit, it indicates that an error has been detected somewhere on the management module. When this LED is lit, the system error LED on each of the BladeCenter system LED panels is also lit.
- Ethernet link: When this green LED is lit, there is an active connection through the port to the network.
- Ethernet activity: When this green LED is flashing, it indicates that there is activity through the port over the network link.

Management module IP reset button: Do not press this button unless you intend to erase your configured IP addresses for the management module and lose connection with the remote management station, the I/O modules, and the blade servers. If you press this button, you will need to reconfigure the management module settings (see the information beginning with "Setting up the remote connection" on page 23 for instructions).

Press this recessed button to reset the IP configuration of the management module network interfaces (Ethernet 1, Ethernet 2, gateway address, and so on) to the factory defaults and then restart the management module.


Use a straightened paper clip to press the button.

# Management module input/output connectors

The management module has the following I/O connectors:

- · One video
- One PS/2® keyboard
- One PS/2 mouse
- One 10/100 Mbps Ethernet for remote console and management

The following illustration shows the I/O connectors on the management module.



# Video connector

Your BladeCenter management module contains one standard video connector. The integrated video controller on each blade server is compatible with SVGA and VGA and communicates through this video port.

Use this connector to connect a video monitor to the BladeCenter unit.



# **Keyboard connector**

Your BladeCenter management module contains one PS/2-style keyboard connector.

Use this connector to connect a PS/2 keyboard to the BladeCenter unit.



# Mouse connector

Your BladeCenter management module contains one PS/2-style mouse connector.

Use this connector to connect a PS/2 mouse to the BladeCenter unit.




# Remote management and console Ethernet connector

Your BladeCenter management module contains one 10/100 Mb Ethernet connector that provides the remote connection to the network management station on the network.

Use this port for remote management and remote console.

The network management station, through this port, can access control functions running in the service processor on each blade server or within each I/O module. However, it cannot use this port to communicate with application programs running in the blade servers. The network management station must direct those communications through a network connected to the external ports in the I/O modules in the BladeCenter unit.

The following illustration shows the Ethernet connector that is on the management module.



# Chapter 4. Configuring the management module

# **Important**

If the management module that you installed is the secondary management module in the BladeCenter unit, you do not configure it. The secondary management module receives the configuration and status information automatically from the primary (active) management module when necessary. The information in this chapter about configuring a management module applies to the primary or only management module in the BladeCenter unit.

If the management module that you installed is a replacement for the only management module in the BladeCenter unit, and you saved the configuration file before replacing the management module, you can apply the saved configuration file to the replacement management module using the management module Web interface. See "Restoring a saved configuration file" on page 28 for information about applying a saved configuration file.

When the BladeCenter unit is started initially, it automatically configures the remote management port on the active (primary) management module, so that you can configure and manage the BladeCenter unit and blade servers. You configure and manage the BladeCenter unit remotely, through the active management module, using the Web-based user interface.

If the management module that you installed is a replacement for the only management module in the BladeCenter unit, and you saved the configuration file before replacing the management module, you can restore the saved configuration file to the replacement management module using the management module Web interface.

For the active management module to communicate with the I/O modules in the BladeCenter unit, you will need to configure the IP addresses for the following internal and external ports:

- The external Ethernet (remote management) port on the management module (see "Configuring the ports" on page 26 for details). The initial management module autoconfiguration enables the network management station to connect to the management module to configure the port completely and to configure the rest of the BladeCenter unit.
- The internal Ethernet port on the management module for communication with the Ethernet I/O modules (see "Configuring the ports" on page 26 for details).

 The management port on each I/O module, for communication between the management module and the I/O module. You configure this port by configuring the IP address for the I/O module (see "Configuring the ports" on page 26 for details).

**Note:** Some types of I/O modules, such as a pass-thru module, have no management port.

To communicate with the blade servers for functions such as deploying an operating system or application program, you also will need to configure at least one external (in-band) port on an Ethernet I/O module. See the *IBM* @server *BladeCenter Type 8677 Installation and User's Guide* for information about configuring external ports on Ethernet I/O modules.

The management module supports the following Web browsers for remote access. The Web browser that you use must be Java-enabled, must support JavaScript 1.2 or later, and must have the Java 1.4 Plug-In installed.

- Microsoft® Internet Explorer 4.0 (with Service Pack 1), or later
- Netscape Navigator 4.72, or later (version 6.0 is not supported)

#### Notes:

- 1. For best results when using the Web browser, set the resolution on your monitor to 800 x 600 pixels or higher and 256 colors.
- 2. The Web interface does not support the double-byte character set (DBCS) languages.

The Web-based user interface communicates with the management and configuration program that is part of the firmware that comes with the management module. You can use this program to perform tasks such as:

- Defining the login IDs and passwords
- Selecting recipients for alert notification of specific events
- Monitoring the status of the BladeCenter unit and blade servers
- Controlling the BladeCenter unit and blade servers
- Accessing the I/O modules to configure them
- · Changing the drive startup sequence in a blade server
- Setting the date and time
- Using a remote console for the blade servers
- · Changing ownership of the keyboard, video, and mouse
- Changing ownership of the CD-ROM drive, diskette drive, and USB port

**Note:** The IBM Director program is a system-management product that comes with the BladeCenter unit. To configure the remote alert recipients for IBM Director over LAN, the remote alert recipient must be an IBM Director-enabled server.

You also can use the management and configuration program to view some of the blade server configuration settings. See "Using the management and configuration program" on page 25 for more information.


## Setting up the remote connection

To configure and manage the BladeCenter unit and blade servers, you must first set up the remote connection through the Ethernet port on the management module.

## Cabling the Ethernet port

Complete the following steps to connect the Ethernet cable to the management module:

- Connect one end of a Category 5 or higher Ethernet cable to the Ethernet port on the management module. Connect the other end of the Ethernet cable to the network.
- 2. Check the Ethernet LEDs to ensure that the network connection is working. The following illustration shows the locations of the Ethernet LEDs.



#### Ethernet link LED

When this green LED is lit, there is an active connection through the port to the network.

#### Ethernet activity LED

When this green LED is flashing, it indicates that there is activity through the port over the network link.

## Configuring the management module for remote access


After you connect the management module to the network, the Ethernet port connection is configured in one of the following ways:

- If you have an accessible, active, and configured dynamic host configuration protocol (DHCP) server on the network, the host name, IP address, gateway address, subnet mask, and DNS server IP address are set automatically.
- If the DHCP server does not respond within 2 minutes after the port is connected, the management module uses the static IP address and subnet address.

Either of these actions enables the Ethernet connection.

Make sure your computer is on the same subnet as the management module, and use your Web browser to connect to the management module (see "Starting the management and configuration program" on page 25 for more information). In the browser **Address** field, specify the IP address the management module is using:

- If the IP address was assigned through a DHCP server, get the IP address
  from your network administrator. The network administrator can use the
  MAC address of the management module network interface to find out what
  IP address and host name are assigned.
- The factory-defined static IP address is 192.168.70.125, the default subnet address is 255.255.255.0, and the default host name is MMxxxxxxxxxxxx, where xxxxxxxxxxx is the burned-in medium access control (MAC) address. The MAC address is on a label on the management module, below the IP reset button.



If you do not want to keep the factory-defined static values, you can configure the static IP address, host name, and subnet mask for the management module through the Web interface.

## Using the management and configuration program

This section provides instructions for using the management and configuration program in the active management module.

## Starting the management and configuration program

Complete the following steps to start the management and configuration program:


- Open a Web browser. In the address or URL field, type the IP address or host name defined for the management module remote connection (see "Configuring the management module for remote access" on page 24 for more details).
  - The Enter Network Password window opens.
- 2. Type your user name and password. If you are logging in to the management module for the first time, you can obtain your user name and password from your system administrator. All login attempts are documented in the event log.

**Note:** The initial user ID and password for the management module are:

- User ID: USERID (all capital letters)
- Password: PASSW0RD (note the zero, not O, in PASSW0RD)

3. Follow the instructions that appear on the screen. Be sure to set the timeout value you want for your Web session.

The BladeCenter management and configuration window opens.



The navigation pane (on the left side of the management module window) contains navigational links that you use to manage your BladeCenter unit and check the status of the components (modules and blade servers).

## Configuring the ports

Complete the following steps to configure the management module internal and external ports:

- 1. Under MM Control in the navigation pane, click Network Interfaces.
- 2. Configure the two Ethernet interfaces: external (remote management and console), and internal (communication with the I/O modules).

**Note:** For I/O module communication with a remote management station, such as the IBM Director server, through the management module external Ethernet port, the I/O module internal network interface and the management module internal and external interfaces must be on the same subnet.

- External Network Interface (eth0) This is the interface for the remote management and console port.
  - Interface Select Enabled (the default) to use the Ethernet connection.

- DHCP Select one of the following choices:
  - DHCP with rollover to static (this is the default).
  - DHCP only
  - Static only
- Hostname (Optional) This is the IP host name you want to use for the management module (maximum of 63 characters).
- Static IP configuration You need to configure this information only if DHCP is disabled.
  - IP address The IP address for the management module. The IP address must contain four integers from 0 to 255, separated by periods, with no spaces or consecutive periods. The default setting is 192.168.70.125.
  - Subnet mask The subnet mask must contain four integers from 0 to 255, separated by periods, with no spaces. The default setting is 255,255,255.0
  - **Gateway address** The IP address for your network gateway router. The gateway address must contain four integers from 0 to 255, separated by periods, with no spaces.
- Internal Network Interface (eth1) This interface communicates with the I/O module.
  - Specify the IP address to use for this interface. The subnet mask must be the same as the subnet mask in the external network interface (eth0).
  - View the data rate, duplex mode, maximum transmission unit (MTU), locally-administered MAC address, and burned-in MAC address for this interface. You can configure the locally-administered MAC address; the other fields are read-only.
- 3. Configure the internal Ethernet management port on each I/O module in the BladeCenter unit.

**Note:** Some types of I/O modules, such as a pass-thru mocule, have no management port.

- a. Under I/O Module Tasks in the navigation pane, click Management.
- b. Click Bay 1.
- c. In the **New Static IP address** fields, specify the IP address to use for this interface. The subnet mask must be the same as the subnet maks in the internal network interface (eth1).
- d. Click Advanced Management → Advanced Setup and enable the following items:
  - I/O module external ports
  - External management for the external ports

**Note:** The initial user ID and password for the I/O module firmware are:

- User ID: USERID (all capital letters)
- Password: PASSW0RD (note the zero, not O, in PASSW0RD)
- e. Specify the IP configuration of the I/O module.

Repeat step 3 for each I/O module in the BladeCenter unit.

To communicate with the blade servers for functions such as deploying an operating system or application program, you also will need to configure at least one external (in-band) port on an Ethernet I/O module. See the *IBM* @server *BladeCenter Type 8677 Installation and User's Guide* for information about configuring external ports on Ethernet I/O modules.

See the *BladeCenter Management Module User's Guide* for more information about the management-module Web interface.

## Restoring a saved configuration file

If you have a saved configuration file, you can apply it to the primary or only management module.

- 1. After the primary or only management module has been installed, follow the instructions in "Setting up the remote connection" on page 23 through "Configuring the management module for remote access" on page 24.
- 2. Follow the instructions in "Starting the management and configuration program" on page 25.
- 3. In the MM Control section in the navigation pane, click **Configuration File** and follow the instructions under **Restore MM Configuration** to apply the saved configuration file.

If a second management module is installed in the BladeCenter unit (see "Preparing for management module redundancy" on page 9 for more information), the new configuration information will be transferred to the secondary management module automatically.

## **Appendix B. Warranty information**

This section contains information about your warranty period and the service and support that are provided by your warranty.

## Warranty period

The warranty period varies by machine type and country or region.

Contact your place of purchase for warranty service information. Some IBM Machines are eligible for on-site warranty service depending on the country or region where service is performed.

Prior to on-site warranty service, you are required to go through problem determination with an IBM service specialist call center technician.

This paragraph applies only to products with a warranty period of 3 years on parts and 1 year on labor. A warranty period of 3 years on parts and 1 year on labor means that IBM will provide warranty service without charge for:

- 1. parts and labor during the first year of the warranty period
- 2. parts only, on an exchange basis, in the second and third years of the warranty period. IBM will charge you for any labor it provides in performance of the repair or replacement.

#### **Problem determination**

Prior to on-site warranty service, you are required to go through problem determination with an IBM service specialist call center technician. The service specialist will run diagnostic tests on the hardware and check the software.

### **Running diagnostics**

The IBM service specialist will help you determine whether your equipment is functioning as specified. It might be necessary to isolate the failing IBM system; IBM component; or both from any active production environment to run diagnostics and perform defect-isolation programs. You are responsible for making the system, IBM component, or both available for running diagnostics and defect-isolation programs.

### Checking software

The IBM service specialist will help you ensure that the correct BIOS code, firmware, device drivers, and other supporting IBM software are installed and correctly configured. It might be necessary to manually gather information about the relevant software levels or run IBM-approved utility programs to gather this information. It might be necessary to isolate the failing system from any active production environment to gather this information. You are responsible, with assistance from the service specialist, for gathering this information. The IBM Statement of Limited Warranty does not include on-site assistance with this activity.

## Warranty service and support

With the original purchase of an IBM system, you have access to extensive service and support. During the IBM Machine warranty period, you may call IBM or your reseller for problem-determination assistance under the terms of the IBM Statement of Limited Warranty.

The following services are available during the warranty period:

- **Problem determination** Trained personnel are available to assist you with determining if you have a hardware problem and deciding what action is necessary to fix the problem.
- **IBM hardware repair** If the problem is determined to be caused by IBM hardware under warranty, trained service personnel are available to provide the applicable level of service, either on-site or at an IBM service center as determined by IBM.
- Engineering Change management Occasionally, there might be changes that are required after a product has been shipped from IBM. In those instances, IBM will make Engineering Changes (ECs) available that apply to your hardware.
- Customer replaceable units (CRUs) Some parts of IBM systems are
  designated as customer replaceable units. IBM ships CRUs to you for
  replacement by you. CRUs include keyboards, monitors, memory, diskette
  drives, hard disk drives, and mice (this list is not inclusive of all CRUs).

The following items are not covered under warranty service:

 Replacement or use of non-IBM parts. All IBM parts contain a 7-character identification in the format IBM FRU XXXXXXX.

- Identification of software problem sources.
- Installation of customer replaceable units (CRUs).
- Installation and configuration of BIOS code, firmware, or device drivers that are designated as customer installable.

See the IBM Statement of Limited Warranty for a full explanation of IBM warranty terms. Be sure to retain your proof of purchase to obtain warranty service.

Please have the following information ready when you call:

- The machine type and model of your IBM hardware product (if available)
- Serial numbers of your IBM hardware products
- A description of the problem
- · The exact wording of any error messages
- · Hardware and software configuration information

## **International Warranty Service**

If you travel with your IBM system or relocate it to a country or region where your system is sold and serviced by IBM or IBM resellers authorized to perform warranty service, International Warranty Service (IWS) is available during the warranty period. Eligible IBM systems are identified by their four-digit machine types.

You can obtain IWS through the service delivery method (such as depot, carry-in, or on-site) provided in the servicing country or region. Service methods and procedures vary by country or region, and some service or parts might not be available in all countries and regions. Service centers in certain countries or regions might not be able to service all models of a particular machine type. In addition, some countries or regions might have fees and restrictions that apply at the time of service.

To determine whether your system is eligible for IWS, go to http://www.ibm.com/pc/support/ and click **Warranty lookup**.

# Purchasing additional services

During and after the warranty period, you can purchase additional services, such as support for IBM and non-IBM hardware, operating systems, and application programs; network setup and configuration; upgraded or extended hardware repair services; and custom installations. Service availability and service name might vary by country or region.

#### Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines: IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

**Extent of Warranty:** The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

**Items Not Covered by Warranty:** IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND.** 

**Warranty Service:** To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Some parts of IBM Machines are designated as Customer Replaceable Units (called "CRUs"), e.g., keyboards, memory, or hard disk drives. IBM ships CRUs to you for replacement by you. You must return all defective CRUs to IBM within 30 days of your receipt of the replacement CRU. You are responsible for downloading designated Machine Code and Licensed Internal Code updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;

- obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and
- 3. where applicable, before service is provided:
  - a. follow the problem determination, problem analysis, and service request procedures that IBM or your reseller provides;
  - b. secure all programs, data, and funds contained in a Machine;
  - c. provide IBM or your reseller with sufficient, free, and safe access to your facilities to permit them to fulfill their obligations; and
  - d. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability: Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.
