Overview of the Ethernet switch module

The following illustration shows the Ethernet switch module.

Note: The illustrations in this document might differ slightly from your hardware.



The Intel Gigabit Ethernet Switch Module for IBM @server BladeCenter T is a hot-swap I/O module that is installed into the rear of the BladeCenter T unit.

For information about the indicators on the front of the switch module, see Chapter 3, "Information panel LEDs and internal and external ports," on page 17.

Chapter 2. Installing and removing the Ethernet switch module

The following illustration shows the I/O-module bay locations at the rear of the BladeCenter T unit.



Attention: To maintain proper system cooling, each I/O-module bay must contain either a module or a filler module; each blade bay must contain either a blade or a filler blade.

I/O-module guidelines

The BladeCenter T unit supports up to four hot-swap four-connector Ethernet switch modules installed in I/O-modules bays 1, 2, 3 and 4. When installed in I/O-module bay 1, the switch module provides a network connection to Ethernet Link 1 to each blade server in the BladeCenter T unit. When installed in I/O-module bay 2, the switch module provides a network connection for Ethernet Link 2 to each blade server. When installed in I/O-module bay 3 (for Ethernet Link 3) or I/O module bay 4 (for Ethernet Link 4) the switch module provides connection to the Ethernet expansion card options installed in the blade servers.

Important: You can install the Ethernet switch module in I/O-module bays 3 or 4 if the blade servers contain either Ethernet expansion cards or compatible pass-thru modules. The switch modules in I/O-module bays 3 and 4 and all blade server expansion cards in the BladeCenter T unit must use the same interface type.

The following table summarizes the application for the Ethernet switch module.

I/O- module	
bay	Switch-module function
1	Connection 1 (Ethernet Link 1) for all blade servers in the BladeCenter T unit
2	Connection 2 (Ethernet Link 2) for all blade servers in the BladeCenter T unit
3	Connection 3 (from all blade server expansion cards in the BladeCenter T unit)
4	Connection 4 (from all blade server expansion cards in the BladeCenter T unit)

Installation guidelines

Before you begin installing the Ethernet switch module in your BladeCenter T units, read the following information:

- Read the safety information beginning on page v and the guidelines in "Handling static-sensitive devices" on page 11. This information will help you work safely with your BladeCenter T unit and options.
- Blue on a component indicates touch points, where you can grip the component to remove it from or install it in the server, open or close a latch, and so on.
- Orange on a component or an orange label on or near a component indicates that the component can be hot-swapped, which means that you can remove or install the component while the BladeCenter T unit is running. (Orange can also indicate touch points on hot-swap components.) See the instructions for removing or installing a specific hot-swap component for any additional procedures that you might have to perform before you remove or install the component.
- You do not have to disconnect the BladeCenter T unit from power to install or replace any of the hot-swap modules in the BladeCenter T unit.

System reliability considerations

To help ensure proper cooling and system reliability, make sure that:

- Each of the I/O-module bays on the rear of the BladeCenter T unit has either an I/O module or a filler module installed.
- A removed hot-swap module is replaced with an identical module or filler module within 1 minute of removal.
- Cables for the optional I/O modules are routed according to the illustrations and instructions in this document.

Handling static-sensitive devices

Attention: Static electricity can damage electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

Use an ESD wrist strap and the ESD connectors on the BladeCenter T unit. Electrostatic discharge (ESD) is the release of stored static electricity that can damage electric circuits. Static electricity is often stored in your body and discharged when you come in contact with an object with a different potential. The ESD wrist strap safely channels the electricity from your body to a proper ground (the BladeCenter T unit).

Use an ESD wrist strap whenever you are working on the BladeCenter T unit, especially when you are handling modules, options, and blade servers. To work properly, the wrist strap must have a good contact at both ends (touching your skin at one end and connected to the ESD connector on the front or back of the BladeCenter T unit).



Location of ESD connector (rear of unit)

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the system unit for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the system unit without setting down the device. If it is necessary to set down the device, place it back into its static-protective package. Do not place the device on the system unit or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

Installing the Ethernet switch module

Complete the following steps to install the Ethernet switch module:

- 1. Review the safety information beginning on page v, "Installation guidelines" on page 10 through "Handling static-sensitive devices" on page 11.
- 2. Select an I/O-module bay in which to install the switch module, in accordance with the instructions in "I/O-module guidelines" on page 9.
- **3**. Remove the filler module from the selected I/O-module bay. Store the filler module for future use.
- 4. Connect an ESD wrist strap to the ESD connector at the rear of the BladeCenter T unit (see the illustration on page 11 for the location of the ESD connector).
- 5. If you have not already done so, touch the static-protective package that contains the switch module to an unpainted metal part of the BladeCenter T unit for at least two seconds.
- 6. Remove the switch module from its static-protective package.
- 7. Press the orange release lever at the end of the release latch and pull the latch to the open position.
- 8. Insert the switch module into the selected I/O-module bay with the release lever at the bottom of the I/O-module bay.
- **9**. Push the switch module into the bay until it stops. The release latch moves slightly toward the closed position.
- 10. Close the release latch until it locks into position.

- 11. After 60 seconds, make sure that the OK LED on the switch module is lit indicating that it has passed the power-on self-test (POST) and is operational. See page 17 for the LED locations on the switch module.
- 12. Make sure that:
 - The input-power LED and the output-power LED on each power module are lit.
 - The error LED on each power module is not lit.
 - The error LED on each management module is not lit.

See the *BladeCenter T Types 8720 and 8730 Installation and User's Guide* for the LED locations of the power modules and management modules.

- **13.** If you have other switch modules to install, do so now; otherwise, continue with step 14.
- 14. Attach any cables that are required by the switch module. See 18 for information about the external Ethernet connectors.

Note: To ensure EMC product regulation compliance for intra-building lightning surges, the Ethernet switch module must be used only with shielded LAN cables that are grounded at both ends.

15. For information about configuring the Ethernet switch module, see Chapter 4, "Configuring the Ethernet switch module," on page 19.

Removing the Ethernet switch module

Complete the following steps to remove the Ethernet switch module or filler module:

- 1. Disconnect any cables from the selected switch module.
- 2. Press the release lever at the end of the release latch and pull the latch to the open position. The switch module moves slightly out of the bay.
- 3. Slide the switch module out of the I/O-module bay and set it aside.
- 4. Within 1 minute, install another I/O module or filler module into the bay.
- 5. If you placed another switch module in the I/O-module bay, reconnect any cables that you disconnected in step 1.

Chapter 3. Information panel LEDs and internal and external ports

This chapter describes the information panel LEDs (also known as indicators) and the internal and external ports on the Ethernet switch module.

Information panel LEDs

The information panel of the Ethernet switch module consists of LEDs and four external RJ-45 connectors. The following illustration shows the LEDs on the switch module. A description of each LED follows the illustration.



Note: The illustrations in this document may differ slightly from your hardware.

OK LED: This green LED is at the top left of the information panel as shown in the illustration. When this LED is lit, it indicates that the switch module has passed the power-on self-test (POST) and is operational.

Ethernet switch error / Fault indicator (!) LED: This amber LED is at the top right of the information panel as shown in the illustration. When this LED is lit, it indicates that the switch module has a fault.

Ethernet link: This green link status LED is at the top right of each external 10/100/1000 Mbps connector as shown in the illustration. When one of these LEDs is lit, it indicates that there is a connection (or link) to a device on the corresponding connector.

Ethernet activity: This green activity LED is at the bottom right of each external 10/100/1000 Mbps connector as shown in the illustration. When one of these LEDs is flashing, it indicates that data is being received or transmitted (that is, activity is occurring) on the corresponding connector. The flashing frequency is proportional to the amount of traffic on that port.

Internal and external ports

The information panel of the Ethernet switch module consists of LEDs and four external RJ-45 connectors, as shown in the following illustration.



The switch module contains the following internal and external connectors:

- Two internal full-duplex 100 Mbps ports that are connected to the BladeCenter T unit management module.
- Eight internal full-duplex 1000 Mbps ports that are connected to the eight blade servers in the BladeCenter T unit.
- Four external RJ-45 Ethernet connectors for 10/100/1000 Mbps connections to external Ethernet devices such as backbones, end stations, and servers. These connectors are identified as Ext1, Ext2, Ext3, and Ext4 in the switch configuration menus and are labeled 1 through 4 on the switch module, as shown in the previous illustration.

Chapter 4. Configuring the Ethernet switch module

The Ethernet switch module supports two remote-access modes for management through Ethernet connections. The Ethernet switch module has an internal Ethernet path to the management module and the four external Ethernet connectors on the switch module. You can select the mode that is best suited for your BladeCenter T environment.

• Default mode: The default mode uses the internal path to the management module only. In this mode, the remote-access link to the management console must be attached to the 10/100 Mbps Ethernet connector on the management module. The IP addresses and SNMP parameters of the Ethernet switch modules can be automatically assigned by the IBM Director BladeCenter Deployment wizard (when available), or you must assign them through the BladeCenter Management and Configuration program. This mode enables the system administrator to provide a secure LAN for management of the BladeCenter T subsystems that is separate from the data network. See "Establishing a TCP/IP session for the Ethernet switch using the management module" on page 22 for additional information.

Important: In this mode, the Ethernet switch module does not respond to remote-management commands through the four external Ethernet ports on the Ethernet switch module.

See the Intel Gigabit Ethernet Switch Module for IBM @server BladeCenter T User's Guide and the Intel Gigabit Ethernet Switch Module for IBM @server BladeCenter T CLI Reference Guide on the IBM BladeCenter T Documentation CD about additional instructions for configuring the Ethernet switch module for this mode of operation.

• Remote management mode: The system administrator can choose to enable remote management of the Ethernet switch module through the four external connectors on the Ethernet switch module instead of access through the management module. This mode can be enabled only through the management-module configuration interface. When this mode is enabled, the external Ethernet ports will support both management traffic and BladeCenter T application-data traffic. See "Enabling management over the external ports" on page 23 for additional information. If the management of the Ethernet switch module is enabled through the four external ports, the switch module will acquire its IP address from a Dynamic Host Configuration Protocol (DHCP) server when the switch module is turned on or reset. The DHCP protocol enables IP addresses, network masks, and default gateways to be assigned by a DHCP server.

This mode enables the Ethernet switch module IP addresses to be on a different IP subnet than the management modules. This is useful when the Ethernet switch modules are to be managed and controlled as part of the overall network infrastructure while secure management of other

BladeCenter T subsystems is maintained through the management module. However, management-module access to the Ethernet switch-module link will be lost if the Ethernet switch-module IP address is not on the same IP subnet as the management module. See "Establishing a TCP/IP session for the switch through the external switch-module connectors" on page 25 for additional information. The *Intel Gigabit Ethernet Switch Module for IBM* @server BladeCenter T User's Guide and the *Intel Gigabit Ethernet Switch Module for IBM* @server BladeCenter T CLI Reference Guide on the IBM BladeCenter T Documentation CD contain additional instructions for configuring the Ethernet switch module for this mode of operation.

Important:

- Before you configure the Ethernet switch module, make sure that the management modules in the BladeCenter T unit are configured correctly. See the *Intel Gigabit Ethernet Switch Module for IBM @server BladeCenter T User's Guide* on the IBM *BladeCenter T Documentation* CD for more information.
- The Ethernet switch module factory-default IP address is 10.90.90.9*x*, where *x* depends on the number of the I/O-module bay into which you have installed the switch module, as shown in the following table.

I/O module bay number	Default IP address
1	10.90.90.91
2	10.90.90.92
3	10.90.90.94
4	10.90.90.97

Table 1. Factory-default IP addresses based on I/O-module bay numbers

- If you change the IP address of the Ethernet switch module and restart the BladeCenter T unit, the Ethernet switch module maintains this new IP address as its default value.
- The management module and the Ethernet switch module can communicate with each other only if they are on the same IP subnet.
- When you use the management-module Web interface to update the Ethernet switch-module configuration, the management-module firmware saves the new configuration in its internal nonvolatile random-access memory (NVRAM). If the switch module restarts, the management module applies the saved configuration to the switch module.

If, for some reason, the switch module restarts and the management module cannot apply the saved configuration to the switch module, the switch module defaults to using the configuration that it had previously saved. If the subnet IP address of the switch module does not match the subnet IP address of the management module, you can no longer manage the switch module.

• For switch communication with a remote management station, such as an IBM Director management server, through the management-module external Ethernet port, the switch-module internal-network interface and the management-module internal and external interfaces must be on the same IP subnet.

You can manage and configure the Ethernet switch using the management module or an external Ethernet switch interface. When the Ethernet switch module is set to use the factory-default configuration, it can be accessed through the management-module VLAN. The following figure is an example of establishing a TCP/IP session through the management module or through the external interface.



Client A manages the Ethernet switch module through the default management-module configuration interface. The management module is always enabled and always a member of VLAN 4095. VLAN 4095 can never be disabled. You can always manage the Ethernet switch module over this interface, provided that the IP addresses of the client, the management module, and the Ethernet switch module are on the same subnet, as shown in the following table.

Complete the following steps to establish a TCP/IP session for the switch using the management module:

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The management-module window opens.
- 2. From the I/O Module Tasks menu, click Management.
- 3. In the **I/O Module Management** section, click the bay number that corresponds to the location of the Ethernet switch module that you installed. The applicable bay number (in this example, bay 1) appears in the bottom of the window, followed by other related switch-module information, including the IP address. The switch-module information is divided into two sections: **Current IP Configuration** and **New Static IP Configuration**.

The Web interface and the Telnet program provide different ways to access the same internal switching software and configure it. Thus, all the settings in Web management are the same as those in the Telnet program.

- If your system application requires that you use the Telnet program, see "Configuring the Ethernet switch module using Telnet" on page 27 for additional information.

Enabling management over the external ports

Complete the following steps to enable management over the external connectors (ports):

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The management-module window opens.
- 2. From the **I/O Module Tasks** menu, click **Management**; then, click the bay where the management module is installed.



- **3**. Click **Advanced Management** under the selected bay and make sure that the following Ethernet switch-module features are enabled:
 - External ports
 - · External management over all ports
 - Preserve new IP configuration on all resets

The default setting is **Disabled** for these features. If any of these features are not already enabled, change the setting to **Enabled**; then, click **Save**.

To do this, you must first enable the external interfaces as described in "Enabling management over the external ports" on page 23 and then configure the TCP/IP address for the Ethernet switch module.

Complete the following steps:

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The management-module window opens.
- 2. From the I/O Module Tasks menu, click Management.
- 3. From the **I/O Module Management** section, click the bay number that corresponds to the location of the Ethernet switch module that you installed. The applicable bay number is displayed in the bottom of the window, followed by other related switch-module information, including the IP address. The switch-module information is divided into two sections: **Current IP Configuration** and **New Static IP Configuration**.
- 4. In the **IP address** field in the **New Static IP Configuration** section, type the TCP/IP address of the Ethernet switch module; then, click **Save**.

You can set up the TCP/IP address for the Ethernet switch module in either of two ways:

- Use the default TCP/IP address
- Obtain a valid, unique TCP/IP address from your system administrator

Notes:

In the **IP** address field in the **New Static IP Configuration** section, type the new TCP/IP address of the Ethernet switch module; then, click **Save**. You are now ready to configure the Ethernet switch module.

Configuring the Ethernet switch module using Telnet

Your Ethernet switch module supports a management interface that you can use to configure and control the Ethernet switch module over the network using the Telnet program. You can use this facility to perform many basic network-management functions. In addition, you can use the Telnet interface to configure the Ethernet switch module for management using an SNMP-based network-management system. The following sections describe how to use the Telnet interface to access the Ethernet switch module, change its settings, and monitor its operation.

Connecting to the Ethernet switch module

If you know the IP address for your switch module and you have an existing network connection, you can use the Telnet program (in VT-100 compatible terminal mode) to access and control the Ethernet switch module. The Telnet program and your switch module must be on the same network. If you have to obtain the IP address for your switch module or establish a network connection, contact your system or network administrator. Be sure to use the correct IP address in the required command, as specified in "Accessing the Ethernet switch-module command-line interface."

Accessing the Ethernet switch-module command-line interface

Complete the following steps to connect to the Ethernet switch module using Telnet:

- 1. Open an MS-DOS console window.
- 2. From the command-line prompt, type telnet *x* where *x* is the IP address for your switch module, and press Enter.
- **3**. Enter your user ID and password. If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User Name** field and the default password (PASSWORD, where the 0 is a zero) in the **Password** field and click **OK**.

After you log on to the Ethernet switch module, you can perform the tasks that are described in the switch module *User's Guide* and other documents on the IBM *BladeCenter T Documentation* CD.

Configuring the Ethernet switch using the management-module Web interface

This section describes how to use the management-module Web interface to access and configure the internal switching software. It also describes some of the Web interface Ethernet switch-module management features.

The Ethernet switch module offers an embedded HTML Web interface that you can use to manage the switch through Netscape Navigator/Communicator, or Microsoft[®] Internet Explorer. This interface is enabled by default. The Web browser acts as an access tool and can communicate directly with the switch using HTTP. Your browser window might vary from the window illustrations in this document. You can access the Web interface only through HTTP port 80. Your computer might have to access and install a Java Plug-in (JRE 1.4.0) to run without errors. Later versions of the JRE might work but are not officially supported.

Note: This Web interface does not accept Chinese language input (or other double-byte character-set languages).

Because the Web interface is a built-in component of the switch-module software, you do not have to install a separate interface program. The Web interface contains the following features:

- Support for Netscape and Internet Explorer Web browsers
- · Password protection
- User-friendly design
- The same configuration and monitoring functions as in the command-line interface (CLI)

Before you can access and start the Web interface, make sure that you have completed the following procedures:

- Install the Ethernet switch module in the BladeCenter T unit.
- Make sure that the latest software is installed on the Ethernet switch module. See "Determining the level of Ethernet switch software" on page 33 for more information.
- Configure at least one IP interface on the switch module.
- Enable the frames and the JavaScript[™] program in your Web browser.
- The following hardware and software are required for the Web interface:
 - A frame-capable Web-browser program, such as Internet Explorer (version 6.0 or later) or Netscape Navigator (version 4.7 or later)
 - A computer or workstation with network access to the switch module

To start the Web interface, complete the following steps:

Chapter 5. Configuring Serial over LAN on the management module

The Ethernet switch module supports Serial over LAN (SOL) protocol with all BladeCenter T processors. The Ethernet switch module must be installed in I/O-module bay 1 for SOL support. SOL virtual local area network (VLAN) support for the Ethernet switch module and the management module must be configured with VLAN information.

To configure the management module for SOL, complete the following steps:

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The management-module window opens.
- 2. From the **Blade Tasks** menu, click **Serial Over LAN**. The Serial Over LAN (SOL) window opens.
- **3**. Click **Serial Over LAN Configuration**. The Serial Over LAN Configuration window opens.
- 4. In the SOL VLAN ID field, enter the applicable VLAN ID number; then, click Save.

Chapter 6. Updating the Ethernet switch software

Two types of software run on the Ethernet switch module. One is the software image and the other one is the Micro-Controller Unit (MCU) code. You can update the software by using either the CLI commands on the switch through a Telnet session or by using the switch module web interface.

This chapter describes how to determine the level of the software that is installed on the Ethernet switch module, how to obtain the latest level of switch software, how to upgrade the switch software, and how to reset the switch module to activate the software upgrade.

Determining the level of Ethernet switch software

After you install the Ethernet switch module in your BladeCenter T unit, make sure that the latest software is installed on the Ethernet switch module. To determine the level of the software that is installed on the Ethernet switch module, complete the following steps:

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.
- 2. From the **Monitors** menu, click **Firmware VPD**. The Firmware VPD window opens.
- **3.** Locate the I/O Module Firmware VPD section. Page down to the I/O module-bay number that contains the Ethernet switch module that you installed; then, note the corresponding level of the software for the switch module.

Obtaining the latest level of switch software

To determine the latest level of the software that is available from IBM, complete the following steps:

- Go to http://www.ibm.com/pc/support/; then, click Support & downloads. The "Support & downloads" page is displayed.
- 2. Click **Downloads & drivers**. The "Downloads & drivers "page is displayed.
- **3.** In the **Search** field, type Ethernet switch module and click **Submit**. A Results window opens, displaying a list of links to the latest available software.
- 4. Compare the level of software that you noted in the I/O Module Firmware VPD section to the latest level of available software. If the two software levels do not match, download the latest level from the Web to your switch module.

Upgrading the switch software

The switch software is upgraded through a TFTP server application. Typically, this software runs as an application under your operating system. Make sure that this software is installed on your server; then, download the software image or the MCU code from the IBM Web site into a directory on your TFTP server. Enable the TFTP server and set its default directory to the one where the image is.

To transfer the software image file or the MCU code from the TFTP server to the switch, you must establish a Telnet session through the management module. To make sure that you have a connection, you must ping the TFTP server. The Telnet session performs optimally if all three network entities (TFTP server, management module, and switch IP addresses) are on the same subnet. Otherwise, you must use a router. Use the management-module interface to configure the IP addresses of the management-module external interface (eth0) and the Ethernet switch module so that they are both on the same subnet as the TFTP server.

- 6. Click Power On Module(s). Wait 70 seconds for POST to be completed.
- 7. Make sure that the latest switch operating-system software is correctly installed on the Ethernet switch module. From the **Monitors** menu, click **Firmware VPD**. The Firmware VPD window opens.
- 8. In the Firmware VPD window, locate the **I/O Module Firmware VPD** section. Scroll down to the number of the I/O-module bay that contains the Ethernet switch module that you just installed; then, note the corresponding level of the software for the switch module. Make sure that the latest switch operating-system software is correctly installed on the Ethernet switch module.

Chapter 7. Solving problems

This section provides basic troubleshooting information to help you solve some problems that might occur while you are setting up the Ethernet switch module.

If you cannot locate and correct the problem using the information in this section, see Appendix A, "Getting help and technical assistance," on page 45.

Running POST

To ensure that it is fully operational, the Ethernet switch module performs a series of tests during power-up or a restart (power-on self-test, or POST). These tests take approximately 1 minute to complete. The management module reads the test results and displays them for you. During normal operation, these tests are completed without error, and the green OK LED is lit on the switch module. However, if the Ethernet switch module fails POST, the amber switch-module error (fault) LED and the amber system-error LED on the BladeCenter T unit is lit. An event is stored in the event log in the System Status panel of the management module. The specific failure is displayed on the System Status I/O Module panel of the management module. The following illustrations are examples of the windows that open if a POST error occurs.

Note: For the location and description of the Ethernet switch-module LEDs, see Chapter 3, "Information panel LEDs and internal and external ports," on page 17.





POST errors

There are two types of errors: noncritical and critical. Noncritical errors apply to one port, and the Ethernet switch module remains operational. You can continue to operate the Ethernet switch module; however, you must replace it as soon as possible. When critical errors occur, the Ethernet switch module does not operate. If a critical error occurs, the switch will try to complete the startup sequence and initialization process. Complete the following steps to run POST:

- Log on to the management module as described in the *BladeCenter T* Management Module User's Guide on the IBM BladeCenter T Documentation CD. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.
- 2. Turn off the Ethernet switch module; then, turn it on again. See page 39 for detailed instructions.

After POST is completed, the management module displays the results. Refresh the window to view the POST results. If the error remains, the Ethernet switch module is defective. Replace the Ethernet switch module.

The following table describes the basic critical and noncritical failures. This abbreviated list is representative; it is not intended as an exhaustive list. An error code is associated with each failure. Error codes appear on the Management Module Switch Information window. Be sure to note the applicable error code and corresponding failure. You might have to provide this information when you call IBM for support. For details, see Appendix A, "Getting help and technical assistance," on page 45.

- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems

When you contact IBM for service, you must follow the problem determination and resolution procedures that IBM specifies. An initial diagnosis of your problem can be made either by a technician over the telephone or electronically by access to an IBM website.

The type of warranty service applicable to your Machine is specified in Part 3 - Warranty Information.

You are responsible for downloading and installing designated Machine Code (microcode, basic input/output system code (called "BIOS"), utility programs, device drivers, and diagnostics delivered with an IBM Machine) and other software updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

If IBM is unable to do either, you may return the Machine to your place of purchase and your money will be refunded.

IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Exchange of a Machine or Part

When the warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

Your Additional Responsibilities

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

service locations around the world), and (c) ensure that such processing complies with any laws applicable to such Personal Data.

Limitation of Liability

IBM is responsible for loss of, or damage to, your Machine only while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller are responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM for any reason. You should remove all such information from the Machine prior to its return.

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

UNDER NO CIRCUMSTANCES IS IBM, ITS SUPPLIERS OR RESELLERS LIABLE FOR ANY OF THE FOLLOWING EVEN IF INFORMED OF THEIR POSSIBILITY: 1) THIRD PARTY CLAIMS AGAINST YOU FOR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, DATA; 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES; OR 4) LOST PROFITS, BUSINESS REVENUE, GOODWILL OR ANTICIPATED SAVINGS. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.

THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR JURISDICTION TO JURISDICTION.

Jurisdiction

All of our rights, duties, and obligations are subject to the courts of the country in which you acquired the Machine.

SINGAPORE

Limitation of Liability: *The words* "**SPECIAL**" and "**ECONOMIC**" *in item 3 in the fifth paragraph are deleted.*

Arbitration: *The following is added under this heading:*

In Albania, Armenia, Azerbaijan, Belarus, Bosnia-Herzegovina, Bulgaria, Croatia, Georgia, Hungary, Kazakhstan, Kyrgyzstan, FYR Macedonia, Moldova, Poland, Romania, Russia, Slovakia, Slovenia, Tajikistan, Turkmenistan, Ukraine, Uzbekistan, and FR Yugoslavia all disputes arising out of this Statement of Limited Warranty or related to its violation, termination or nullity will be finally settled under the Rules of Arbitration and Conciliation of the International Arbitral Center of the Federal Economic Chamber in Vienna (Vienna Rules) by three arbitrators appointed in accordance with these rules. The arbitration will be held in Vienna, Austria, and the official language of the proceedings will be English. The decision of the arbitrators will be final and binding upon both parties. Therefore, pursuant to paragraph 598 (2) of the Austrian Code of Civil Procedure, the parties expressly waive the application of paragraph 595 (1) figure 7 of the Code. IBM may, however, institute proceedings in a competent court in the country of installation.

In Estonia, Latvia and Lithuania all disputes arising in connection with this Statement of Limited Warranty will be finally settled in arbitration that will be held in Helsinki, Finland in accordance with the arbitration laws of Finland then in effect. Each party will appoint one arbitrator. The arbitrators will then jointly appoint the chairman. If arbitrators cannot agree on the chairman, then the Central Chamber of Commerce in Helsinki will appoint the chairman.
