





## **Chapter 1. Introduction**

This *Installation Guide* contains instructions for setting up your IBM<sup>®</sup> @server<sup>m</sup> xSeries<sup>®</sup> 346 Type 8840 server and basic instructions for installing some options. More detailed instructions for installing options are in the *Option Installation Guide* on the IBM *xSeries Documentation* CD, which comes with your server. This document contains information about:

- · Setting up and cabling your server
- · Starting and configuring your server
- · Installing some options
- Solving problems

Your server might have features that are not described in the documentation that you received with the server. The documentation might be updated occasionally to include information about those features, or technical updates might be available to provide additional information that is not included in your server documentation. These updates are available from the IBM Web site. Complete the following steps to check for updated documentation and technical updates:



### Hardware and software requirements

The IBM *xSeries Documentation* CD requires the following minimum hardware and software:

- Microsoft<sup>®</sup> Windows NT<sup>®</sup> 4.0 (with Service Pack 3 or later), Windows<sup>®</sup> 98, Windows 2000, or Red Hat Linux<sup>®</sup>.
- 100 MHz microprocessor.
- 32 MB of RAM.
- Adobe Acrobat Reader 3.0 (or later) or Xpdf, which comes with Linux operating systems. Acrobat Reader software is included on the CD, and you can install it when you run the Documentation Browser.

## Using the Documentation Browser

Use the Documentation Browser to browse the contents of the CD, read brief descriptions of the documents, and view documents using Adobe Acrobat Reader or Xpdf. The Documentation Browser automatically detects the regional settings in use in your system and displays the documents in the language for that region (if available). If a document is not available in the language for that region, the English version is displayed.

Use one of the following procedures to start the Documentation Browser:

- If Autostart is enabled, insert the CD into your CD-ROM drive. The Documentation Browser starts automatically.
- If Autostart is disabled or is not enabled for all users, use one of the following procedures:

 If you are using a Windows operating system, insert the CD into your CD-ROM drive and click Start --> Run. In the Open field, type e:\win32.bat

where *e* is the drive letter of the CD-ROM drive, and click **OK**.

 If you are using Red Hat Linux, insert the CD into your CD-ROM drive; then, run the following command from the /mnt/cdrom directory: sh runlinux.sh

Select your server from the **Product** menu. The **Available Topics** list displays all the documents for your server. Some documents might be in folders. A plus sign (+) indicates each folder or document that has additional documents under it. Click the plus sign to display the additional documents.

When you select a document, a description of the document appears under **Topic Description**. To select more than one document, press and hold the Ctrl key while you select the documents. Click **View Book** to view the selected document or documents in Acrobat Reader or Xpdf. If you selected more than one document, all the selected documents are opened in Acrobat Reader or Xpdf.

To search all the documents, type a word or word string in the **Search** field and click **Search**. 

(Orange can also indicate touch points on hot-swap components.) # **Chapter 2. Installing options**

This chapter provides basic instructions for installing hardware options in the server. These instructions are intended for users who are experienced with setting up IBM server hardware. If you need more detailed instructions, see the *Option Installation Guide* on the IBM *xSeries Documentation* CD.

## Installation guidelines

Before you begin installing options, read the following information:

- Read the safety information beginning on page v and the guidelines in "Handling static-sensitive devices" on page 8. This information will help you work safely with the server and options.
- Make sure that you have an adequate number of properly grounded electrical outlets for your server, monitor, and other devices.
- Back up all important data before you make changes to disk drives.
- Have a small flat-blade screwdriver available.
- You do not have to turn off the server to install or replace hot-swap power supplies, hot-swap fans, or hot-plug Universal Serial Bus (USB) devices.
- Blue on a component indicates touch points, where you can grip the component to remove it from or install it in the server, open or close a latch, and so on.
- Orange on a component or an orange label on or near a component indicates that the component can be hot-swapped, which means that if the server and operating system support hot-swap capability, you can remove or install the component while the server is running. (Orange can also indicate touch points on hot-swap components.) See the instructions for removing or installing a specific hot-swap component for any additional procedures that you might have to perform before you remove or install the component.
- For a list of supported options for your server, go to http://www.ibm.com/pc/compat/.

## System reliability guidelines

To help ensure proper cooling and system reliability, make sure that:

- Each of the drive bays has a drive or a filler panel and electromagnetic compatibility (EMC) shield installed in it.
- Each of the power-supply bays has a power supply or power-supply blank installed in it.
- There is adequate space around the server to allow the server cooling system to work properly. Leave approximately 50 mm (2.0 in.) of open space around the front and rear of the server. Do not place objects in front of the fans. For proper cooling and airflow, replace the server cover before turning on the server. Operating the server for extended periods of time (more than 30 minutes) with the server cover removed might damage server components.
- You have followed the cabling instructions that come with optional adapters.
- You have replaced a failed fan within 48 hours.
- You have replaced a hot-swap drive within 2 minutes of removal.
- You do not remove the air baffle while the server is running. Operating the server without the air baffle might cause the microprocessor to overheat.
- Microprocessor socket 2 always contains either a microprocessor baffle or a microprocessor and heat sink.

## Working inside the server with the power on

The server supports hot-swap devices and is designed to operate safely while it is turned on and the cover is removed. Follow these guidelines when you work inside a server that is turned on:

- Avoid wearing loose-fitting clothing on your forearms. Button long-sleeved shirts before working inside the server; do not wear cuff links while you are working inside the server.
- Do not allow your necktie or scarf to hang inside the server.
- Remove jewelry, such as bracelets, necklaces, rings, and loose-fitting wrist watches.
- Remove items from your shirt pocket, such as pens and pencils, that could fall into the server as you lean over it.
- Avoid dropping any metallic objects, such as paper clips, hairpins, and screws, into the server.

## Handling static-sensitive devices

**Attention:** Static electricity can damage the server and other electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.


To reduce the possibility of damage from electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Wear an electrostatic-discharge wrist strap, if one is available.
- Handle the device carefully, holding it by its edges or its frame.
- · Do not touch solder joints, pins, or exposed circuitry.
- Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the server for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the server without setting down the device. If it is necessary to set down the device, put it back into its static-protective package. Do not place the device on the server cover or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

## Installing an adapter

The following notes describe the types of adapters that the server supports and other information that you must consider when installing adapters:


- PCI-X slots 1 and 2 support non-hot-plug, 64-bit, 100 MHz, low-profile adapters.
- PCI-X slots 3 and 4 support non-hot-plug, 64-bit, 133 MHz, standard full-length adapters.
- The optional IBM Remote Supervisor Adapter II SlimLine can be installed only in a dedicated slot on the system board. The following illustration shows how to install the Remote Supervisor Adapter II SlimLine.



Slip the free end of the card under the tab on the retainer bracket; then, press the card in the connector and make sure that all tabs on the latch bracket secure the card in place.

- If you are installing an optional ServeRAID<sup>™</sup>-7k, review the following information:
  - No rerouting of the internal SCSI cable is required if you are installing the ServeRAID-7k.
  - The ServeRAID-7k can be installed only in a dedicated slot on the system board.


The following illustration shows how to install the ServeRAID-7k.





#### **PCI** low-profile card




PCI riser card




Complete the following steps to install an adapter:

- 1. Read the safety information beginning on page v and "Installation guidelines" on page 7.
- 2. Turn off the server and peripheral devices, and disconnect the power cords and all external cables.
- 3. Remove the top cover.
- 4. If you are installing an adapter in PCI slot 1 or 2, remove the PCI low-profile-card cage.



If you are installing an adapter in PCI slot 3 or 4, remove the PCI riser-card cage.




- 5. Slide the expansion-slot cover out of the PCI low-profile-card cage or PCI riser-card cage.
- 6. Install the adapter.
- 7. Reinstall the PCI low-profile card cage or PCI riser-card cage.
- 8. Connect any needed cables to the adapter.

#### Attention:

- When you route cables, do not block any connectors or the ventilated space around any of the fans.
- Make sure that cables are not routed on top of components under the PCI riser-card cage or the PCI low-profile-card cage.
- Make sure that cables are not pinched by the server components.


The following illustration shows the cable routing for an adapter installed in the PCI low-profile-card cage.

**Note:** Remove the fan guide before you route the cables. Reinstall the fan guide when you complete the cable routing.

- 10. If you have other options to install or remove, do so now.
- 11. Replace the top cover. Go to "Completing the installation" on page 22.

## Installing a memory module

The following notes describe the types of dual inline memory modules (DIMMs) that the server supports and other information that you must consider when installing DIMMs:


- The server supports 256 MB, 512 MB, 1 GB, and 2 GB DIMMs, for a maximum of 16 GB of system memory. The server supports up to eight 1.8 V, 240-pin, PC3200, ECC DDR II SDRAM, 200 MHz DIMMs. Go to the ServerProven list at http://www.ibm.com/pc/compat/ for a list of memory modules that you can use with the server.
- The server comes with a minimum of two 256 MB DIMMs, installed in slots 1 and 2. When installing additional DIMMs, you must install two DIMMS at a time, in the order shown in the following table, to maintain performance.

- Each DIMM in a pair must be the same size and technology to ensure that the server will operate properly.
- You can configure the server to use memory mirroring. Memory mirroring stores data in two pairs of DIMMs simultaneously. Memory mirroring reduces the amount of available memory. Enable memory mirroring through the Configuration/Setup Utility program. See the *User's Guide* on the IBM *xSeries Documentation* CD for details about enabling memory mirroring.

When using memory mirroring, you must install two pairs of DIMMs at a time. The four DIMMs in each group must be identical. See Table 3 for the DIMM connectors that are in each group.

Group	DIMM connectors
1	1, 2, 3, and 4
2	5, 6, 7, and 8

Table 3. Memory mirroring DIMM installation sequence

 The server supports online-spare memory. This feature disables the failed memory from the system configuration and activates an online-spare memory pair of DIMMs to replace the failed active DIMM pair. Online-spare memory reduces the amount of available memory. Before you can enable this feature, you must install one additional pair of DIMMs. The online-spare memory DIMM pair must be the same speed, type, and the same size, or larger, than the active DIMM pair.

Enable online-spare memory through the Configuration/Setup Utility program. The BIOS code assigns the online-spare memory DIMM pair according to your DIMM configuration. See the *User's Guide* on the IBM *xSeries Documentation* CD for information about enabling online-spare memory. See Table 4 for the online-spare memory DIMM connector assignments.




- You can enable either online-spare memory or memory mirroring, but not both at the same time.
- When you install or remove DIMMs, the server configuration information changes. When you restart the server, the system displays a message indicating that the memory configuration has changed.

- 2. Turn off the server and peripheral devices, and disconnect the power cords and all external cables, if necessary; then, remove the top cover.


- 4. Determine the connectors into which you will install the DIMMs.
- 5. Install the DIMMs in the connectors.
- 6. If you have other options to install or remove, do so now.
- 7. Install the air baffle.
- 8. Replace the top cover. Go to "Completing the installation" on page 22.

## Installing a hard disk drive

The following notes describe the types of hard disk drives that the server supports and other information that you must consider when installing hard disk drives:

- The server supports six 1-inch (26 mm) slim, 3.5-inch low-voltage differential (LVD) hard disk drives installed on Ultra-Slim hard disk drive trays. For a list of supported hard disk drives, go to the ServerProven Web site at http://www.ibm.com/pc/compat/.
- All hot-swap drives in the server should have the same throughput speed rating. Mixing hard drives with different speed ratings will cause all drives to operate at the lower throughput speed.
- The SCSI ID that is assigned to each bay is printed on the server front.

The following illustration shows how to install a hot-swap hard disk drive.



Complete the following steps to install a hard disk drive.

**Attention:** To maintain proper system cooling, do not operate the server for more than 10 minutes without either a drive or a filler panel installed in each bay.

- 1. Read the safety information beginning on page v and "Installation guidelines" on page 7.
- 2. Remove the filler panel.
- 3. Place the drive handle in the open position and slide the drive into the bay.
- 4. Close the drive handle.
- 5. If you have other options to install or remove, do so now.
- 6. Go to "Completing the installation" on page 22.

## Installing an additional microprocessor

The following notes describe the type of microprocessor that the server supports and other information that you must consider when installing a microprocessor:


- When you install the microprocessor in socket J23, you must also install the voltage regulator module (VRM) that comes with the microprocessor in VRM connector J72.
- If the thermal-grease protective cover (for example, a plastic cap or tape liner) is removed from the heat sink or fan sink, do not touch the thermal grease on the bottom of the heat sink or fan sink or set down the heat sink or fan sink.
  - **Note:** Removing the heat sink or fan sink from the microprocessor destroys the even distribution of the thermal grease and requires replacing the thermal grease. Setting down the heat sink or fan sink onto any surface when the thermal-grease protective cover is removed will contaminate the thermal grease. If the thermal grease becomes contaminated with particles, it must be replaced.

For information about replacing contaminated thermal grease on the heat sink or fan sink, contact IBM Services. For support phone numbers, go to http://www.ibm.com/planetwide/, or in the U.S. and Canada, call 1-800-IBM-SERV (1-800-426-7378).


Have the following information ready when you call:

- Machine type and model
- Serial number of your server or computer

#### Attention:

- A startup (boot) processor must always be installed in socket J22 on the system board.
- To ensure proper server operation when you install an additional microprocessor, use microprocessors that have the same cache size and type, and the same clock speed. Microprocessor internal and external clock frequencies must be identical.

Complete the following steps to install an additional microprocessor:


- 1. Read the safety information beginning on page v and "Installation guidelines" on page 7.
- 2. Turn off the server and peripheral devices, and disconnect the power cords and all external cables, if necessary; then, remove the top cover.
- 3. Remove the air baffle and the microprocessor baffle.
- 4. Install a VRM in the VRM connector (J72).
- 5. Install the microprocessor:
  - a. Touch the static-protective package containing the microprocessor to any unpainted metal surface on the server. Then, remove the microprocessor from the package.
  - b. Remove the protective cover, tape, or label from the surface of the microprocessor socket, if present.

**Attention:** You must ensure that the locking lever on the microprocessor socket is in the fully open position before you insert the microprocessor in the socket. Failure to do so might result in permanent damage to the microprocessor, microprocessor socket, and system board.

 Rotate the locking lever on the microprocessor socket from its closed and locked position until it stops or clicks in the fully open position (approximately 135° angle).

#### Attention:


- Do not use excessive force when pressing the microprocessor into the socket.
- Make sure that the microprocessor is oriented and aligned with pin number 1 in the socket before you try to close the lever.
- d. Center the microprocessor over the microprocessor socket. Align the triangle on the corner of the microprocessor with the triangle on the corner of the socket and carefully press the microprocessor into the socket.




- e. Carefully close the locking lever to secure the microprocessor in the socket.
- 6. Install a heat sink on the microprocessor.

#### Attention:

· Do not set down the heat sink after you remove the plastic cover.



- Do not touch the thermal grease on the bottom of the heat sink or set down the heat sink. Touching the thermal grease will contaminate it. For details, see the information about thermal grease on page 18.
- a. Remove the plastic protective cover from the bottom of the heat sink.
- b. Make sure that the heat-sink lever is in the open position.
- c. Align the heat sink above the microprocessor with the thermal grease side down.



- d. Slide the flange of the heat sink into the opening beneath the retainer bracket.
- e. Press down firmly on the heat sink until it is seated securely.
- f. Attach the heat sink to the microprocessor by rotating the heat-sink lever to the closed position and hooking it underneath the lock tab.
- 7. Install the air baffle.
- 8. If you have other options to install or remove, do so now.
- 9. Replace the top cover. Go to "Completing the installation."

## Completing the installation

Complete the following steps to complete the installation:

- 1. Install the top cover.
- 2. Install the server in a rack. See the *Rack Installation Instructions* that come with the server for complete rack installation and removal instructions.

#### Attention:

- · Install the server only in a rack cabinet with perforated doors.
- Do not leave open spaces above or below an installed server in the rack cabinet. To help prevent damage to server components, always install a blank filler panel to cover the open space and to help ensure proper air circulation. See the documentation that comes with your rack cabinet for more information.
- · Install the server in a rack that meets the following requirements:
  - Minimum depth of 70 mm (2.76 in.) between the front mounting flange and the inside of the front door
  - Minimum depth of 157 mm (6.18 in.) between the rear mounting flange and the inside of the rear door
  - Minimum depth of 718 mm (28.27 in.) and maximum depth of 762 mm (30.00 in.) between the front and rear mounting flanges
- 3. Connect the cables and power cords. See "Connecting the cables" on page 23 for more information.


## **Connecting the cables**

The following illustrations show the locations of the input and output connectors on your server. Detailed cabling instructions are in the *Rack Installation Instructions* that come with the server.

#### Notes:

- 1. You must turn off the server before connecting cables to or disconnecting any cables from the server (see "Turning off the server" on page 28).
- See the documentation that comes with your options for additional cabling instructions. It might be easier for you to route cables before you install certain options.
- 3. Cable identifiers are printed on the cables that come with the server and options. Use these identifiers to connect the cables to the correct connectors.

## Updating the server configuration

When you start the server for the first time after you add or remove an internal option or external SCSI device, you might receive a message that the configuration has changed. The Configuration/Setup Utility program starts automatically so that you can save the new configuration settings. For more information, see the section about configuring the server in the *User's Guide* on the IBM *xSeries Documentation* CD.

Some options have device drivers that you must install. See the documentation that comes with each option for information about installing device drivers.

The server comes with at least one microprocessor. If more than one microprocessor is installed, the server can operate as a symmetric multiprocessing (SMP) server. You might have to upgrade the operating system to support SMP. For

more information, see the section about using the *ServerGuide Setup and Installation* CD in the *User's Guide* and the operating-system documentation.

If the server has an optional RAID adapter and you have installed or removed a hard disk drive, see the documentation that comes with the RAID adapter for information about reconfiguring the disk arrays.

If the server has a RAID configuration using the SCSI controller with integrated RAID and you have installed or removed a hard disk drive, you might have to reconfigure the disk arrays. See the RAID documentation on the IBM *ServeRAID-7e* (*Adaptec HostRAID*) Support CD for more information about reconfiguring the disk arrays.



# Chapter 3. Server power, controls, and indicators

This chapter describes the controls and light-emitting diodes (LEDs) and how to turn the server on and off.

## **Front view**

The following illustration shows the controls, LEDs, and connectors on the front of the server.




Rack release latches: Press these latches to release the server from the rack.

**Hard disk drive activity LED:** On some server models, each hot-swap hard disk drive has an activity LED. When this LED is flashing, it indicates that the drive is in use.

**Hard disk drive status LED:** On some server models, each hot-swap hard disk drive has a status LED. When this LED is lit, it indicates that the drive has failed. If an optional IBM ServeRAID controller is installed in the server, when this LED is flashing slowly (one flash per second), it indicates that the drive is being rebuilt. When the LED is flashing rapidly (three flashes per second), it indicates that the controller is identifying the drive.

**Operator information panel:** This panel contains controls, LEDs, and connectors. The following illustration shows the controls, LEDs, and connectors on the operator information panel.



The following controls, LEDs, and connectors are on the operator information panel:

- **Release latch:** Slide this latch to the left to access the light path diagnostics panel.
- System-error LED: When this LED is lit, it indicates that a system error has occurred. An LED on the light path diagnostics panel is also lit to help isolate the error.

- Information LED: When this LED is lit, it indicates that a noncritical event has occurred. An LED on the light path diagnostics panel is also lit to help isolate the error.
- **System-locator LED:** Use this LED to visually locate the server among other servers. You can use IBM Director to light this LED remotely.
- SCSI activity LED: When this LED is lit, it indicates that there is activity on the SCSI or IDE bus.
- **Power-control button:** Press this button to turn the server on and off manually. A power-control-button shield comes installed on the server to prevent the server from being turned off accidentally.
- **Power-on LED:** When this LED is lit and not flashing, it indicates that the server is turned on. When this LED is flashing, it indicates that the server is turned off and still connected to an ac power source. When this LED is off, it indicates that ac power is not present, or the power supply or the LED itself has failed.
  - **Note:** If this LED is off, it does not mean that there is no electrical power in the server. The LED might be burned out. To remove all electrical power from the server, you must disconnect the power cord from the electrical outlet.
- **USB connector:** Connect a USB device to this connector.

**Diskette-eject button:** Press this button to release a diskette from the diskette drive.


**Diskette drive activity LED:** When this LED is lit, it indicates that the diskette drive is in use.

**DVD-eject button:** Press this button to release a CD from the DVD-ROM drive.

**DVD-ROM drive activity LED:** When this LED is lit, it indicates that the DVD-ROM drive is in use.

## **Rear view**

The following illustration shows the connectors and LEDs on the rear of the server.



**Ethernet link status LEDs:** When these LEDs are lit, they indicate that there is an active link connection on the 10BASE-T, 100BASE-TX, or 1000BASE-TX interface for the Ethernet port.

**Ethernet activity LEDs:** When these LEDs are lit, they indicate that the server is transmitting to or receiving signals from the Ethernet LAN that is connected to the Ethernet port.

Ethernet 2 connector: Use this connector to connect the server to a network.

Ethernet 1 connector: Use this connector to connect the server to a network.

**Remote Supervisor Adapter II SlimLine Ethernet connector:** Use this connector to connect the server to a network for systems-management information control. This connector is active only if you have installed a Remote Supervisor Adapter II SlimLine.

Power-cord connectors: Connect the power cords to these connectors.

**AC power LED:** On some server models, each hot-swap power supply has an ac power LED and a dc power LED. During typical operation, both the ac and dc power LEDs are lit. For any other combination of LEDs, see the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD.

**DC power LED:** On some server models, each hot-swap power supply has a dc power LED and an ac power LED. During typical operation, both the ac and dc power LEDs are lit. For any other combination of LEDs, see the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD.

SCSI connector: Connect a SCSI device to this connector.

**ASM connectors:** Use either of these connectors to connect the server to an Integrated xSeries Adapter (IXA) that is installed in the server.

**System-locator LED:** Use this LED to visually locate the server among other servers. You can use IBM Director to light this LED remotely.

**USB connectors:** Connect USB devices to these connectors.

Video connector: Connect a monitor to this connector.

Mouse connector: Connect a mouse or other PS/2<sup>®</sup> device to this connector.

Keyboard connector: Connect a PS/2 keyboard to this connector.

Serial connector: Connect a 9-pin serial device to this connector.

### Server power features

When the server is connected to an ac power source but is not turned on, the operating system does not run, and all core logic except for the service processor is shut down; however, the server can respond to requests from the service processor (also called the baseboard management controller), such as a remote request to

turn on the server. The power-on LED flashes to indicate that the server is connected to ac power but is not turned on.

## Turning on the server

Approximately 5 seconds after the server is connected to ac power, the power-control button becomes active, and you can turn on the server and start the operating system by pressing the power-control button.

The server can also be turned on in any of the following ways:

- If a power failure occurs while the server is turned on, the server will restart automatically when power is restored.
- If your operating system supports the systems-management software for an optional Remote Supervisor Adapter II SlimLine, the systems-management software can turn on the server.
- If your operating system supports the Wake on LAN feature, the Wake on LAN feature can turn on the server.
- **Note:** When 4 GB or more of memory (physical or logical) is installed, some memory is reserved for various system resources and might be unavailable to the operating system. The amount of memory that is reserved for system resources depends on the operating system, the configuration of the server, and the configured PCI options.

## Turning off the server

When you turn off the server and leave it connected to ac power, the server can respond to requests from the service processor, such as a remote request to turn on the server. To remove all power from the server, you must disconnect it from the power source.


Some operating systems require an orderly shutdown before you turn off the server. See your operating-system documentation for information about shutting down the operating system.

Statement 5





The power-control button on the device and the power switch on the power supply do not turn off the electrical current supplied to the device. The device also might have more than one power cord. To remove all electrical current from the device, ensure that all power cords are disconnected from the power source.



The server can be turned off in any of the following ways:

• You can turn off the server from the operating system, if your operating system supports this feature. After an orderly shutdown of the operating system, the server will be turned off automatically.

- You can press the power-control button to start an orderly shutdown of the operating system and turn off the server, if your operating system supports this feature.
- If the operating system stops functioning, you can press and hold the power-control button for more than 4 seconds to turn off the server.
- The service processor can turn off the server as an automatic response to a critical system failure.
- You can turn off the server through a request from the service processor.

# Chapter 4. Configuring the server

The *ServerGuide Setup and Installation* CD provides software setup tools and installation tools that are specifically designed for your IBM server. Use this CD during the initial installation of the server to configure basic hardware features and to simplify the operating-system installation.

In addition to the *ServerGuide Setup and Installation* CD, you can use the following configuration programs to customize the server hardware:

- Configuration/Setup Utility program
- Baseboard management controller utility programs
- SCSISelect Utility program for Adaptec<sup>®</sup> HostRAID<sup>™</sup> configuration
- SCSISelect Utility program

For more information about these programs, see "Configuring the server" in the *User's Guide* on the IBM *xSeries Documentation* CD.

## Using the ServerGuide Setup and Installation CD

The *ServerGuide Setup and Installation* CD provides state-of-the-art programs to detect the server model and installed hardware options, configure the server hardware, provide device drivers, and help you install the operating system. For information about the supported operating-system versions, see the label on the CD. If the *ServerGuide Setup and Installation* CD did not come with your server, you can download the latest version from http://www.ibm.com/pc/qtechinfo/MIGR-4ZKPPT.html.

Complete the following steps to start the ServerGuide Setup and Installation CD:

- 1. Insert the CD, and restart the server. If the CD does not start, see "ServerGuide problems" on page 54.
- 2. Follow the instructions on the screen to:
  - a. Select your language.
  - b. Select your keyboard layout and country.
  - c. View the overview to learn about ServerGuide features.
  - d. View the readme file to review installation tips about your operating system and adapter.
  - e. Start the setup and hardware configuration programs.
  - f. Start the operating-system installation. You will need your operating-system CD.

## Using the Configuration/Setup Utility program

The Configuration/Setup Utility program is part of the BIOS code. You can use it to:

- Change interrupt request (IRQ) settings
- Change the startup drive sequence
- Configure serial-port assignments
- Resolve configuration conflicts
- · Set the date and time
- · Set passwords and security settings

Complete the following steps to start the Configuration/Setup Utility program:

- 1. Turn on the server.
- 2. When the message Press F1 for Configuration/Setup appears, press F1. If an administrator password has been set, you must type the administrator password to access the full Configuration/Setup Utility menu.
- 3. Follow the instructions on the screen.

## Using the baseboard management controller

The baseboard management controller provides environmental monitoring for the server. If environmental conditions exceed thresholds or if system components fail, the baseboard management controller lights LEDs to help you diagnose the problem and also records the error in the System Event/Error log.

The baseboard management controller also provides the following remote server management capabilities through the OSA SMBridge management utility program:

Command-line interface (IPMI Shell)

The command-line interface provides direct access to server management functions through the IPMI 1.5 protocol. Use the command-line interface to issue commands to control the server power, view system information, and identify the server. You can also save one or more commands as a text file and run the file as a script.

Serial over LAN

Establish a Serial over LAN (SOL) connection to manage servers from a remote location. You can remotely view and change the BIOS settings, restart the server, identify the server, and perform other management functions. Any standard Telenet client application can access the SOL connection.

# Enabling and configuring SOL using the OSA SMBridge management utility program

To enable and configure the server for SOL by using the OSA SMBridge management utility program, you must update and configure the BIOS code and enable the operating system for an SOL connection.

Note: In an SOL session, use the following commands instead of function keys:

- To start the Configuration/Setup Utility program when the prompt Press F1 for Configuration/Setup appears, press Esc, Shift+o, then Shift+p.
- To start the diagnostic programs, when the prompt F2 for Diagnostics appears, press Esc, Shift+o, then Shift+q.

### **BIOS update and configuration**

Complete the following steps to update and configure the BIOS code to enable SOL:

- 1. Update the BIOS code:
  - a. Download the latest version of the BIOS code from http://www.ibm.com/pc/support/.
  - b. Update the BIOS code, following the instructions that come with the update file that you downloaded.
- 2. Configure the BIOS settings:
  - a. Restart the server and press F1 when prompted to start the Configuration/Setup Utility program.

- b. Select **Devices and I/O Ports**; then, make sure that the values are set as follows:
  - Serial Port A: Auto-configure
  - Serial Port B: Auto-configure
- c. Select **Remote Console Redirection**; then, make sure that the values are set as follows:
  - Remote Console Active: Enabled
  - Remote Console COM Port: COM 1
  - Remote Console Baud Rate: 19200
  - Remote Console Data Bits: 8
  - Remote Console Parity: None
  - Remote Console Stop Bits: 1
  - Remote Console Text Emulation: ANSI
  - Remote Console Keyboard Emulation: ANSI
  - Remote Console Active After Boot: Enabled
  - Remote Console Flow Control: Hardware
- d. Press Esc twice to exit the **Remote Console Redirection** and **Devices and I/O Ports** sections of the Configuration/Setup Utility program.

**Note:** Do not use Planar Ethernet 1 for PXE/DHCP booting or installation.

- e. Select **Start Options**; then, set **Planar Ethernet PXE/DHCP** to one of the following settings:
  - Disabled
  - Planar Ethernet 2. If you set Planar Ethernet PXE/DHCP to Planar Ethernet 2, you must also set Run PXE only on selected Planar NIC to Enabled.
- f. Press Esc to exit the **Start Options** section of the Configuration/Setup Utility program.
- g. Select Save Settings; then, press Enter.
- h. Press Enter to confirm.
- i. Select Exit Setup; then, press Enter.
- j. Make sure that Yes, exit the Setup Utility is selected; then, press Enter.

### Linux configuration

For SOL operation on the server, you must configure the Linux operating system to expose the Linux initialization (booting) process. This enables users to log in to the Linux console through an SOL session and directs Linux output to the serial console. See the documentation for your specific Linux operating-system type for information and instructions.

Use one of the following procedures to enable SOL sessions for your Linux operating system. You must be logged in as a root user to perform these procedures.

#### Red Hat Enterprise Linux ES 2.1 configuration:

**Note:** This procedure is based on a default installation of Red Hat Enterprise Linux ES 2.1. The file names, structures, and commands might be different for other versions of Red Hat Linux.

Complete the following steps to configure the general Linux parameters for SOL operation when using the Red Hat Enterprise Linux ES 2.1 operating system.

- **Note:** Hardware flow control prevents character loss during communication over a serial connection. You must enable it when using a Linux operating system.
- 1. Add the following line to the end of the # Run gettys in standard runlevels section of the /etc/inittab file. This enables hardware flow control and enables users to log in through the SOL console.

 Add the following line at the bottom of the /etc/securetty file to enable a user to log in as the root user through the SOL console: ttyS1

  - b. In the Boot Entries section, locate the boot entry ID for the section with an OS friendly name of Windows Server 2003, Standard. Write down the boot entry ID for use in the next step.
- To enable the Microsoft Windows Emergency Management System (EMS), at a Windows command prompt, type bootcfg /EMS ON /PORT COM1 /BAUD 19200 /ID boot\_id

where *boot\_id* is the boot entry ID from step 1b; then, press Enter.

- 3. Complete the following steps to verify that the EMS console is redirected to the COM2 serial port:
  - a. Type bootcfg at a Windows command prompt; then, press Enter to display the current boot options for your server.
  - b. Verify the following changes to the bootcfg settings:
    - In the Boot Loader Settings section, make sure that redirect is set to COM2 and that redirectbaudrate is set to 19200.
    - In the Boot Entries section, make sure that the OS Load Options: line has /redirect appended to the end of it.

The utility starts automatically when the server is started. You can also locate the /ect/init.d directory to start the utility and use the following commands to manage the utility:

smbridge status smbridge start smbridge stop smbridge restart

Use the baseboard management controller utility programs to configure the baseboard management controller, download firmware updates and SDR/FRU updates, and remotely manage a network.

# Using the baseboard management controller configuration utility program

Use the baseboard management controller configuration utility program to view or change the baseboard management controller configuration settings. You can also use the utility program to save the configuration to a file for use on multiple servers.

Go to http://www.ibm.com/pc/support/ to download the utility program; then, copy the bmc\_cfg.exe file to a configuration utility diskette.

Complete the following steps to start the baseboard management controller configuration utility program:

- 1. Insert the configuration utility diskette into the diskette drive and restart the server.
- 2. From a command-line prompt, type bmc\_cfg and press Enter.
- 3. Follow the instructions on the screen.

# Using the baseboard management controller firmware update utility program

Use the baseboard management controller firmware update utility program to download a baseboard management controller firmware update or a SDR/FRU update. The firmware update utility program updates the baseboard management controller firmware or SDR/FRU data only and does not affect any device drivers.

Go to http://www.ibm.com/pc/support/ to download the utility program; then, copy the Flash.exe file to a firmware update diskette.

**Note:** To ensure proper server operation, be sure to update the server baseboard management controller firmware before updating the BIOS code.

To update the firmware, if the Linux or Windows operating-system update package is available from the World Wide Web and you have obtained the applicable update package, follow the instructions that come with the update package.

### Using the OSA SMBridge management utility program

Use the OSA SMBridge management utility program to remotely manage and configure a network. The utility program provides the following remote management capabilities:

#### • CLI (command-line interface) mode

Use CLI mode to remotely perform power-management and system identification control functions over a LAN or serial port interface from a command-line interface. Use CLI mode also to remotely view the System Event/Error log.

Use the following commands in CLI mode:

- identify
  - Control the system-locator LED on the front of the server.
- power

Turn the server on and off remotely.

– sel

Perform operations with the System Event/Error log.

- sysinfo

Display general system information that is related to the server and the baseboard management controller.

Serial over LAN

Use the Serial over LAN capability to remotely perform control and management functions over a Serial over LAN (SOL) network. You can also use SOL to remotely view and change the server BIOS settings.

At a command prompt, type telenet localhost 623 to access the SOL network. Type help at the smbridge> prompt for more information.

Use the following commands in an SOL session:

– connect

Connect to the LAN. Type connect -ip *ip\_address* -u *username* -p *password*.

- identify

Control the system-locator LED on the front of the server.

power

Turn the server on and off remotely.

- reboot

Force the server to restart.

sel get

Display the System Event/Error log.

– sol

Configure the SOL function.

sysinfo

Display system information that is related to the server and the globally unique identifier (GUID).

# Using the SCSISelect Utility program for Adaptec HostRAID configuration

Use the SCSISelect Utility program to add RAID level-0, level-1, and level-10 functionality with the option of a hot-spare drive to the SCSI controller with integrated RAID. Installing a ServeRAID-7k enables the SCSI controller to provide additional RAID levels. This utility is part of the BIOS code in the server.

The SCSI RAID feature comes disabled by default. You must enable it and install the device drivers before you can use it. SCSI RAID configuration utilities, device drivers, and information are available on the *ServeRAID-7e (Adaptec HostRAID) Support* CD. If this CD did not come with your server, you can download it from http://www.ibm.com/pc/support/.

## **Enabling the SCSI HostRAID feature**

Complete the following steps to enable the SCSI HostRAID feature:

- 1. Turn on the server.
- 2. When the prompt Press <CTRL><A> for SCSISelect Utility appears, press Ctrl+A. If you have set an administrator password, you are prompted to type the password.
- 3. Use the arrow keys to select the channel for which you want to change settings and press Enter.
- 4. Select Configure/View SCSI Controller Setting; then, select HostRAID.
- 5. Select Enabled.
- 6. Press Esc; then, select **Yes** to save the changes.

You can use the SCSISelect Utility program to view information about the SCSI controller. From the list of available arrays, select an array and press Enter. Press Esc to exit the utility.

## Using the SCSISelect Utility program

Use the SCSISelect Utility program to view or change SCSI controller settings and view SCSI ID assignments.

Complete the following steps to start the SCSISelect Utility program:

1. Turn on the server.

- 2. When the message Press <CTRL><A> for SCSISelect Utility appears, press Ctrl+A. If an administrator password has been set, you are prompted to type the password.
- 3. Select the channel for which you want to change settings, and press Enter.
- 4. When the message Would you like to configure the SCSI controller, or run the SCSI Disk Utilities? appears, select a choice and press Enter.
- 5. Use the arrow keys to select a choice from the menu, and follow the instructions on the screen.

# **Chapter 5. Updating IBM Director**

If you plan to use IBM Director to manage your server, you must check for the latest applicable IBM Director updates and interim fixes.

Complete the following steps to install the IBM Director updates and any other applicable updates and interim fixes:

- 1. Check for the latest version of IBM Director:
  - a. Go to http://www.ibm.com/pc/us/eserver/xseries/systems\_management/dwnl.html.
  - b. If a newer version of IBM Director than what comes with the server is shown in the drop-down list, follow the instructions on the Web page to download the latest version.
- 2. Install the IBM Director program.
- 3. Download and install any applicable updates or interim fixes for your server:
  - a. Go to http://www.ibm.com.
  - b. Click Support & downloads.
  - c. Click Downloads & drivers.
  - d. In the search field, type director 8840 and click Submit.
  - e. Select any applicable update or interim fix that you want to download.
  - f. Click the file link for the executable file to download the file, and follow the instructions in the readme file to install the update or interim fix.
  - g. Repeat steps 3e and 3f for any additional updates or interim fixes that you want to install.

# **Chapter 6. Solving problems**

This chapter provides basic troubleshooting information to help you solve some common problems that might occur while you are setting up the server.

If you cannot locate and correct the problem using the information in this section, see Appendix A, "Getting help and technical assistance," on page 63, the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD, and the "Server Support" flowchart in the front of this document.

### **Diagnostic tools overview**

The following tools are available to help you diagnose and solve hardware-related problems:

#### POST beep codes

The power-on self-test beep codes indicate the detection of a problem.

- One beep indicates successful completion of POST, with no errors.
- More than one beep indicates that POST detected a problem. Error messages also appear during startup if POST detects a hardware-configuration problem.

See "POST beep code descriptions" and the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD for more information.

#### Troubleshooting charts

These charts list problem symptoms and steps to correct the problems. See "Troubleshooting charts" on page 55 for more information.

#### Diagnostic programs and error messages

The system diagnostic programs are provided in ROM. These programs test the major components of your server. See the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD for more information.

#### Light path diagnostics

Use light path diagnostics to diagnose system errors quickly. See "Light path diagnostics" on page 60 for more information.

## **POST beep code descriptions**

POST emits one beep to signal successful completion. If POST detects a problem during startup, other beep codes might occur. You can use the following beep code descriptions to help identify and resolve problems that are detected during startup.

**Note:** See the *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *xSeries Documentation* CD for more information about the POST beep codes.

#### One beep

POST was completed successfully without finding any errors.

#### One long beep and two short beeps

A video error has occurred, and the BIOS cannot initialize the monitor screen to display additional information.

#### Other beep codes

Additional beep codes are listed in the following table.

#### Table 5. POST beep code descriptions

Beep code	Description	
No beep	Call for service.	
One short	POST was completed successfully. One beep also occurs after POST if you enter an incorrect password.	
Two short	Follow the instructions that appear on the screen.	
Repeating three short	POST detected a system memory error. Make sure that the memory is installed correctly. If it is, replace the failing memory module.	
Repeating short	<ol> <li>The system board might contain a failing component. Complete the following steps:</li> <li>Make sure that the keyboard and pointing devices are connected correctly.</li> <li>Make sure that nothing is resting on the keyboard.</li> <li>Disconnect the pointing device; then, restart the server. If the problem is corrected, replace the pointing device. If the problem remains, call for service.</li> </ol>	
All other beep codes	<ol> <li>Make sure that the system memory modules are installed correctly.</li> <li>Turn off the server; then, restart the server. If the problem remains, call for service.</li> </ol>	

# **POST error messages**

POST message	Failing device or problem found	Suggested action
161	The real-time clock battery has failed.	Replace the battery or call for service.
162	A device configuration has changed.	<ul> <li>Run the Configuration/Setup Utility program; then, exit, saving the configuration settings.</li> <li>Make sure that optional devices are turned on and installed correctly.</li> </ul>
163	The time of day has not been set.	Set the date and time.
289	A failing DIMM was disabled.	Make sure that the DIMMs are supported by the server and that they are installed correctly.
301, 303	Keyboard and keyboard controller	Make sure that the keyboard cable is connected and that nothing is resting on the keyboard keys.
1162	Serial port configuration conflict	Run the Configuration/Setup Utility program and make sure that the IRQ and I/O port assignments that are needed by the serial port are available.
00019 <i>xxx</i>	Microprocessor <i>x</i> is not functioning or failed the built-in self-test.	Make sure that microprocessor $x$ is installed correctly. If the problem remains, replace microprocessor $x$ .
00180 <i>xxx</i>	PCI device error	Make sure that all PCI adapters are installed correctly. In the Configuration/Setup Utility program, make sure that all PCI devices are enabled. Disable option ROMs and integrated devices that are not needed and set the PCI device boot priority to ensure that the boot device option ROM is able to load.
012980 <i>xx</i>	Data for microprocessor x	Download and install the latest level of BIOS code.
012981 <i>xx</i>		
1962	POST could not find an operating system.	Install an operating system.

The following table lists problem symptoms and suggested solutions.

Table 7. ServerGuide Setup and Installation CD

Symptom	Suggested action
The ServerGuide Setup and Installation CD will not start.	<ul> <li>Make sure that the server supports the ServerGuide program and has a startable (bootable) CD-ROM (or DVD-ROM) drive.</li> <li>If the startup (boot) sequence settings have been altered, make sure that the CD-ROM drive is first in the startup sequence.</li> <li>If more than one CD-ROM drive is installed, make sure that only one drive is set as the primary drive. Start the CD from the primary drive.</li> </ul>
The SCSI RAID program cannot view all installed drives, or the operating system cannot be installed.	<ul> <li>Make sure that there are no duplicate SCSI IDs or IRQ assignments.</li> <li>Make sure that the hard disk drive is connected correctly.</li> </ul>
The operating-system installation program continuously loops.	Make more space available on the hard disk.
The ServerGuide program will not start the operating-system CD.	Make sure that the operating-system CD is supported by the ServerGuide program. See the <i>ServerGuide Setup and Installation</i> CD label for a list of supported operating-system versions.
The operating system cannot be installed; the option is not available.	Make sure that the operating system is supported on your server. If the operating system is supported, either there is no logical drive defined (SCSI RAID systems) or the ServerGuide System Partition is not present. Run the ServerGuide program and make sure that setup is complete.

If you cannot find the problem in these charts, run the diagnostic programs. If you have run the diagnostic programs or if running the tests does not reveal the problem, call for service.

## **DVD-ROM drive problems**

Symptom	Suggested action
The DVD-ROM drive is not recognized.	<ul> <li>Make sure that:</li> <li>The IDE channel to which the DVD-ROM drive is attached (primary or secondary) is enabled in the Configuration/Setup Utility program. If the server has a single IDE channel, only the primary channel can be used.</li> <li>All cables and jumpers are installed correctly.</li> <li>The correct device driver is installed for the DVD-ROM drive.</li> <li>If the problem remains, call for service.</li> </ul>
A DVD is not working correctly.	Clean the DVD.
	If the problem remains, call for service.
The DVD-ROM drive tray is not working.	The server must be turned on for the DVD-ROM tray to work. Insert the end of a straighten paper clip into the manual tray-release opening.
	If the problem remains, call for service.

## **Diskette drive problems**

Symptom	Suggested action
The diskette drive activity LED stays lit, or the server bypasses the diskette drive.	<ul> <li>If there is a diskette in the drive, make sure that:</li> <li>The diskette drive cables are correctly and securely connected.</li> <li>The diskette drive is enabled in the Configuration/Setup Utility program.</li> <li>The diskette is good and not damaged. (Try another diskette if you have one.)</li> <li>The diskette contains the necessary files to start the server.</li> <li>Your software program is working properly.</li> <li>If the problem remains, call for service.</li> </ul>

## **Expansion enclosure problems**

Symptom	Suggested action
The SCSI expansion enclosure used to work but does not work now.	<ul> <li>Make sure that:</li> <li>The cables for all external SCSI options are connected correctly.</li> <li>The last device in each SCSI chain, or the end of the SCSI cable, is terminated correctly.</li> <li>Any external SCSI devices are turned on. You must turn on external SCSI devices before turning on the server.</li> <li>For more information, see your SCSI expansion enclosure documentation.</li> </ul>

# **General problems**

Symptom	Suggested action
A cover lock is broken, an LED is not working, or a similar problem has occurred.	Call for service.

# Hard disk drive problems

Symptom	Suggested action
Not all drives are recognized by the hard disk drive diagnostic test (the Fixed Disk test).	<ol> <li>Remove the first drive that is not recognized and try the hard disk drive diagnostic test again.</li> <li>If the remaining drives are recognized, replace the drive that you removed with a new one.</li> </ol>
The server stops responding during the hard disk drive diagnostic test.	<ol> <li>Remove the hard disk drive that was being tested when the server stopped responding and try the diagnostic test again.</li> <li>If the hard disk drive diagnostic test runs successfully, replace the drive that you removed with a new one.</li> </ol>

# Intermittent problems

Symptom	Suggested action
A problem occurs only occasionally and is difficult to diagnose.	<ul> <li>Make sure that:</li> <li>All cables and cords are connected securely to the rear of the server and attached devices.</li> <li>When the server is turned on, air is flowing from the rear of the server at the fan grille. If there is no airflow, the fan is not working. This can cause the server to overheat and shut down.</li> <li>The SCSI bus and devices are configured correctly and the last external device in each SCSI chain is terminated correctly.</li> <li>If the problem remains, call for service.</li> </ul>

# Keyboard, mouse, or pointing-device problems

Symptom	Suggested action
All or some keys on the keyboard do not work.	• Make sure that the keyboard cable is securely connected to the server and that the keyboard and mouse cables are not reversed.
	Make sure that the server and the monitor are turned on.
	Try using another keyboard.
	If the problem remains, call for service.
The mouse or pointing device does not work.	• Make sure that the mouse or pointing-device cable is securely connected to the server and that the keyboard and mouse cables are not reversed.
	Make sure that the mouse device drivers are installed correctly.
	Make sure that the server and the monitor are turned on.
	Try using another mouse or pointing device.
	If the problem remains, call for service.

## **Memory problems**

Symptom	Suggested action
The amount of system memory that is displayed is less than the amount of installed physical memory.	<ul> <li>Make sure that:</li> <li>The DIMMs are seated correctly.</li> <li>You have installed the correct type of memory.</li> <li>If you changed the memory, you updated the memory configuration in the Configuration/Setup Utility program.</li> <li>All banks of memory are enabled. The server might have automatically disabled a memory bank when it detected a problem, or a memory bank might have been manually disabled.</li> <li>Memory mirroring and online-spare memory are disabled.</li> <li>Check the POST error log for error message 289:</li> <li>If the DIMM was disabled by a system-management interrupt (SMI), replace the DIMM.</li> <li>If the DIMM was disabled by the user or by POST, run the Configuration/Setup Utility program and enable the DIMM.</li> <li>If this error remains, replace the DIMM.</li> </ul>

# **Microprocessor problems**

Symptom	Suggested action
The server emits a continuous tone during POST.	The startup (boot) microprocessor is not working correctly. Make sure that the startup microprocessor is seated correctly. If it is, replace the startup microprocessor. If the problem remains, call for service.

## **Monitor problems**

Some IBM monitors have their own self-tests. If you suspect a problem with your monitor, see the information that comes with the monitor for instructions for testing and adjusting the monitor. If you cannot diagnose the problem, call for service.

Symptom	Suggested action
The screen is blank.	<ul> <li>Make sure that:</li> <li>The server power cord is connected to the server and a working electrical outlet.</li> <li>The monitor cables are connected correctly.</li> <li>The monitor is turned on and the brightness and contrast controls are adjusted correctly.</li> </ul>
	<b>Important:</b> In some memory configurations, the 3-3-3 beep code might sound during POST, followed by a blank monitor screen. If this occurs and the <b>Boot Fail Count</b> feature in the <b>Start Options</b> of the Configuration/Setup Utility program is enabled (its default setting), you must restart the server three times to force the BIOS to reset the configuration settings to the default configuration (the memory connector or bank of connectors enabled).
	If the problem remains, call for service.
Only the cursor appears.	Call for service.

Symptom	Suggested action
The monitor works when you turn on the server, but the screen goes blank when you start some application programs.	Make sure that you have installed the necessary device drivers for the application programs. If the problem remains, call for service.
The monitor has screen jitter, or the screen image is wavy, unreadable, rolling, or distorted.	<ul> <li>If the monitor self-tests show that the monitor is working correctly, consider the location of the monitor. Magnetic fields around other devices (such as transformers, appliances, fluorescent lights, and other monitors) can cause screen jitter or wavy, unreadable, rolling, or distorted screen images. If this happens, turn off the monitor.</li> <li>Attention: Moving a color monitor while it is turned on might cause screen discoloration.</li> <li>Move the device and the monitor at least 300 mm (12 in.) apart, and turn on the monitor.</li> <li>Notes: <ol> <li>To prevent diskette drive read/write errors, make sure that the distance between the monitor and diskette drives is at least 75 mm (3 in.).</li> <li>Non-IBM monitor cables might cause unpredictable problems.</li> <li>An enhanced monitor cable with additional shielding is available for the 9521 and 9527 monitors. For information about the enhanced monitor cable, contact your IBM marketing representative or authorized reseller.</li> </ol> </li> </ul>
	If the problem remains, call for service.

# **Option problems**

Symptom	Suggested action
An IBM option that was just installed does not work.	<ul> <li>Make sure that:</li> <li>The option is designed for the server. See the "Server Support" flowchart for information about obtaining ServerProven compatibility information from the World Wide Web.</li> <li>You followed the installation instructions that come with the option.</li> <li>The option is installed correctly.</li> <li>You have not loosened any other installed options or cables.</li> <li>You have updated the configuration information in the Configuration/Setup Utility program. Whenever memory or an option is changed, you must update the configuration.</li> </ul>
	If the problem remains, call for service.
An IBM option that used to work does not work now.	<ul> <li>Make sure that all of the option hardware and cable connections are secure.</li> <li>If the option comes with test instructions, use those instructions to test the option.</li> <li>If the failing option is a SCSI device, make sure that: <ul> <li>The cables for all external SCSI options are connected correctly.</li> <li>The last device in each SCSI chain, or the end of the SCSI cable, is terminated correctly.</li> <li>Any external SCSI devices are turned on. You must turn on external SCSI devices before turning on the server.</li> </ul> </li> </ul>
	If the problem remains, call for service.

# **Power problems**

Symptom	Suggested action
The server does not turn on.	<ul> <li>Make sure that the server power cord is connected to the server and a working electrical outlet.</li> <li>Make sure that the type of memory that is installed is supported by the server.</li> <li>If you just installed an option, remove it, and restart the server. If the server now turns on, you might have installed more options than the power supply supports.</li> <li>If the problem remains, call for service.</li> </ul>
The server does not turn off.	<ul> <li>Determine whether you are using an ACPI or non-ACPI operating system.</li> <li>If you are using a non-ACPI operating system, complete the following steps:</li> <li>1. Press Ctrl+Alt+Delete.</li> <li>2. Turn off the server by using the power-control button. You might have to press and hold the power-control button for 5 seconds to force the server to turn off.</li> <li>If the problem remains or if you are using an ACPI operating system, call for service.</li> </ul>

# Serial port problems

For more information about the serial port, see the *Option Installation Guide* on the IBM *xSeries Documentation* CD.

Symptom	Suggested action
The number of serial ports that are identified by the operating system is less than the number of installed serial ports.	<ul> <li>Make sure that:</li> <li>Each port is assigned a unique address in the Configuration/Setup Utility program and none of the serial ports is disabled.</li> <li>The serial port adapter, if you installed one, is seated correctly.</li> <li>If the problem remains, call for service.</li> </ul>
A serial device does not work.	<ul> <li>Make sure that:</li> <li>The device is compatible with the server.</li> <li>The serial port is enabled and is assigned a unique address.</li> <li>The device is connected to the serial port.</li> <li>The serial port is assigned to the system.</li> <li>If the problem remains, call for service.</li> </ul>

# Software problems

Symptom	Suggested action
You suspect a software problem.	<ul> <li>To determine whether the problem is caused by the software, make sure that:</li> <li>Your server has the minimum memory needed to use the software. For memory requirements, see the information that comes with the software. If you have just installed an adapter or memory, the server might have a memory-address conflict.</li> <li>The software is designed to operate on the server.</li> <li>Other software works on the server.</li> <li>The software works on another server.</li> </ul>
	If you received any error messages when using the software, see the information that comes with the software for a description of the messages and suggested solutions to the problem. If the problem remains, contact your place of purchase of the software.


## **Universal Serial Bus device problems**

Symptom	Suggested action
A USB device does not work.	<ul> <li>Make sure that:</li> <li>You are not trying to use a USB device during POST if a standard (non-USB) keyboard is connected to the keyboard connector. If a standard (non-USB) keyboard is connected to the keyboard connector, the USB is disabled, and no USB device will work during POST.</li> <li>The correct USB device driver is installed.</li> <li>Your operating system supports USB devices.</li> <li>If the problem remains, call for service.</li> </ul>

## Light path diagnostics

Use light path diagnostics to diagnose system errors. The light path diagnostics panel is inside the light path diagnostics drawer, on the right front of the server. To access the light path diagnostics panel, slide the latch to the left on the front of the light path diagnostics drawer.

The following illustration shows the controls and LEDs on the light path diagnostics panel.



To acknowledge a system error but not take immediate action, press the remind button and place light path diagnostics in remind mode. When the server is in Remind mode, the system-error LED on the front of the server flashes. If a new failure occurs, the system-error LED is lit again.

Press the reset button to reset the server and run the power-on self-test (POST). You might have to use a pen or the end of a straightened paper clip to press the button.

The server is designed so that LEDs remain lit when the server is connected to an ac power source but is not turned on, provided that the power supply is operating correctly. This feature helps you to isolate the problem when the operating system is shut down.

# Diagnosing problems using light path diagnostics

LEDs in two locations on the server are available to help you diagnose problems that might occur during installation. Use them in the following order:

- 1. Light path diagnostics panel Look at this panel first. If a system error has occurred, the system-error LED on the front of the light path diagnostics drawer is lit. Slide the latch to the left on the front of the light path diagnostics drawer to access the light path diagnostics panel. Note any LEDs that are lit, and then close the drawer.
- 2. **LEDs on the system board** To identify the component that is causing the error, note the lit LED on or beside the component.

# Light path diagnostics LEDs

The following table lists the LEDs on the light path diagnostics panel, the problems that they indicate, and actions to solve the problems.

LED	Problem	Action
None	An error has occurred and cannot be diagnosed, or the ASM processor has failed. The error is not represented by a light path diagnostics LED.	Check the system error log for information about the error.
OVER SPEC	The power supplies are using more power than their maximum rating.	Replace the failing power supply, or remove optional devices from the server.
PS 1	When the LED is lit, the power supply in bay 1 has failed. When the LED flashes, an invalid power-supply configuration has occurred.	If the power supply has failed, call for service. If a configuration error has occurred, make sure that the power supply is installed correctly.
PS 2	When the LED is lit, the power supply in bay 2 has failed. When the LED flashes, an invalid power-supply configuration has occurred.	If the power supply has failed, call for service. If a configuration error has occurred, make sure that the power supply is installed correctly.
CPU	When the LED is lit, a microprocessor has failed. When the LED flashes, an invalid microprocessor configuration has occurred.	If a lit LED on the system board indicates a problem with a microprocessor, make sure that the microprocessor is installed correctly. See the <i>Option Installation Guide</i> on the IBM <i>xSeries Documentation</i> CD for information about installing a microprocessor.
		If the problem remains, call for service.
		If a configuration error has occurred, make sure that the microprocessors have the same cache size and type, and the same clock speed. Microprocessor internal and external clock frequencies must be identical.
VRM	When the LED is lit, an error occurred on the microprocessor voltage regulator module (VRM). When the LED flashes, an invalid VRM configuration has occurred.	Replace the VRM. If the problem remains, call for service. If a configuration error has occurred, make sure that the VRM is installed correctly. If the problem remains, replace the VRM.
CNFG	When the LED flashes, a hardware configuration error has occurred.	Check the system error log for information about the error. The light path diagnostic LED for the component that is causing the configuration error also flashes.
MEM	When the LED is on, a memory error has occurred. When the LED flashes, an invalid DIMM configuration has occurred.	Replace the failing DIMM, which is indicated by the lit LED on the system board. If a configuration error has occurred, make sure the DIMMs are installed correctly.

LED	Problem	Action
NMI	A machine check error has occurred.	Check the system error log for information about the error.
S ERR	A soft error has occurred.	Check the system error log for information about the error.
SP	The service processor has failed.	Remove ac power from the server; then, reconnect the server to ac power and restart the server. If the problem remains, call for service.
DASD	A hard disk drive error has occurred.	Check the LEDs on the hard disk drives and replace the indicated drive.
RAID	A RAID controller error has occurred.	Check the system error log for information about the error. See the documentation that comes with the RAID controller.
FAN	When the LED is lit, a fan has failed or is operating too slowly. A failing fan can also cause the TEMP LED to be lit.	Replace the failing fan, which is indicated by the lit LED. If a configuration error has occurred, make sure that the fans are installed correctly.
	When the LED flashes, an invalid fan configuration has occurred.	
TEMP	The system temperature has exceeded a threshold level.	<ul> <li>Determine whether a fan has failed. If it has, replace it.</li> <li>Make sure that the room temperature is not too high. See the <i>User's Guide</i> on the IBM <i>xSeries Documentation</i> CD for temperature information.</li> <li>Make sure that the air vents are not blocked.</li> </ul>
		If the problem remains, call for service.
BRD	An error has occurred on the system board.	<ul><li>Check the LEDs on the system board to identify the component that is causing the error.</li><li>Check the system error log for information about the error.</li></ul>
PCI A PCI B PCI C	An error has occurred on a PCI bus.	<ul> <li>Check the system error log for information about the error.</li> <li>If you cannot isolate the failing adapter through the information in the system error log, remove one adapter at a time from the failing PCI bus, and restart the server after each adapter is removed.</li> </ul>
		If the problem remains, call for service.

# Appendix A. Getting help and technical assistance

- Go to the IBM Support Web site at http://www.ibm.com/pc/support/ to check for technical information, hints, tips, and new device drivers or to submit a request for information.

You can solve many problems without outside assistance by following the troubleshooting procedures that IBM provides in the online help or in the publications that are provided with your system and software. The information that comes with your system also describes the diagnostic tests that you can perform. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

#### What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. Unless IBM specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

#### What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

#### How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.


