



Chapter 1. Introduction

Thank you for purchasing an IBM® @server xSeries $^{\text{TM}}$ 205 Type 8480 server with IBM X-Architecture $^{\text{TM}}$ technologies. This *Installation Guide* contains instructions for setting up your IBM xSeries 205 Type 8480 server and basic instructions for installing some options. More detailed instructions are in the *Option Installation Guide* on the IBM *xSeries Documentation* CD, which comes with your server. This publication contains information about:

- Setting up and cabling your server
- Starting and configuring your server
- Installing your operating system

Packaged with this Installation Guide are software CDs that you can use to configure the hardware, install device drivers, and install the operating system.

Also included is an IBM Documentation CD that contains detailed information about this server.

If you have access to the World Wide Web, you can obtain up-to-date information about your server and other IBM server products at http://www.ibm.com/eserver/xseries/.



Major components of the xSeries 205 Type 8480


The following illustration shows the locations of major components in your server.

Chapter 2. Installing options

This chapter provides basic instructions for installing hardware options in your server. These instructions are intended for users who are experienced with setting up IBM server hardware. If you need more detailed instructions, see the *Option Installation Guide* on the IBM *xSeries Documentation* CD.

Installation guidelines

Before you begin installing options in your server, read the following information:

- Read the guidelines in "Handling static-sensitive devices" on page 6, and read the safety statements in "Safety" on page v. This information will help you work safely with your server and options.
- Make sure that you have an adequate number of properly grounded electrical outlets for your server, monitor, and other devices that you will connect to the server.
- Back up all important data before you make changes to disk drives.
- Have a small flat-blade screwdriver available.
- Before accessing the inside of the server, rotate the two front stabilizing feet a
 quarter turn inward toward the server, so that they do not break. Before returning
 the server to an upright position, rotate the front stabilizing feet a quarter turn
 outward from the server.
- For a list of supported options for your server, go to http://www.ibm.com/pc/compat/ on the World Wide Web.

System reliability guidelines

To help ensure proper system cooling and system reliability, make sure that:

- Each of the drive bays has a drive or a filler panel and electromagnetic compatibility (EMC) shield installed in it.
- There is adequate space around the server to allow the server cooling system to work properly. Leave approximately 50 mm (2 in.) of open space around the front and rear of the server. Do not place objects in front of the fans.
- You have followed the cabling instructions that come with optional adapters.
- You have replaced a failed fan as soon as possible.

Working inside the server with the power on

Your server supports hot-plug, hot-add, and hot-swap devices and is designed to operate safely while it is turned on and the cover is removed. Follow these guidelines when you work inside a server that is turned on:

- Avoid wearing loose-fitting clothing on your forearms. Button long-sleeved shirts before working inside the server; do not wear cuff links while you are working inside the server.
- Do not allow your necktie or scarf to hang inside the server.
- Remove jewelry, such as bracelets, necklaces, rings, and loose-fitting wrist watches.
- Remove items from your shirt pocket, such as pens and pencils, that could fall into the server as you lean over it.
- Avoid dropping any metallic objects, such as paper clips, hairpins, and screws, into the server.

Handling static-sensitive devices

Attention: Static electricity can damage electronic devices, including your server. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of damage from electrostatic discharge, observe the following precautions:


- Limit your movement. Movement can cause static electricity to build up around
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed circuitry.
- Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the server for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the server without setting down the device. If it is necessary to set down the device, place it back into its static-protective package. Do not place the device on your server cover or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

Moving the stabilizing feet

When the four feet on the bottom of the server are in the stabilizing position, they provide additional stability.

Complete the following steps to place the feet in the stabilizing position:


- 1. Place the server on its side.
- 2. Locate the release tab inside the foot; then, lift up on the tab. The following illustration shows the rear feet on the bottom rear of the server.



3. Rotate the foot inward to the unlocked position; then, remove the foot from the server.

4. Align the post in the center of the foot with the hole on the bottom of the server and place the foot between the guides as indicated.

The following illustration shows the rear feet on the bottom rear of the server.




- 5. Rotate the foot outward until the foot locks into place.
- 6. Complete steps through for each foot.

Attention: When you need to access the inside of the server to install options, you might find it easier to lay the server on its side. If you do so, make sure the feet are in the horizontal position (see the previous steps). Otherwise, the feet might break off from the server because of the weight of the server.

Removing the side cover

Complete the following steps to remove the side cover of the server:

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server and peripheral devices and disconnect all external cables and power cords.
- 3. If necessary, unlock the side cover.
- 4. Pull out on the cover-release latch, which will slide the side cover toward the rear of the server approximately 12.7 mm (0.5 in.). Then, remove the side cover from the server and set it aside.



To replace the side cover, see "Installing the side cover" on page 25.


Attention: For proper cooling and airflow, replace the side cover before turning on the server. Operating the server with the side cover removed might damage server components.

Removing the frame-support bracket

When working with some options such as hard disk drives, microprocessors, and memory modules, you must first remove the frame-support bracket to access the location of the option.

Complete the following steps to remove the frame-support bracket:

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server and peripheral devices and disconnect all external cables and power cords; then, remove the side cover. See "Removing the side cover" on page 8 for details.
- 3. Pull the end of the frame-support-bracket out approximately 152.4 mm (6 in.) from the rear of the server.
- 4. Pull the front end of the frame-support bracket away from the server and place the assembly aside.




To reinstall the frame-support bracket, reverse these steps.

Working with adapters

Your server comes with five PCI adapter connectors, or *slots* and one AGP slot. You can install one AGP video adapter in the AGP slot. All PCI expansion slots are 32-bit, 33 MHz slots.

The following illustration shows the location of the PCI expansion slots on the system board and PCI extender board.



Adapter considerations

Before you install an adapter, review the following information:

- Locate the documentation that comes with the adapter and follow those
 instructions in addition to the instructions in this chapter. If you need to change
 switch or jumper settings on your adapter, follow the instructions that come with
 the adapter.
- You can install full-length adapters in all five PCI expansion slots.
- Your server supports 5.0 V and universal PCI adapters; it does not support 3.3 V adapters.
- Your server uses a rotational interrupt technique to configure PCI adapters.
 Therefore, you can install a variety of PCI adapters that currently do not support sharing of PCI interrupts.

- If you are installing an adapter that will control your startup (boot) drive, install the adapter in PCI expansion slot 2.
- PCI expansion slots 1 through 5 are on PCI bus 0.

The system scans the AGP slot and PCI expansion slots 1 through 5 to assign system resources; then, the system starts (boots) devices in the following order, if you have not changed the default boot sequence: the AGP slot, PCI expansion slots 1 through 5; then, the system board integrated drive electronics (IDE) or SCSI devices.


Installing an adapter

Complete the following steps to install an adapter.

Attention: When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details about handling these devices, see "Handling static-sensitive devices" on page 6.

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server and peripheral devices and disconnect all external cables and power cords; then, remove the side cover. For more information about removing the side cover, see "Removing the side cover" on page 8.
- 3. Remove the frame-support bracket. See "Removing the frame-support bracket" on page 9.
- 4. If you are installing a full-length adapter, rotate the front adapter-support bracket to the open (unlocked) position.
- 5. Rotate the rear adapter-retaining bracket to the open (unlocked) position, and then remove it from the server.
- 6. Remove the PCI expansion-slot cover. From the rear of the server, press in on the slot cover. Grasp it and pull it out of the slot. Store it in a safe place for future use.
 - Attention: PCI expansion-slot covers must be installed on all vacant slots. This maintains the electronic emissions characteristics of the server and ensures proper cooling of server components.
- 7. Touch the static-protective package containing the adapter to any unpainted metal surface on the server. Then, remove the adapter from the static-protective package. Avoid touching the components and gold-edge connectors on the adapter.
- 8. Place the adapter on a flat, static-protective surface, and set any jumpers or switches as described by the adapter manufacturer.

9. Carefully grasp the adapter by its top edge or upper corners, and align it with the expansion slot guides; then, press the adapter firmly into the PCI expansion slot.



Attention: When you install an adapter in the server, be sure that it is completely and correctly seated in the PCI expansion slot before you turn on the server. Incomplete insertion might cause damage to the system board or the adapter.

10. Connect required cables to the adapter.

Attention: Route cables so that they do not block airflow from the fans.


- 11. If you have another adapter to install, do so now.
- 12. If you have installed a full-length adapter, rotate the front adapter-support bracket to the closed (locked) position.
- 13. Reinstall the rear adapter-retaining bracket; then, rotate the bracket to the closed (locked) position.
- 14. If you have other options to install, do so now.
- 15. Reinstall the side cover (see "Installing the side cover" on page 25 for details).
- 16. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

Installing a SCSI or RAID adapter

Complete the following steps to install a SCSI or RAID adapter:

- 1. If you have not already installed the SCSI adapter, complete steps 1 through 10 of "Installing an adapter" on page 11. Then, return to this procedure to complete the installation.
- 2. Connect one end of the SCSI signal cable (purchased separately) to the adapter; then, connect one or more of the signal cable connectors to the rear of the SCSI devices.
- 3. Connect the SCSI activity indicator cable (purchased separately) to the adapter and to the SCSI LED connector on the system board. See "System-board internal cable connectors" on page 4.


Note: If you are installing an adapter that will control your startup (boot) drive, install the adapter in PCI expansion slot 2.



- 4. If you have another adapter to install, do so now.
- 5. If you have installed a full-length adapter, rotate the front adapter-support bracket to the closed (locked) position.
- 6. Reinstall the rear adapter-retaining bracket; then, rotate the bracket to the closed (locked) position.
- 7. If you have other options to install, do so now.
- 8. Reinstall the frame-support bracket.
- 9. Reinstall the side cover. See "Installing the side cover" on page 25 for details.
- 10. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

Installing internal drives

Your server comes with an IDE CD-ROM drive installed in bay 1 and a 3.5-in., 1.44 MB diskette drive in bay 3. Some models have a hard disk drive installed in bay 5.



Before you install an internal drive, review the following information:

- Diskette drives, tape drives, and CD-ROM drives are removable-media drives. You can install removable-media drives in bays 1, 2, 3, and 4.
- You can install a 3.5-in., slim-high or a 5.25-in., half-high, removable-media drive, such as a tape backup drive, in bay 2.
- You can install only a 3.5-in., slim-high, removable-media drive in bay 4.
- The xSeries 205 server supports only one diskette drive, which uses 1 MB and 2 MB diskettes.
- Before you install a 3.5-in. drive in a 5.25-in. bay, you must attach the 5.25-in. conversion kit, supplied with your option, to the 3.5-in. drive. See the documentation that comes with the option for the conversion kit installation instructions.

Note: Only 3.5-in. options that come with proper mounting hardware are supported in the 5.25-in. bays.

- If you have a tape backup drive in your server, use a dry-process cleaning cartridge to clean the tape head 2 hours after you first use a new data cartridge. Then, clean the tape head once a month, or after each 8 hours of continuous read/write operations, whichever occurs first. For complete details about the tape backup drive, see the documentation that comes with your server or your backup option.
- The electromagnetic interference (EMI) integrity and cooling of the server are both protected by having bays 1 through 4 covered or occupied. When you install a drive, save the EMC shield and filler panel from the bay, in case you later remove the drive and do not replace it with another.

For a list of supported options for your server, go to http://www.ibm.com/pc/compat/ on the World Wide Web.

Preinstallation steps (all bays)

Before you install drives in your server, verify that you have all the cables and any other equipment specified in the documentation that comes with the drive. You might also need to perform certain preinstallation activities. Some of the steps are required only during the initial installation of an option.

- 1. Read "Safety" on page v, "Handling static-sensitive devices" on page 6, and the documentation that comes with your drive.
- 2. Choose the bay in which you want to install the drive.
- 3. Check the instructions that come with the drive to see if you need to set any switches or jumpers on the drive.

Power and signal cables for internal drives

Your server uses cables to connect IDE devices to the power supply and to the system board. The following cables are provided:

- Four-wire power cables connect the drives to the power supply. At the end of these cables are plastic connectors that can be attached to different drives; these connectors vary in size. Also, certain power cables are attached to the system board.
- Flat signal cables, also called ribbon cables, connect IDE and diskette drives to the system board. There are two sizes of ribbon cables that come with your
 - The wider IDE signal cable has two or three connectors.
 - If the cable has three connectors, one of these connectors is attached to the drive, one is a spare, and the third is attached to the primary or secondary IDE connector on the system board.
 - If the cable has two connectors, one of these connectors is attached to the hard disk drive, and the other is attached to the primary or secondary IDE connector on the system board.

Note: The CD-ROM drive is attached to an ATA 66 signal cable. The hard disk drive is attached to an ATA 100 signal cable. ATA 66 and ATA 100 signal cables are color-coded. The blue connector attaches to the system board. The black connector attaches to the primary device. If the cable has a gray middle connector, it attaches to the secondary device. If you are installing a hard disk drive, you must change the switch setting on the CD-ROM drive to secondary and change the connector used for the CD-ROM drive to the gray middle connector.

- The narrower signal cable has two connectors, one to attach to the diskette drive, and the other to attach to the connector (FDD1) on the system board.
- SCSI signal cables connect SCSI devices to a SCSI adapter or to the internal SCSI connector on the extender card (some models). If you have a SCSI adapter installed in your server, the SCSI signal cable has four connectors. One connector is attached to the SCSI connector on the extender card, two connectors are spares, and the fourth connector is attached to a SCSI hard disk drive.

To locate connectors on the system board, see "System-board internal cable connectors" on page 4.

Review the following information before connecting power and signal cables to internal drives:

- The drives that are preinstalled in your server come with power and signal cables attached. If you replace any drives, it is important to remember which cable is attached to which drive.
- When you install a drive, ensure that the drive connector at the end of the signal cable is always connected to a drive, and ensure that the drive connector at the other end is connected to the system board.
- If you have only one IDE device on a cable, it must be set as a primary device.
- If two IDE devices are used on a single cable, one must be designated as the primary device and the other as the secondary device; otherwise, the server might not detect some of the IDE devices. The primary and secondary designation is determined by switch or jumper settings on each IDE device.
- If two IDE devices are on a single cable and only one is a hard disk drive, the hard disk drive must be set as a primary device.
- You must set the SCSI ID for any SCSI device that you install in your server. Each SCSI device has its own methods and considerations for setting the SCSI ID. See the instructions that come with the device for details about setting the SCSI ID for the SCSI device.

Installing a drive in bay 2 or 4

Complete the following steps to install a drive in bay 2 or 4.

Attention: When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details on handling these devices, see "Handling static-sensitive devices" on page 6.

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server and peripheral devices and disconnect the external cables and power cords; then, remove the side cover (see "Removing the side cover" on page 8 for details).
- 3. Remove the frame-support bracket and disconnect the fan cable from the connector on the system board. See "Removing the frame-support bracket" on page 9 for details.
- 4. Use a screwdriver to gently pry the filler panel and EMC shield away from the server.

Note: If you are installing a drive that is a laser product, observe the following safety precaution.

Statement 3



CAUTION:

When laser products (such as CD-ROMs, DVD drives, fiber optic devices, or transmitters) are installed, note the following:

- Do not remove the covers. Removing the covers of the laser product could result in exposure to hazardous laser radiation. There are no serviceable parts inside the device.
- Use of controls or adjustments or performance of procedures other than those specified herein might result in hazardous radiation exposure.



Danger

Some laser products contain an embedded Class 3A or Class 3B laser diode. Note the following. Laser radiation when open. Do not stare into the beam, do not view directly with optical instruments, and avoid direct exposure to the beam.



- 5. Touch the static-protective package containing the drive to any unpainted metal surface on the server; then, remove the drive from the package and place it on a static-protective surface.
- 6. Set any jumpers or switches on the drive according to the documentation that comes with the drive.

7. Install the drive:

- If you are installing a 5.25-in. drive in bay 2, push the drive into the bay. Then, use the two screws that come with your option to attach the drive to the drive cage.
- If you are installing a 3.5-in. drive in bay 2, you must attach the 5.25-in. conversion kit, supplied with your option, to the 3.5-in. drive.

Note: You can install a 3.5-in. device only in bay 4.



- 8. Cable the drive. For details about the power and signal cables for the drive, see "Power and signal cables for internal drives" on page 15.
 - If the drive is an IDE device, plug one connector of the IDE signal cable into the back of the drive and the other end of the cable into the IDE connector (IDE1) on the system board. For the location of the IDE connectors, see "System-board internal cable connectors" on page 4.
 - If the drive is a SCSI device, your server must have a SCSI controller or adapter installed. Plug one connector of the SCSI signal cable into the back of the drive and the other end of the cable into the connector on the SCSI controller or adapter. See "Installing an adapter" on page 11.

Note: Make sure to route the signal cable so that it does not block the airflow to the rear of the drives or over the microprocessor.

- 9. If you have another drive to install or remove, do so now.
- 10. Plug one of the power cables from the power supply into the back of the drive. The connectors are keyed and can be inserted only one way.
- 11. Replace the frame-support bracket.
- 12. If you have other options to install, do so now.
- 13. Reinstall the side cover. See "Installing the side cover" on page 25 for details.

14. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

Installing a non-hot-swap hard disk drive in bay 5, 6, or 7

Complete the following steps to install a hard disk drive in bay 5, 6, or 7.

Attention: When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details on handling these devices, see "Handling static-sensitive devices" on page 6.


- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Read the information in "Preinstallation steps (all bays)" on page 15.
- 3. Turn off the server and peripheral devices and disconnect all external cables and power cords; then, remove the cover (see "Removing the side cover" on page 8 for details).
- 4. Remove the frame-support bracket. See "Removing the frame-support bracket" on page 9 for details.
- 5. Access the drive cage:
 - a. If your server has hard disk drives installed in the drive cage, disconnect the power and signal cables from the rear of the drives.
 - b. Rotate the drive cage out of the server until it locks into place over the drivecage-retention tab.

Note: Before you install a hard disk drive, ensure that the drive cage locks into place over the drive-cage-retention tab by pressing on the side of the drive cage.

- 6. Touch the static-protective package containing the drive to any unpainted metal surface on the server; then, remove the drive from the package and place it on a static-protective surface.
- 7. Set any jumpers or switches on the drive according to the documentation that comes with the drive.
- 8. Attach the blue plastic guide rails to the sides of the drive using the screws and guide rails provided in the drive cage.
- 9. Slide the drive into the drive cage until the plastic tabs on the guide rails lock into place in the drive cage.

10. Press in on the drive-cage-retention tab, and rotate the drive cage back into the

Note: Clear any cables that might impede the replacement of the drive cage.



11. Connect the power and signal cables to the rear of each drive.

Note: Make sure to route the signal cable so that it does not block the airflow to the rear of the drives or over the microprocessor.

- 12. If you have other options to install or remove, do so now.
- 13. Replace the frame-support bracket. See "Removing the frame-support bracket" on page 9 for details.
- 14. Reinstall the side cover. See "Installing the side cover" on page 25 for details.
- 15. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

Installing a hot-swap hard disk drive in bay 5, 6, or 7

If your server is a hot-swap model, you can install or replace a hard disk drive without turning off the server. Therefore, you can continue to operate your system while a hard disk drive is removed or installed. To do this, you must install a hot-swap hard disk drive. If a hot-swap disk drive is connected to an optional controller, such as a RAID controller that supports this function, and if your hot-swap drive becomes defective, the RAID controller can rebuild the data from that drive onto another hotswap drive. See the information that comes with your RAID controller for details.


Each hot-swap drive has two LEDs: the hard disk drive activity LED and the hard disk drive status LED. When the green hard disk drive activity LED is flashing, the controller is accessing the hard disk drive. When this occurs, the hard disk drive activity LED on the front of the server is also lit. If the amber hard disk drive status LED for a drive is lit continuously, that individual drive is faulty and requires

replacement. When the hard disk drive status LED indicates a drive fault, you can replace a hot-swap drive without turning off the server.

Each hot-swap drive that you plan to install comes mounted in a hot-swap-drive tray. The drive must have a single connector attachment (SCA) connector. Hot-swap-drive trays come with hot-swap drives.


The hot-swap bays are connected to a SCSI backplane. This backplane is the printed circuit board behind the bay. The backplane controls the SCSI IDs for the hot-swap drives.

The following illustration shows the hot-swap-drive backplane component locations, as viewed from the front of the server.



Note: The hard disk drive activity LED and hard disk drive status LED on the backplane match the hard disk drive activity LED and hard disk drive status LED on the hot-swap drive.

The following illustration shows the rear connectors on the hot-swap-drive backplane, as viewed from the rear of the server.



Note: When you install hot-swap hard disk drives, install them in the following order: bay 7, bay 6, and bay 5.


Attention:

- When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details on handling these devices, see "Handling staticsensitive devices" on page 6.
- To maintain proper system cooling, do not operate the server for more than 10 minutes without either a drive or a filler panel installed in each bay.

Complete the following steps to install a hot-swap hard disk drive in bay 5, 6, or 7.

Note: You do not have to turn off the server to install hot-swap hard disk drives in these bays.

- Read the information in "Preinstallation steps (all bays)" on page 15.
- Remove the filler panel from one of the empty hot-swap bays by inserting your finger into the depression at the left side of the filler panel and pulling it away from the server.
- 3. Install the hard disk drive in the hot-swap bay:
 - a. Ensure that the tray handle is open (that is, perpendicular to the drive).
 - b. Align the drive-tray assembly with the guide rails in the bay.
 - c. Gently push the drive-tray assembly into the bay until the drive stops.
 - d. Push the tray handle to the closed (locked) position.



e. Check the hard disk drive status LED to verify that the hard disk drive is operating properly.

If the amber disk drive status LED for the drive is lit continuously, that individual drive is faulty and needs to be replaced. If the green hard disk drive activity LED is flashing, the drive is being accessed.

Note: If you install a RAID adapter in your server, you might need to reconfigure your disk arrays after installing hard disk drives. See the information that comes with your RAID adapter.

If you have other options to install, do so now.

Installing memory modules

Your server comes with a dual inline memory module (DIMM) installed on the system board in DIMM connector 1.

Before you install memory modules, review the following information:


- When installing additional memory modules, install the second memory module in DIMM connector 2. (See the illustration on page 24 for memory connector locations.)
- Your xSeries 205 server supports 256 MB, 512 MB, and 1.0 GB DIMMs. Your server supports a minimum of 256 MB and a maximum of 2.0 GB of system memory. See the ServerProven list at http://www.ibm.com/pc/compat/ for a list of memory modules for use with your server.

Complete the following steps to install a DIMM.

Attention: When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details on handling these devices, see "Handling static-sensitive devices" on page 6.

- 1. Review the safety precautions listed in "Safety" on page v.
- 2. Turn off the server and peripheral devices and disconnect all external cables and power cords; then, remove the side cover (see "Removing the side cover" on page 8 for details).
- 3. Remove the frame-support bracket. See "Removing the frame-support bracket" on page 9 for details.
- 4. Touch the static-protective package containing the DIMM to any unpainted metal surface on the server. Then, remove the DIMM from the package.
- 5. Gently open the retaining clip on each end of the DIMM connector. Turn the DIMM so that the pins align correctly with the connector.
- 6. Insert the DIMM into the connector. Firmly press the DIMM straight down into the connector by applying pressure on both ends of the DIMM simultaneously. The retaining clips snap into the locked position when the DIMM is firmly seated in the connector.

7. If there is a gap between the DIMM and the retaining clips, the DIMM has not been properly installed. In this case, open the retaining clips and remove the DIMM; then, reinsert it.



- 8. If you have other options to install or remove, do so now.
- 9. Replace the frame-support bracket. See "Removing the frame-support bracket" on page 9.
- 10. Replace the side cover. See "Installing the side cover" on page 25.
- 11. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

If you want to remove a DIMM, reverse these steps.

Installing a security rope clip

To help prevent hardware theft, you can add a security clip and cable to your server. After you add the security cable, make sure that it does not interfere with other cables that are connected to the server.


Before you begin:

- Obtain the following items:
 - A flat-blade screwdriver
 - An adjustable wrench
 - A 19 mm (0.75 in.) rope clip or wire rope (similar to National Manufacturing No. 3230, Stock No. 176-735)
 - Threaded nuts that fit the rope clip

- A security cable
- A lock, such as a combination lock or padlock
- Read "Safety" on page v and "Handling static-sensitive devices" on page 6.

Complete the following steps to install a rope clip:

- 1. Turn off the server and peripheral devices and disconnect all external cables and power cords; then, remove the side cover (see "Removing the side cover" on page 8 for details).
- 2. Use a screwdriver to remove the two metal knockouts.
- 3. Insert the rope clip through the rear panel; then, attach and tighten the nuts.



- 4. If you have other options to install or remove, do so now.
- 5. Reinstall the side cover. See "Installing the side cover" for details.
- 6. Thread the cable through the rope clip and around an object that is a part of or permanently secured to the building structure or foundation, and from which it cannot be removed; then, fasten the cable ends together with a lock.
- 7. Reconnect the external cables and power cords; then, turn on the peripheral devices and the server.

Installing the side cover


Note: If you removed the frame-support bracket after you removed the side cover, reinstall it before you install the side cover. See "Removing the frame-support bracket" on page 9 for details.

Complete the following steps to install the side cover:

- 1. Clear any cables that might impede the reinstallation of the side cover.
- 2. Install the side cover.

Note: The cover-release latch must be in the unlocked (opened) position before you install the side cover on the server.

- a. Insert the tabs inside the cover into the slots on the server chassis.
- b. Close the cover-release latch to secure the side cover in place.



Note: Make sure each tab on the side cover is in its corresponding slot before closing the cover-release latch.


- 3. Lock the side cover.
- 4. If you have not done so already, make sure the stabilizing feet are in the stabilizing position so that they properly support the server. See "Moving the stabilizing feet" on page 6.
- 5. Reconnect the external cables and power cords to the server, and then plug the power cords into properly grounded electrical outlets.
- 6. Turn on the peripheral devices; then, turn on the server.

Cabling the server

If your server cables and connector panel have color-coded connections, match the color of each cable end with the color of the connector. For example, match a blue

cable end with a blue panel connector, a red cable end with a red connector, and so on.






Your server has one keyboard connector on the back of the server. Use this connector to attach a keyboard or optional concole switch to the server.

You can also connect a USB keyboard to the server using one of the USB connectors. After installing a USB keyboard, you might need to use the Configuration/Setup Utility program to enable keyboardless operation and prevent the POST error message 301 from being displayed during startup. For detailed information about this option and how to connect it to your server, see the documentation that comes with the option.

Chapter 3. Server controls, LEDs, and power

This chapter describes the controls and light-emitting diodes (LEDs) and how to turn the server on and off.

Server controls and LEDs



Ethernet speed 1 Gbps LED: When this LED on the Ethernet (RJ-45) connector is lit, the Ethernet speed is 1 Gbps. When the LED is off, the Ethernet speed is 10 Mbps or 100 Mbps.

Ethernet transmit/receive activity LED: When this LED on the Ethernet (RJ-45) connector is lit, there is activity between the server and the network.

CD-eject button: Push this button to open the tray to insert or remove a CD.

CD-ROM drive activity LED: When this LED is lit, the CD-ROM drive is in use.

Diskette-eject button: Push this button to release a diskette from the drive.

Diskette drive activity LED When this LED is lit, the diskette drive is in use.

Hard disk drive activity LED: When this LED is lit, the hard disk drive is in use.

Power-on LED: This LED is lit when the server is turned on.

Power-control button: Press this button to manually turn the server on or off.

Server power features

When you connect the server to an ac power source, the server goes into Standby mode. After approximately 20 seconds, the power-control button becomes active, and you can turn on the server and start the operating system by pressing the powercontrol button. The following section describes other ways in which the server can be turned on.

A power-control-button shield comes with your server. You can install this disk-shaped shield to prevent the server from being turned off accidentally.

Turning on the server

After the server is connected to an ac power source, it can be turned on in any of the following ways:

- You can press the power-control button.
- If a power failure occurs while the server is turned on, the server will restart automatically when power is restored.
- If your operating system supports the system-management software for an optional Remote Supervisor Adapter, the system-management software can turn on the server.
- If your operating system supports the Wake on LAN® feature, the Wake on LAN feature can turn on the server.

Turning off the server

Some operating systems require an orderly shutdown before you turn off the server. See your operating-system documentation for information about shutting down the operating system.


Statement 5





CAUTION:

The power control button on the device and the power switch on the power supply do not turn off the electrical current supplied to the device. The device also might have more than one power cord. To remove all electrical current from the device, ensure that all power cords are disconnected from the power source.



The server can be turned off in any of the following ways:

- You can press the power-control button to start an orderly shutdown of the operating system, if your operating system supports this feature, and turn off the server.
- If the operating system stops functioning, you can press and hold the powercontrol button for more than 4 seconds to turn off the server.
- If the Wake on LAN feature turned on the server, the Wake on LAN feature can turn off the server.
- You can remove all power from the server by disconnecting the server from the ac power source.

Standby mode

When the server is connected to an ac power source but has not been turned on, it is in Standby mode. When the server is in Standby mode, the operating system is not running, and all core logic except for the service processor is shut down. The poweron LED flashes to indicate that the server is in Standby mode. The server can respond to requests from the service processor, such as a remote request to turn on the server.

To put the server into Standby mode when the server is turned on, shut down the operating system (see your operating-system documentation), and press the powercontrol button.

You can also put the server into Standby mode through a request from the service processor.

Chapter 4. Configuring your server

The following configuration programs are provided with your server.

Configuration/Setup Utility

This program is part of the basic input/output system (BIOS) code that comes with your server. You can use this program to configure serial- and parallel-connector assignments, change the drive startup sequence, set the date and time, and set passwords. For more information about how to start this utility, see "Starting the Configuration/Setup Utility program".

Broadcom NetXtreme Gigabit Ethernet Boot Agent

The Broadcom NetXtreme Gigabit Ethernet Boot Agent is part of the BIOS code that comes with your server. You can enable the Broadcom NetXtreme Gigabit Ethernet Boot Agent in the Configuration/Setup Utility program. The Broadcom NetXtreme Gigabit Ethernet Boot Agent enables you to configure the network option as a startable device and customize where the network appears in your startup sequence.

SCSISelect Utility (some models)

With the SCSISelect Utility program, you can configure the devices that are connected to the optional SCSI controller or adapter. Use this program to change default values, resolve configuration conflicts, and perform a low-level format on a SCSI hard disk drive. For information about how to start this utility, see "Starting the SCSISelect Utility program" on page 34.

ServerGuide Setup and Installation CD

The ServerGuide™ Setup and Installation CD includes software setup and installation tools that are specifically designed for IBM xSeries servers. You can use this CD during the initial installation of your server to configure the server hardware and to simplify your NOS installation. The ServerGuide Setup and Installation CD also contains a collection of application programs that you can install after your server is up and running. See "Using the ServerGuide Setup and Installation CD" on page 34.

See the *User's Guide* on the *IBM xSeries Documentation* CD for detailed instructions for using the configuration programs and *ServerGuide Setup and Installation* CD.

Starting the Configuration/Setup Utility program

The Configuration/Setup Utility program is a menu-driven utility that is part of the BIOS code that comes with your server. You can use it to:

- Configure serial connector assignments
- · Change the drive startup sequence
- Enable USB keyboard and mouse support
- Resolve configuration conflicts
- Set the date and time
- Set passwords

Complete the following steps to start the Configuration/Setup Utility program:

- 1. Turn on the server and watch the monitor screen.
- 2. When the message Press F1 for Configuration/Setup appears, press F1.
- 3. Follow the instructions that appear on the screen.

Starting the Broadcom NetXtreme Gigabit Ethernet Boot Agent program

The Broadcom NetXtreme Gigabit Ethernet Boot Agent is part of the BIOS code that comes with your server. You can enable the Broadcom NetXtreme Gigabit Ethernet Boot Agent in the Configuration/Setup Utility program. You can use the Broadcom NetXtreme Gigabit Ethernet Boot Agent to configure the network as a startable device and customize where the network appears in your startup sequence. For more information about enabling this feature, see the User's Guide on the IBM xSeries Documentation CD.

Starting the SCSISelect Utility program

SCSISelect is a menu-driven configuration utility program for models that come with a SCSI adapter installed. You can use SCSISelect to:

- View the default SCSI IDs
- Locate and correct configuration conflicts

Note: If your server has a redundant arrays of independent disks (RAID) adapter installed, use the configuration method that is supplied with the RAID adapter to view or change SCSI settings for devices attached to the adapter.

Complete the following steps to start the SCSISelect Utility program:

- Turn on the server.
- 2. When the <<< Press <CTRL><A> for SCSISelect Utility! >>> prompt appears, press Ctrl+A.
- 3. When the Would you like to configure the host adapter or run the SCSI disk utility? question appears, make your selection and press Enter.
- 4. Use the arrow keys to select a choice from the menu.
- Follow the instructions on the screen to change the settings of the selected items: then, press Enter.

Using the ServerGuide Setup and Installation CD

The ServerGuide Setup and Installation CD provides state-of-the-art programs to detect the server model and hardware options that are installed, configure the server hardware, provide device drivers, and install your network operating system (NOS).

Note: If the ServerGuide Setup and Installation CD does not start, see the Hardware Maintenance Manual and Troubleshooting Guide.

- 1. Insert the ServerGuide Setup and Installation CD, and restart the server.
- 2. Follow the instructions that appear on the screen to:
 - Select your language.
 - Select your keyboard layout and country.
 - c. View the overview to learn about ServerGuide features.
 - d. View the README file to review installation tips about your NOS and adapter.
 - e. Start the setup and hardware configuration programs.
 - Start the NOS installation. You will need your copy of the NOS CD.

Diagnostic tools overview

The following tools are available to help you identify and resolve hardware-related problems:

POST beep codes

The power-on self-test (POST) beep codes indicate the detection of a problem. See the *Hardware Maintenance Manual and Troubleshooting Guide* for more details.

· Diagnostic programs and error messages

The server-diagnostic programs are provided on the *Device Driver and IBM Enhanced Diagnostics* CD. These programs test the major components of your server

Note: See *Hardware Maintenance Manual and Troubleshooting Guide* on the *IBM xSeries Documentation* CD for more detailed information about the diagnostic programs.

Troubleshooting chart

Power-on self-test (POST)

When you turn on the server, the Power On Self-Test (POST) performs a series of tests to check the operation of system components and some of the installed options.

If POST finishes without detecting any problems, the first window of your operating system or application program appears.

If POST detects a problem, more than one beep sounds and an error message appears on your screen.

Notes:

- 1. If you have a user password set, you must type the password and press Enter, when prompted, before the operating system will load.
- 2. A single problem might cause several error messages. When this occurs, work to correct the cause of the first error message. After you correct the cause of the first error message, the other error messages usually will resolve the next time you run the test.

POST beep codes

The possible types of beep codes are as follows:

No beeps

If no beep occurs after your server completes POST, call for service.

Continuous beep

Your microprocessor has failed, or your system board or speaker subsystem might contain a failing component. If the system continues through POST with no errors, call for service. If no video appears, the microprocessor processor has failed. Call for service.

POST error messages

The following table provides an abbreviated list of the error messages that might appear during POST.

Prior to on-site warranty service, you are required to go through problem determination with an IBM service specialist call center technician.

A warranty period of 3 years on parts and 1 year on labor means that IBM will provide warranty service without charge for:

- 1. parts and labor during the first year of the warranty period
- parts only, on an exchange basis, in the second and third years of the warranty period. IBM will charge you for any labor it provides in performance of the repair or replacement.

Problem determination

Prior to on-site warranty service, you are required to go through problem determination with an IBM service specialist call center technician. The service specialist will run diagnostic tests on the hardware and check the software.

Running diagnostics: The IBM service specialist will help you determine whether your equipment is functioning as specified. It might be necessary to isolate the failing xSeries, Netfinity[®], or IntelliStation system; IBM component; or both from any active production environment to run diagnostics and perform defect-isolation programs. You are responsible for making the system, IBM component, or both available for running diagnostics and defect-isolation programs.

Checking software: The IBM service specialist will help you ensure that the correct BIOS code, firmware, device drivers, and other supporting IBM software are installed and correctly configured. It might be necessary to manually gather information about the relevant software levels or run IBM-approved utility programs to gather this information. It might be necessary to isolate the failing system from any

active production environment to gather this information. You are responsible, with assistance from the service specialist, for gathering this information. The IBM Statement of Limited Warranty does not include on-site assistance with this activity.

Warranty service and support

With the original purchase of an IBM xSeries or IntelliStation system, you have access to extensive service and support. During the IBM Machine warranty period, you may call IBM or your reseller for problem-determination assistance under the terms of the IBM Statement of Limited Warranty.

The following services are available during the warranty period:

- Problem determination Trained personnel are available to assist you with determining if you have a hardware problem and deciding what action is necessary to fix the problem.
- IBM hardware repair If the problem is determined to be caused by IBM hardware under warranty, trained service personnel are available to provide the applicable level of service, either on-site or at an IBM service center as determined by IBM.
- Engineering Change management Occasionally, there might be changes that are required after a product has been shipped from IBM. In those instances, IBM will make Engineering Changes (ECs) available that apply to your hardware.
- Customer replaceable units (CRUs) Some parts of IBM xSeries and IntelliStation systems are designated as customer replaceable units. IBM ships CRUs to you for replacement by you. CRUs include keyboards, monitors, memory, diskette drives, hard disk drives, and mice (this list is not inclusive of all CRUs).

The following items are not covered under warranty service:

- Replacement or use of non-IBM parts. All IBM parts contain a 7-character identification in the format IBM FRU XXXXXXX.
- Identification of software problem sources.
- Installation of customer replaceable units (CRUs).
- Installation and configuration of BIOS code, firmware, or device drivers that are designated as customer installable.

See the IBM Statement of Limited Warranty for a full explanation of IBM warranty terms. Be sure to retain your proof of purchase to obtain warranty service.

Please have the following information ready when you call:

- The machine type and model of your IBM hardware product (if available)
- Serial numbers of your IBM hardware products
- A description of the problem
- The exact wording of any error messages
- Hardware and software configuration information

International Warranty Service

If you travel with your xSeries or IntelliStation system or relocate it to a country or region where your system is sold and serviced by IBM or IBM resellers authorized to perform warranty service, International Warranty Service (IWS) is available during the warranty period. Eligible IBM systems are identified by their four-digit machine types.

You can obtain IWS through the service delivery method (such as depot, carry-in, or on-site) provided in the servicing country or region. Service methods and procedures vary by country or region, and some service or parts might not be available in all countries and regions. Service centers in certain countries or regions might not be able to service all models of a particular machine type. In addition, some countries or regions might have fees and restrictions that apply at the time of service.

Purchasing additional services

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 -Country-unique Terms. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

The IBM Warranty for Machines: IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications"). The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded.

Extent of Warranty: The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED. INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Items Not Covered by Warranty: IBM does not warrant uninterrupted or error-free operation of a Machine. Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided WITHOUT WARRANTIES OF ANY KIND.

Warranty Service: To obtain warranty service for a Machine, contact IBM or your reseller. If you do not register your Machine with IBM, you may be required to present proof of purchase.

During the warranty period, IBM or your reseller, if approved by IBM to provide warranty service, provides without charge certain types of repair and exchange service to keep Machines in, or restore them to, conformance with their Specifications.

IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. At its discretion, IBM or your reseller will 1) either repair or exchange the failing Machine and 2) provide the service either at your location or a service center. IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Some parts of IBM Machines are designated as Customer Replaceable Units (called "CRUs"), e.g., keyboards, memory, or hard disk drives. IBM ships CRUs to you for replacement by you. You must return all defective CRUs to IBM within 30 days of your receipt of the replacement CRU. You are responsible for downloading designated Machine Code and Licensed Internal Code updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part.

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to

- 1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange:
- 2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and
- 3. where applicable, before service is provided:

 - c. provide IBM or your reseller with sufficient, free, and safe access to your facilities to permit them to fulfill their obligations; and
 - d. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

Limitation of Liability: Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes

of this item, the term "Machine" includes Machine Code and Licensed Internal Code.

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

Disputes and differences arising out of or in connection with this Agreement shall be finally settled by arbitration which shall be held in Singapore in accordance with the rules of the International Chamber of Commerce (ICC). The arbitrator or arbitrators designated in conformity with those rules shall have the power to rule on their own competence and on the validity of the Agreement to submit to arbitration. The arbitration award shall be final and binding for the parties without appeal and the arbitral award shall be in writing and set forth the findings of fact and the conclusions of law.

All proceedings shall be conducted, including all documents presented in such proceedings, in the English language. The number of arbitrators shall be three, with each side to the dispute being entitled to appoint one arbitrator.

The two arbitrators appointed by the parties shall appoint a third arbitrator before proceeding upon the reference. The third arbitrator shall act as chairman of the proceedings. Vacancies in the post of chairman shall be filled by the president of the ICC. Other vacancies shall be filled by the respective nominating party. Proceedings shall continue from the stage they were at when the vacancy occurred.

If one of the parties refuses or otherwise fails to appoint an arbitrator within 30 days of the date the other party appoints its, the first appointed arbitrator shall be the sole arbitrator, provided that the arbitrator was validly and properly appointed.

The English language version of this Agreement prevails over any other language version.
