





Chapter 1. Introduction

The IBM[®] @server BladeCenter[™] HS40 Type 8839 blade server is based on the IBM Enterprise X-Architecture[™] technologies¹.

Your HS40 blade server is a double-width blade-model server and can be installed in an IBM @server BladeCenter Type 8677 unit or IBM @server BladeCenter T Types 8720 and 8730 units.

Note: Unless otherwise stated, references to the BladeCenter unit also apply to the BladeCenter T unit.

A combination of single-width HS20 blade servers and double-width HS40 blade servers can be installed in the same BladeCenter unit. These high-performance blade servers are ideally suited for networking environments that require superior microprocessor performance, efficient memory management, flexibility, and reliable data storage.

This Installation and User's Guide provides information for:

- · Setting up the blade server
- Starting and configuring the blade server
- · Installing options
- Installing the operating system
- · Performing basic troubleshooting of the blade server

Packaged with the *Installation and User's Guide* are software CDs that help you to configure hardware, install device drivers, and install the operating system. To download the latest device drivers, go to the IBM Support Web site at http://www.ibm.com/pc/support/.




The model number and serial number are on the ID label that is behind the control panel door on the front of the blade server, and on a label on the left side of the blade server that is visible when the blade server is not in the BladeCenter unit. You will need these numbers when you register your blade server with IBM.

Your BladeCenter HS40 blade server will have one of the bezels shown in the following illustration.




A set of user labels comes with the blade server. When you install the blade server in the BladeCenter unit, write identifying information on a label and place the label on the BladeCenter unit bezel.

The following illustration shows the placement of the label, just below the blade server, on the BladeCenter unit.



Important: Do not place the label on the blade server itself or in any way block the ventilation holes on the blade server.

The following illustration shows the placement of the label, just to the side of the blade server, on the BladeCenter T unit.

- 32 MB of RAM.
- Adobe Acrobat Reader 3.0 (or later) or xpdf, which comes with Linux operating systems. Acrobat Reader software is included on the CD, and you can install it when you run the Documentation Browser.

Using the Documentation Browser

Use the Documentation Browser to browse the contents of the CD, read brief descriptions of the documents, and view documents using Adobe Acrobat Reader or xpdf. The Documentation Browser automatically detects the regional settings in use in your system and displays the documents in the language for that region (if available). If a document is not available in the language for that region, the English version is displayed.

Use one of the following procedures to start the Documentation Browser:

- If Autostart is enabled, insert the CD into your CD-ROM drive. The Documentation Browser starts automatically.
- If Autostart is disabled or is not enabled for all users, use one of the following procedures:
 - If you are using a Windows operating system, insert the CD into your CD-ROM drive and click Start --> Run. In the Open field, type e:\win32.bat

where e is the drive letter of your CD-ROM drive, and click **OK**.

- If you are using Red Hat Linux, insert the CD into your CD-ROM drive; then, run the following command from the /mnt/cdrom directory:

sh runlinux.sh

Select your server from the Product menu. The Available Topics list displays all the documents for your server. Some documents might be in folders. A plus sign (+) indicates each folder or document that has additional documents under it. Click the plus sign to display the additional documents.

When you select a document, a description of the document appears under Topic **Description**. To select more than one document, press and hold the Ctrl key while you select the documents. Click View Book to view the selected document or documents in Acrobat Reader or xpdf. If you selected more than one document, all the selected documents are opened in Acrobat Reader or xpdf.

To search all the documents, type a word or word string in the **Search** field and click **Search**. The documents in which the word or word string appears are listed in order of the most occurrences. Click a document to view it, and press Crtl+F to use the Acrobat search function or Alt+F to use the xpdf search function within the document.

Impressive performance using the latest microprocessor technology

Your blade server supports up to four Intel Xeon microprocessors. Your blade server comes with at least one microprocessor installed; you can install additional microprocessors to further enhance performance and symmetric multiprocessing (SMP) capability.

I/O expansion

Your blade server comes with two connectors on the I/O board for optional I/O expansion cards for adding more network communication capabilities to the blade server.

· Integrated network support

Your blade server comes with four integrated Gigabit Ethernet controllers. Each Ethernet controller has an interface for connecting to 10/100/1000-Mbps networks through an Ethernet switch module in the BladeCenter unit. The blade server automatically selects between 10BASE-T and 100/1000BASE-TX environments. Each controller provides full-duplex (FDX) capability, which enables simultaneous transmission and reception of data on the Ethernet local area network (LAN). The controllers support Wake on LAN® technology.

· Light path diagnostics

Light path diagnostics provides LEDs to help you diagnose problems. For more information, see "Light path diagnostics" on page 72.

Serial over LAN

Your blade server supports serial over LAN (SOL) technology, which provides advanced remote management capability. It provides the ability to redirect server serial data over a LAN without the use of serial concentrators. It also eliminates the need for serial cabling by internally rerouting serial packets over the LAN. The SOL feature is accessed through the management-module command-line interface. The SOL feature does not require any special client software because it is designed to work with existing standard Telnet consoles. 


The following illustration shows the major components in the BladeCenter HS40 blade server.


Processor board components

I/O board components


The following illustration shows the components on the I/O board.





The following illustration shows the LEDs on the processor board.




The following illustration shows the LEDs on the I/O board.

Jumpers

When the BIOS code page jumper (J1E2) is moved from pins 1 and 2 to pins 2 and 3, you can start the blade server from a backup BIOS page. The default position is pins 1 and 2. See the blade server *Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *BladeCenter Documentation* CD or the IBM *BladeCenter T Documentation* CD for more information.

Note: If you start the blade server from the backup page because the primary BIOS page has become damaged, you need to flash the primary BIOS code.

Chapter 2. Power, controls, and indicators

This chapter describes the power features, how to turn on and turn off the blade server, and what the controls and indicators mean.

Turning on the blade server

After you connect the blade server to power through the BladeCenter unit, the blade server can start in any of the following ways:

Note: Unless otherwise stated, references to the BladeCenter unit also apply to the BladeCenter T unit.

 You can press the power-control button on the front of the blade server (behind the control panel door) to start the server.

Notes:

- Wait until the power-on LED on the blade server flashes slowly before
 pressing the blade server power-control button. During this time, the service
 processor in the BladeCenter management module is initializing; therefore,
 the power-control button on the blade server does not respond.
- 2. While the blade server is starting up, the power-on LED on the front of the server is lit steady. See "Controls and LEDs" on page 18 for the power-on LED states.
- If a power failure occurs, the BladeCenter unit and then the blade server can start automatically when power is restored (if the blade server is configured through the BladeCenter management module to do so).
- You can turn on the blade server remotely by means of the service processor in the BladeCenter management module.
- If your operating system supports the Wake on LAN feature and the blade server power-on LED is flashing slowly, the Wake on LAN feature can turn on the blade server under the following conditions:
 - The Wake on LAN feature has not been disabled through the management-module Web interface.
 - The blade server was previously turned on and the operating system was shut down properly.

Turning off the blade server

When you turn off the blade server, it is still connected to power through the BladeCenter unit. The blade server can respond to requests from the service processor, such as a remote request to turn on the blade server. To remove all power from the blade server, you must remove it from the BladeCenter unit.

Shut down your operating system before you turn off the blade server. See your operating system documentation for information about shutting down the operating system. Improper shutdown of a blade server will prevent that blade server from being restarted using Wake on LAN.

The blade server can be turned off in any of the following ways:

You can press the power-control button on the blade server (behind the control
panel door). This starts an orderly shutdown of the operating system, if this
feature is supported by your operating system.

Note: After turning off the blade server, wait at least 5 seconds before you press the power-control button to turn on the blade server again.


- If the operating system stops functioning, you can press and hold the power-control button for more than 4 seconds to turn off the blade server.
- · The management module can turn off the blade server.

Note: After turning off the blade server, wait at least 30 seconds for its hard disk drives to stop spinning before you remove the blade server from the BladeCenter unit.

Controls and LEDs

This section describes the controls and light-emitting diodes (LEDs) on your blade server.

Note: The control panel door is shown in the closed (normal) position in this illustration. You must open the control panel door to access the power-control button.



CD/diskette/USB select button: Press this button to associate the CD-ROM drive, diskette drive, and USB port with this blade server. The LED on this button flashes while the request is being processed, then is steady when the ownership of the CD-ROM drive, diskette drive, and USB port has been transferred to this blade server. It can take approximately 20 seconds for the operating system in this blade server to recognize the CD-ROM drive, diskette drive, and USB port.

The operating system in the blade server must provide USB support for the blade server to recognize and use the CD-ROM drive, diskette drive, and USB port. The BladeCenter unit uses USB for internal communication with these devices. If there is no response when you press the CD/diskette/USB select button, you can use the management-module Web interface to see whether local control has been disabled on the blade server.

Keyboard/mouse/video select button: Press this button to associate the keyboard port, mouse port, and video port with this blade server. The LED on this button flashes while the request is being processed, then is steady when the ownership of the keyboard, mouse, and video has been transferred to this blade server. It can take up to 20 seconds to switch the keyboard, video, and mouse control to the blade server.

Although the keyboard that is attached to the BladeCenter unit is a PS/2®-style keyboard, communication with it is through the Universal Serial Bus (USB). The operating system in the blade server must provide USB support for the blade server to recognize and use the keyboard and mouse. The BladeCenter unit uses USB for internal communication with these devices. When you are running an operating system that does not have USB device drivers, such as in the following situations, the keyboard responds very slowly.

- · Running the blade server integrated diagnostics
- Running a BIOS update diskette on a blade server
- · Updating the diagnostics on a blade server

If there is no response when you press the keyboard/mouse/video select button, you can use the management-module Web interface to see whether local control has been disabled on the blade server.

You can also press keyboard keys in the following sequence to switch keyboard/mouse/video control between blade servers:

NumLock NumLock blade server number Enter

where *blade server number* is the two-digit number for the blade bay in which the blade server is installed. A blade server that occupies more than one blade bay is identified by the lowest bay number that it occupies.

If you install the Microsoft Windows 2000 operating system on the blade server while it is not the current owner of the keyboard, video, and mouse, a delay of up to 1 minute occurs the first time you switch the keyboard, video, and mouse to the blade server. During this one-time-only delay, the blade server device manager enumerates the keyboard, video, and mouse and loads the device drivers. All subsequent switching takes place in the normal keyboard-video-mouse switching time frame (up to 20 seconds).

Power-control button: This button is located behind the control panel door. Press this button to manually turn the blade server on or off.

Note: This button has effect only if local power control is enabled for the blade server. Local power control is enabled and disabled through the BladeCenter management-module Web interface.

Power-on LED: This green LED indicates the power status of the blade server in the following manner:

- Flashing rapidly The service processor on the blade server is handshaking with the BladeCenter management module.
- Flashing slowly The blade server has power but is not turned on.
- Lit continuously The blade server has power and is turned on.

Activity LED: When this green LED is lit, it indicates that there is hard disk drive, flash drive, or network activity.

Location LED: When this blue LED is lit, it has been turned on remotely by the system administrator to aid in visually locating the blade server. The location LED on the BladeCenter unit will be lit also. The location LED can be turned off through the BladeCenter management-module Web interface or through the IBM Director Console.

Information LED: When this LED is lit, it indicates that a noncritical event has occurred. The information LED can be turned off through the BladeCenter management-module Web interface or through the IBM Director Console.

Blade-error LED: When this amber LED is lit, it indicates that a system error has occurred in the blade server. The blade-error LED will turn off only after the error is corrected.

Chapter 3. Installing options

This chapter provides instructions for adding options to your blade server. Some option-removal instructions are provided in case you need to remove one option to install another.

Installation guidelines

Before you begin installing options in your blade server, read the following information:

- Read the safety information beginning on page vii and the guidelines in "Handling static-sensitive devices." This information will help you work safely with your blade server and options.
- · Back up all important data before you make changes to disk drives.
- Before you remove a hot-swap blade server from the BladeCenter unit, you must shut down the operating system and turn off the blade server. You do not have to shut down the BladeCenter unit itself.
- Blue on a component indicates touch points, where you can grip the component to remove it from or install it in the server, open or close a latch, and so on.
- Orange on a component or an orange label on or near a component indicates
 that the component can be hot-swapped, which means that if the server and
 operating system support hot-swap capability, you can remove or install the
 component while the server is running. (Orange can also indicate touch points on
 hot-swap components.) See the instructions for removing or installing a specific
 hot-swap component for any additional procedures that you might have to
 perform before you remove or install the component.
- For a list of supported options for your blade server, go to http://www.ibm.com/pc/compat/.

System reliability considerations

To help ensure proper cooling and system reliability, make sure that each microprocessor socket always contains either a microprocessor heat-sink filler or a microprocessor and heat sink and that the air baffle is correctly installed.

Handling static-sensitive devices

Attention: Static electricity can damage electronic devices and your system. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- When working on the BladeCenter T unit, use an electrostatic discharge (ESD) wrist strap, especially when you will be handling modules, options, and blade servers. To work properly, the wrist strap must have a good contact at both ends (touching your skin at one end and firmly connected to the ESD connector on the front or back of the BladeCenter T unit).
- Limit your movement. Movement can cause static electricity to build up around you.
- · Handle the device carefully, holding it by its edges or its frame.
- · Do not touch solder joints, pins, or exposed printed circuitry.


- Do not leave the device where others can handle and possibly damage the device.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the BladeCenter unit or any unpainted metal surface on any other grounded rack component in the rack you are installing the device in for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into your blade server
 without setting it down. If it is necessary to set the device down, place it in its
 static-protective package. Do not place the device on your blade server cover or
 on a metal table.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

Removing the blade server from the BladeCenter unit


The following illustration shows how to remove the blade server from the BladeCenter unit.

- 2. Unless otherwise stated, references to the BladeCenter unit also apply to the BladeCenter T unit.



The following illustration shows how to remove the blade server from the BladeCenter T unit.



Attention:

- To maintain proper system cooling, do not operate the BladeCenter unit without either a blade server, expansion unit, or filler blade installed in each blade bay for more than 1 minute for the BladeCenter unit and 20 minutes for the BladeCenter T unit.
- Note the bay number. Reinstalling a blade server into a different bay than the
 one from which it was removed could have unintended consequences. Some
 configuration information and update options are established according to bay
 number; if you reinstall the blade server into a different bay, you might need to
 reconfigure the blade server.

Complete the following steps to remove the blade server:


- 1. If the blade server is operating, shut down the operating system; then, press the power-control button (behind the blade server control panel door) to turn off the blade server. See "Controls and LEDs" on page 18 for more information about the location of the power-control button.
 - **Attention:** Wait at least 30 seconds, until the drives stop spinning, before proceeding to the next step.
- 2. Open the two release levers as shown in the illustration. The blade server moves out of the bay approximately 0.6 cm (0.25 inch).

Note: You must remove the bezel assembly from the BladeCenter T unit before you can access the blade server. Firmly grip the blue touch points (at the top-left and top-right sides of the bezel) and forcefully pull forward, lifting the bezel up and away from the BladeCenter T unit. Carefully set the bezel assembly aside in a safe place. (See the *BladeCenter T Types 8720 and 8730 Installation and User's Guide* for detailed instructions about removing the bezel assembly.)

- 3. Pull the blade server out of the bay. Spring-loaded doors farther back in the bay move into place to cover the bay temporarily.
- 4. Place either a filler blade or another blade server in the bay within 1 minute for the BladeCenter unit and 20 minutes for the BladeCenter T unit. The recessed spring-loaded doors will move out of the way as you insert the blade server.

Opening the blade server cover

The following illustration shows how to open the cover on the blade server.



Complete the following steps to open the blade server cover:

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Carefully lay the blade server down on a flat, static-protective surface, with the cover side up.
- 3. Press the blade-cover release on each side of the blade server and lift the cover open, as shown in the illustration.
- 4. Lay the cover flat, or lift it from the blade server.


Removing the blade server bezel assembly

To install certain options, you must first remove the blade server bezel assembly.


Complete the following steps to remove the blade server bezel assembly:

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Open the blade server cover (see "Opening the blade server cover" for instructions) and lift it off the blade server.

3. Press the bezel-assembly release and rotate the bezel assembly away from the blade server chassis; then, unhook the tabs on the bottom of the bezel from the holes on the server chassis and remove the bezel.



4. Disconnect the control-panel cable from the control-panel connector.



- 5. Pull the bezel assembly away from the blade server.
- 6. Store the bezel assembly in a safe place.

Installing an IDE drive

Your blade server has two connectors on the I/O board for installing an optional 2.5-inch HS20 IDE Hard Disk Drive or BladeCenter Flash Disk Drive. Each IDE connector is on a separate bus. Some models might come with at least one hard disk drive or one flash drive already installed.


Note: In this document, both types of drives are referred to as IDE drives.

Each IDE connector is on a separate bus. Depending on your blade server, at least one IDE hard disk drive might already be installed. If your blade server is equipped with one IDE hard disk drive, you can install an additional IDE hard disk drive. These two IDE hard disk drives can be used to implement and manage redundant

array of independent disks (RAID) level-1 under both the Linux and Microsoft Windows 2000 operating systems. See "Configuring an IDE RAID" on page 59 for information about IDE RAID configuration.

Attention: To maintain proper system cooling, do not operate the BladeCenter unit without either a blade server, expansion unit, or filler blade installed in each blade bay for more than 1 minute for the BladeCenter unit and 20 minutes for the BladeCenter T unit.

Important: Ensure that the storage capacities and speeds of the drives are identical when configuring or replacing drives in a mirrored configuration.



Complete the following steps to install a 2.5-inch IDE drive.

Note: Do not install an IDE drive into IDE connector 2 if you intend to also install an optional I/O expansion card. The I/O expansion card occupies the same area as the second IDE drive.

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit. See "Removing the blade server from the BladeCenter unit" on page 22 for instructions.
- 3. Carefully lay the blade server on a flat, static-protective surface.
- 4. Open the blade server cover (see "Opening the blade server cover" on page 24 for instructions).
- 5. Insert the riser card from the option kit into an IDE connector on the blade server I/O board.

Important: IDE drives must be installed in the following order: IDE connector 1 first, then IDE connector 2.

- 6. Place the IDE drive tray from the option kit over the riser card as shown in the illustration, aligning the tray with the screw holes on the I/O board. Two of the screw holes have screws in them.
- 7. Remove the tray temporarily; then, remove the two screws from the screw holes on the I/O board and replace the tray. Secure the tray to the I/O board with screws from the kit.
- 8. Set any jumpers or switches on the IDE drive.

Important: Both IDE drives must be set to Master.

Attention: Do not press on the top of the IDE drive. Pressing the top could damage the IDE drive.

- 9. Place the IDE drive into the tray and push it, from the rear edge of the IDE drive, into the connector on the riser card until the IDE drive moves past the lever at the back of the tray. The IDE drive clicks into place.
- 10. If you have other options to install or remove, do so now; otherwise, go to "Completing the installation" on page 44.

Installing memory modules


The following notes describe the types of dual inline memory modules (DIMMs) that the blade server supports and other information that you must consider when installing DIMMs:


- The processor board contains eight DIMM connectors and supports two-way memory interleaving.
- The DIMM options supported for your blade server are 256 MB, 512 MB, 1 GB, and 2 GB. Your blade server supports a minimum of 512 MB and a maximum of 16 GB.
- You might have to enable large-memory support for your operating system to access all of the memory that is installed in your blade server. See the documentation for your operating system for information.
- Your blade server comes with two or more DIMMs installed, in pairs, starting with the DIMM 4 (J9E1) and DIMM 8 (J9H1) memory connectors. When you install additional DIMMs, be sure to install them as pairs, in the connectors and order shown in the following table.

Pair	DIMM connectors		
First	4 (J9E1) and 8 (J9H1)		
Second	3 (J9D1) and 7 (J9G1)		
Third	2 (J9C2) and 6 (J9F1)		
Fourth	1 (J9B3) and 5 (J9E2)		

- Both DIMMs in a pair must be the same size, speed, type, and technology. You can mix compatible DIMMs from various manufacturers.
- If you are using the hot-spare memory feature, all DIMMs that are installed in the blade server must be the same size, speed, type, and technology. If you are not using the hot-spare memory feature, the DIMMs of one memory pair do not have to match the DIMMs of the other memory pairs. To use the hot-spare memory feature, at least two DIMM pairs must be installed in the blade server. The hot spare memory feature is enabled using the Configuration/Setup Utility program (see "Configuration/Setup Utility menu choices" on page 52 for information).

 Install only 2.5 V, 184-pin, double-data-rate (DDR), PC2100, registered synchronous dynamic random-access memory (SDRAM) with error correcting code (ECC) DIMMs. These DIMMs must be compatible with the latest PC2100 SDRAM Registered DIMM specification, which is available from http://www.jedec.org/.





Before you begin, read the documentation that comes with the DIMMs.

Complete the following steps to install a DIMM:

- Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit. See "Removing the blade server from the BladeCenter unit" on page 22 for instructions.
- 3. Carefully lay the blade server on a flat, static-protective surface.
- 4. Open the blade server cover (see "Opening the blade server cover" on page 24 for instructions) and lift it off the blade server.
- 5. Press the I/O-tray release and rotate the I/O-board tray open, as shown in the illustration. The I/O tray is hinged and will support itself in the open position.
- 6. Locate the DIMM connectors on the processor board. Determine the connectors into which you will install the DIMMs (see the table on page 27.).
- 7. Touch the static-protective package that contains the DIMM option to any *unpainted* metal surface on the BladeCenter unit or any *unpainted* surface on any other grounded rack component. Then, remove the DIMM from the package.
- 8. To install the DIMMs, repeat the following steps for each DIMM that you install:
 - a. Turn the DIMM so that the DIMM keys align correctly with the connector on the processor board.

Attention: To avoid breaking the retaining clips or damaging the DIMM connectors, handle the clips gently.

- b. Insert the DIMM by pressing the DIMM along the guides into the connector. Make sure that the retaining clips snap into the closed positions.
 Important: If there is a gap between the DIMM and the retaining clips, the DIMM has not been correctly installed. In this case, open the retaining clips and remove the DIMM; then, reinsert the DIMM.
- 9. Before closing the I/O-board tray, check that all components are installed and seated correctly and that you have not left loose tools or parts inside the blade server. Pivot the I/O-board tray to the closed position until it clicks into place.
- 10. If you have other options to install or remove, do so now; otherwise, go to "Completing the installation" on page 44.

Installing an additional microprocessor


The following notes describe the type of microprocessor that your blade server supports and other information that you must consider when installing a microprocessor:

Your blade server supports up to four microprocessors. With two or four microprocessors, your blade server can operate as a symmetric multiprocessing (SMP) server. With one or three microprocessors, the blade server will not operate as an SMP server; however, installing more than one microprocessor will still result in improved server performance, even if the blade server is not configured for SMP operation. With SMP, certain operating systems and application programs can distribute the processing load between the microprocessors. To use SMP, obtain an SMP-capable operating system. For a list of supported operating systems and other options, go to http://www.ibm.com/pc/compat/.

Attention: To ensure proper server operation when you install an additional microprocessor, use microprocessors that have the same cache size and type, and the same clock speed. Internal and external clock frequencies of all microprocessors installed in the server must be identical (including system bus speed).

- For a list of microprocessors supported by your blade server, go to the ServerProven[®] list at http://www.ibm.com/pc/compat/.
- Thoroughly review the documentation that comes with the microprocessor, so
 that you can determine whether you need to update the blade server BIOS code.
 The latest level of BIOS code for your blade server is available from the World
 Wide Web. See Appendix A, "Getting help and technical assistance," on page 77
 for the World Wide Web addresses.
- The microprocessor sockets in this blade server contain built-in termination for the microprocessor bus; therefore, terminator cards are not required for empty microprocessor sockets. However, for proper airflow, an empty microprocessor socket must contain a microprocessor heat-sink filler, sometimes called a microprocessor baffle.
- The microprocessor speeds are automatically set for this blade server; therefore, you do not need to set any microprocessor frequency-selection jumpers or switches.

The following illustration shows how to install the additional microprocessors on the processor board.



Complete the following steps to install an additional microprocessor:

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit. See "Removing the blade server from the BladeCenter unit" on page 22 for instructions.
- 3. Carefully lay the blade server on a flat, static-protective surface.
- 4. Open the blade server cover (see "Opening the blade server cover" on page 24 for instructions) and lift it off the blade server.
- 5. Lift and remove the air baffle covering the microprocessors.
- 6. Locate the microprocessor socket on the processor board. See "Processor board components" on page 12 for numbering order of processors.


Note: Processors must be installed in order, starting with microprocessor 1, then microprocessors 2, 3, and 4.

- 7. Using a #2 Phillips screwdriver, loosen the captive screw on the heat-sink retention mechanism and rotate the mechanism up.
- 8. Remove the microprocessor heat-sink filler.
- 9. Install the microprocessor:
 - a. Remove the protective cover, tape, or label from the surface of the microprocessor socket, if one is present.
 - b. Touch the static-protective package containing the new microprocessor to any *unpainted* metal surface on the BladeCenter unit or any *unpainted* surface on any other grounded rack component; then, remove the microprocessor from the package.


Attention: Do not use any tools or sharp objects to lift the locking lever on the microprocessor socket. Failure to do so might result in permanent damage to the processor board.

 Rotate the locking lever on the microprocessor socket from its closed and locked position until it stops or clicks in the fully open position (approximately a 135° angle), as shown.

Attention: You must make sure that the locking lever on the microprocessor socket is in the fully open position before you insert the microprocessor in the socket. Failure to do so might result in permanent damage to the microprocessor, microprocessor socket, and processor board.



d. Center the microprocessor over the microprocessor socket. Align the triangle on the corner of the microprocessor with the triangle on the corner of the socket and carefully press the microprocessor into the socket.



Attention:


- Do not use excessive force when pressing the microprocessor into the socket.
- Make sure that the microprocessor is oriented and aligned correctly in the socket before you try to close the lever.
- e. Carefully close the lever to secure the microprocessor in the socket.
- 10. Install a heat sink on the microprocessor:
 - Remove the plastic protective cover from the bottom of the heat sink, if one is present.

Attention:

- 1) Do not set down the heat sink after you remove the plastic cover.
- 2) Do not touch the thermal grease on the bottom of the heat sink. Touching the thermal grease will contaminate it. If the thermal grease becomes contaminated, contact your service technician.
- b. Align and place the heat sink on top of the microprocessor. Press firmly on the heat sink.
- 11. Lower the retention mechanism; then, screw down the captive mounting screw using a #2 Phillips screwdriver. Do not overtighten the screw. If you are using a torque wrench, tighten the screws to 8.5 to 13 Newton-meters (Nm) (6.3 to 9.6 foot-pounds).

Attention: To help ensure proper cooling and system reliability the air baffle must be correctly positioned and fully seated.

12. Install the air baffle covering microprocessor 1 and microprocessor 4, making sure that the air baffle is positioned and pushed down so that both heat sink captive mounting screws are through the holes in the air baffle.



13. If you have other options to install or remove, do so now; otherwise, go to "Completing the installation" on page 44.

Installing an I/O expansion card

You can add one or two optional I/O expansion cards to your blade server to give the blade server up to four additional network connections for communicating on a network. Each I/O expansion card provides two additional network connections that are routed through I/O-module bays 3 and 4 of the BladeCenter unit. If two I/O expansion cards are installed, both expansion cards must be of the same type.


Attention: When you add an I/O expansion card, you must make sure that the switch modules in I/O-module bays 3 and 4 on the BladeCenter unit both support the I/O expansion card network-interface type. For example, if you add an Ethernet expansion card to your blade server, the modules in I/O-module bays 3 and 4 on the BladeCenter unit must both be compatible with the Ethernet expansion card. All other I/O expansion cards that are installed on other blade servers in the BladeCenter unit must also be compatible with these switch modules. In this example, you could then install two Ethernet switch modules, two pass-thru modules, or one Ethernet switch module and one pass-thru module. Because pass-thru modules are compatible with a variety of I/O expansion cards, installing two pass-thru modules would allow use of several different types of compatible I/O expansion cards within the same BladeCenter unit.

Important: Installation of an I/O expansion card requires removing the IDE drive installed in IDE connector 2. The I/O expansion card occupies the same space as this IDE drive and replaces it. You cannot install an IDE drive in IDE connector 2 while an I/O expansion card is installed in the blade server.

If the IDE drive that is installed in IDE connector 2 contains any information that you want to keep, back it up to another storage device.

If the IDE hard disk drive that is installed in IDE connector 2 is part of a RAID array, delete this IDE RAID array configuration before removing the hard disk drive. When you delete the RAID array, the array configuration information is removed; no data is deleted. See "Deleting an IDE RAID array configuration" on page 61 for instructions.

The following illustration shows how to install an I/O expansion card on the blade server. The same procedure is used to install an expansion card in either IDE connector location; however, the illustration shows installing an expansion card only in IDE connector 2.



Important: If you are installing only one I/O expansion card in your blade server, it must be installed in connector location 2.

Complete the following steps to install an I/O expansion card:


- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit (see "Removing the blade server from the BladeCenter unit" on page 22 for information).
- 3. Carefully lay the blade server on a flat, static-protective surface.
- 4. Open the blade server cover (see "Opening the blade server cover" on page 24 for instructions) and lift it off the blade server.
- 5. Remove the two screws near connector J8H1 (or connector J4H1, if you are installing an I/O expansion card in I/O expansion location 2) that secure the I/O board to the unit, as shown in the illustration.
- 6. Install the I/O expansion card:
 - a. Install the I/O expansion card tray. Secure the tray to the I/O board with the four screws from the option kit, as shown in the illustration.
 - b. Orient the I/O expansion card as shown in the illustration.
 - c. Slide the notch in the narrow end of the card into the raised hook on the tray; then, gently pivot the wide end of the card into the I/O expansion card connectors, as shown in the illustration.
- 7. See the documentation that comes with the I/O expansion card for device-driver and configuration information to complete the installation of the I/O expansion card. Some documentation might also be on the IBM BladeCenter Documentation CD or the IBM BladeCenter T Documentation CD that comes with the blade server.

8. If you have other options to install or remove, do so now; otherwise, go to "Completing the installation" on page 44.

Installing a PCI I/O expansion unit

You can install up to two PCI adapters by installing the Peripheral Card Interface (PCI) I/O Expansion Unit on the blade server.

The following illustration shows how to install a PCI I/O Expansion Unit on a blade server.



For complete information about installing this expansion unit, see the *Installation Instructions* that comes with the optional expansion unit.

Installing a SCSI storage expansion unit

Attention: You must install a SCSI storage expansion unit that is specified for use with the BladeCenter HS40 Type 8839 blade server. Two types of SCSI storage expansion unit are available for BladeCenter products, only one of which is compatible with the BladeCenter HS40 Type 8839 blade server. See the ServerProven list at http://www.ibm.com/pc/compat/ or the *Hardware Maintenance Manual and Troubleshooting Guide* for your blade server on the IBM *BladeCenter Documentation* CD or the IBM *BladeCenter T Documentation* CD for more information.

To use SCSI hard disk drives with your blade server, install a SCSI storage expansion unit, such as the IBM BladeCenter SCSI Storage Expansion Unit, on the

blade server. You will then be able to install two 3.5-inch, hot-swap, SCSI, 1-inch (26 mm) slim-high hard disk drives in the expansion unit, for use by the blade server. The SCSI controller in the BladeCenter SCSI storage expansion unit supports embedded mirroring, which is similar to RAID level-1.

Important: To avoid potential performance and reliability problems when configuring or replacing drives in a mirrored configuration, make sure that the storage capacities and speeds of the drives are identical.


After you install the SCSI storage expansion unit on your blade server, the blade server and expansion unit are a unit that occupies three blade bays in the BladeCenter unit.

Attention: To ensure proper cooling and system reliability, make sure that each of the SCSI hard disk drive bays on the SCSI storage expansion unit contains either a hot-swap SCSI hard disk drive or a filler panel.

Complete the following steps to install the SCSI storage expansion unit:

Note: The illustrations used in this procedure depict the installation process on a BladeCenter HS40 blade server in a BladeCenter Type 8677 unit. These illustrations might differ slightly from your hardware.


- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit (see "Removing the blade server from the BladeCenter unit" on page 22 for instructions).
- 3. Carefully lay the blade server on a flat, static-protective surface.
- 4. Remove the blade server cover (see "Opening the blade server cover" on page 24 for instructions).

6. Before installing the SCSI storage expansion unit, check that all components are installed and seated correctly and that you have not left loose tools or parts inside the blade server.


Attention: To help ensure proper cooling and system reliability the air baffle must be correctly positioned and fully seated.

7. Make sure that the air baffle covering microprocessor 1 and microprocessor 2, is positioned and pushed down so that both heat sink captive mounting screws are through the holes in the air baffle.




8. Install the SCSI storage expansion unit:

Attention: Install only a SCSI storage expansion unit that is specified for use with the BladeCenter HS40 Type 8839 blade server. Compatible SCSI storage expansion units do not have a shield, as shown in the following illustration.




a. Orient the storage expansion unit as shown in the following illustration.




b. Lower the storage expansion unit so that the slots at the rear slide down onto the cover pins at the rear of the blade server.

c. Pivot the storage expansion unit closed and press it firmly into place until the blade-cover releases click. The connector on the expansion unit automatically aligns with and connects to the blade expansion connector (J3A1) on the processor board.



9. Insert the combined blade and expansion unit into three adjacent BladeCenter unit bays.



Note: When any blade server or option is in blade bay 7 through 14 (in the BladeCenter unit) or blade bay 5 through 8 (in the BladeCenter T unit), power modules must be present in all four power bays.

- 10. Turn on the blade server.
- 11. If you have not already done so, install the LSI SCSI device drivers for your operating system. LSI device drivers are on the *ServerGuide Setup and*

Installation CD that comes with the blade server. You can also get the latest version of the drivers from the IBM Support Web site at http://www.ibm.com/pc/support/.

With the storage expansion unit installed on your blade server, you can install up to two hot-swap SCSI hard disk drives in the expansion unit and configure them for embedded mirroring (RAID level 1). Each SCSI device must have a unique SCSI ID. This ID enables the SCSI controller in the expansion option to identify the device and ensure that different devices on the same SCSI channel do not attempt to transfer data simultaneously. The SCSI IDs for the hard disk drives in the expansion unit are permanent (not configurable). Table 2 lists the SCSI IDs for the hard disk drives that are installed in the expansion unit. See "Installing a SCSI hot-swap hard disk drive" for instructions for installing hard disk drives.

Table 2. SCSI IDs for hot-swap hard disk drives in the expansion unit

Device	SCSI ID
Drive bay 1	0
Drive bay 2	1

Note: SCSI ID 7 is usually reserved for the SCSI controller; however, this SCSI ID is changeable through the ServeRAID[™] configuration program or the LSI configuration utility program.

Use the Configuration/Setup Utility program in the blade server to enable or disable the SCSI controller in the storage expansion unit. See the documentation that comes with the storage expansion unit for information about configuring the storage expansion unit and SCSI hard disk drives.

Installing a SCSI hot-swap hard disk drive

If you have installed a SCSI storage expansion unit on the blade server, you can install up to two SCSI hot-swap hard disk drives in the bays in the expansion unit.


If a hot-swap hard disk drive in the expansion unit fails, you can replace it without turning off the blade server. Therefore, you have the advantage of continuing to operate your blade server while a hard disk drive in this unit is removed or installed.

Each hot-swap drive has two indicator LEDs. If the amber hard disk drive status LED for a drive is lit continuously, that drive is faulty and must be replaced.

Each hot-swap drive that you plan to install must be mounted in a hot-swap-drive tray. The drive must have a Single Connector Attachment (SCA) connector. Hot-swap-drive trays come with hot-swap drives.

The following illustration shows how to install a SCSI hot-swap hard disk drive.

Note: The illustrations used in this procedure depict the installation process on a BladeCenter HS40 blade server in a BladeCenter Type 8677 unit. These illustrations might differ slightly from your hardware. However, this installation process is the same regardless of the BladeCenter unit.



Complete the following steps to install a drive in a storage expansion unit.

Attention: To maintain proper system cooling, do not operate the BladeCenter unit for more than 1 minute without either a hot-swap hard disk drive or a filler panel installed in each storage expansion unit bay.

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Remove the filler panel from one of the empty hot-swap bays by inserting your finger into the depression at the top of the filler panel and pulling it away from the expansion unit.
- 3. Install the SCSI hot-swap hard disk drive:
 - a. Make sure that the tray handle is open (that is, perpendicular to the hard disk drive).
 - b. Align the hard disk drive assembly with the guide rails in the bay.
 - c. Gently push the hard disk drive assembly into the bay until the drive stops.
 - d. Push the tray handle to the closed (locked) position.
 - e. Check the hard disk drive LEDs to make sure that the hard disk drive is operating correctly.
 - If the amber hard disk drive status LED for a hard disk drive is lit continuously, that hard disk drive is faulty and needs to be replaced.
 - If the green hard disk drive activity LED is flashing, the hard disk drive is being accessed.



Replacing a SCSI hot-swap hard disk drive

If a hard disk drive in the storage expansion unit fails, you can replace it without turning off the blade server.

Complete the following steps to replace a SCSI hot-swap hard disk drive in a storage expansion unit hot-swap bay.

Note: The illustrations used in this procedure depict the installation process on a BladeCenter HS40 blade server in a BladeCenter Type 8677 unit. These illustrations might differ slightly from your hardware. However, this installation process is the same regardless of the BladeCenter unit.



Attention: To maintain proper system cooling, do not operate the BladeCenter unit for more than 1 minute without either a hot-swap hard disk drive or a filler panel installed in each storage expansion unit bay.

- 1. Read the safety information beginning on page vii and "Installation guidelines" on page 21.
- 2. Locate the defective hard disk drive (look for an amber status LED on the front of the hard disk drive).
- 3. Make sure that the hard disk drive has stopped spinning.
- 4. Move the handle on the hard disk drive to the open position (perpendicular to the hard disk drive), and pull the hot-swap hard disk drive assembly from the bay.
- 5. Within 1 minute, install the replacement hard disk drive in the hot-swap bay (see "Installing a SCSI hot-swap hard disk drive" on page 40 for instructions).

Replacing the battery






Attention: To help ensure proper cooling, performance, and system reliability, make sure that each of the blade bays on the front of the BladeCenter unit has a blade server, expansion unit, or filler blade installed. Do not operate the BladeCenter unit for more than 1 minute or the BladeCenter T unit for more than 20 minutes without either a blade server, expansion unit, or filler blade installed in each blade bay.

- 4. Make sure that the release levers on the blade server are in the open position (perpendicular to the blade).
- Slide the blade server into the bay until it stops. The spring-loaded doors further back in the bay that cover the bay opening move out of the way as you insert the blade server.
- 6. Push the release levers on the front of the blade server closed.
- 7. Turn on the blade server. See "Turning on the blade server" on page 17 for instructions.
- 8. Make sure that the power-on LED on the blade control panel is lit continuously, indicating that the blade server is receiving power and is turned on.
- 9. Write identifying information on one of the user labels that comes with the blade server; then, place the label on the BladeCenter unit bezel just below the blade server, as shown in the following illustration.



Important: Do not place the label on the blade server itself or in any way block the ventilation holes on the blade server.

The following illustration shows the placement of the label, just to the side of the blade server, on the BladeCenter T unit.



10. If you have other blades to install, do so now.

Note: Reinstall the bezel assembly on the BladeCenter T unit after you have finished installing the blade servers (see the *BladeCenter T Types 8720 and 8730 Installation and User's Guide* for detailed instructions about reinstalling the bezel assembly). However, if you installed an option such as a PCI I/O Expansion Unit with PCI adapters that require cables, you will not be able to install the bezel assembly, which contains an air filter for the BladeCenter T unit. If you require an air filter, a filter must be provided on the rack.

If this is the initial installation for a blade server in the BladeCenter unit, you must configure the blade server with the blade server Configuration/Setup Utility and install the blade server operating system. See "Updating your blade server configuration" and Chapter 5, "Installing the operating system," on page 63 for details.

Updating your blade server configuration

When you start your blade server for the first time after you add or remove an internal option or external SCSI device (if the storage expansion unit has been installed), you might receive a message that the configuration has changed. The blade server Configuration/Setup Utility program starts automatically so that you can save the new configuration settings. For more information, see "Using the Configuration/Setup Utility program" on page 51.

Some options have device drivers that you must install. See the documentation that comes with each option for information about installing device drivers.

If your blade server comes with more than one microprocessor or if your blade server comes with one microprocessor and you have installed additional microprocessors, your blade server might be able to operate as an SMP server. You might need to upgrade the operating system to support SMP. For more information, see Chapter 5, "Installing the operating system," on page 63 and your operating-system documentation.

Input/output connectors and devices

The input/output connectors that are available to your blade server are supplied by the BladeCenter unit. See the documentation that comes with your BladeCenter unit for information about the input/output connectors.

The blade server has two selection buttons on the control panel: the CD/diskette/USB select button and the keyboard/mouse/video select button. See "Controls and LEDs" on page 18 for information about these buttons and their functions.

The Ethernet controllers on your blade server communicate with the network through the Ethernet-compatible switch modules on the BladeCenter unit. Network signals to and from the blade server or any I/O expansion cards are automatically routed to a same-network-interface switch module through circuitry in the BladeCenter unit.

Chapter 4. Configuring your blade server

The following configuration programs come with your blade server:

Configuration/Setup Utility program

The Configuration/Setup Utility program is part of the basic input/output system (BIOS) code in your blade server. Use it to change interrupt request (IRQ) settings, set the date and time, and set passwords. See "Using the Configuration/Setup Utility program" for more information.

IBM ServerGuide Setup and Installation CD

The ServerGuide program provides software-setup tools and installation tools that are designed for your blade server. Use this CD during the installation of your blade server to configure basic hardware features, such as a SCSI controller with RAID capabilities, and to simplify the installation of your operating system. For information about using this CD, see "Using the ServerGuide Setup and Installation CD" on page 54.

Preboot Execution Environment (PXE) boot agent utility program

The PXE boot agent utility program is part of the BIOS code in your server. Use it to change network startup (boot) protocols and startup order and to select operating-system wake-up support. For information about using this utility program, see "Using the PXE boot agent utility program" on page 56.

The following product is available for purchase:

IBM Remote Deployment Manager (RDM) Version 4.11 Update 3 or later

You can use the IBM RDM Version 4.11 Update 3 or later to install a BIOS code update onto the blade server. For information about using this product, see "Using RDM Version 4.11 Update 3 or later" on page 64.

To determine if your operating system supports the RDM program or for updated information about RDM and information about purchasing the software, go to http://www.ibm.com/pc/ww/eserver/xseries/systems_management/index.html.

For information about setting up your network configuration for remote management, such as with the IBM Director products, depending on your blade server, see the IBM @server BladeCenter Planning and Installation Guide or the IBM @server BladeCenter T Planning and Installation Guide. You can obtain the planning guides from http://www.ibm.com/pc/support/.

Using the Configuration/Setup Utility program

This section provides the instructions to start the Configuration/Setup Utility program and descriptions of the menu choices.

Starting the Configuration/Setup Utility program

Complete the following steps to start the Configuration/Setup Utility program:

- 1. Turn on the blade server and watch the monitor screen.
- 2. When the prompt Press F1 for Configuration/Setup appears, press F1.
- 3. Select settings to view or change.

Configuration/Setup Utility menu choices

The following choices are on the Configuration/Setup Utility main menu. Depending on the version of the BIOS code in your blade server, some menu choices might differ slightly from these descriptions.

System Summary

Select this choice to display configuration information, including the type, speed, and cache sizes of the microprocessors and the amount of installed memory. When you make configuration changes through other options in the Configuration/Setup Utility program, the changes are reflected in the system summary; you cannot change settings directly in the system summary.

Processor Summary

Select this choice to view information about the microprocessors installed in the blade server.

System Information

Select this choice to display information about your blade server, such as: the machine type and model of your blade server, the serial number, and the revision level or issue date of the BIOS and diagnostics code stored in electrically erasable programmable ROM (EEPROM). When you make configuration changes through other options in the Configuration/Setup Utility program, some of those changes are reflected in the system information; you cannot change settings directly in the system information.

Devices and I/O Ports

Select this choice to enable or disable the Ethernet controllers. Enable is the default setting for the Ethernet controller. If you disable a device, it cannot be configured, and the operating system will not be able to detect it (this is equivalent to disconnecting the device). If you disable the Ethernet controller, the blade server will have no Ethernet capability.

Remote Console Redirection

Select this choice to enable serial over LAN (SOL) and to set remote console communication parameters.

System MAC Addresses

Select this choice to set and view the MAC addresses for the Ethernet controllers on the blade server.

Date and Time

Select this choice to set the system date and time, in 24-hour format (hour:minute:second).

System Security

Select this choice to set or change the password (see "Using passwords" on page 54 for more information).

Start Options

Select this choice to view or change the start options. Start options take effect when you start your blade server. You can set keyboard operating characteristics, such as whether the blade server starts with the keyboard number lock on or off. You can also enable a virus-detection test that checks for changes in the boot record when the blade server starts.

Note: To set the startup sequence, which is the order in which the blade server checks devices to find a boot record, you must use the BladeCenter management-module Web interface. You can enable the blade server to run without a diskette drive or keyboard. The Extensible Firmware Interface (EFI) start option should not be selected for any of the startup or boot device fields.

If the EFI is accidentally started, after the boot process is complete type Ctrl+Alt+Delete at the Shell > prompt; then, press F1 when the prompt Press F1 for Configuration/Setup appears and remove EFI as a startup option in the Startup Options > Startup Sequence screen.

Advanced Setup

Select this choice to change settings for advanced hardware features.

Important: The server might malfunction if these options are incorrectly configured. Follow the instructions on the screen carefully.

Memory Settings

Select this choice to check memory status and to adjust other memory settings.

If a memory error is detected during POST or memory configuration, the blade server automatically disables the failing memory pair and continues operating with reduced memory. After the problem is corrected, you must enable **Retesting of Disabled DIMMs**. This will cause the disabled memory connectors to be retested during POST and enabled if they are operating correctly.

To maintain optimum system operation in the event of a memory failure, you can enable the **Hot Spare Row** feature. This feature removes the failed memory from the system configuration and activates a Hot Spare Memory pair of DIMMs to replace the failed memory pair of DIMMs. Before you can enable the Hot Spare Memory feature, at least two pairs of DIMMs must be installed in the blade server that adhere to the special requirements described in "Installing memory modules" on page 27.

- CPU Options

Select this choice to enable or disable hyper-threading and adjust microprocessor performance settings. If enabled, hyper-threading will only be active if it is supported by your operating system.

- PCI Bus Control

Select this choice to view and configure the master-latency-timer value for the blade server.

USB Configuration

Select this choice to enable and configure USB devices. All devices in the BladeCenter media tray and the BladeCenter keyboard and mouse are viewed as USB devices by the blade server.

FRB

Select this choice to configure the blade server Integrated System Management Processor (ISMP), including how the ISMP responds to POST errors, the time limit for blade server expansion option detection, and blade server microprocessor detection and activation.

Error Logs

Select this choice to enable and clear the blade server error and event logs. Error and event logs are viewed using the BladeCenter management-module Web interface. See the *BladeCenter Management Module User's Guide* on the IBM *BladeCenter Documentation* CD or the *BladeCenter T Management Module User's Guide* on the IBM *BladeCenter T Documentation* CD for information and instructions.

Save Settings

Select this choice to save the changes you have made in the settings and exit from the Configuration/Setup Utility program.

Restore Settings

Select this choice to cancel the changes you have made in the settings and restore the previous settings.

Load Default Settings

Select this choice to cancel the changes you have made in the settings and restore the factory settings.

Exit Setup

Select this choice to exit from the Configuration/Setup Utility program without saving the changes you might have made in the settings.

Using passwords

From the **System Security** choice, you can set, change, and delete the supervisor password. You can also set when this password needs to be entered. If you set the password to **Power-on**, you must type the password to complete the system startup. Setting the password to **Setup** restricts access to the Configuration/Setup Utility program.

You can use any combination of up to six characters (A–Z, a–z, and 0–9) for the password. Keep a record of your password in a secure place.

If you forget the password, change the position of the power-on password clear switch (switch 2 on switch block S6H1 on the I/O board) to clear the power-on password. Shut down the operating system, turn off the blade server, and remove the blade server from the BladeCenter unit to access the switches. After you change the position of the switch, you can start the Configuration/Setup Utility program and change the power-on password the next time the server is turned on. Move the switch back to the previous position after the password is changed. See "Switches and jumpers" on page 16 for the location of switch block 2.

Using the ServerGuide Setup and Installation CD

The ServerGuide Setup and Installation CD includes an easy-to-use setup and installation program that is designed for your IBM blade server. The ServerGuide program detects the blade server model and hardware options that are installed and uses that information during setup to configure the hardware. The ServerGuide program simplifies operating-system installations by providing updated device drivers and, in some cases, installing them automatically.

Note: The ServerGuide program works only with 32-bit Windows operating systems.

If a later version of the ServerGuide program is available, you can download a free image of the ServerGuide Setup and Installation CD, or you can purchase the CD. To download the image, go to the IBM ServerGuide Web page at http://www.ibm.com/pc/qtechinfo/MIGR-4ZKPPT.html. To purchase the latest ServerGuide Setup and Installation CD, go to the ServerGuide fulfillment Web site at http://www.ibm.com/pc/coupon/.

The ServerGuide program has the following features to make setup easier:

- · An easy-to-use interface
- Diskette-free setup, and configuration programs that are based on detected hardware

- ServeRAID Manager program, which configures your SCSI controller with RAID capabilities
- Device drivers that are provided for your blade server model and detected hardware
- Operating-system partition size and file-system type that are selectable during setup

ServerGuide features

Features and functions can vary slightly with different versions of the ServerGuide program. To learn more about the version that you have, start the *ServerGuide Setup and Installation* CD and view the online overview. Not all features are supported on all blade server models.

The ServerGuide program requires a supported IBM blade server that is associated with an enabled startable (bootable) CD-ROM drive. In addition to the *ServerGuide Setup and Installation* CD, you must have your operating-system CD to install your operating system.

The ServerGuide program has the following features:

- · Sets system date and time
- Detects the SCSI RAID adapter, controller, or integrated SCSI controller with RAID capabilities and runs the SCSI RAID configuration program (with LSI chip sets for ServeRAID adapters only)
- Checks the microcode (firmware) levels of a ServeRAID adapter and determines whether a later level is available from the CD
- Detects installed hardware options and provides updated device drivers for most adapters and devices
- · Provides diskette-free installation for supported Windows operating systems
- Includes an online readme file with links to tips for your hardware and operating-system installation

Setup and configuration overview

When you use the *ServerGuide Setup and Installation* CD, you do not need setup diskettes. You can use the CD to configure any supported IBM blade server model. The setup program provides a list of tasks that are required to set up your blade server model. On a blade server with an optional SCSI storage expansion unit, you can run the SCSI RAID configuration program to create logical drives.

Note: Features and functions can vary slightly with different versions of the ServerGuide program.

When you start the *ServerGuide Setup and Installation* CD, the program prompts you to complete the following tasks:

- · Select your language.
- Select your keyboard layout and country.
- View the overview to learn about ServerGuide features.
- View the readme file to review installation tips for your operating system and adapter.
- Start the operating-system installation. You will need your operating-system CD.

Typical operating-system installation

You can use the ServerGuide program to shorten your installation time. The ServerGuide program provides the device drivers that are required for your

hardware and for the operating system that you are installing. This section describes a typical ServerGuide operating-system installation.

Note: Features and functions can vary slightly with different versions of the ServerGuide program.

- 1. After you have completed the setup process, the operating-system installation program starts. (You will need your operating-system CD to complete the installation.)
- 2. The ServerGuide program stores information about the blade server model, service processor, hard disk drive controllers, and network adapters. Then, the program checks the CD for newer device drivers. This information is stored and then passed to the operating-system installation program.
- 3. The ServerGuide program presents operating-system partition options that are based on your operating-system selection and the installed hard disk drives.
- 4. The ServerGuide program prompts you to insert your operating-system CD and restart the server. At this point, the installation program for the operating system takes control to complete the installation. The BladeCenter CD-ROM drive must be associated with the blade server before you perform this step.

Installing your operating system without ServerGuide

If you have already configured the blade server hardware and you decide not to use the ServerGuide program to install your operating system, complete the following steps to download the latest operating-system installation instructions from the IBM Support Web page:

- 1. Go to http://www.ibm.com/pc/support/.
- 2. In the **Download** section, click **Downloads & drivers**.
- 3. On the "Downloads and drivers" page, in the **Brand** field, select **Servers**.
- 4. In the Family field, select BladeCenter HS40.
- 5. Click Continue.
- 6. In the View by document type field, select OS installation.
- 7. Select the instructions for your operating system.

Using the PXE boot agent utility program

This program is a built-in, menu-driven configuration utility program that you can use to select the boot protocol and other boot options and select a power management option.

Note: The RPL selection for the boot protocol option is not supported for this server.

Complete the following steps to start the PXE boot agent utility program:

- 1. Turn on the server.
- 2. When the Broadcom NetXtreme Boot Agent vX.X.X prompt appears, press Ctrl+S. You have 2 seconds (by default) to press Ctrl+S after the prompt appears.
 - If the PXE setup prompt is not displayed, use the Configuration/Setup Utility program to enable the Ethernet PXE/DHCP option.
- 3. Use the arrow keys and press Enter to select a choice from the menu.
- 4. Follow the instructions on the screen to change the settings of the selected items; then, press Enter.

Firmware updates

IBM will periodically make firmware updates available for your blade server. Use the following table to determine the methods you can use to install these firmware updates.

You must set up a custom task.

Important: To avoid problems and to maintain proper system performance, always make sure that the blade server BIOS code, service processor firmware, and diagnostic firmware levels are consistent for all blade servers within the BladeCenter unit.

The service processor in your blade server provides the following features:

- · Continuous health monitoring and control
- · Configurable notification and alerts
- Event logs that are timestamped, saved in nonvolatile memory, and can be attached to e-mail alerts
- · Remote graphics console redirection
- · Point-to-point protocol (PPP) support
- · Remote power control
- · Remote firmware update and access to critical server settings
- · Around-the-clock access to the blade server, even if the server is turned off

At some time, you might need to flash the service processor to apply the latest firmware. Download the latest firmware for your blade server service processor from the IBM Support Web site at http://www.ibm.com/pc/support/. Use the BladeCenter management-module Web interface to flash the service processor. The Web interface is described in the IBM @server BladeCenter Type 8677 Installation and User's Guide on the IBM BladeCenter Documentation CD and IBM @server BladeCenter T Types 8720 and 8730 Installation and User's Guide on the IBM BladeCenter T Documentation CD.

Configuring the Gigabit Ethernet controllers

Four Ethernet controllers are integrated on the blade server system board. Each controller provides a 1000-Mbps full-duplex interface for connecting to one of the Ethernet-compatible switch modules in I/O-module bays 1 and 2, which enables simultaneous transmission and reception of data on the Ethernet local area network (LAN). Each Ethernet controller on the system board is routed to a different switch module in I/O-module bay 1 or bay 2. The routing from Ethernet controller to I/O-module bay will vary according to blade server type and the operating system

that is installed. See "Blade server Ethernet controller enumeration" for information about how to determine the routing from Ethernet controller to I/O-module bay for your blade server.

Note: Other types of blade servers, such as the BladeCenter HS20 Type 8678 blade server, that are installed in the same BladeCenter unit as this BladeCenter HS40 Type 8839 blade server might have different Ethernet controller routing. See the documentation that comes with the other blade servers for detailed information.

You do not need to set any jumpers or configure the controllers for the blade server operating system. However, you must install a device driver to enable the blade server operating system to address the Ethernet controllers. For device drivers and information about configuring your Ethernet controllers, see the Intel Ethernet Software CD that comes with your blade server. For updated information about configuring the controllers, go to the IBM Support Web site at http://www.ibm.com/pc/support/.

Your Ethernet controllers support failover, which provides automatic redundancy for your Ethernet controllers. Without failover, you can have one Ethernet controller from each server attached to each virtual LAN or subnet. With failover, you can configure more than one Ethernet controller from each server to attach to the same virtual LAN or subnet. Any one of the integrated Ethernet controllers can be configured as the primary Ethernet controller. If you have configured the controllers for failover and the primary link fails, a secondary controller takes over. When the primary link is restored, the Ethernet traffic switches back to the primary Ethernet controller. (See your operating system device driver documentation for information about configuring for failover.)

Important: To support failover on the blade server Ethernet controllers, the Ethernet switch modules in the BladeCenter unit must have identical configurations.

Blade server Ethernet controller enumeration

The enumeration of the Ethernet controllers in a blade server is operating-system dependent. You can verify the Ethernet controller designations a blade server uses through your operating-system settings.

The routing of an Ethernet controller to a particular I/O-module bay depends on the type of blade server. You can verify which Ethernet controller is routed to which I/O-module bay by using the following test:

- 1. Install only one Ethernet switch module or pass-thru module in I/O-module bay
- 2. Make sure that the ports on the switch module or pass-thru module are enabled (click Switch Tasks → Management → Advanced Switch Management in the management-module Web-based user interface).
- 3. Enable only one of the Ethernet controllers on the blade server. Note the designation that the blade server operating system has for the controller.
- 4. Ping an external computer on the network connected to the switch module. If you can ping the external computer, the Ethernet controller that you enabled is associated with the switch module in I/O-module bay 1. The other Ethernet controller in the blade server is associated with the switch module in I/O-module bay 2.

If you have installed an I/O expansion card on a blade server, communications from the option are routed to I/O-module bays 3 and 4. You can verify which controller on the card is routed to which I/O-module bay by performing the same test, using a controller on the I/O expansion card and a compatible switch module or pass-thru module in switch bay 3 or 4.

Command-line interface and serial over LAN

The IBM @server BladeCenter Management Module Command-Line Interface provides direct access to BladeCenter management functions as an alternative to using the management-module Web interface. Using the command-line interface, you can issue commands to control the power and configuration of the blade server and other components installed in the BladeCenter unit. The command-line interface also provides access to the text-console command prompt for your blade server through a serial over LAN (SOL) connection. See the IBM @server BladeCenter Management Module Command-Line Interface User's Guide and the IBM @server BladeCenter Serial Over LAN Setup Guide for information and instructions.

Configuring an IDE RAID

Note: Configuring an IDE RAID only applies to a blade server that has two IDE hard disk drives installed.

You can configure an IDE redundant array of independent disks (RAID) array for your blade server. Two IDE hard disk drives in the blade server can be used to implement and manage RAID level-0 (stripe) and RAID level-1 (mirror) arrays under operating systems that are listed on the ServerProven list at http://www.ibm.com/pc/compat/. For your blade server, you must configure IDE RAID in the following areas:

- In BIOS, using the Configuration/Setup Utility program, and the MegaRAID IDE Setup Utility program, which is part of the firmware in your server
- In your operating system, using the operating-system configuration tools and the MegaRAID IDEal Software RAID utility

Important: You must create the RAID array *before* you install the operating system on your blade server.

Creating an IDE RAID array configuration

Complete the following steps to set up an IDE RAID array on your blade server.

Attention: Information that is stored on the IDE hard disk drives will be affected when the drives become part of a RAID array. If the IDE hard disk drives contain any information that you want to keep, back them up to another storage device.

- 1. Obtain the IDE RAID documentation and device drivers for your operating system from the IBM Support Web site at http://www.ibm.com/pc/support/.
- Review your operating-system and MegaRAID IDE documentation for information about IDE hard disk drive RAID configuration. The latest version of the MegaRAID IDEal Software RAID Utility program and documentation are available for download from the IBM Support Web site at http://www.ibm.com/pc/support/.
- 3. Make sure that the operating system that you plan to install supports IDE RAID. Operating systems that support IDE RAID on your server type are listed on the ServerProven list at http://www.ibm.com/pc/compat/.

- 4. Make sure that two IDE hard disk drives are installed in the blade server (see the "Installing an IDE drive" on page 25 for instructions).
 - **Important:** To avoid potential performance and reliability problems when configuring or replacing hard disk drives in a mirrored RAID configuration, make sure that the storage capacities and speeds of the hard disk drives are identical.
- 5. Create a diskette or CD containing the IDE RAID device drivers for your operating system. The latest IDE RAID device drivers for supported operating systems are available for download from the IBM Support Web site at http://www.ibm.com/pc/support/.
- 6. Complete the following steps to enable IDE RAID in BIOS using the Configuration/Setup Utility program:
 - a. Turn on the blade server and watch the monitor screen.
 - b. When the message Press F1 for Configuration/Setup appears, press F1.
 - c. Select **Devices and I/O Ports** from the Configuration/Setup Utility main menu; then, select IDE Configuration.
 - d. Set the IDE RAID feature to **Enabled** (the default setting is **Disabled**).
 - e. Select Save Settings from the Configuration/Setup Utility main menu.
 - f. Exit the Configuration/Setup Utility program, making sure that you save the settings. The blade server restarts automatically.
- 7. Complete the following steps to configure IDE RAID in BIOS using the MegaRAID IDE Setup Utility program:
 - a. When the message Press Ctrl+M to run MegaRAID IDE Setup Utility appears, press Ctrl+M.
 - b. From the MegaRAID IDE Setup Utility program, select the automatic configuration option (F1 or F2) for the type of RAID array you are setting up. You can also manually configure the RAID array (F4) using the MegaRAID IDE Setup Utility program; however, your blade server supports only RAID level-0 (stripe) or RAID level-1 (mirror). Attempting to manually configure any other type of RAID array will cause an error.
 - c. Select Initialize Array; then, press Enter. Using the Spacebar, select the logical drives that will be part of the RAID array.
 - d. Press F10 to save the changes and exit the MegaRAID IDE Setup Utility program. The blade server restarts automatically. Status messages that are displayed during restart indicate status of the RAID array.
- 8. Install the operating system on your blade server, making sure that you install the correct IDE RAID device drivers (see Chapter 5, "Installing the operating system," on page 63 for instructions). The latest IDE RAID device drivers and NOS installation instructions for supported operating systems are available for download from the IBM Support Web site at http://www.ibm.com/pc/support/.
 - **Note:** Some operating systems allow device drivers to be installed only during a short period of time during operating-system setup; make sure you pay attention to all messages that are displayed. Use care when performing an unattended operating-system installation for IDE RAID.
- 9. Perform additional IDE RAID configuration that is required for your operating system or application, using the operating-system configuration tools and the MegaRAID IDEal Software RAID utility. See your operating-system documentation for information about using the operating-system tools for IDE hard disk drive RAID configuration. The latest version of the MegaRAID IDEal

Software RAID utility and IDE RAID device drivers for supported operating systems are available for download from the IBM Support Web site at http://www.ibm.com/pc/support/.

Deleting an IDE RAID array configuration

Complete the following steps to delete an IDE RAID array configuration on your blade server:

1. Turn on the blade server and watch the monitor screen.

Note: If the blade server is turned on, restart the blade server.

- 2. When the message Press Ctrl+M to run MegaRAID IDE Setup Utility appears, press Ctrl+M.
- 3. From the MegaRAID IDE Setup Utility program, press F5 (the Delete Array option) to remove the array configuration.
- 4. Press F10 to save the changes and exit the MegaRAID IDE Setup Utility program. The blade server restarts automatically. Status messages that are displayed during restart indicate status of the RAID array.
- 5. Complete the following steps to disable IDE RAID in BIOS using the Configuration/Setup Utility program:
 - a. Restart the blade server and watch the monitor screen.
 - b. When the message Press F1 for Configuration/Setup appears, press F1.
 - c. Select **Devices and I/O Ports** from the Configuration/Setup Utility main menu; then, select **IDE Configuration**.
 - d. Set the IDE RAID feature to **Disabled**.
 - e. Select Save Settings from the Configuration/Setup Utility main menu.
 - f. Exit the Configuration/Setup Utility program, making sure that you save the settings. The blade server restarts automatically.

Chapter 5. Installing the operating system

To install the operating system on a blade server, you can use any of the following methods:

- Use the *ServerGuide Setup and Installation* CD to install a supported Microsoft Windows operating system.
- Use the Remote Deployment Manager (RDM) Version 4.11 Update 3 (or later) program to install a supported Microsoft Windows operating system or Red Hat Advanced Server 2.1.
 - To determine if your operating system supports the RDM program or for updated information about RDM and information about purchasing the software, go to http://www.ibm.com/pc/ww/eserver/xseries/systems management/index.html.
- Download the latest operating-system installation instructions from the IBM Support Web page at http://www.ibm.com/pc/support/ and install the operating system at the BladeCenter unit (local deployment).

Note: Local deployment for Microsoft Windows 2000 requires an integrated CD that contains Windows 2000 with Service Pack 3 applied. Instructions for creating a Windows 2000 Integrated CD are contained in the latest operating system installation instructions for Windows 2000 on the IBM Support Web page.

Important:

 The operating system in the blade server must provide USB support for the blade server to recognize and use the keyboard, mouse, CD-ROM drive, and diskette drive. The BladeCenter unit uses USB for internal communication with these devices.

Note: Unless otherwise stated, references to the BladeCenter unit also apply to the BladeCenter T unit.

- 2. Some operating systems, such as Red Hat Enterprise Linux, allow you to select the type of mouse that is being used. If you are offered this choice, select USB instead of PS/2. Although the mouse is a PS/2-style device, communication with the mouse is through an internal USB bus in the BladeCenter chassis; therefore, the operating system in your blade server must recognize the mouse as a USB device.
- If you are configuring a redundant array of independent disks (RAID) array for your server, you must create the RAID array before you install the operating system on your blade server.

Using the ServerGuide Setup and Installation CD

The ServerGuide Setup and Installation CD provides state-of-the-art programs to detect the blade server model and installed hardware options, configure the blade server hardware, provide device drivers, and help you install your operating system. For information about the supported operating-system versions, see the label on the CD.

Complete the following steps to start the ServerGuide Setup and Installation CD:

- 1. Press the CD/diskette/USB select button on the front of the blade server to associate the BladeCenter CD-ROM drive with the blade server.
- 2. Insert the CD, and restart the blade server. If the CD does not start, see "ServerGuide problems" on page 67.

- 3. Follow the instructions on the screen to:
 - a. Select your language.
 - b. Select your keyboard layout and country.
 - c. View the overview to learn about ServerGuide features.
 - d. View the readme file to review installation tips about your operating system and adapter.
 - e. Start the setup and hardware configuration programs.
 - Start the operating-system installation. You will need your operating-system CD.

Using RDM Version 4.11 Update 3 or later

You can use the RDM version 4.11 Update 3 (or later) program to install a supported Microsoft Windows operating system or Red Hat Advanced Server 2.1 on a blade server. Follow the instructions in the documentation that comes with the RDM program.

To determine if your operating system supports the RDM program or for updated information about RDM and information about purchasing the software, go to http://www.ibm.com/pc/ww/eserver/xseries/systems_management/index.html.

Downloading installation instructions

Complete the following steps to download the installation instructions:

Chapter 6. Solving problems

This section provides basic troubleshooting information to help you solve some common problems that might occur while setting up your blade server.

If you cannot locate and correct the problem using the information in this section, see the *BladeCenter HS40 Type 8839 Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *BladeCenter Documentation* CD or the IBM *BladeCenter T Documentation* CD that comes with your blade server, and the "Server Support" flowchart in the front of this document.

Note: Unless otherwise stated, references to the BladeCenter unit also apply to the BladeCenter T unit.

Diagnostic tools overview

The following tools are available to help you diagnose and solve hardware-related problems:

· Beep codes and error messages

The beep codes indicate that the power-on self-test (POST) or the baseboard management controller (BMC) have detected a problem during startup. Error messages also appear during startup if POST detects a hardware-configuration problem. See "Beep code descriptions" on page 66, "POST error messages" on page 67, and the *BladeCenter HS40 Type 8839 Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *BladeCenter Documentation* CD or the IBM *BladeCenter T Documentation* CD that comes with your blade server for more information.

Troubleshooting charts

These charts list problem symptoms and steps to correct the problems. See the "Troubleshooting charts" on page 68 for more information.

· Diagnostic programs and error messages

Real Time Diagnostics tests the major components of your BladeCenter Unit, including the management modules, switch modules, CD-ROM drive, diskette drive, and your blade server, while the server operating system is running. Real Time Diagnostics can either be plugged into an existing IBM Director environment or installed without IBM Director present. For documentation and download information for the Real Time Diagnostics, go to http://www.ibm.com/servers/eserver/xseries/systems_management/xseries_sm.html.

Notes:

- As of the date of this document, the IBM Director CD does not come with the BladeCenter T unit. If you have the BladeCenter T unit, see "IBM Director" on page 10 for more information.

Beep code descriptions

If POST or the BMC detects a problem during startup, it might emit one or more beep. You can use the following beep code descriptions to help diagnose and solve problems that are detected during startup. Beep codes indicating specific system problems are listed in the following tables. See "Diagnostics" in the *BladeCenter HS40 Type 8839 Hardware Maintenance Manual and Troubleshooting Guide* on the IBM *BladeCenter Documentation* CD that comes with your blade server for more information about the beep codes.

1, 2, or 3	 Memory error. Complete the following steps if this problem occurs: Make sure that the memory modules are installed correctly. Turn off the blade server; then, restart the blade server. If the problem remains, call for service.

5 short and 1 long	 Memory error. Complete the following steps if this problem occurs: Make sure that the memory modules are installed correctly. Turn off the blade server; then, restart the blade server. If the problem remains, call for service.
6 short and 1 long	Memory error. Complete the following steps if this problem occurs:1. Make sure that the memory modules are of the correct type and that they are installed correctly.2. Turn off the blade server; then, restart the blade server. If the problem remains, call for service.

	If you changed the memory, you updated the memory configuration in the Configuration/Setup Utility program.
	 All banks of memory are enabled. The server might have automatically disabled a memory bank when it detected a problem, or a memory bank might have been manually disabled.
	Check in the POST error log for error message 289:
	If the DIMM was disabled by a system-management interrupt (SMI), replace the DIMM.
	If the DIMM was disabled by the user or by POST, run the Configuration/Setup Utility program and enable the DIMM.
	If this error remains, replace the DIMM.
	If the problem remains, call for service.

Microprocessor problems

Symptom	Suggested action
The blade server emits a continuous tone during POST.	The startup (boot) microprocessor is not working correctly.
	Make sure that the startup microprocessor is seated correctly. If it is, replace the startup microprocessor.
	If the problem remains, call for service.

Monitor problems

Note: The monitor remains blank until it is directed to a blade server that is turned on; this is normal behavior.

The monitor goes blank when you direct it to a working blade server, or it goes blank when you start some	Make sure that the monitor cable is connected to the video connector on the BladeCenter management module. Some IBM monitors have their own self-tests. If you suspect a problem with your monitor, see the information that comes with the monitor for adjusting and testing instructions.
application programs in the blade servers.	If you still cannot find the problem, try using the monitor with another blade server. 	Make sure that the mouse works correctly with other blade servers.
	 Make sure that the mouse is recognized as a USB device, not PS/2, by your blade server. Although the mouse is a PS/2-style device, communication with the mouse is through an internal USB bus in the BladeCenter unit. Some operating systems allow you to select the type of mouse during installation of the operating system. Select USB.
	If the problem remains, call for service.

Network connection problems

Symptom	Suggested action
One or more blade servers	Make sure that:
are unable to communicate with the network.	• The switch modules for the network interface being used are installed in the correct BladeCenter bays and are configured and operating correctly. See the IBM @server BladeCenter Type 8677 Hardware Maintenance Manual and Troubleshooting Guide on the IBM BladeCenter Documentation CD or the IBM BladeCenter T Types 8720 and 8730 Hardware Maintenance Manual and Troubleshooting Guide on the IBM BladeCenter T Documentation CD for details.
	 The settings in the switch module are appropriate for the blade server (settings in the switch module are blade server specific).

installed does not work.	The option is designed for the blade server. See the "Server Support" flowchart on the cover for information about obtaining ServerProven compatibility information from the World Wide Web.
	You followed the installation instructions that came with the option.
	The option is installed correctly.
	You have not loosened any other installed options or cables.
	If the problem remains, call for service.
An IBM option that used to work does not work now.	Make sure that all of the option hardware and cable connections are secure.

	If the problem remains, call for service.

Power problems

Symptom	Suggested action	
The blade server does not	1. Make sure that:


Light path diagnostics


If the system-error LED on the system LED panel on the front or rear of the BladeCenter unit is lit, one or more error LEDs on the BladeCenter I/O board and processor board also might be lit. These LEDs help identify the cause of the problem.

Diagnosing problems using the light path diagnostics

To locate the component that caused the error, locate the lit error LED on that component.

The following illustration shows the LEDs on the processor board.





The following illustration shows the LEDs on the I/O board.

The following example illustrates how to use the light path diagnostics to diagnose a system error:

- 1. Note that the blade-error LED on the control panel is lit.
- 2. Remove the blade server from the BladeCenter unit (see "Removing the blade server from the BladeCenter unit" on page 22).
- 3. Place the blade server on a flat, static-protective surface.
- 4. Remove the cover from the blade server (see "Opening the blade server cover" on page 24).
- 5. Press and hold the light path diagnostics button on the I/O board to relight the I/O board LEDs that were lit before you removed the blade server from the BladeCenter unit. The LEDs will remain lit for as long as you press the button, to a maximum of 25 seconds.
- 6. Press the I/O-tray release and rotate the I/O-tray open. The I/O tray is hinged and will support itself in the open position.
- 7. Press and hold the light path diagnostics button on the processor board to relight the processor board LEDs that were lit before you removed the blade server from the BladeCenter unit. The LEDs will remain lit for as long as you press the button, to a maximum of 25 seconds.

Use the information in "Light path diagnostics LEDs" on page 74 to determine the cause of the error and the action you should take.

Light path diagnostics LEDs

Power is available to relight the light path diagnostics LEDs for a short period of time after the blade server is removed from the BladeCenter unit. During that period of time, you can relight the light path diagnostics LEDs for a maximum of 25 seconds (or less, depending on the number of LEDs that are lit and the length of time the blade server is removed from the BladeCenter unit) by pressing the light path diagnostics button on the I/O board or processor board.

The light path diagnostics LEDs on the I/O board and processor board light when the light path diagnostics buttons are pressed if power is available to relight the blade-error LEDs. If the light path diagnostics LEDs are not lit when the light path diagnostics buttons are pressed, no power is available to light the blade-error LEDs, and they will be unable to provide any diagnostic information.

Table 7 describes the light path diagnostic LEDs on the I/O board. Table 8 on page 75 describes the light path diagnostic LEDs on the processor board. See the illustrations on page 72 and page 73 for LED locations.

If an error has occurred, power is available to light the LEDs, and no light path diagnostic LEDs are lit, the error cannot be diagnosed, or the service processor has failed. The error is not represented by a light path diagnostic LED and you should check the system error log in the BladeCenter management module for information about the error.

Table 7. I/O board light path diagnostics LEDs

LED	Problem	Action
Light path diagnostics LED (green)	If this green LED does <i>not</i> light when you press and hold the light path diagnostics button on the I/O board, there might be no power available to light the LED.	Replace the blade server cover and reinsert the blade server in a powered BladeCenter unit; then, after the blade server has been in the BladeCenter unit for several minutes, remove it and try to light the light path diagnostics LED.

The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you:

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems
