

For additional information, see the instructions in your BladeCenter unit documentation. The Server Connectivity Module for IBM BladeCenter is also referred to throughout this document as the switch module or I/O module.


### Notes:

- Unless otherwise stated, references to the BladeCenter unit apply to all BladeCenter unit types.
- Changes are made periodically to the IBM Web site. Procedures for locating firmware and documentation might change from what is described in this document.
- The illustrations in this document might differ slightly from your hardware.
- The sample screens that appear in this document might differ slightly from the screens that are displayed by your system. Screen content varies according to the type of BladeCenter unit and the firmware versions and options that are installed.
- The Advanced Management Module is the only type of management module that supports the Server Connectivity Module. Thus, in this document, the term "management module" refers to the Advanced Management Module.

This document explains how to update and configure BladeCenter components for SOL operation. The SOL connection provides access to the text-console command prompt on each blade server, enabling the blade servers to be managed from a remote location.

## Features and specifications

This section provides a summary of the features and specifications that apply to the Server Connectivity Module for IBM BladeCenter. For detailed information about the features, see the *Server Connectivity Module for IBM BladeCenter User's Guide*.

#### Table 1. Features and specifications

- Simple Configuration and Control: This device should be configurable by a non-networking system administrator through a graphical user interface (GUI) or a command-line interface (CLI). Typical networking concepts, such as spanning tree redundancy, virtual local area networks (VLANs), port filters, link aggregation, port trunks, and remote monitoring (RMON) statistics are not typically used or understood by this class of administrator. The default operation will be to hide the underlying networking function and configuration from the user. Some functions, such as Spanning Tree Protocol, are eliminated since they are not required. Only a few simple networking parameters are available to the user to configure and control the Server Connectivity Module.
- Ports
  - Internal ports
    - Fourteen internal full-duplex Gigabit ports, one connected to each of the blade servers in the BladeCenter unit. Eight internal links in a BladeCenter-T chassis.
    - Two internal full-duplex 100 Mbps ports connected to the management module in slots 1 and 2.
  - External copper ports
    - Six external ports are provided using standard Category 5 enhanced (5e) copper cable connectors.
    - 10/100/1000 Mbps interfaces: The external ports connect at 10 Mbps Full Duplex, 100 Mbps Full Duplex, or 1 Gbps Full Duplex.
    - Auto-negotiation capability.
    - Copper connection for making connections to a backbone, end stations, and servers.
- Internal Switching: This device provides packet switching between the blade servers and management modules within the chassis to support Serial over LAN (SOL) and other future traffic flows. Blade-server-to-blade-server switching is supported for those blade server ports that are assigned to a common group. This support does not require explicit configuration to be operational.
- Configuration of the Server Connectivity Module is only through a connection to a management-module port and not through the external switch ports.
- Support for tagged VLANs: The administrator can define VLAN identifiers (IDs) to match specific server application requirements.
- Cisco EtherChannel compatible static link aggregation.
- · Management-module control that allows for external ports to be enabled or disabled.
- Support for Ethernet jumbo frame formats (up to 9K bytes per frame).

Table 1. Features and specifications (continued)

- Two independent internal 100 Mbps FDX links connected to each of two management modules (jumbo frame support not required on these links).
- Management-module I<sup>2</sup>C interface that provides VPD and register access.
- Level-2 (L2) switching per current industry standards and practice.
- "Non-networking" device appearance allows administration and installation of this device by the system manager rather than a network administrator.
- Port aggregation (external ports).
- Port group failover (triggered by external ports).
- IEEE 802.3x Flow Control.
- Internet group multicast protocol (IGMP) snooping.
- IEEE 802.1Q support for SOL and optional user VLAN tagging of external ports.
- An embedded central processing subsystem for initialization, configuration, and management.
- RADIUS or TACACS+ user authentication.



# Chapter 2. Installing and removing an I/O module and its components

See the *Installation and User's Guide* for your BladeCenter unit type for information about the I/O-module bay locations in the BladeCenter unit and specific requirements for installing I/O modules in your BladeCenter unit.

**Attention:** To maintain proper system cooling, each I/O-module bay must contain either an I/O module or a filler module.

For details about network interface requirements and expansion options, see the following documents:

- Installation and User's Guide for your BladeCenter unit type
- Installation and User's Guide for each blade server type

## Installation guidelines

Before you begin to install the I/O module in your BladeCenter unit, read the following information:

- Read the safety information that begins on page v and the guidelines in "Handling static-sensitive devices" on page 10, and read the safety statements in the BladeCenter unit publications. This information will help you work safely.
- Observe good housekeeping in the area where you are working. Place removed covers and other parts in a safe place.
- Do not attempt to lift an object that you think is too heavy for you. If you have to lift a heavy object, observe the following precautions:
  - Make sure that you can stand safely without slipping.
  - Distribute the weight of the object equally between your feet.
  - Use a slow lifting force. Never move suddenly or twist when you lift a heavy object.
  - To avoid straining the muscles in your back, lift by standing or by pushing up with your leg muscles.
- Make sure that you have an adequate number of properly grounded electrical outlets for the BladeCenter unit, monitor, and other devices.
- Back up all important data before you make changes to disk drives.
- Have a small flat-blade screwdriver available.
- You do not have to turn off the BladeCenter unit to install or replace any of the hot-swap modules in the BladeCenter unit.
- Orange on the release latch on the I/O module identifies this device as a hot-swap component. You can install or remove this component while the

BladeCenter unit is running. See the instructions in this chapter for more information about installing or removing hot-swap or hot-plug components.

- If you plan to install additional I/O modules in the I/O-module bays of your BladeCenter unit, you might also have to install an I/O expansion card in the applicable blade server to support the I/O modules in these bays. For information about the types of compatible I/O expansion cards for the blade servers, contact your IBM authorized reseller. See the I/O expansion card documentation for details about I/O expansion card installation, configuration, and use.
- When you are finished working on the I/O module and all other BladeCenter unit components, reinstall all safety shields, guards, labels, and ground wires.

## Handling static-sensitive devices


**Attention:** Static electricity can damage the system and other electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed circuitry.
- Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an *unpainted* metal part of the BladeCenter unit or any *unpainted* metal surface on any other grounded rack component in the rack in which you are installing the device for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the BladeCenter unit without setting down the device. If it is necessary to set down the device, put it back into its static-protective package. Do not place the device on the BladeCenter chassis or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

# Installing an I/O module

The following illustration shows how to install an I/O module into a Type 8677 BladeCenter unit. The appearance of your BladeCenter unit might be different. For additional information, see the documentation for your BladeCenter unit.



To install an I/O module, complete the following steps:

**Attention:** If the I/O module has a cover, make sure that the cover is installed and closed before you install the I/O module in the BladeCenter unit.

- 1. Read the safety information that begins on page v and "Installation guidelines" on page 9.
- If an acoustic attenuation module is installed on your BladeCenter unit, remove it. See the documentation for your BladeCenter unit for instructions.
- 3. Select an I/O-module bay in which to install the I/O module.

**Note:** For details about I/O-module bay requirements, see the documentation for your BladeCenter unit and blade servers.

4. Remove the filler module from the selected I/O-module bay. Store the filler module for future use.

- 5. If you have not already done so, touch the static-protective package that contains the I/O module to any *unpainted* metal surface of the BladeCenter unit or any *unpainted* metal surface on any other grounded rack component for at least 2 seconds.
- 6. Remove the I/O module from its static-protective package.
- 7. Make sure that the release latch on the I/O module is in the open position (perpendicular to the module).
- 8. Slide the I/O module into the I/O-module bay until it stops.

**Important:** The BladeCenter unit must be turned on before you can perform steps 9 and 10.

- **9**. Push the release latch on the front of the I/O module to the closed position. After you insert and lock the I/O module, it is turned on, and a power-on self-test (POST) occurs to verify that the I/O module is operating correctly.
- 10. The POST results are displayed by the status LEDs. Make sure that the LEDs on the I/O module indicate that it is operating correctly. Make sure that the power LED on each I/O module is lit. See Chapter 3, "Information panel LEDs and external ports," on page 15 for a more detailed description of the operation of these LEDs.

For additional information, see Chapter 6, "Solving problems," on page 35.


- 11. If you have other I/O modules to install, do so now; otherwise, go to step 12.
  - **Note:** To make sure that the BladeCenter unit installation complies with EMC product regulations for intra-building lightning surges, you must use shielded LAN cables that are grounded at both ends.
- 12. Attach any cables or cords that are required by the I/O module. For cable requirements, see page 5.
- **13**. Replace the acoustic attenuation module, if you removed it in step 2 on page 11.

## Removing an I/O module

**Attention:** To maintain proper cooling and system reliability, each I/O-module bay in the BladeCenter unit must have either an I/O module or filler module installed. If you remove a hot-swap module, you must replace it with another module or filler module within 1 minute of removal.

To remove an I/O module, complete the following steps:

- 1. Read the safety information that begins on page v and "Installation guidelines" on page 9.
- 2. If an acoustic attenuation module is installed on your BladeCenter unit, remove it. See the documentation for your BladeCenter unit for instructions.
- **3.** Observe or record the locations of the cable connectors on the I/O module. You will need this information when you reconnect the cables. Then, disconnect any cables from the I/O module that you are removing.
- 4. Pull the release latch toward the bottom of the I/O module as shown in the following illustration. The module moves out of the I/O-module bay approximately 0.64 cm (0.25 inch).



- 5. Slide the I/O module out of the I/O-module bay and set it aside.
- 6. Place either another I/O module or a filler module in the I/O-module bay within 1 minute.

- 7. If you placed another I/O module in the I/O-module bay, reconnect any compatible cables that you disconnected in step 3 on page 13. If a cable that you disconnected is not compatible with the new I/O module, you will have to connect a new cable that is compatible with the new I/O module.
- 8. Replace the acoustic attenuation module, if you removed it in step 2 on page 13.

# Chapter 3. Information panel LEDs and external ports


This chapter describes the information panel and LEDs on the Server Connectivity Module. This chapter also identifies the external ports on the information panel.

## Information panel

As shown in the following illustrations, the information panel of the I/O module contains the following LEDs and ports:

- The LEDs that display the status of the I/O module and the network (see "LEDs" on page 16).
- The I/O module has six external 1000BASE-T Ethernet ports for 10/100/1000 Mbps connections to external Ethernet devices, such as backbones, end stations, and servers. These ports are identified as EXT1, EXT2, EXT3, EXT4, EXT5, and EXT6 in the switch configuration menus and are labeled 1 through 6 (from top to bottom) on the I/O module.
- The I/O module has a serial port that is reserved for service technicians only. This port does not support additional devices; therefore, do not connect any devices to this port.


The following illustration shows the information panel for the I/O module.



## LEDs

The LEDs on the information panel of the I/O module are power and I/O module error (fault). In addition, each external port on the I/O module contains an Ethernet link LED and an Ethernet Tx/Rx LED. The following illustrations show the LEDs on the I/O modules. A description of each LED follows the illustrations.

The following illustration shows the LEDs on the I/O module.



**Power:** This green active LED is on the left side of the information panel, above the service port. When this LED is lit, it indicates that the I/O module has passed the power-on self-test (POST) with no critical faults and is operational.

**! I/O module error (fault):** This amber LED is on the right side of the information panel, above the service port. When this LED is lit, it indicates that the I/O module has failed the POST or detected an operational fault.

**Note:** When the I/O module error LED is lit, the system-error LED on the BladeCenter unit will also be lit.

**Ethernet link:** This green link status LED is at the top of each external 10/100/1000 Mbps port. When this LED is lit on a port, it indicates that there is an active connection (or link) to a device using that connector.

**Ethernet Tx/Rx:** This green activity LED is at the bottom of each external 10/100/1000 Mbps port. When this LED flashes on a port, it indicates that data is being transmitted or received (that is, activity is occurring) between that port and another device on the network link. The flash frequency is proportional to the amount of traffic on the network link.

# Chapter 4. Configuring the I/O module

The I/O module supports one remote-access mode for management through Ethernet connections. The I/O module has an internal Ethernet path to the management module.

The only available mode uses the internal path to the management module. In this mode, the remote-access link to the management console must be attached to the Ethernet connector on the management module.

### Important:

- 1. The I/O module does not respond to remote-management commands from the six external Ethernet ports on the I/O module.
- 2. For transmission control protocol/Internet protocol (TCP/IP) applications to work with the I/O module, there must be a two-way route path between the Advanced Management Module and your workstation.

For detailed information about establishing a TCP/IP session through the management module, see the *BladeCenter Management Module User's Guide*.

- **3.** For I/O module (switch) communication with a remote management station, such as the IBM Director server, through the management-module external Ethernet port, the I/O module internal network interface and the management-module internal and external interfaces must be on the same Internet protocol (IP) subnet.
- 4. You can use two types of command-line interfaces (CLIs):
  - The management-module CLI

Use this CLI to communicate with the management module. For instructions and additional information, see the *BladeCenter Management Module Command-Line Interface Reference Guide*.

• The Server Connectivity Module CLI

Use this CLI to communicate with the Server Connectivity Module. For instructions and additional information, see the *Server Connectivity Module for IBM BladeCenter User's Guide*.

**Note:** The Advanced Management Module is the only type of management module that supports the Server Connectivity Module. Thus, in this document, the term "management module" refers to the Advanced Management Module.

You can access, manage, configure, and secure the I/O module through the management module, TCP/IP applications, or remote applications, as described in the *Server Connectivity Module for IBM BladeCenter User's Guide*.

Also see the applicable *BladeCenter Installation and User's Guide* documents for specific details about configuring the I/O module.

In addition to the documents in this library, be sure to review the following documents for information to help you prepare for system installation and configuration:

- The BladeCenter Management Module User's Guide for your BladeCenter unit type
- The *BladeCenter Management Module Installation Guide* for your BladeCenter unit type

The browser-based interface and the Telnet program are different ways to access the same internal I/O module software and configure it. Thus, all the settings that you encounter in browser-based management are the same as those in the Telnet program.

- If your system application requires that you use the browser-based interface program, see "Configuring through the browser-based interface" on page 23 for additional information.
- If your system application requires that you use the Telnet program, see "Configuring through the Telnet interface" on page 25 for additional information.
- For information about running an SSH session, see the *Server Connectivity Module for IBM BladeCenter User's Guide*.

## Enabling the external ports

To access the I/O module from an external environment, you must enable certain features, such as the external ports, through the management module. After you enable these features, you can establish a TCP/IP session for the I/O module through the external I/O module connection as described in the *Server Connectivity Module for IBM BladeCenter User's Guide*.

To configure the external Ethernet interface and to enable the external ports, complete the following steps:

1. Access and log on to the management module as described in the *BladeCenter Management Module User's Guide*. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.

Enter your user ID and password.

If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User ID** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*) and click **OK**. The main page in the management-module interface opens.

- **Note:** The **User ID** and **Password** fields are case-sensitive. Enter your information in uppercase letters only (for example, ABCDE). To maintain system security, change the password after you log on for the first time.
- Select Admin/Power/Restart from the I/O Module Tasks menu on the left side of the BladeCenter Management Module window. The Admin/Power/Restart window opens.

For additional information, see the *BladeCenter Management Module User's Guide*.

3. Make sure that the external ports feature is enabled.

If this feature is not already enabled, change the value to **Enabled**. Then, click **Save**.

**Note:** The "external management over all ports" feature is not available for the I/O module. For additional information about the requirements for using this feature, see the applicable *BladeCenter Installation and User's Guide* documents.

## Configuring through the management-module interface

This section describes how to use the management-module interface to configure the following items:

- Enable/disable external ports
- Restore factory defaults
- Network address translation (NAT) table rules

To configure these items, complete the following steps:

1. Access and log on to the management module as described in the *BladeCenter Management Module User's Guide*. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.

Enter your user ID and password.

If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User ID** field and the default password (PASSW0RD) in the **Password** field (where the sixth character is the number zero, not the letter *O*) and click **OK**. The main page in the management-module interface opens.

**Note:** The **User ID** and **Password** fields are case-sensitive. Enter your information in uppercase letters only (for example, ABCDE). To maintain system security, change the password after you log on for the first time.

 Select Configuration from the I/O Module Tasks menu on the left side of the BladeCenter Management Module window. The I/O Module Tasks window opens.

For additional information, see the *BladeCenter Management Module User's Guide*.

**3**. Each I/O-module bay has its own section. Go to the section for the applicable I/O module; then, click **Network Protocol Configuration**.

For the selected I/O module, a NAT table similar to the following example will be displayed. This example contains the current Network Protocol settings for an I/O module in port 1.



You can activate or modify the Network Protocol settings on this page of the management-module interface by clicking one of the following buttons:

- To activate all of the values in the NAT table, click the **Apply changes** (activate) NAT Table button.
- To immediately reset all of the values in the NAT table to their defaults, click the **Reset to defaults** button.

The first column of the NAT table contains links that you can use to configure the protocol values. The maximum number of protocols is ten. Five protocols are predefined; for example, the first protocol will always be hypertext transfer protocol (HTTP), and the second protocol will always be Telnet.

In addition, you can launch a Telnet or Web-based session to the I/O module and configure values through the selected session. To do this, click **Start Telnet Session** or click **Start Web Session** in the following BladeCenter Management Module window.



# Configuring through the browser-based interface

This section describes how to use the browser-based interface to access and configure the internal I/O module software.

This section also describes some of the browser-based I/O module management features. For more detailed information about configuring the I/O module, see the *Server Connectivity Module for IBM BladeCenter User's Guide*.

The I/O module offers an embedded HTML, browser-based interface that you can use to manage the I/O module through a standard browser, such as Opera, Netscape Navigator/Communicator, or Microsoft<sup>®</sup> Internet Explorer. The Web browser acts as an access tool and can communicate directly with the I/O module, using HTTP. HTTP is enabled by default. Your browser window might vary from the window illustrations in this document.

**Note:** This browser-based interface does not accept Chinese language input (or other double-byte character-set languages).

Because the browser-based interface is a built-in component of the I/O module (switch) software, you do not have to install a separate interface program. The browser-based interface contains these features:

- Two levels of password protection.
- The same configuration and monitoring functions as in the management-module CLI.

The browser-based interface requires a computer or workstation with network access to the I/O module and a frame-capable Web-browser program, such as Internet Explorer (version 6.0 or later) or Netscape Navigator (version 4.7 or later). Before you can access and start the browser-based interface, you must have:

- Installed the I/O module in the BladeCenter unit (see "Installing an I/O module" on page 11)
- Verified that the latest I/O module software is installed on the I/O module (see Chapter 5, "Updating the software," on page 29)
- Enabled the frames and the JavaScript<sup>™</sup> program in your Web browser
- · Enabled access to the browser-based interface

To enable access to the browser-based interface, use the following command from the Server Connectivity Module CLI. You can also use e instead of enable in the following command syntax:

>> Main# /cfg/sys/http <enable>

For additional information about using the Server Connectivity Module CLI, see the Server Connectivity Module for IBM BladeCenter User's Guide.

To start the browser-based interface, complete the following steps:

1. Type the following information in the address field of your browser, in the format http://xxx.xxx:yyzzz and press Enter.

(Where *xxx.xxx* is the IP address for the management module, *yy* is the I/O-module bay number in the BladeCenter unit, and *zzz* is the port number on the I/O module).

The login window opens.

2. If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User Name** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*). Click **OK**.

## Notes:

- a. The passwords used to access the I/O module are case-sensitive.
- b. To increase system security, change the password after you log on for the first time.

A browser-based interface window opens. The left-side pane contains the main menu. The top panel shows a real-time information-pane display of the I/O module. The browser-based interface is described in detail in the *Server Connectivity Module for IBM BladeCenter User's Guide*.

## Configuring through the Telnet interface

The I/O module supports a management interface that you can use to set up and control the I/O module over the network by using the Telnet protocol. You can use this facility to perform many basic network management functions. The following sections describe how to use the Telnet interface to access the I/O module, change its settings, and monitor its operation.

## Connecting to the I/O module

You can use the Telnet program (in VT-100 compatible terminal mode) to access and control the I/O module, if you have an existing network connection and if you know all of the following values:

- The IP address for the management module
- The I/O-module bay number in the BladeCenter unit
- The port number on the I/O module

If you have to obtain the IP address for the management module or establish a network connection, contact your system or network administrator. Be sure to use the correct IP address in the required command, as specified in "Accessing the main menu" on page 26.

#### Telnet usage conventions

The Telnet program is not menu-driven. You must type all of the Telnet commands that you want to be processed. After you have accessed the Telnet interface, you can type **help** at the command prompt if you need help with the Telnet commands.

**Important:** The **APPLY** command makes changes to the I/O module configuration for the current session only. If you want your changes to be permanent, select **Save Changes** from the main menu. Selecting **Save Changes** enters the current I/O module configuration, including all changes, into NVRAM, and then restarts the I/O module.

## Accessing the main menu

To connect to the I/O module through the Telnet interface, complete the following steps:

- From a DOS prompt command line, type telnet *x yyzzz* and press Enter (where *x* is the IP address for the management module, *yy* is the I/O-module bay number in the BladeCenter unit, and *zzz* is the port number on the I/O module).
- 2. If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User Name** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*). Press Enter.
- 3. Press Enter. The main menu is displayed.

For additional information about the Telnet program main menu, see the *Server Connectivity Module for IBM BladeCenter User's Guide*.

**Note:** The first user automatically gets root privileges. Create at least one root-level user for the I/O module when you set up your user accounts. See the *Server Connectivity Module for IBM BladeCenter User's Guide* for details.

## Logging onto the I/O module

To log in after you have created a registered user, complete the following steps from the login window (see "First-time connection to the I/O module" for additional information):

- 1. Type your user ID and press Enter.
- 2. Type your password and press Enter. The main menu window opens according to your access level or privilege.

After you log on to the I/O module, you can perform the tasks that are described in the *Server Connectivity Module for IBM BladeCenter User's Guide*.

## First-time connection to the I/O module

The I/O module supports user-based security that enables you to prevent unauthorized users from accessing the I/O module or changing its settings. This section describes how to log on to the I/O module.

The first time that you turn on the I/O module, you must set the date and time, through either the browser-based interface or the Telnet interface. Because the I/O module does not contain a battery-backed real-time clock, you also must reset the date and time whenever any of the following conditions exists:

- The I/O module is turned off and then back on
- The I/O module is restarted
- The I/O module software is updated

To set or reset the system date through the Telnet interface, use the following command from the Server Connectivity Module CLI:

/cfg/sys/date

To set or reset the system time through the Telnet interface, use the following command from the Server Connectivity Module CLI:

/cfg/sys/time

## Chapter 5. Updating the software

This chapter provides information for the following tasks:

- · Obtaining the management-module software
- Obtaining the I/O module software and performing the following tasks to update the I/O module:
  - Determining the level of the software installed
  - Obtaining the latest level of software for the I/O module
  - Updating the software on the I/O module
  - Resetting the I/O module to activate the software update

### Management-module software level

Make sure that you are using the latest version of management-module firmware for your BladeCenter unit type. See the *Management Module User's Guide* for your BladeCenter unit type for additional information.

## Updating the I/O module software

The following sections provide information for obtaining and updating the I/O module software.

## Determining the level of the I/O module software

After you install the I/O module in your BladeCenter unit, make sure that the latest I/O module (switch) software is installed on the I/O module. To determine the level of the I/O module software that is installed on the I/O module, complete the following steps:

1. Access and log on to the management module as described in the *Management Module User's Guide* for your BladeCenter unit type. If necessary, obtain the IP address of the management module from your system administrator. The login window opens.

If you do not have an assigned user identifier (ID) and initial password, type the default user ID (USERID) in the **User ID** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*) and click **OK**. The main page in the management module opens.

- Select Firmware VPD from the Monitors menu on the left side of the BladeCenter Management Module window. The Firmware VPD window opens.
- 3. On the Firmware VPD window, locate the I/O Module Firmware VPD heading between the Blade Server Firmware VPD and Management

**Module Firmware VPD** headings. Page down to the number of the I/O-module bay that contains the I/O module that you just installed; then, note the corresponding level of the software for the I/O module.

## Obtaining the latest level of software for the I/O module

To determine the latest level of the I/O module software that is available from IBM, complete the following steps:

- 1. Go to http://www.ibm.com/support/; then, click **Support & downloads**.
- 2. Type the I/O module model number. A window opens, displaying the latest level of available software.
- 3. Compare the level of software that you noted in the **I/O Module Firmware VPD** section of the Firmware VPD window to the latest level of available software. If the two software levels do not match, download the latest level from the World Wide Web.

The I/O module contains two software operating-system images. Therefore, you can always return to a previous image if the current download process fails.

## Upgrading the I/O module software

The I/O module software is upgraded through a TFTP server application. Typically, this software runs as an application under your operating system. Make sure that this software is installed on your server; then, download the software images from the IBM support Web site (http://www.ibm.com/support/) into a directory on your TFTP server. Enable the TFTP server and set its default directory to the one where the image is located.


For additional information, see the Server Connectivity Module for IBM BladeCenter User's Guide.

Use the management-module interface to start a Telnet session, as described in the following steps. The requirements for running a Telnet session are described in Chapter 4, "Configuring the I/O module," on page 19.

1. Access and log on to the management module as described in the *Management Module User's Guide* for your BladeCenter unit type. The login window opens.

If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User ID** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*) and click **OK**. Type n when asked if you want to run setup. The main page in the management-module interface opens.

- **Note:** The **User ID** and **Password** fields are case-sensitive. Enter your information in uppercase letters only (for example, ABCDE). To maintain system security, change the password after you log on for the first time.
- Select Management from the I/O Module Tasks menu on the left side of the BladeCenter Management Module window. The I/O Module Tasks window opens.
- **3**. Click **Advanced Management** under the applicable bay information in the BladeCenter Management Module window.
- 4. Click **Start Telnet Session** in the following window. If you do not have an assigned user ID and initial password, type the default user ID (USERID) in the **User ID** field and the default password (PASSWORD) in the **Password** field (where the sixth character is the number zero, not the letter *O*) and press Enter.



To upgrade the I/O module software, complete the following steps:

1. Using the management-module CLI, type the following command and press Enter:

/boot/gtimg *imageX TADDR zzzzz* (where *imageX* is the image to be installed, *TADDR* is the target address of the TFTP server, and *zzzzz* is the operating-system image file name, for example, SCM-1.0.020-os.img).

- 2. Reset and restart the I/O module as described in "Resetting and restarting the I/O module."
- **3**. Using the management-module CLI, type the following command and press Enter:

/boot/gtimg boot *TADDR yyyyy* (where *TADDR* is the target address of the TFTP server, and *yyyyy* is the boot image file name, for example, SCM-1.0.0.24-boot.img).

4. Using the management-module CLI, type the following command and press Enter:

/boot/image *imageX* (where *imageX* is the image to be copied from the image that was just loaded.

- 5. Reset and restart the I/O module as described in "Resetting and restarting the I/O module."
- **Note:** In some cases, there might only be one image to install. In other cases, two images might be available. If two images are available, you must select the one that you want to use for the I/O-module upgrade procedure.

## Resetting and restarting the I/O module

To activate the new image or images, you must reset the I/O module through the management-module interface. To reset the I/O module, complete the following steps:

- Select Management from the I/O Module Tasks menu on the left side of the BladeCenter Management Module window. The I/O Module Tasks window opens.
- 2. Select the I/O module bay on which the software update was just installed.
- 3. From the I/O Module Tasks window, select Power/Restart.
- 4. Click POWER OFF SWITCH MODULE.
- 5. Select the I/O module bay on which the software update was just installed.
- 6. Click POWER ON SWITCH MODULE.
- 7. Wait 70 seconds for POST to be completed.

- 8. Make sure that the latest I/O module software was correctly installed on the I/O module. Select **Firmware VPD** on the **Monitors** menu on the left side of the BladeCenter Management Module window. The Firmware VPD window opens.
- 9. On the Firmware VPD window, locate the **I/O Module Firmware VPD** heading between the **Blade Server Firmware VPD** and **Management Module Firmware VPD** headings. Page down to the number of the I/O-module bay that contains the I/O module that you just installed; then, note the corresponding level of the software for the I/O module.
- 10. Make sure that the latest I/O module software was correctly installed on the I/O module.

## Chapter 6. Solving problems

This section provides basic troubleshooting information to help you solve some problems that might occur while you are setting up the I/O module.

If you cannot locate and correct the problem using the information in this section, see Appendix A, "Getting help and technical assistance," on page 39.

## **Running POST**

To ensure that it is fully operational, the I/O module processes a series of tests during power-up or a restart (power-on self-test, or POST). These tests take approximately 1 minute to complete. The management module reads the test results and displays them for you. During normal operation, these tests are completed without error, and the green OK LED is lit. However, if POST fails, the amber I/O module error (fault) LED and the system-error LED on the BladeCenter unit will be lit. An event is stored in the event log in the System Status panel of the management module. The specific failure is displayed on the System Status I/O Module pane of the management-module interface.

#### Notes:

- For the location and description of the I/O module LEDs, see Chapter 3, "Information panel LEDs and external ports," on page 15.
- See the *BladeCenter Management Module User's Guide* for additional information about system status, event logs, and system errors.

## **POST errors**

There are two types of errors: noncritical and critical. A noncritical error applies to one port, and the I/O module is operational. You can continue to operate the I/O module; however, you must replace it as soon as possible. When critical errors occur, the I/O module does not operate. If a critical error occurs, complete the following steps:

- 1. Open the Management Module Switch Information window.
- 2. Turn off the I/O module; then, turn it back on.
- **3**. After POST is completed, the management-module interface displays the results. Refresh the window to view the POST results. If the error remains, the I/O module is defective. Replace the I/O module.

The following table describes the basic critical and noncritical failures. This abbreviated list is representative; it is not intended as an exhaustive list. An error code is associated with each failure. Error codes appear on the Management Module Switch Information window. Be sure to note the

applicable error code and corresponding failure. You might have to provide this information when you call IBM. For more details, see Appendix A, "Getting help and technical assistance," on page 39.

This Statement of Limited Warranty includes Part 1 - General Terms, Part 2 -Country-unique Terms, and Part 3 - Warranty Information. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

#### What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 -Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. Unless IBM specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine. THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

#### What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

#### How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

#### What IBM Will Do to Correct Problems

When you contact IBM for service, you must follow the problem determination and resolution procedures that IBM specifies. An initial diagnosis of your problem can be made either by a technician over the telephone or electronically by access to an IBM website.

The type of warranty service applicable to your Machine is specified in Part 3 - Warranty Information.

#### Limitation of Liability

IBM is responsible for loss of, or damage to, your Machine only while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller are responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM for any reason. You should remove all such information from the Machine prior to its return.

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

#### Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.

#### THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE OR JURISDICTION TO JURISDICTION.

#### Jurisdiction

All of our rights, duties, and obligations are subject to the courts of the country in which you acquired the Machine.


