

General Description

The IBM NetMEDIA Systems Management Adapter is an optional interface adapter card available for the NetMEDIA chassis. The NetMEDIA Adapter interfaces between the SCSI signals from a server to the devices installed in the NetMEDIA, providing SCSI Ultra2 compatibility, chassis system monitoring, and other system enhancements.

Specifically, the NetMEDIAAdapter:

- Provides a Low Voltage Differential Single-Ended (LVDS) to Single-Ended (S.E.) SCSI conversion feature which auto-senses for S.E. or LVD mode. This will allow the attachment of an LVDS channel to the NetMEDIA without requiring LVDS devices inside.
- Provides a SCSI signal repeater function. This will accommodate longer overall cable lengths to support Ultra2 (LVD).
- Provides system monitoring. The SAF-TE (SCSI Accessed Fault Tolerant Enclosures) circuitry on-board will monitor environmental parameters such as power supplies, fans, and temperature statuses.
- Provides on-board SCSI signal circuitry that will automatically enable or disable termination, adjusting accordingly. This allows multiple NetMEDIAs to be daisy-chained together.




Figure 1: NetMEDIA Systems Management Adapter

NetMEDIA Systems Management Adapter (External)




Figure 2: NetMEDIA Adapter (External)

Figure 2 displays the following:

LEDs- Illuminate to provide a visual indication for:

TERM PWR External Termination Power EnableS.E. SCSI External Single-Ended Mode

LVD SCSI External LVD Mode

External SCSI I/O Connectors- The NetMEDIA Adapter is equipped with two (2) 68-pin VHDCI connectors.

NetMEDIA Systems Management Adapter (Internal)





Figure 3: NetMEDIA Adapter (Internal)

Figure 3 displays the following:

Internal SCSI I/O Connector- The NetMEDIA Adapter is equipped with one (1) 68-pin Wide SCSI connector.

DC Power Connector- The NetMEDIA Adapter package includes one (1) DC power cable.

SAF-TE Monitoring Chip- Provides the control logic needed to monitor and manage such environmental parameters as fans, power supplies, and temperature status. This chip is implemented as a standard SCSI target and supports the SAF-TE specification. It accepts input from external sensors and allows the host system to control audible alarms and visual indicators (i.e. LEDs) in the NetMEDIA Storage Expansion Chassis.

Jumper Options-

- J1- Not used
- J4- Not used
- **J8** External Term Power Enabled (with jumper installed)
- **J9** Internal Term Power Enabled (with jumper installed)

LED- Provides a visual indication of SCSI bus activity (illuminates while SCSI bus is busy).

NetMEDIA SYSTEMS MANAGEMENT ADAPTER INSTALLATION

Installing the NetMEDIA Adapter(s) into the NetMEDIA Chassis

While performing the steps in this section, work on a soft surface to prevent excessive shock to the adapter(s) and to protect the finish of the chassis. If already installed into a rack cabinet, the NetMEDIA chassis *must be removed* so that the top panel can be accessed. The removal of the top panel is necessary for the installation of the NetMEDIA Adapter and its accompanying DC power cable. A flat head screwdriver will be required.

Removing the Slot Card

- Remove ALL power from the NetMEDIA chassis before working on the unit.
- 2. Verify that all power and I/O cables have been disconnected from the NetMEDIA chassis. Remove the unit from the rack cabinet, if already installed.
- 3. Place the unit on a soft, clean surface in a well-lit area with sufficient working space around the chassis.




Figure 4: NetMEDIA Slot Card Removal

- 4. Remove the two (2) M3.5 screws that secure the slot card to the NetMEDIA chassis as shown in Figure 4. After the screws are removed, carefully remove the slot card. The slot card will be attached to the internal SCSI I/O cable.
- 5. Carefully disconnect the internal SCSI I/O cable from the slot card and remove card.

Installing the DC Power Cable

- 1. Remove ALL power from the NetMEDIA chassis before working on the unit.
- 2. Remove the top panel from the NetMEDIA chassis (Refer to the IBM NetMEDIA Storage Expansion Chassis Unit EL User's Guide for specific instructions).




Figure 5: Connecting the DC Power Cable to the Power Supply Bracket

- 3. With the top panel removed, the power supply bracket can be accessed for installation of the DC power cable. The DC power cable (via the power supply interface connector) connects to the power supply bracket within the NetMEDIA chassis as shown below in Figure 5.
- 4. Connect the DC power cable to the default location on the power supply bracket as shown below in Figure 5. Do not reinstall top panel at this point.

Installing the NetMEDIA Adapter

- 1. Remove ALL power from the NetMEDIA chassis before working on the unit.
- 2. Once the DC power cable is connected to the power supply bracket, the NetMEDIAAdapter can be installed.





Figure 6: NetMEDIA Adapter Installation

- 3. Connect the DC power and internal SCSI I/O cables to the NetMEDIAAdapter through the rear of the chassis as shown below in Figure 6.

NOTE:

To prevent twisting of the DC power cable, proper orientation of the NetMEDIA Adapter is important. The LEDs should be at the top when positioning the NetMEDIA Adapter for connection and installation as shown in Figure 7 on the next page.

- 4. Once the DC power and internal SCSI I/O cables are connected, carefully insert the NetMEDIAAdapter into the open slot and secure using the two (2) M3.5 screws as shown in Figure 6 on the previous page.
- 5. Reinstall the top panel.

Statement of Limited Warranty

The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you originally purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. If you have any questions, contact IBM or your reseller.

Machine: IBM NetMEDIA Systems Management Adapter

Warranty Period: 1 year

Production Status

Each Machine is manufactured from new parts, or new and used parts. In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's warranty terms apply.

The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if authorized by IBM, will provide warranty service under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

For IBM or your reseller to provide warranty service for a feature, conversion, or upgrade, IBM or your reseller may require that the Machine on which it is installed be 1) for certain Machines, the designated, serial-numbered Machine and 2) at an engineering-change level compatible with the feature, conversion, or upgrade. Many of these transactions involve the removal of parts and their return to IBM. You represent that all removed parts are genuine and unaltered. A part that replaces a removed part will assume the warranty service status of the replaced part.

If a machine does not function as warranted during the warranty period, IBM or your reseller will repair it or replace it with one that is at least functionally equivalent without charge. The replacement may not be new, but will be in good working order. If IBM or your reseller is unable to repair or replace the Machine, you may return it to your place of purchase and your money will be refunded.

IBM or your reseller will provide certain types of repair and exchange service, either at your location or at IBM's or your reseller's service center, to restore a Machine to good working order. Types of service may vary from country to country. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation.

When a type of service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced.
