一般安全準則

請務必遵守下列預防措施以減少受傷及財產損壞的風險。

維修

請勿嘗試自己維修產品,除非 IBM 支援中心指示您這麼做。只將產品送至經核准修理您特定產品的 IBM 授權 服務供應商。

註:客戶可以自行升級或更換部份零件。這些零件稱為客戶可更換裝置或 CRU。IBM 會明確指出這些 CRU, 並在客戶更換這些零件時提供說明文件。您在執行這樣的更換時必須嚴格遵循所有指示。在嘗試更換前,請務 必確定電源已關閉,而且產品也切斷任何電源。如果您有任何問題或考量,請與 IBM 支援中心聯絡。

電源線和電源整流器

只使用產品製造廠商提供的電源線和電源整流器。

請勿將電源線繞在電源整流器或其他物品上。這麼做會導致電線磨損、斷裂或捲曲。這會帶來安全上的顧慮。

請勿將電源線佈置在容易被踩到、將人絆倒或被物品擠壓的地方。

避免電線及電源整流器碰觸到液體。例如,請勿將電源線或電源整流器留在靠近水槽、浴缸、廁所的地方或使 用液體清潔劑清潔過的地板上。液體會引起短路,尤其是在不當使用而壓壞了電線或電源整流器的情況下。液 體還會使電源線終端及/或整流器上的接頭終端逐漸腐蝕,最終導致過熱。

請務必按照正確的順序連接電源線及訊號線,並確保所有電源線接頭都安全並完全插入插座。

請勿使用交流電輸入接腳腐蝕及/或交流電輸入處或電源整流器上的任何地方有過熱跡象(如塑料變形)的任何電源整流器。

請勿使用任一端電氣接點有腐蝕或過熱跡象或電源線顯然已損壞的任何電源線。

延長線及相關裝置

確保延長線、穩壓保護器、不斷電系統、以及所使用的多孔延長線評估為可控制此產品的電性需求。請勿超載 使用這些裝置。如果使用多孔延長線,負載不應超過多孔延長線輸入額定功率。有關電源負載、電源需求及輸 入額定功率的問題,請向電氣技術人員請教以獲得更多資訊。

插頭及插座

如果與電腦設備搭配使用的插座(電源插座)看起來損壞或腐蝕,請讓合格的電氣技術人員更換插座後再使用。

請勿彎曲或變更插頭。如果插頭損壞,請與製造廠商聯絡以取得更換品。

部份產品配有三相插頭。這類插頭只適合接地電源插座。這是安全特殊裝置。請勿嘗試將其插入非接地的插座 中,會破壞此項安全特性。如果您無法將插頭插入插座,請與電氣技術人員聯絡,取得經核准的插座整流器, 或將插座更換為可使用這類安全特殊裝置的插座。請勿使電子插座超載。系統的總負載不能超過分支電路分級 的百分之八十。有關電源負載及分支電路額定功率的問題,請向電氣技術人員請教以獲得更多資訊。 請確定您使用的電源插座適當接線、可方便存取且位置接近設備。請勿將電源線拉伸到處於受力的狀態。

小心地將設備從電源插座上插拔。

電池

所有 IBM 個人電腦都附有不可充電的硬幣狀電池,來為系統時鐘提供電源。此外,許多攜帶式產品(如 Thinkpad 筆記型電腦)在攜帶時是利用可充電電池組提供系統電源。IBM 提供來與您的產品搭配使用的電池已 經過相容性測試,僅應以 IBM 核准的零件更換。

切勿嘗試打開或維修任何電池。請勿壓碎、戳破或焚燒電池或使金屬接點短路。請勿讓電池接觸到水或其他液體。請務必嚴格遵照產品文件中所附的說明來對電池組充電。

電池過度使用或處理不當會導致電池過熱,可能造成電池組或硬幣電池「放出」氣體或火焰。如果您的電池已 經受損,或您注意到電池有任何的漏溢情況,或電池極端出現雜質堆積,請停止使用電池,並向電池製造廠商 購買新電池。

電池很久沒用時會降解。對於一些充電電池來說(尤其是鋰電池),電池在放電狀態下不使用會增加電池短路 的危險,縮短電池的壽命,也具有安全上的顧慮。請勿讓充電鋰電池完全放電,或讓這些電池處於放電狀態。

熱能及產品通風

電腦在開啓和電池充電時會產生熱能。筆記型電腦由於體積較小,因此會產生相當多的熱能。請務必遵循以下 的基本預防措施:

- 當電腦正在運作或電池充電時,請勿長時間將電腦底座放在膝上或身體的任一部份。您的電腦在一般操作 期間會產生一些熱能。長時間與身體接觸可能會引起不舒服或可能造成皮膚灼傷。
- 請勿在易燃物附近或易爆炸的環境下操作電腦或為電池充電。
- 「為求安全、舒適和可靠操作,產品附有通風槽、風扇及/或散熱器。這些特殊裝置可能會由於產品放置在 床、沙發、地毯或其他彈性表面上而無法發揮功能。切勿阻礙、遮蓋或停用這些特殊裝置。

CD 和 DVD 光碟機安全

CD 和 DVD 光碟機以高速旋轉光碟。如果 CD 或 DVD 有破裂或任何受損,使用 CD 光碟機時,光碟有可能會斷開甚至會破碎。為了防止這種情況可能導致的損傷並減少機器損壞的危險,請執行下列步驟:

- 務必將 CD/DVD 光碟存放在原始包裝中
- 務必將 CD/DVD 光碟存放在遠離陽光直射及直接熱源處
- 不用時,請從電腦中取出 CD/DVD 光碟
- 勿彎曲或屈折 CD/DVD 光碟,或將它們強行放入電腦或其包裝中
- 在使用每片 CD/DVD 光碟前請檢查是否有破裂。請勿使用破裂或損壞的光碟

產品說明

本選用設備套件適用於多媒體應用程式。本光碟機隨附一片 CD,內含的軟體適用於下列作業系統:

- Microsoft[®] Windows[®] 2000 Professional
- Microsoft Windows Millennium Edition (Me)
- Microsoft Windows XP

您的套件包含以下項目:

- 使用手冊與軟體光碟(包含 Multi-Burner Plus 使用手冊及軟體應用程式)
- IBM Multi-Burner Plus 光碟機
- 有牙的四個安裝螺絲 (M3 x 5-mm) 一袋
- IDE 接線
- IBM Multi-Burner Plus 快速啓動手冊
- 雷射安全手册

上述物品若有遺漏或損壞,請和原經銷商連絡。請務必保留本產品的購買證明;日後在要求售後保證服務時,可能會用到這些資料。請參閱第 D-1 頁的附錄 D, 『Service and Support』,以取得技術支援資訊。

您的 Multi-Burner Plus 與 DVD Forum DVD-Multi Recorder 規格相容,也可以記錄和讀取 DVD-RAM、 DVD-RW 以及 DVD-R (一般為 650 nm)媒體。您的光碟機也可以記錄和讀取 DVD+RW Alliance DVD+RW 以及 DVD+R 格式。此外,光碟機也可以記錄 CD-R、CD-RW (標準、高速、Ultra-Speed 以及 Ultra-Speed+) 媒體,並使用防止緩衝區不足的技術做到可靠的 CD 與 DVD 燒錄作業。您的 Multi-Burner Plus 可以讀取其 他許多格式,包括 DVD 視訊、視訊光碟、音訊光碟、多重寫入 (multiple-session)、擴充架構 (XA) 光碟與 Kodak Photo CD。在設計上,這部 Multi-Burner Plus 必須安裝於採用整合型光碟機電路 (IDE) 或加強型 IDE (EIDE) 架構的電腦上。

軟體說明

Your IBM Multi-Burner Plus 使用手册與軟體光碟包含以下軟體:

Intervideo WinDVD Creator

此軟體可讓您將視訊檔記錄至大多數獨立式 DVD 播放程式均可播放的 DVD-RW、DVD-R、DVD+RW 或 DVD+R 媒體。您也可以使用此軟體在錄製前編輯和修改您自己的視訊資產。本軟體也支援 DVD-RAM 錄 製。

如果您的電腦中安裝了類比或 IEEE 1394 擷取裝置,您可以使用此軟體從攝影機錄製視訊。

• IBM Drive Letter Access (DLA)

此軟體可讓您如同寫入磁片般,透過光碟代號直接寫入 CD 和 VCD 媒體。您也可以格式化 DVD-RAM、DVD-RW、DVD-R、DVD+RW 以及 DVD+R 媒體。透過 DLA,您可以拖放檔案、建立新目錄或在任何應用程式中將檔案直接儲存至 Multi-Burner Plus。

• UDF Reader

UDF Reader 可以讓您安裝軟體,並讀取具備 DVD 光碟機的別台電腦上的 DVD-RAM、DVD-RW、DVD+RW 和 CD-RW 媒體。

IBM Record Now

此軟體可讓您複製 CD、建立音訊光碟、建立 MP3 光碟和編輯資料光碟。您也可以使用 RecordNow 將資料 寫入 DVD-RAM、DVD-RW、DVD-R、DVD+RW 以及 DVD+R 光碟,以便在其他電腦或相容的消費性電 子產品上使用。您還可以利用它來製作開機光碟,並儲存 CD 映像檔以備下一次燒錄時使用。

• IBM Simple Backup

此軟體可讓您建立完整或漸增式的系統檔案備份於 DVD-RAM、DVD-RW、DVD-R、 DVD+RW、DVD+R、CD-R 或 CD-RW 媒體,並且可以在電腦資料毀損時還原您的電腦。

Intervideo WinDVD

此軟體可讓您在電腦上播放 DVD 視訊或播放硬碟中的視訊檔。

安裝需求

安裝光碟機之前,請先確定您的電腦是否符合下列系統需求:

您必須有 Intel Pentium II 266MHz MHz(含)以上的微處理器,以及 AGP 2X 視訊功能才能編輯和播放 DVD。

- Windows 2000 Professional、Windows Me 或 Windows XP

準備工作

操作上的預防措施


請使用下列操作上的預防措施來保護您的光碟機:

- 請將 Multi-Burner Plus 置於防靜電袋中,等您準備要安裝時才取出。安裝時不要任意移動,移動容易產生靜 電。
- 請小心處理光碟機。掉落或搖動光碟機可能損壞光碟機中的元件。
- 不要強行插入 IDE 或電源線。這樣做可能會傷害接頭或光碟機。

磁碟機控制和接頭

以下圖解顯示光碟機控制與接頭的位置及功能。

光碟機正面



1 光碟托盤

您要使用這個托盤來載入以及取出光碟。

2 工作中指示燈

這個指示燈會在光碟機讀取、播放或播放光碟時亮起。


3 緊急退出孔

這個孔提供退出機制,用來取出光碟機中的光碟。

4 開啓/關閉按鈕

只要按下這個按鈕就可以開啓或關閉光碟托盤。

2 音效輸出接頭

3 配置接腳

這些接腳用來設定光碟機的配置。

4 IDE 埠

第2章安裝

安裝光碟機

安裝光碟機時,請完成下列步驟:

步驟 1. 打開電腦

- 1. 關閉電腦及其所有附屬裝置的電源。
- 2. 拔掉電腦及其所有附屬裝置的電源線。
- 3. 卸下電腦外殼。參閱您的電腦說明文件中關於卸下電腦外殼的指示。


步驟 2. 打開光碟機包裝

- 1. 在打開包裝光碟機的防靜電袋之前,請先將袋子和未上漆的金屬表面接觸至少二秒鐘。這樣可以釋放包裝 以及您身上的靜電。
- 2. 從袋中取出光碟機。

如果您必須放下光碟機,請先將防靜電袋放置在平坦而且光滑的表面,然後再將光碟機放置在防靜電袋上。

步驟 3. 設定配置跳接器

您可以按照所顯示的方式,將跳接器插在配置接腳上,以便將您的光碟機配置成「主要」(master) 1、「附屬」 (slave) 2 或「電纜線選取」(cable-select) 3。



請依據下列準則來判斷光碟機的配置是否正確。

- 如果這部光碟機是唯一連接至 IDE 接線的裝置,請將它配置為主要光碟機。這是預設的配置。
- 如果這部光碟機是連接至 IDE 接線的第二個裝置,請將它配置為附屬光碟機。請務必將其他裝置配置成「主要」(master)。在某些情況下,當同一條接線上的另一個裝置配置為「附屬」(slave)時,硬碟機可能會要求「主要和附屬裝置並存」跳接器設定。如需在其他裝置上設定配置跳接器的相關資訊,請參閱您電腦所隨附的說明文件。
- 有些電腦使用的裝置接頭有二條線相互交換的特殊 ATA 接線,使光碟機的配置是由接線而非跳接器位置來 決定。只有在配備這些特殊接線的電腦上,才能使用「電纜線選取」位置。請參閱電腦附隨的說明文件來 判斷您的 ATA 配接卡是否需要在「電纜線選取」位置放置跳接器。

如果您將跳接器插在「電纜線選取」位置上,IDE 接線會依據光碟機在接線上的位置,自動指定「主要」 (master)和「附屬」(slave)設定。在這種接線系統上,無論光碟機是唯一或第二個連接至接線的裝置,都必 須使用纜線選取設定。最靠近 IDE 控制器的磁碟機,會自動成為「主要」(master)磁碟機。在 IDE 接線上 任何其他的裝置,也必須設成「電纜線選取」。

步驟 4. 將光碟機裝至機槽

- 請注意 -


用螺絲直接鎖上光碟機時,請務必使用套件包裝中的 M3 x 5 公釐裝載螺絲。使用太長的螺絲可能會使光 碟機受損。

您可將光碟機用水平或垂直方式裝至電腦中。如果要垂直安裝光碟機,您必須在光碟機托盤關閉之前,先固定光碟機中的光碟,否則光碟機將無法正確地讀取光碟資料。

- 將光碟機滑入機槽。您的電腦可能需要進行安裝儲存裝置的程序。如需更多關於儲存裝置的資訊,請參閱 電腦附隨的說明文件。
- 2. 將光碟機機槽螺絲孔對準光碟機槽或安裝框架上的螺紋孔。
- 輕拴螺絲來檢查其位置。通常每側必須拴上二個螺絲。確認已經正確對準,然後再栓緊螺絲來固定光碟機。請不要拴得太緊。

步驟 5. 連接接線到光碟機

以下圖解顯示接線連接至光碟機的位置。



 將 40 接腳的 IDE 接線接頭 1 連接至光碟機的 IDE 連接埠上。對齊接線,使彩色編碼的邊緣最靠近電 源線接頭 2 。若 IDE 連接埠上沒有連接接線,或者電腦 IDE 連接埠上只有一個裝置接頭,或者您電腦 上的現有接線為 40-conductor 低速接線,則請使用此套件隨附的 80-conductor 高速 IDE 接線。IDE 接線 最多有三個接頭。如果只有一個裝置連接至 IDE 接線,請將接頭的一端連接至 IDE 埠,將接線的另一端 連接至光碟機。請不要使用中間的接頭。

如果您要連接二個裝置到 IDE 接線,請將接線的一端連接至 IDE 埠,將主要及附屬裝置連接至接線另一端的其餘接頭。大部份電腦都有二條接線,最多可連接四個 ATA 裝置。為求最佳效能,請將最快的裝置 (硬碟裝置)連接至主要 IDE 埠的接線,將光碟機或其他較慢的裝置(CD 光碟機、磁帶機、軟碟機)等 連接至次要 IDE 埠的接線。

2. 將 4 腳電源線 2 連接至光碟機上的電源接頭。

請檢查並確定所有接線不會被裝回的電腦外殼夾到或扭曲,而且所有的訊號排線和電源線均已固定接妥。

步驟 6. 完成硬體安裝

- 1. 確定光碟機已經裝妥,而且接頭已穩固連接。
- 2. 確定接線不會妨礙電腦外殼,也不會擋住電源供應器風扇葉片或通風路線。
- 3. 重新裝回電腦外殼。
- 4. 重新連接所有外部裝置。
- 5. 重新連接所有電源線至電源插座。

步驟 7. 安裝軟體

光碟機的所有軟體均包含於使用手冊與軟體光碟中。使用手冊與軟體光碟包含本使用手冊、IBM RecordNow、 IBM Simple Backup、IBM DLA、Intervideo WinDVD 以及 WinDVD Creator Plus。若要安裝軟體,請完成下 列程序:

- 1. 將使用手冊與軟體光碟插入光碟機。如果光碟自動啓動,請略過步驟 6。
- 2. 如果光碟未自動啓動,請按一下開始,再按下執行。
- 3. 輸入 e:\launch.bat, 其中 e 為 CD 或 DVD 光碟機的磁碟代號。
- 4. 按一下**確定**。
- 5. 選取您的語言。
- 6. 選取您要安裝的軟體。
- 7. 請遵循螢幕上的指示進行。
- 8. 當軟體安裝完畢,請重新啓動電腦。
- 註: 要使用完整的光碟機功能,請安裝瀏覽器視窗中列出的所有軟體應用程式,除了 UDF Reader 之外;這個 程式適用於其他不能辨識 UDF 檔案的電腦。

註: 快速安裝將會覆寫已安裝的所有軟體版本。

步驟 8. 設定 CD 播放系統

為了在光碟機上播放音訊光碟,您必須啓用數位播放。數位播放時,是以 IDE 資料傳輸線將音訊資料從光碟機 傳輸到電腦,而非使用類比音訊傳輸線。這樣可以有更好的播放品質,但是為了將數位資料轉換為類比音效, 電腦的負載會較高。要收聽 CD 音效,應設定兩部分:設定光碟機與播放應用程式。

數位播放時的光碟機設定

若使用 Windows XP, 會自動將光碟機設定成數位播放。







若要讀取資料光碟,請完成下列程序:

- 1. 開啓電腦的電源。
- 2. 按下光碟機前方的開啓/關閉按鈕。

使用 DVD 播放軟體

本節說明了如何使用和自訂 DVD 播放軟體。您可以在使用手冊與軟體光碟中的 Readme 檔,找到 DVD 播放 軟體的最新資訊。

使用軟體之前

WinDVD 需要相容的視訊裝置驅動程式和 IDE 匯流排主控功能才能運作。請參閱第 C-1 頁的附錄 C, 『自訂 裝置驅動程式配置設定』以便取得啓用 DMA 匯流排主控功能以及找出視訊裝置驅動程式的資訊。

使用 DVD 播放程式

當您將 DVD 視訊光碟插入光碟機時,DVD 播放軟體會自動啓動,並開始播放視訊光碟。如果 DVD 光碟中 包含了視訊和程式內容,程式內容將會自動執行。

若要檢視視訊/程式 DVD 光碟的視訊內容,請從開始功能表、 Pa WinDVD、再按一下 Play。

在 Microsoft Windows XP 中,您也可以使用 Windows Media Player 應用程式播放 DVD 視訊內容。

變更 DVD 的區域碼

「區域化及反複製」(DVD 區域碼)採用內容混雜系統 (CSS) 標準,來防止 DVD 上的智慧財產權遭人非法 複製。該項標準原本由「美國電影協會」(MPAA) 用於處理影片盜錄的問題,不過現在任何內容均適用。 CSS 的運作原理在於抑制未授權之未加密資料的傳輸。播放系統必須先向 CSS 取得授權,才能將加密資料解碼。

CSS 規格將全球分為七個唯一的區域。指定給某區域的內容不能由另一區域的播放系統加以讀取。CSS 用於防止 DVD 內容的數位複製; Macrovision 所設計出的另一種技術則用於防止 DVD 內容的類比複製。 Macrovision 標準是電影界廣泛採用的一種混雜系統,用於防止商業用 VCR 對影片內容進行非法複製。DVD 播放系統一定可以同時支援 CSS 與 Macrovision 的反複製標準。

在您第一次將 DVD 視訊光碟插入光碟機時,系統會提示您設定區域。如果您重置於世界上的另一區域,您可使用 DVD 播放軟體來變更區域碼。

註: DVD 區域碼只能變更五次。區域碼變更五次後,光碟機便只能播放與您所設定的第五個區域碼有關聯的 MPEG-2 影片標題。

若要變更區域碼,請執行下列步驟:

- 1. 開啓電腦的電源並啓動作業系統。
- 2. 按一下開始。

- 3. 選取程式集。
- 4. 按一下 Intervideo WinDVD。
- 5. 按一下 Intervideo WinDVD。

- 8. 插入新區域的單區 DVD。
- 9. 選取貴國正確的區域碼。
- 10. 按一下**確定**。

使用 Drive Letter Access (DLA)

Drive Letter Access (DLA) 可讓您將資料寫入 DVD-RAM、DVD-RW、DVD-R、DVD+RW、DVD+R、CD-R 以及 CD-RW 媒體。DVD-RAM DVD-RW、DVD+RW 以及 CD-RW 媒體可以多次寫入,而 DVD-R、DVD+R 以及 CD-R 媒體僅可格式化或寫入一次。

若要格式化和寫入 DVD-RAM、DVD-RW、DVD-R、DVD+RW、DVD+R、CD-R 或 CD-RW 媒體:

- 1. 將光碟插入光碟機。
- 2. 連按兩下我的電腦。在 Multi-Burner Plus 磁碟代號上,按一下滑鼠右鍵。
- 3. 按一下格式化。格式化 DVD 會需要 90 分鐘。
- 4. 完成格式化後,您可以將檔案拖放至 Multi-Burner Plus 光碟機圖示,或在「Windows 檔案總管」中移動檔案。

若要使 CD-R 和 DVD-R 媒體可與其他電腦相容:

- 1. 連按兩下我的電腦。在 Multi-Burner Plus 磁碟代號上,按一下滑鼠右鍵。
- 2. 按一下 Make Compatible。

為了在其他電腦上使用 UDF 格式的 DVD-RAM、DVD-RW、DVD+RW 或 CD-RW 媒體,您可以使用使用手 冊與軟體光碟內附的 UDF Reader 程式。若要使用 UDF Reader 程式,請依循此程序:

- 1. 將使用手冊與軟體光碟插入您要使用 UDF 格式光碟之電腦的 CD 或 DVD 光碟機。
- 2. 按一下**開始**。
- 3. 按一下**執行**。
- 4. 輸入 e:\UDF\1anguage, 其中 e 為 CD 或 DVD 光碟機的磁碟代號, language 是您所使用的語言。

使用 RecordNow

利用 RecordNow,您可以利用各種方式錄製您自己的 DVD、音樂光碟、資料光碟,並可複製現有光碟。 RecordNow 也可以將光碟的映像檔儲存到硬碟,之後再將那些映像檔燒錄成光碟。關於使用 RecordNow 的詳 細資訊包括在 RecordNow 說明中。您可以按下 RecordNow 功能表中的 F1,來存取 RecordNow 說明。

若要在 Windows Me 或 Windows 2000 中啓動 RecordNow, 選取開始>程式>IBM RecordNow。

RecordNow 專案

一旦啓動 RecordNow,您就有機會選取三個具有不同功能的標籤。

- 「音效專案」標籤可讓您建立音樂光碟、MP3 Jukebox 光碟、收聽音樂光碟或製作光碟命名標籤。
- 「資料專案」標籤可讓您製作資料光碟、製作精確的複製、抹寫可重寫光碟或製作 CD 或 DVD 標籤。
- 「備份專案」功能表可讓您保存您的檔案,製作精確複製、儲存 CD 或 DVD 的映像檔、將所儲存的映像檔 燒錄在光碟中或製作光碟標籤。

對所有可變更的光碟與 DVD 專案而言,只要選取了專案檔, RecordNow 可從光碟機中 CD 或 DVD 上的任何資料開始。

製作開機 CD 或 DVD

要製作開機 CD 或 DVD,開啓一個資料專案,並按下視窗右上角的 bootable CD 按鈕。會提示您從硬碟上選 取一個開機映像檔或用軟碟製作一個開機映像檔。

關於 CD 與 DVD 映像檔

RecordNow 能夠儲存並建立 ISO 與 GI 類型的 CD 映像檔。ISO 映像檔僅用於儲存僅具有一個資料階段作業 的資料光碟。您必須使用 GI 格式來儲存音訊光碟、DVD、多階段作業光碟以及混合類型光碟。

使用 Intervideo WinDVD Creator

您可以使用 Intervideo WinDVD Creator 來擷取、編輯和錄製視訊和音訊檔。您也可以使用自己的視訊和音訊 檔,透過 Intervideo WinDVD Creator 來建立和錄製 DVD 視訊。如需了解 Intervideo's WinDVD Creator 功 能的更多資訊,請參閱使用手冊與軟體光碟中的線上 WinDVD Creator 使用手冊。

WinDVD Creator 主視窗中的主要功能為**擷取、編輯、編寫**以及**製作影片**。透過這些功能,您可以匯入並編輯自己的視訊和音訊檔案;並以下列任一支援格式加以儲存:MPEG-1、MPEG-2、ASF、WMV 以及 AVI。

準備好您的視訊和音訊檔案之後,您可以藉由**擷取**以及編輯的步驟,在編寫功能中新增自訂功能表。您可以匯入自己的靜態影像檔做為功能表的背景,或選取其中一個範例影像檔。您的影片備妥之後,請到製作影片來選取輸出格式以及建立影片使用的視訊標準。將影片寫入光碟,或儲存到硬碟機中稍後寫入。 如果您使用WinDVD Creator Plus 在硬碟機中建立 DVD 映像檔,您可以從「專案」功能表中,選取將映像檔載入 Burn。

WinDVD Creator 也可以使用光碟管理程式,直接將視訊錄製到可讀取式 DVD 媒體中,而不需額外使用硬碟 機的空間。透過「光碟管理程式」,您可以擷取新的視訊,或是使用已具備的視訊檔案;藉著建立自訂功能 表,完成您的影片。您的影片可以建立為 +VR 或 -VR 的視訊格式。透過「光碟管理程式」,您在任何時間都 可以編輯影片、新增或刪除視訊區段或變更您自訂的功能表。

註: 舊式的 Set-Top DVD 播放程式中,+/-VR 格式光碟有相容性的限制。

光碟的操作與維護

• 電腦或光碟機無法正確地操作,或是作業指示燈不亮。

請採取下列動作:

- 1. 請檢查在放入光碟時,標籤面是否向上。
- 2. 請檢查所有的裝置,是否已適當地連接到電腦和電源插座上。
- 3. 關閉電腦的電源,拔掉您電腦和所有連接裝置的接線,再取下電腦外殼。
- 請檢查所有的電源和 IDE 接線,是否已連接妥當。請拔除 IDE 接線的連接,並檢查接腳是否彎曲或沒 有對齊。如果您找不到任何問題,請重新連接排線。





附錄 E. IBM Statement of Limited Warranty - Z125-4753-0804/2004

Part 1 - General Terms

This Statement of Limited Warranty includes Part 1 - General Terms, Part 2 - Country-unique Terms, and Part 3 - Warranty Information. The terms of Part 2 replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

What this Warranty Covers

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original Date of Installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the Date of Installation unless IBM or your reseller informs you otherwise. Many features, conversions, or upgrades involve the removal of parts and their return to IBM. A part that replaces a removed part will assume the warranty service status of the removed part. Unless IBM specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse (including but not limited to use of any Machine capacity or capability, other than that authorized by IBM in writing), accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- · failure caused by a product for which IBM is not responsible; and
- any non-IBM products, including those that IBM may procure and provide with or integrate into an IBM Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

IBM does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

How to Obtain Warranty Service

If the Machine does not function as warranted during the warranty period, contact IBM or your reseller to obtain warranty service. If you do not register the Machine with IBM, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What IBM Will Do to Correct Problems

When you contact IBM for service, you must follow the problem determination and resolution procedures that IBM specifies. An initial diagnosis of your problem can be made either by a technician over the telephone or electronically by access to an IBM website.

The type of warranty service applicable to your Machine is specified in Part 3 - Warranty Information.

You are responsible for downloading and installing designated Machine Code (microcode, basic input/output system code (called "BIOS"), utility programs, device drivers, and diagnostics delivered with an IBM Machine) and other software updates from an IBM Internet Web site or from other electronic media, and following the instructions that IBM provides.

If your problem can be resolved with a Customer Replaceable Unit ("CRU") (e.g., keyboard, mouse, speaker, memory, hard disk drive), IBM will ship the CRU to you for you to install.

If the Machine does not function as warranted during the warranty period and your problem cannot be resolved over the telephone or electronically, through your application of Machine Code or software updates, or with a CRU, IBM or your reseller, if approved by IBM to provide warranty service, will either, at its discretion, 1) repair it to make it function as warranted, or 2) replace it with one that is at least functionally equivalent. If IBM is unable to do either, you may return the Machine to your place of purchase and your money will be refunded.

IBM or your reseller will also manage and install selected engineering changes that apply to the Machine.

Exchange of a Machine or Part

When the warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

Your Additional Responsibilities

Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service.

You also agree to:

- 1. ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange;
- 2. obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and

Limitation of Liability

IBM is responsible for loss of, or damage to, your Machine only while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller are responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM for any reason. You should remove all such information from the Machine prior to its return.

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), except for any liability that cannot be waived or limited by applicable laws, IBM is liable for no more than

- 1. damages for bodily injury (including death) and damage to real property and tangible personal property; and
- 2. the amount of any other actual direct damages, up to the charges (if recurring, 12 months' charges apply) for the Machine that is subject of the claim. For purposes of this item, the term "Machine" includes Machine Code and Licensed Internal Code ("LIC").

This limit also applies to IBM's suppliers and your reseller. It is the maximum for which IBM, its suppliers, and your reseller are collectively responsible.

SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

Governing Law

Both you and IBM consent to the application of the laws of the country in which you acquired the Machine to govern, interpret, and enforce all of your and IBM's rights, duties, and obligations arising from, or relating in any manner to, the subject matter of this Statement of Limited Warranty, without regard to conflict of law principles.
