

# **Chapter 1. Introduction**

The *IBM® TotalStorage® DS300* and *DS400 Hardware Maintenance Manual* contains basic information, such as specifications and symptom lists, about the IBM TotalStorage DS300 and DS400 storage subsystems. You can use this information to perform basic hardware maintenance and resolve problems on your storage subsystem. You can also use this information to complete the tasks given in the problem determination procedures provided in the *IBM TotalStorage DS300 Problem Determination Guide* and *DS400 Problem Determination Guide*. Each Problem Determination Guide is an interactive document that is available on the IBM support Web site:

**Note:** The component information that is provided in the maintenance portion of this document has been extracted from the individual installation and user's guides for each component. Therefore, you might find it helpful to see the individual installation and user's guides for specific components.

The storage subsystem documentation might be updated occasionally to include information about new features, a translated version of the documentation might be available in your language, or technical updates might be available to provide additional information that is not included in the storage subsystem documentation. # **Using the Documentation Browser**

When you select a document, a description of the document appears under **Topic** Description. To select more than one document, press and hold the Ctrl key while you select the documents. Click View Book to view the selected document or documents in Acrobat Reader or xpdf. If you selected more than one document, all the selected documents are opened in Acrobat Reader or xpdf.

To search all the documents, type a word or word string in the **Search** field and click Search. The documents in which the word or word string appears are listed in order of the most occurrences. Click a document to view it, and press Crtl+F to use the Acrobat search function or Alt+F to use the xpdf search function within the document.

# Chapter 2. IBM TotalStorage DS300 storage subsystem type 1701 (models 1RL, 1RS, 2RD)

This chapter covers basic hardware maintenance information for the DS300 storage subsystem type 1701 (models 1RL, 1RS, 2RD). For more detailed information on the installation and use of the DS300 storage subsystem, refer to the *DS300 and DS400 Hardware Installation and User's Guide.*

#### General checkout

- The IBM TotalStorage DS300 storage subsystem model 1RS comes with the following components:
  - One iSCSI RAID controller
  - 14 hard disk drive filler panels
  - Two power supplies
  - One or more power cords
- The IBM TotalStorage DS300 storage subsystem model 2RD comes with the following components:
  - Two iSCSI RAID controller
  - 14 hard disk drive filler panels
  - Two power supplies
  - One or more power cords

# **Specifications**

The following information is a summary of the specifications of the storage subsystem. Depending on the storage subsystem model, some specifications might not apply.

Racks are marked in vertical increments of 1.75 inches. Each increment is referred to as a unit, or "U." A 1-U-high device is 1.75 inches tall.

#### Acoustical noise emissions:

# Storage subsystem components

The following sections show the components of the storage subsystem.

The hot-swap features of the storage subsystem enable you to remove and replace hard disk drives and power supplies without turning off the storage subsystem. Therefore, you can maintain the availability of the system while a hot-swap device is removed, installed, or replaced.

#### Front view

The following illustration shows the components and controls on the front of the DS300 type 1701 (models 1RS, 2RD) storage subsystem.

Note: The illustrations in this document might differ slightly from your hardware.




Figure 1. DS300 (type 1701 (models 1RS, 2RD) storage subsystem front components

#### Hard disk drive

You can install up to 14 Ultra320 hot-swap hard disk drive customer replaceable units (CRUs) in the storage subsystem. Each hard disk drive CRU contains a hard disk drive and tray.

#### **Drive filler panel**

The storage subsystem comes without installed hard disk drives and contains filler panels in the unused drive bays. Before installing new drives, you must remove the filler panels and save them. Each of the 14 bays must always contain either a filler panel or a hard disk drive to maintain proper cooling and airflow.

#### Tray handle and latch

Use the blue latch on the tray handle to release or lock the hard disk drive in place.

For information about installing and replacing a hard disk drive, see "Installing a hot-swap hard disk drive" on page 36 and "Replacing a hot-swap hard disk drive" on page 37.

The following illustration shows the components and controls on the front of the DS300 (model 1RL) storage subsystem.




Figure 2. DS300 (model 1RL) storage subsystem front components

The DS300 (model 1RL) storage subsystem supports seven hard disk drives. You can add seven more hard disk drives with the purchase of a second power supply.

#### Rear view

The following illustrations show the components at the rear of the two DS300 storage subsystem models.




Figure 3. DS300 storage subsystem model 1RS rear view




Figure 4. DS300 storage subsystem model 1RL rear view




Figure 5. DS300 storage subsystem model 2RD rear view

#### iSCSI RAID controller

The DS300 storage subsystem models come with one iSCSI RAID controller. There is a filler panel in the right RAID controller bay (side B), which must remain in place to maintain proper cooling.

The DS300 storage subsystem model 1RL contains one iSCSI RAID controller with one 1 Gb/sec (gigabit per second) Ethernet input connector for data and management and eight LEDs.

#### Notes:

- 1. Make sure that you always install a power supply above a controller.
- 2. The RAID controller in model 1RL does not contain a cache battery.

The DS300 storage subsystem model 1RS contains one iSCSI RAID controller with one 1 Gb/sec Ethernet input connector for management, two 1 Gb/sec Ethernet input connectors for data, and 12 LEDs.

The DS300 storage subsystem model 2RD contains two iSCSI RAID controller with one 1 Gb/sec Ethernet input connector for management, two 1 Gb/sec Ethernet input connectors for data, and 12 LEDs.

Each RAID controller also contains a cache battery to maintain cache data in the event of a power failure. For more information, see "Cache memory and RAID controller battery" on page 12.

#### Power supply

The DS300 storage subsystem comes with either one or two hot-swap power supplies. Each unit is a self-contained power supply with three integral cooling fans, a power switch, and two status LEDs.

If the storage subsystem comes with only one power supply, there is a filler panel in the right power supply bay (side B). The filler panel must remain in place to maintain proper cooling.

**Note:** If storage subsystem model 1RL has only one power supply installed, both the RAID controller and the power supply must be installed in side A.

# Storage subsystem controls and LEDs

The following sections show the DS300 storage subsystem controls and LEDs.

#### Front view

The following illustration shows the LEDs on the front of the DS300 storage subsystem.




Figure 6. DS300 storage subsystem front LEDs

#### Rear view

**Power supply:** The following illustration shows the LEDs, controls, and connectors on the power supply.




Figure 7. DS300 power supply LEDs, controls, and connectors

#### Power cord connector

Connect the power cord to this connector.

#### AC power on/off switch

Use this switch to turn the power supply on and off.

#### Power OK LED (green)

When this LED is lit, it indicates that the power supply is turned on.

#### Fault LED (amber)

When this LED is lit, there is a fault with either the power supply or a fan.

#### iSCSI RAID controller with one Ethernet connector (type 1701 (model 1RL):

The following illustration shows an iSCSI RAID controller with one Ethernet connector (model 1RL).




Figure 8. iSCSI RAID controller (model 1RL) LEDs, controls, and connectors

#### Serial connectors (SP1 and SP2)

The serial connectors are for diagnostic purposes only.

#### Data and management iSCSI connector

The data and management connector is for ServeRAID Manager function and iSCSI data traffic.




Figure 9. iSCSI RAID controller (models 1RS, 2RD) LEDs, connectors, and controls

# Cache memory and RAID controller battery

Each RAID controller contains 256 MB of cache memory. It also contains a sealed, rechargeable lithium ion battery that maintains data in the cache for up to three days in the event of a power failure. The service life of the battery is 36 months, after which time the battery should be replaced. For information about replacing the battery, see "Replacing the cache battery in the RAID controller" on page 41.

# Monitoring status through software

Use the ServeRAID Manager program to monitor the status of the storage subsystem. Run the software constantly, and check it frequently. ServeRAID Manager provides the best way to diagnose and repair storage subsystem failures. The software can help you:

- · Determine the nature of the failure
- Locate the failed component
- Determine the recovery procedures to repair the failure

For example, the recovery procedure for an IBM Predictive Failure Analysis<sup>®</sup> (PFA) flag (impending drive failure) on a drive varies depending on the drive status (hot spare, unassigned, RAID level, current logical drive status, and so on). Depending on the circumstances, a PFA flag on a drive can indicate a high risk of data loss (if the drive is in a RAID 0 volume) or a minimal risk (if the drive is unassigned). Only the ServeRAID Manager software can identify the risk level and provide the necessary recovery procedures.

Note: For PFA flags, the General-system-error LED and Drive fault LEDs do not turn on, so checking the LEDs will not notify you of the failure, even if the risk of data loss is high.

Recovering from a storage subsystem failure might require you to perform procedures other than replacing the component (such as backing up the logical drive or failing a drive before you remove it). The ServeRAID Manager software gives these procedures.

**Attention:** You might lose data if you do not follow the software recovery procedures.

# Using the diagnostic hardware

A wrap-plug can be ordered as a IBM CRU option (Part Number 00G2380). The wrap-plug is used to perform the wrap test and to identify ethernet path problems.




Figure 10. DS300 type 1701 (models 1RL, 1RS, 2RD) storage subsystem parts list

# Storage subsystem components

#### Front view

The following illustration shows the components and controls on the front of the DS400 storage subsystem.




Figure 11. DS400 storage subsystem front components

#### Hard disk drive

You can install up to 14 Ultra320 hot-swap hard disk drive *customer replaceable units* (CRUs) in the storage subsystem. Each hard disk drive CRU contains a hard disk drive and tray.

#### **Drive filler panel**

The storage subsystem comes without installed hard disk drives and contains filler panels in the unused drive bays. Before installing new drives, you must remove the filler panels and save them. Each of the 14 bays must always contain either a filler panel or a hard disk drive to maintain proper cooling and airflow.

#### Tray handle and latch

Use the blue latch on the tray handle to release or lock the hard disk drive in place.

#### Rear view




Figure 12. DS400 storage subsystem model 1700-1RS rear view




Figure 13. DS400 storage subsystem model 1700-2RD rear view

#### Fibre Channel RAID controller

The DS400 storage subsystem comes with one or two Fibre Channel RAID controllers. Each Fibre Channel RAID controller has one 1 Gb/sec (gigabit per second) Ethernet connector for management, two 2 Gb/sec Fibre Channel host ports, and 12 LEDs.

If the storage subsystem comes with only one RAID controller, there is a filler panel in the right RAID controller bay (side B). The filler panel must remain in place to maintain proper cooling.

Each RAID controller also contains a battery to maintain cache data in the event of a power failure. For more information, see "Cache memory and RAID controller battery" on page 26..

#### **Power supply**

The DS400 storage subsystem contains two hot-swap power supplies. Each unit is a self-contained power supply with three integral cooling fans, a power switch, and two status LEDs.




Figure 14. DS400 storage subsystem front LEDs




Figure 15. DS400 power supply LEDs, controls, and connectors




Figure 16. Fibre Channel RAID controller LEDs and connectors




Figure 17. DS400 storage subsystem parts list

# Appendix A. Installing and replacing components

This appendix provides instructions for installing and replacing hardware components in the storage subsystem.

### Installation guidelines

Before you begin installing options, read the following information:

- Read the safety information beginning on page iii and the guidelines in "Handling static-sensitive devices." This information will help you work safely with the server and options.
- Make sure that you have an adequate number of properly grounded electrical outlets for your server, external storage subsystem, and other devices.
- · Back up all important data before you make changes to disk drives.
- · Have a small flat-blade screwdriver available.
- You do not have to turn off the storage subsystem to install or replace a hard disk drive or power supply.
- Blue on a component indicates touch points, where you can grip the component to remove it from or install it in the storage subsystem, open or close a latch, and so on.
- Orange on a component or an orange label on or near a component indicates
  that the component can be hot-swapped, which means that you can remove or
  install the component while the storage subsystem is running. (Orange can also
  indicate touch points on hot-swap components.) See the instructions for removing
  or installing a specific hot-swap component for any additional procedures that
  you might have to perform before you remove or install the component.
- For a list of supported options for the storage subsystem, go to http://www.ibm.com/pc/compat/.

# System reliability guidelines

To help ensure proper cooling and system reliability, make sure that:

- Each of the drive bays has a drive or a filler panel and electromagnetic compatibility (EMC) shield installed in it.
- If the storage subsystem has redundant power, each of the power-supply bays has a power supply installed in it.
- There is adequate space around the storage subsystem to allow the storage subsystem cooling system to work properly. Leave approximately 50 mm (2.0 in.) of open space around the front and rear of the storage subsystem. Do not place objects in front of the fans.
- You have replaced a failed power supply within 10 minutes of removal.
- · You have replaced a hot-swap drive within 2 minutes of removal.

# Handling static-sensitive devices

**Attention:** Static electricity can damage the server and other electronic devices. To avoid damage, keep static-sensitive devices in their static-protective packages until you are ready to install them.

To reduce the possibility of damage from electrostatic discharge, observe the following precautions:

- Limit your movement. Movement can cause static electricity to build up around you.
- · Wear an electrostatic-discharge wrist strap, if one is available.
- Handle the device carefully, holding it by its edges or its frame.
- · Do not touch solder joints, pins, or exposed circuitry.
- · Do not leave the device where others can handle and damage it.
- While the device is still in its static-protective package, touch it to an unpainted metal part of the storage subsystem for at least 2 seconds. This drains static electricity from the package and from your body.
- Remove the device from its package and install it directly into the storage subsystem without setting down the device. If it is necessary to set down the device, put it back into its static-protective package. Do not place the device on the storage subsystem cover or on a metal surface.
- Take additional care when handling devices during cold weather. Heating reduces indoor humidity and increases static electricity.

# Installing and removing the bezel on DS300 Models 1700-1RS and 1700-2RD, and DS400

**Note:** Before installing the bezel on the storage subsystem, install it in the rack. For more information, see the *Rack Mounting Instructions* that come with the storage subsystem.

Complete the following steps to install the storage subsystem bezel:

- 1. Position the bezel directly in front of the storage subsystem.
- 2. Insert the three tabs on the bottom of the bezel into the matching holes on the storage subsystem chassis.




Figure 18. Installing the bezel on the DS300 and DS400

- 3. Rotate the top of the bezel toward the storage subsystem until the two tabs on the top of the bezel snap into place.
- 4. To remove the bezel:

- a. Press in on the blue tab on the top outside edge of both sides of the bezel, and pull the top of the bezel slightly away from the storage subsystem.
- b. Pull the bezel up to release the three tabs at the bottom edge of the bezel. Store the bezel in a safe place.

### Installing and removing the bezel on the DS300 type 1701 (model 1RL)

**Note:** Before installing the bezel on the storage subsystem, install it in the rack. For more information, see the *Rack Mounting Instructions* that come with the storage subsystem.

Complete the following steps to install the storage subsystem bezel:

1. Make sure that the EMI panel on the left side of the storage subsystem remains in place for proper cooling.




Figure 19. Installing the bezel on the DS300 model 1RL

- 2. Place the 7-hard disk drive cover insert into the left side of the bezel. Make sure that the cover insert tabs are flush with the bezel frame.
- 3. Position the bezel directly in front of the storage subsystem.
- 4. Insert the three tabs on the bottom of the bezel into the matching holes on the storage subsystem chassis.
- 5. Rotate the top of the bezel toward the storage subsystem until the two tabs at the top of the bezel snap into place.
- 6. To remove the bezel:
  - a. Press in on the blue tab on the top outside edge on both sides of the bezel, and pull the top of the bezel slightly away from the storage subsystem.
  - b. Pull the bezel up to release the three tabs at the bottom edge of the bezel. Store the bezel in a safe place.

### Installing a hot-swap hard disk drive

The storage subsystem supports up to 14 IBM Ultra320 SCSI hard disk drives. These IBM drives come preassembled in a drive tray, ready for installation. (Do not detach the drive from the tray.) Be sure to record the location information for each drive in Appendix A of the *DS300 and DS400 Hardware Installation and User's Guide*.

The storage subsystem comes with filler panels in the drive bays. Before installing a new hard disk drive, remove the filler panel and save it for future use. Each of the 14 bays must contain either a filler panel or a hard disk drive.

Complete the following steps to install a hard disk drive in the storage subsystem. You can install drives while the storage subsystem is turned on.

**Note:** If you are replacing a drive, see "Replacing a hot-swap hard disk drive" on page 37 for more information.

- 1. Read the instructions that come with the hard disk drive.
- 2. Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 3. Determine the bay into which you want to install the hard disk drive.
- 4. Remove the filler panel:
  - a. Insert a finger into the square hole at the top of the filler panel to grip and pull the filler panel out of the drive bay.
  - b. Save the filler panel for future use.
- 5. Install the hard disk drive.

**Note:** The hard disk drive comes with a tray already attached. Do not attempt to detach the drive from the tray.




Figure 20. Installing a hard disk drive

- a. Press the latch on the bottom of the tray handle to release it.
- b. Pull out the tray handle to the open position.
- c. Gently slide the drive into the empty bay until the tray handle touches the expansion-unit bezel.
- d. Push down the tray handle into the closed (latched) position.
- 6. Check the hard disk drive LEDs:
  - When a drive is ready for use, the green activity LED is off and the amber drive-fault LED is off.
  - If the amber drive-fault LED is lit and not flashing, remove the drive from the unit and wait 10 seconds; then, reinstall the drive.

ServeRAID information: In some cases, the ServeRAID Manager program will automatically reset the drive to the Hot Spare or Rebuild state. If the drive-state change does not occur automatically (amber LED stays lit), see the ServeRAID Manager program online help for information about changing the state of the drive from the current state to another state, such as Hot Spare or Ready. The amber LED turns off within 10 seconds after the drive-state change.

7. Configure the hard disk drive using the appropriate software.

### Replacing a hot-swap hard disk drive

Hard disk drive problems include any malfunctions that delay, interrupt, or prevent successful I/O activity between the hosts and the hard disk drives in the storage subsystem. This includes transmission problems between the host controllers and the drives. This section explains how to replace a failed drive.

Attention: Failure to replace a hard disk drive in the correct bay might result in loss of data. If data is stored on the hard disk, label the drive before you remove it. Then, when you replace the drive, install it in the same drive bay from which you removed it.

Check the hardware and software documentation that comes with your server to see whether there are restrictions regarding hard disk drive configurations. Some system SCSI configurations might not allow mixing different hard disk drive capacities or types within an array.

Complete the following steps to replace a hot-swap hard disk drive:

- 1. Read the instructions that come with the hard disk drive.
- 2. Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 3. Find the hard disk drive that you want to remove.

Attention: Never hot-swap a hard disk drive when its green activity LED is flashing. Hot-swap a drive only when its amber status LED is lit (not flashing) or when the drive is inactive (activity LED is off).

4. Remove the hard disk drive.




Figure 21. Removing a hard disk drive

- a. Press the latch on the bottom of the tray handle to release it.
- b. Pull out the tray handle to the open position.

- c. Lift the drive partially out of the bay and wait at least 20 seconds before fully removing the drive from the storage subsystem. This enables the drive to spin down and avoids possible damage to the drive.
- d. Make sure that there is proper identification (such as a label) on the hard disk drive; then, gently slide it completely out of the storage subsystem.
- 5. Install the new hard disk drive:
  - a. Gently push the drive into the empty bay until the tray handle touches the storage subsystem tray.
  - b. Push down the tray handle into the closed (latched) position.
- 6. Check the hard disk drive LEDs.
  - · When a drive is ready for use, the green activity LED and the amber status LED are off.
  - If the amber status LED is lit and not flashing, remove the drive from the unit and wait 10 seconds; then, reinstall the drive. If the amber LED is flashing, the drive is being rebuilt.

ServeRAID information: In some cases, the ServeRAID Manager program will automatically reset the drive to the Hot Spare or Rebuild state. If the drive-state change does not occur automatically (amber LED stays lit), see the ServeRAID Manager program online help for information about changing the state of the drive from the current state to another state, such as Hot Spare or Ready. The amber LED turns off within 10 seconds after the drive-state change.

### Replacing the real-time clock battery in the RAID controller

When replacing the real-time clock lithium battery, you must replace it with a lithium battery of the same type.

- Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 2. Label each cable that is connected to the RAID controller so that you can correctly reconnect them to the RAID controller after you replace the battery.
- 3. For storage subsystems with only one controller installed: Stop the host I/O data to the storage subsystem; then, turn off the power-supply switches on the rear of the storage subsystem.
- 4. For storage subsystems with two controllers installed: Move the I/O data to the alternate controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address.
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer disable.
    The controller that you are removing will shut down and all I/O data will have moved to the alternate controller.
- 5. Remove the Ethernet cables from the RAID controller.
- 6. For a Fibre Channel RAID controller only: Remove the fiber-optic cables and the SFP modules from the RAID controller. For more information, see the DS300 and DS400 Hardware Installation and User's Guide.
  - **Attention:** When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details about handling static-sensitive devices, see "Handling static-sensitive devices" on page 33.
- 7. Remove the RAID controller that contains the battery that you want to replace:
  - a. While squeezing together the latch and lever that are on each side of the controller, press down on the orange area on each latch. The controller will slide out of the bay a short distance.






Figure 22. Removing a RAID controller

- b. Grasp both latches and pull the controller out of the bay.
- c. Place the controller on a dry, level surface.
- 8. Remove the battery:

- a. Use a blunt object to press the side of the battery in the direction of the battery socket spring. The battery pops up when released.
- b. Use your thumb and index finger to lift the battery from the socket.





- 9. Insert the new battery:
  - a. Tilt the battery so that you can insert it into the socket on the side opposite the battery clip.
  - b. Press the battery down into the socket until it clicks into place. Make sure the battery socket holds the battery securely.
- 10. Install the RAID controller:
  - a. Make sure that the lever on each side of the controller is down as far as it will go.
  - b. Push the controller into the bay until it meets resistance (about 6 mm [0.25 in.] from the end of the chassis).
  - c. While squeezing together the latch and lever, push both latches up as far as they will go. The controller will slide the rest of the way into the bay.
- 11. Reconnect the Ethernet cables that you removed in step 7 on page 41 to the RAID controller.
- 12. **For a Fibre Channel RAID controller only:** Install the SFP modules and the fiber-optic cables that you removed in step 8 on page 41.
- 13. **For a storage subsystem with only one controller installed:** Turn on the power-supply switches on the rear of the storage subsystem.
- 14. For a storage subsystem with two controllers installed: Move the I/O data back to the original controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address. If the Telnet session is open from step 4 on page 39, go to step 14d.
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer enable.
  - e. Enter controller info.
    - Information about the controller is displayed on the screen. If the information shows that the peer controller status is Not Ready, repeat this step until the status is Ready.
  - f. Enter array failback.The I/O data is moved back to the original controller.
- Wait approximately 10 minutes for the ServeRAID Manager program to come back online.
- Use the ServeRAID Manager program to monitor the status of the storage subsystem.

### Replacing the cache battery in the RAID controller

**Note:** The iSCSI RAID controller in the DS300 model 1RL does not contain a cache battery.

Each RAID controller contains a rechargeable battery that maintains the data in the cache memory for three days without power to the unit.

Complete the following steps if the ServeRAID Manager program instructs you to replace the battery because the current battery has failed or is nearing its expiration date. You can also use the ServeRAID Manager program to check the status of the battery.

**Attention:** For storage subsystems with only one controller installed: To prevent data loss, you must shut down the system before you replace the RAID controller battery. For the correct shutdown sequence, see the *DS300 and DS400 Hardware Installation and User's Guide*.

- 1. Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 2. Label each cable that is connected to the RAID controller so that you can correctly reconnect them to the RAID controller after you replace the battery.
- 3. **For a storage subsystem with only one controller installed:** Stop the host I/O data to the storage subsystem.
- 4. For storage subsystems with two controllers installed: Move the I/O data to the alternate controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address.
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer disable.
    The controller that you are removing will shut down and all I/O data will have moved to the alternate controller.
- 5. If you are not using write-cache mirroring, you might have to clear cache memory on the RAID controller that contains the battery that has failed. To clear the cache, either shut down the controller before removing it from the storage subsystem or turn off caching in the storage subsystem by using the ServeRAID Manager program. Follow the steps in the ServeRAID Manager program before you continue with this procedure.
- 6. For a storage subsystem with one controller installed: Turn off the power-supply switches on the rear of the storage subsystem.
- 7. Remove the Ethernet cables from the RAID controller.
- 8. **For a Fibre Channel RAID controller only:** Remove the fiber-optic cables and the SFP modules from the RAID controller. For more information, see the *DS300 and DS400 Hardware Installation and User's Guide.* 
  - **Attention:** When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details about handling static-sensitive devices, see "Handling static-sensitive devices" on page 33.
- 9. Remove the RAID controller that contains the battery that you want to replace:
  - a. While squeezing together the latch and lever that are on each side of the controller, press down on the orange area on each latch. The controller will slide out of the bay a short distance.




Figure 23. Removing a RAID controller

- b. Grasp both latches and pull the controller out of the bay.
- c. Place the controller on a dry, level surface.
- 10. Remove the cache battery from the controller:
  - a. Loosen the thumbscrew that holds the battery in place.




Figure 24. Removing the RAID controller battery

- b. Hold down the edge of the controller base on the battery side (near the thumbscrew).
- c. Pull up on the blue lift tab on the battery to remove it from the connector.
- d. Slide the battery toward the open end of the controller to remove it.
- e. Dispose of the used battery according to local and federal regulations, which might include hazardous material handling procedures. For more information, see "Battery return program" on page 57.
- 11. Unpack the replacement battery and set it on a dry, level surface. Save the packing material and documentation in case you have to return the battery.
- 12. Install the new cache battery into the RAID controller:
  - a. Slide the battery under the tab near the front of the RAID controller.




Figure 25. Installing a cache battery in the RAID controller

- b. Press down on the blue lift tab to secure the battery to the connector.
- c. Tighten the thumbscrew.
- 13. Install the RAID controller:
  - a. Make sure that the lever on each side of the controller is down as far as it will go.
  - b. Push the controller into the bay until it meets resistance (about 6 mm [0.25 in.] from the end of the chassis).
  - c. While squeezing together the latch and lever, push both latches up as far as they will go. The controller will slide the rest of the way into the bay.
- 14. Reconnect the Ethernet cables that you removed in step 7 on page 41 to the RAID controller.
- 15. **For a Fibre Channel RAID controller only:** Install the SFP modules and the fiber-optic cables that you removed in step 8 on page 41.
- 16. For a storage subsystem with one controller installed: Turn on the power supply switches on the rear of the storage subsystem.
- 17. For a storage subsystem with two controllers installed: Move the I/O data back to the original controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address. If the Telnet session is open from step 4a on page 41, go to step 17d.
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer enable.
  - e. Enter controller info.
    - Information about the controller is displayed on the screen. If the information shows that the peer controller status is Not Ready, repeat this step until the status is Ready.
  - f. Enter array failback.
    - The I/O data is moved back to the original controller.
- 18. Wait approximately 10 minutes for the ServeRAID Manager program to come back online.

**Note:** It might take from 15 minutes to a few hours for a new battery to become fully charged. The ServeRAID Manager program might show the battery as failed until it is fully charged. Controller caching is automatically disabled until the new battery becomes fully charged.

19. Use the ServeRAID Manager program to monitor the status of the storage subsystem.

### Replacing a cache memory module

Complete the following steps to replace a cache dual inline memory module (DIMM). The Cache DIMM amber LED is lit.

- Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- Label each cable that is connected to the RAID controller so that you can correctly reconnect them to the RAID controller after you replace the cache DIMM.
- 3. For a storage subsystem with only one controller installed: Stop the host I/O data to the storage subsystem.
- 4. For a storage subsystem with only one controller installed: Use the ServeRAID Manager program to shut down the RAID controller; then, turn off the power-supply switches on the rear of the storage subsystem.
- 5. For storage subsystems with two controllers installed: Move the I/O data to the alternate controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address.
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer disable.
    The controller that you are removing will shut down and all I/O data will have moved to the alternate controller.
- 6. Remove the Ethernet cables from the RAID controller.
- 7. **For a Fibre Channel RAID controller only:** Remove the fiber-optic cables and the SFP modules from the RAID controller. For more information, see the *DS300 and DS400 Hardware Installation and User's Guide*.
  - **Attention:** When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details about handling static-sensitive devices, see "Handling static-sensitive devices" on page 33.
- 8. Remove the RAID controller that contains the RAID cache DIMM that you want to replace:
  - a. While squeezing together the latch and lever that are on each side of the controller, press down on the orange area on each latch. The controller will slide out of the bay a short distance.




Figure 26. Removing a RAID controller

- b. Grasp both latches and pull the controller out of the bay.
- c. Place the controller on a dry, level surface.

**Attention:** To avoid breaking the retaining clips or damaging the DIMM connectors, open and close the clips gently.

- 9. Remove the RAID cache DIMM from the RAID controller:




Figure 27. Removing the RAID cache DIMM

  - a. Open the retaining clip on each end of the RAID cache DIMM connector. Figure 27 shows the cache DIMM you will replace.

- b. Remove the cache DIMM.
- c. Touch the static-protective package that contains the new RAID cache DIMM to any unpainted metal surface on the storage subsystem. Then, remove the DIMM from the package.
- d. Angle the DIMM so that the DIMM keys align correctly with the slot.




Figure 28. Inserting a DIMM into the connector

- e. Insert the DIMM into the connector by aligning the edges of the DIMM with the slots at the ends of the DIMM connector. Firmly press the DIMM into the connector by applying pressure on both ends of the DIMM simultaneously. The retaining clips snap into the locked position when the DIMM is firmly seated in the connector. If there is a gap between the DIMM and the retaining clips, the DIMM has not been correctly inserted; open the retaining clips, remove the DIMM, and then reinsert it.
- 10. Install the RAID controller in the storage subsystem:
  - a. Make sure that the lever on each side of the controller is down as far as it
  - b. Push the controller into the bay until it meets resistance (about 6 mm [0.25 in.] from the end of the chassis).
  - c. While squeezing together the latch and lever, push both latches up as far as they will go. The controller will slide the rest of the way into the bay.
- 11. Reconnect the Ethernet cables that you removed in step 6 on page 44.
- 12. For a Fibre Channel RAID controller only: Install the SFP modules and the fiber-optic cables that you removed in step 7 on page 44.
- 13. For a storage subsystem with only one controller installed: Turn on the power-supply switches on the rear of the storage subsystem.
- 14. For a storage subsystem with two controllers installed: Move the I/O data back to the original controller:
  - a. Open a Telnet session and connect to the alternate controller management port IP address. If the Telnet session is open from step 5a on page 44, go
  - b. At the command prompt, enter admin.
  - c. Enter the administrator password.
  - d. Enter controller peer enable.
  - e. Enter controller info.
    - Information about the controller is displayed on the screen. If the information shows that the peer controller status is Not Ready, repeat this step until the status is Ready.
  - f. Enter array failback. The I/O data is moved back to the original controller.

# Replacing a RAID controller

**Important:** If the storage subsystem has two controllers installed, do not use the procedure in this section. See the Technical Update about replacing a controller that comes with the replacement controller and is available on the IBM Support Web site (http://www.ibm.com/pc/support/).

When instructed to do so by the ServeRAID Manager program, replace a RAID controller that has failed.

#### Notes:

- The replacement RAID controller does not come with a cache battery or RAID cache DIMM installed. You must remove the cache battery and cache DIMM that are inside the RAID controller that you are replacing, and install them in the replacement RAID controller. The steps to remove and install the battery and DIMM are included in the following procedure.
- 2. The RAID controller in the DS300 model 1RL does not contain a cache battery.

Complete the following steps to replace a RAID controller:

- 1. Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 2. Check the ServeRAID Manager program for instructions for recovering from a RAID controller failure. Follow the instructions in the software documentation before continuing with step 4.
- 3. Turn off the power supply switches on the rear of the storage subsystem.
- Label each cable that is connected to the RAID controller that has failed. This
  ensures that all cables will be correctly reconnected to the new RAID
  controller.
- 5. Remove all Ethernet cables from the RAID controller.
- 6. For a Fibre Channel RAID controller only: Remove the fiber-optic cables and the SFP modules from the RAID controller. For more information, see the DS300 and DS400 Hardware Installation and User's Guide.

**Attention:** When you handle static-sensitive devices, take precautions to avoid damage from static electricity. For details about handling static-sensitive devices, see "Handling static-sensitive devices" on page 33.

- 7. Remove the failed RAID controller (the fault LED is on):
  - a. While squeezing together the latch and lever that are on each side of the controller, press down on the orange area on each latch. The controller will slide out of the bay a short distance.




Figure 29. Removing a RAID controller

- b. Grasp both latches and pull the controller out of the bay.
- c. Place the controller on a dry, level surface.
- 8. Remove the cache battery (DS300 Model 1700-1RS and DS400 only):

a. Loosen the thumbscrew that holds the battery in place.




Figure 30. Removing the RAID controller battery

- Hold down the edge of the controller base on the battery side (near the thumbscrew.
- c. Pull up on the blue lift tab on the battery to remove it from the connector.
- d. Slide the battery toward the open end of the controller to remove it.
- e. Place the battery on a dry, level surface.
- Unpack the replacement RAID controller and set it on a dry, level surface.
   Save the packing material and documentation in case you have to return the RAID controller.
- 10. Install the battery (that you removed in step 8 on page 47) into the replacement RAID controller:
  - a. Slide the battery under the tab near the front of the RAID controller.




Figure 31. Installing a cache battery in the RAID controller

- b. Press down on the blue lift tab to secure the battery to the connector.
- c. Tighten the thumbscrew.
- 11. Remove the RAID cache DIMM from the failed RAID controller:
  - a. Open the retaining clip on each end of the cache DIMM connector.
     Figure 27 on page 45 shows the cache DIMM that you will remove.




Figure 32. Removing the RAID cache DIMM

- b. Carefully remove the cache DIMM.
- 12. Install the RAID cache DIMM in the new RAID controller:
  - a. Open the retaining clip on each end of the RAID cache DIMM connector.
  - b. Angle the DIMM so that the DIMM keys align correctly with the slot.




Figure 33. Inserting a DIMM into the connector

- 13. Install the replacement RAID controller in the storage subsystem:
  - a. Make sure that the lever on each side of the controller is down as far as it will go.
  - b. Push the controller into the bay until it meets resistance (about 6 mm [0.25 in.] from the end of the chassis).
  - c. While squeezing together the latch and lever, push both latches up as far as they will go. The controller will slide the rest of the way into the bay.
- 14. Reconnect the Ethernet cables that you removed in step 5 on page 47.
- 15. **For a Fibre Channel RAID controller only:** Insert the SFP modules and fiber-optic cables that you removed in step 6 on page 47.
- 16. Turn on the power supply switches on the rear of the storage subsystem.
- 17. Wait approximately 10 minutes and then check the status LEDs on the RAID controller. Make sure that:
  - The Ethernet link green LEDs are lit.
  - · The Fibre Channel port green LEDs are lit.
  - · The Controller ready green LED is lit.
  - · The Controller not ready amber LED is off.

For more information about network configuration, see the *DS300* and *DS400* Hardware Installation and User's Guide and the *DS300* and *DS400* Software Installation Guide.

# Replacing a hot-swap power supply

Before replacing a power supply, read the following important information:

- The power supply does not require preventive maintenance.
- The unit must be installed in the correct place to maintain proper expansion unit cooling.
- Use only power supplies that are supported for your specific storage subsystem.

Complete the following steps to replace a hot-swap power supply:

- 1. Read the safety information beginning on page iii and "Installation guidelines" on page 33.
- 2. Turn off the power supply.
- 3. Disconnect the power cord from the electrical outlet and from the power supply.
- 4. Remove the power supply from the storage subsystem:
  - a. While squeezing together the latch and lever that are on each side of the power supply, press down on the orange area on each latch. The power supply will slide out of the bay a short distance.




Figure 34. Removing a power supply

- b. Grasp both latches and pull the power supply out of the bay.
- c. Place the power supply on a dry, level surface.
- 5. Make sure that the power switch on the replacement power supply is turned off.
- 6. Install the replacement power supply in the storage subsystem:
  - a. Make sure that the lever on each side of the power supply is down as far as it will go.
  - b. Push the power supply into the bay until it meets resistance (about 6 mm [0.25 in.] from the end of the chassis).
  - c. While squeezing together the latch and lever, push both latches up as far as they will go. The power supply will slide the rest of the way into the bay.
- 7. Connect the power cord to the power supply.

- 8. Untwist the power cord strain-relief plastic tie (located below and to the right of the ac power switch).
- 9. Wrap the strain-relief tie around the power cord approximately 10 cm (4 in.) from the ac power connector end; then, twist the tie.
- 10. Connect the power-supply cord into a properly grounded electrical outlet.

**Note:** The fault (amber) LED is lit on the new power supply because its power switch is turned off.

11. Turn on the power supply.

After you turn on the power, the fault (amber) LED is off and the Power OK (green) LEDs are lit.
