The ornamental design for a portable computer, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of the portable computer showing our new design.

FIG. 2 is a top, front, right side perspective view thereof, the keyboard being detached.

FIG. 3 is a bottom, rear, left side perspective view thereof.

FIG. 4 is a front elevational view thereof.

FIG. 5 is a front elevational view thereof with the computer in the closed position and the handle extended.

FIG. 6 is a rear elevational view thereof.

FIG. 7 is a right side elevational view thereof.

FIG. 8 is a left side elevational view thereof.

FIG. 9 is a top plan view thereof.

FIG. 10 is a bottom plan view thereof.

FIG. 11 is a top, front, right side perspective view thereof in the closed position and with the handle in the extended position;

FIG. 12 is a bottom, rear, left side perspective view thereof.

FIG. 13 is a right side elevational view thereof.

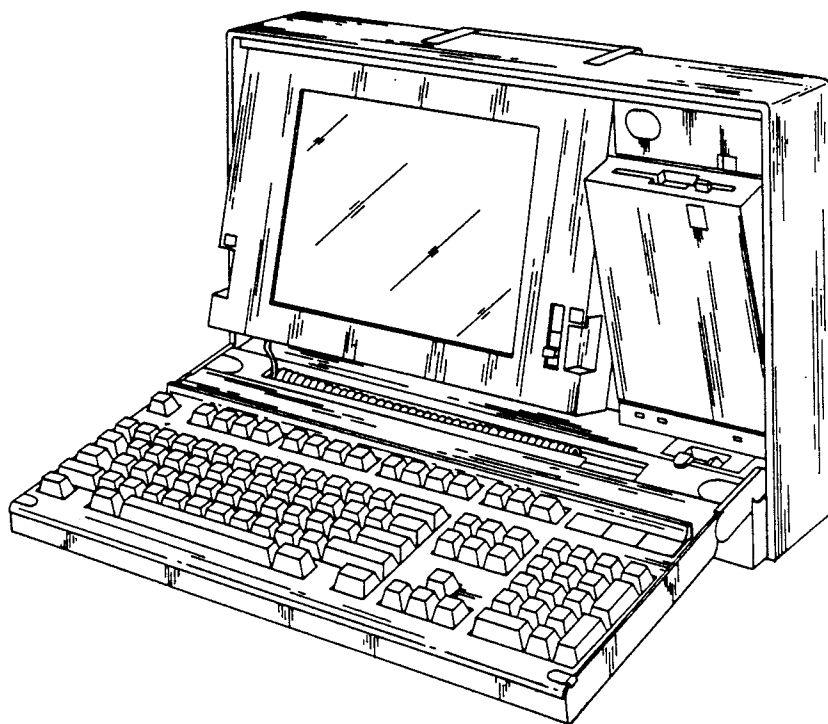
FIG. 14 is a left side elevational view thereof.

FIG. 15 is a top plan view thereof.

FIG. 16 is a bottom plan view thereof.

FIGS. 17 and 18 are respectively left and right side elevational views thereof with the keyboard's supports angled in the downward position.

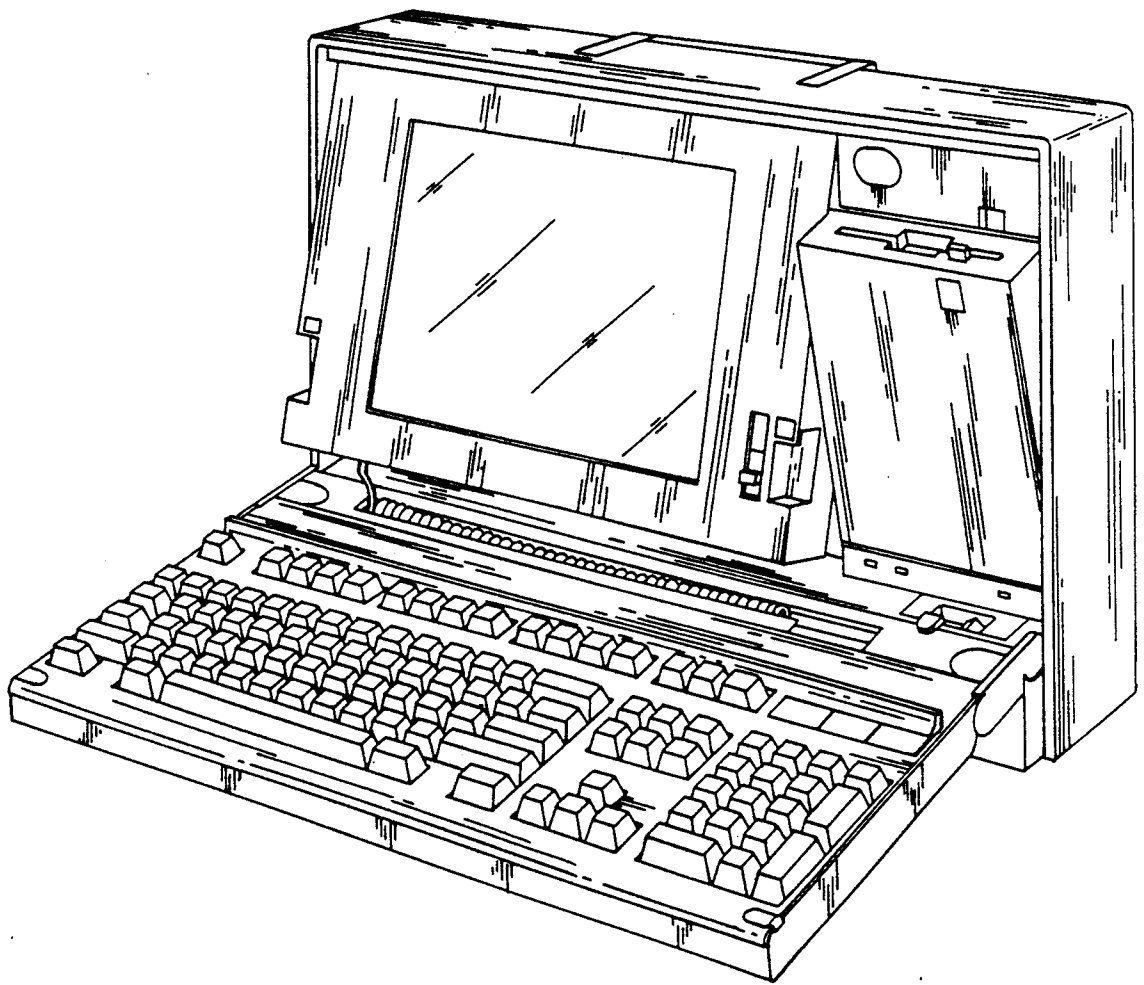

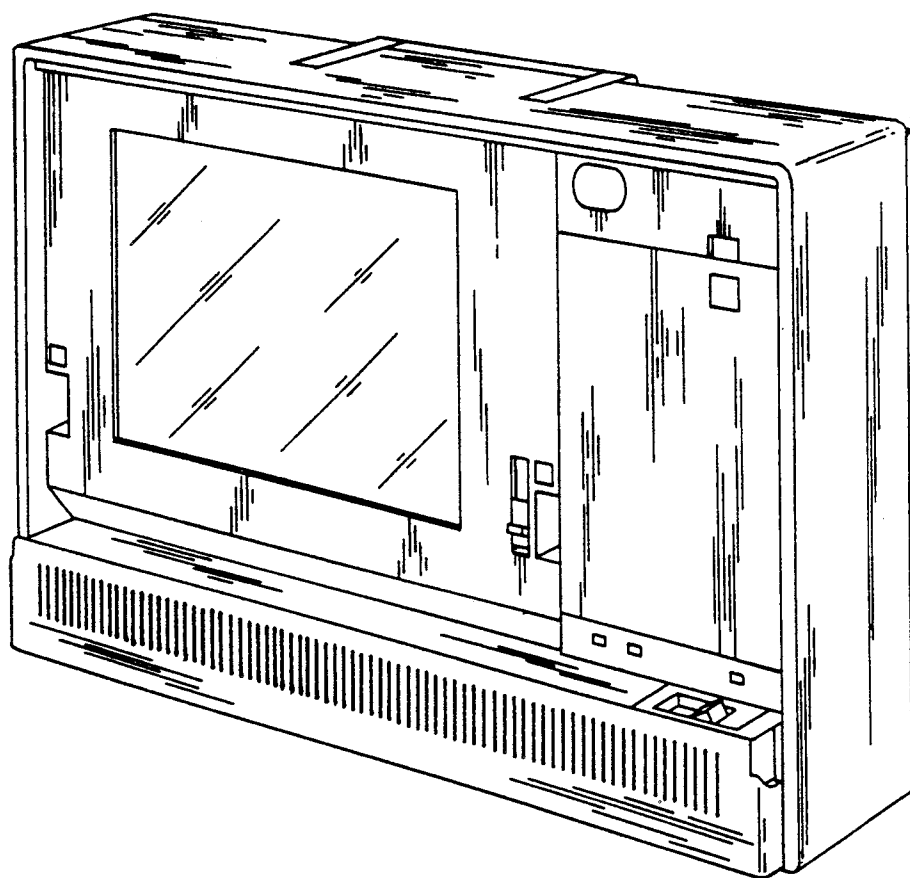

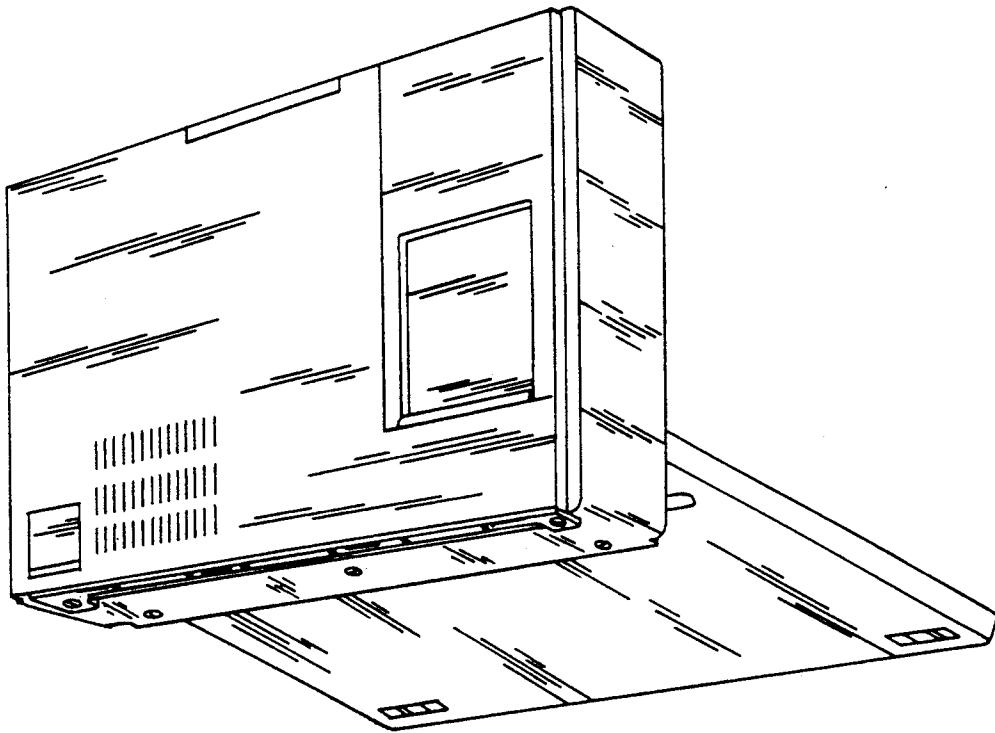

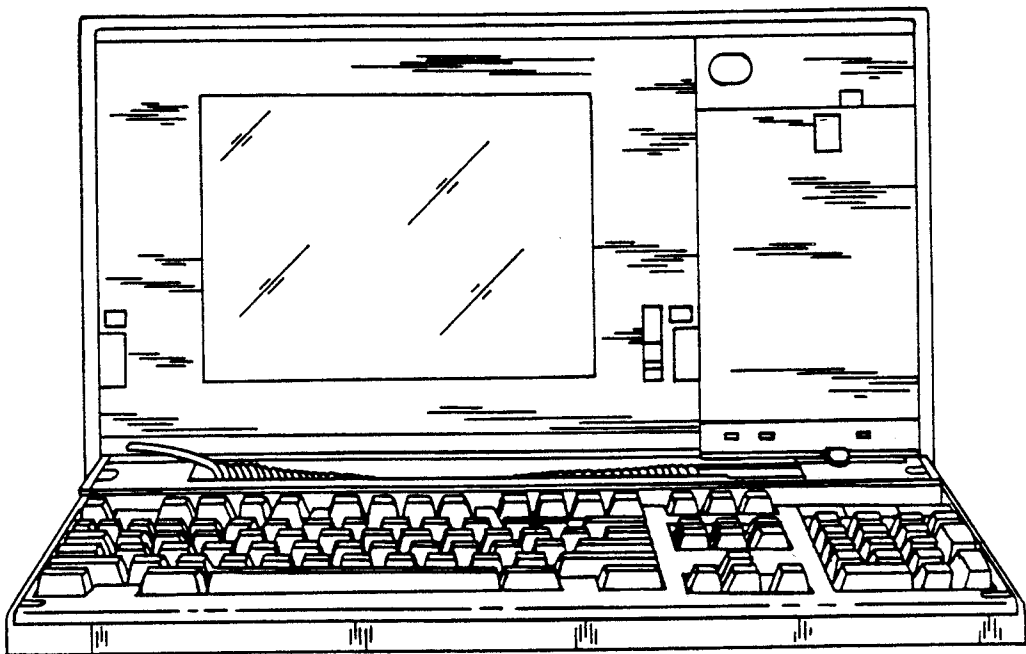

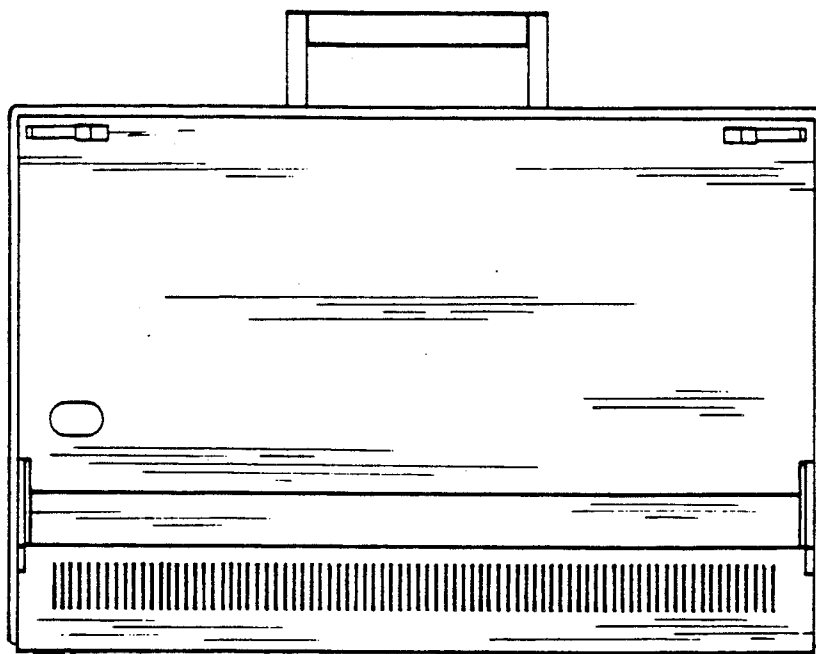

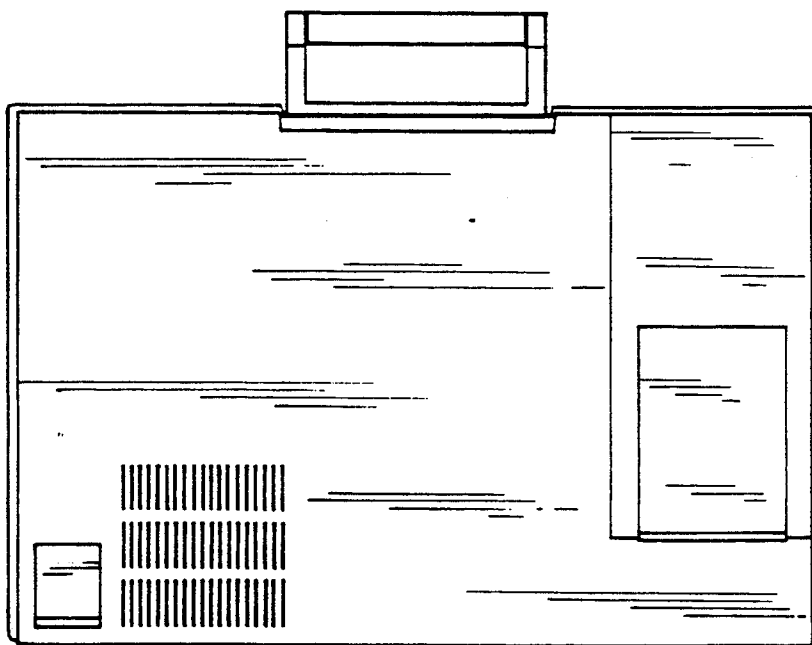

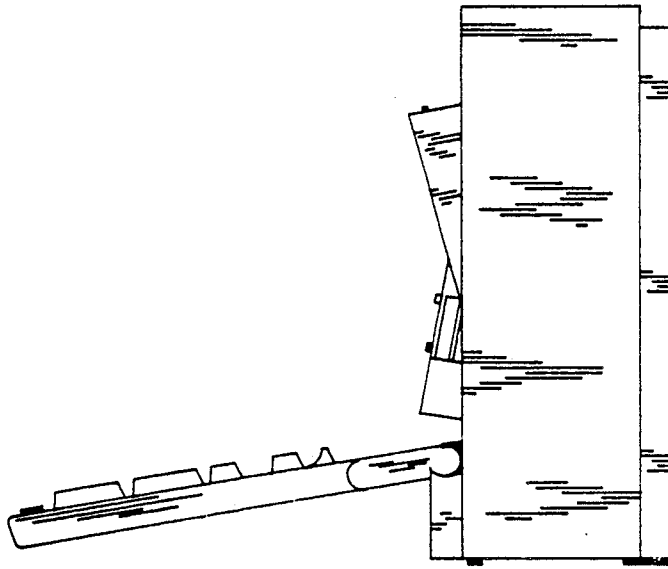

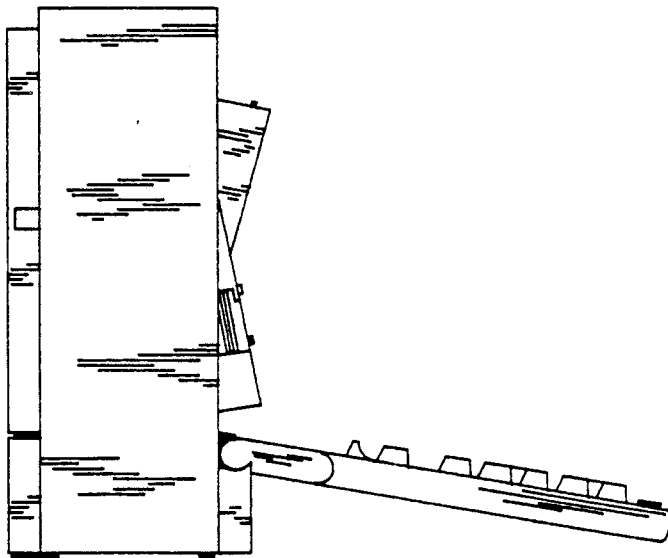

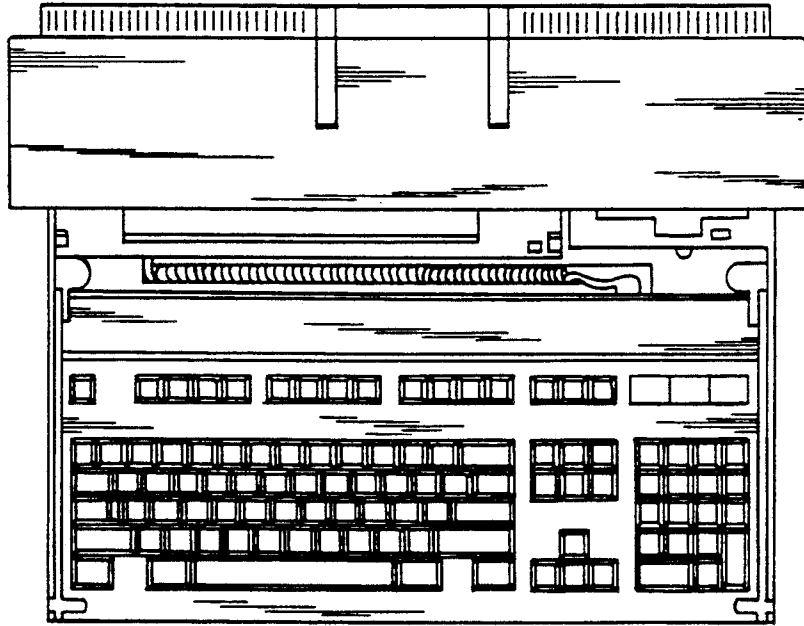
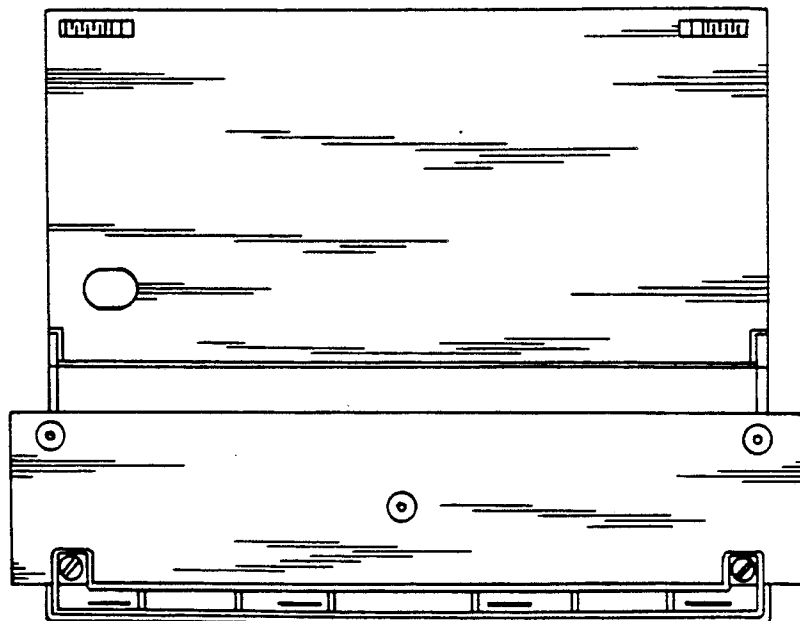

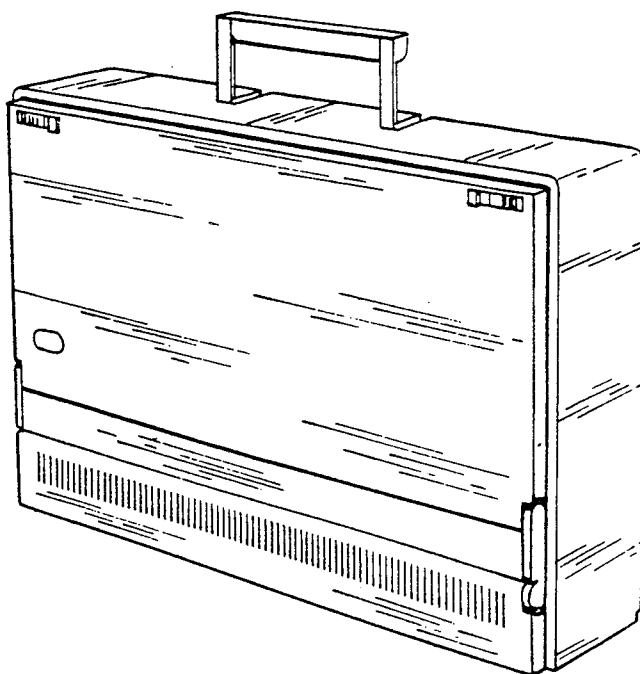

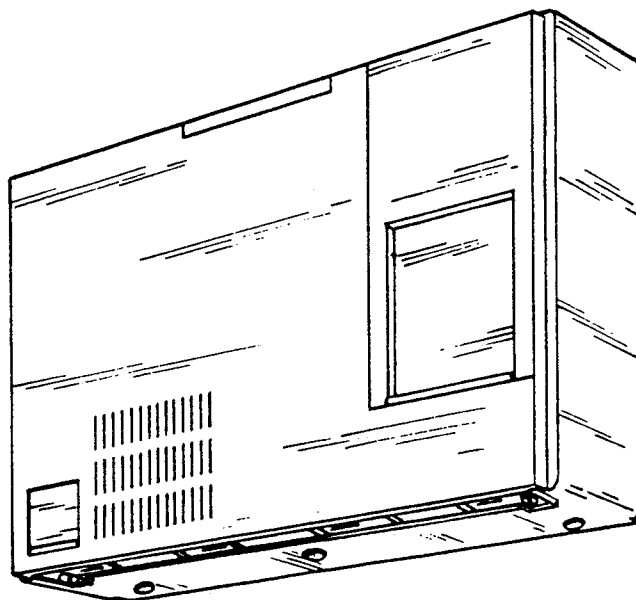

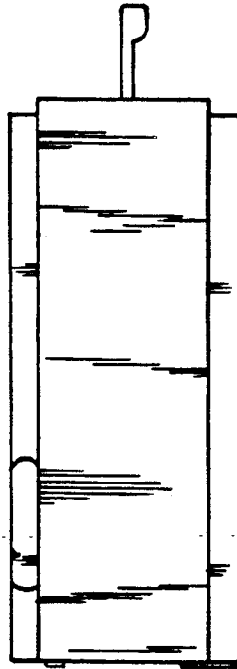
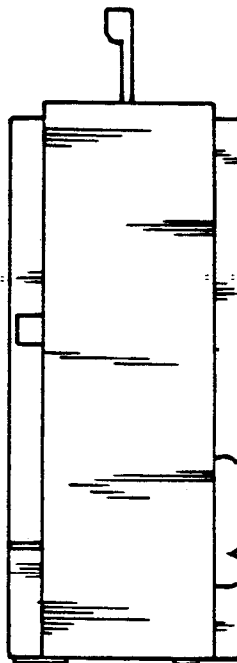

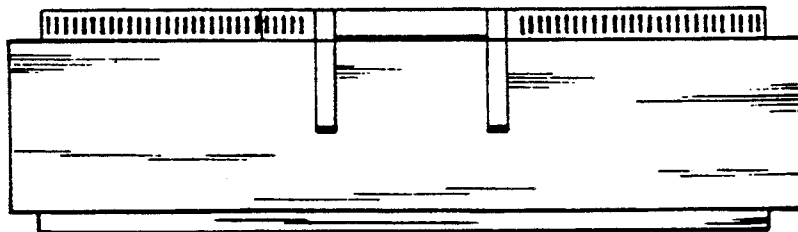

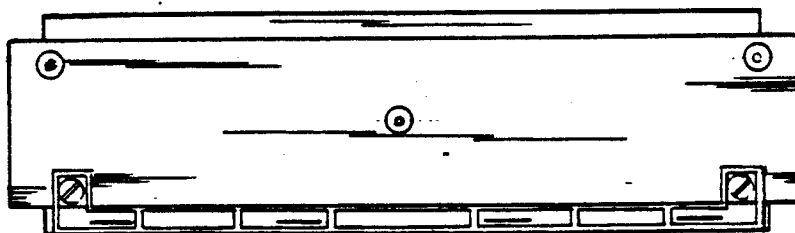

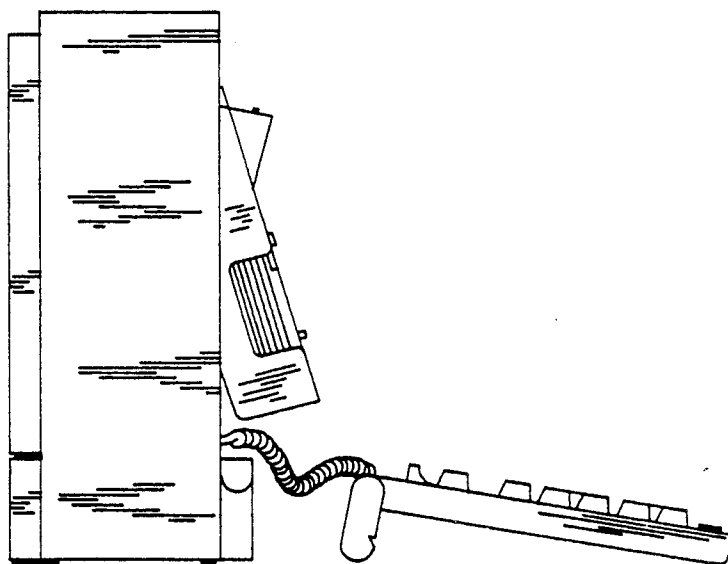

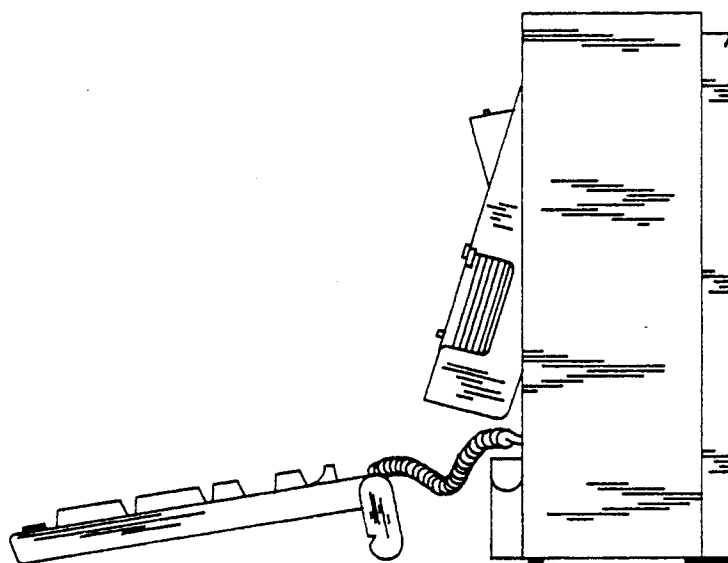
